

Water, water, everywhere! I hope that last weekends rains and winds didn't destroy everyones gardens. We have managed to put everything back into place, and even though we had over a foot of water <u>inside</u> the nursery we were very fortunate that we suffered little or no damage just a lot of very soaked and muddy plants. Hope you were as lucky.

But these rains are going to cause many problems (other than drowning) for our plants. Watch them closely for mildew, funguses, wilting, and rot. Remove all affected areas and destroy. The newer hybrid crapemyrtles should be OK but watch them. An application of fungenex every 3-5 days should keep the problems under control.

Another side affect of the rains will be snails and slugs. Dursban granules will control them, or put shallow bowls of beer around the beds and you'll be surprised at how many you can trap each eveing.

One of the most delightful things about this time of year are the hummingbirds are back. They have been drifting through in small numbers for several weeks but now they are here in force. If you don't want to feed just sugar to them, there are several very good plants that do very well here to attract them, and that keep blooming most of the summer. SALVIA GREGGORII is a bushy sagelike native that has bright red, white or pink flowers. There is also the trumpet vine, trumpet honeysuckle, coral honeysuckle, scarlet monarda, cannas, lillies, and cleome. Plant some or all of these in an area and watch the air show.

OK - things you can still plant in the garden: sweet potatoes, eggplant, corn, beans, okra, peppers, heat tolerant lettuce, and spinach in the shade of other plantings. Celery planted now will mature in the fall. Also, southern. peas, blackeyed peas, lima beans.

Plants and flowers for summer blooming include: Copper plant, cannas, ginger, zinnias, verbena, lantana, yarrow, and the portulacas and moss rose. There are many more that will continue to bloom as long as they are planted in succession plantings and it doesn't get too hot too soon. One of the most beautiful are the lillies. They

are beginning to bloom now and look great.

Remember...watch for problems and get them when they begin, not when it's too late. Onions, garlic, and shallots will begin to turn yellow; this means they are near maturing. Stop watering them to produce longer keeping bulbs, and let them cure for 1 month before you store them.

Optimum height for St. Augustine is 3". Set your mowers for that height. Well, this ought to keep you busy till next time.

### SKIN CANCER RELATED TO LONG TERM SUN EXPOSURE

Basking in the summer sun may seem like a relaxing and healthy activity. But the Texas Medical Association says the long-term effects of too much sun include skin cancer.

There are three types of skin cancer: basal cell carcinoma, squamous cell carcinoma, and malignant melanoma. A chief cause of all three types seems to be years of exposure to strong sunlight.


In basal cell carcinoma, the most common type of skin cancer, cells just below the surface of the skin become cancerous, and a tumor develops and becomes ulcerated. The ulcer grows slowly as it destroys the tissue at its edges. Unlike many other malignant (lifethreatening) growths, it does not spread to other parts of the body until it has been present a long time. A basal cell carcinoma can be removed in a number of ways, and all methods have a high success rate.

Squamous cell carcinoma is characterized by a firm, fleshy, hard-surfaced lump that develops and grows steadily. In some cases, it looks like a wart. In others, it looks like an ulcer, but the ulceration never heals completely. squamous cell tumor usually A appears on a place that is constantly exposed to sunlight, such as the lower lip, the ears, and the hands. Like basal cell carcinoma, this skin cancer usually can be treated successfully if it is detected early.


Malignant melanoma is the most serious of the three types of skin cancer because it often metastisizes, or spreads, throughout the body. In this form of skin cancer, a tumor develops from cells in a mole or sometimes from pigment cells in what looks like ordinary skin. The most common symptom is change in a mole present since childhood. When malignant melanoma is diagnosed,

treatment consists of removal of the melanoma along with a wide margin of nearby tissue. In addition, any nearby lymph glands may be removed, because the cancer can spread through them. In some cases, cytotoxic, or anticancer drugs also are given.

Although physicians can treat many skin cancers successfully, prevention is the wisest course. Limit your exposure to strong sunlight and use sunscreen or sunblock lotion with an SPF (Sun Protection Factor) rating of at least 10.


He's having a hard time dealing with the prospects of life without the Marine Corp as he is quickly reaching mandatory retirement.

### CRIPPLED CHILDREN'S BENEFIT


There will be an all day Fajita Cook-Off held at the Kountry 'N on Hwy. 90 just West of Brackettville on Saturday, June 13, 1987.

Judy Burks will be the Music Director and Kathy Conrey will be the accompanist. The Southwest Texas Genealogical Society will hold its fourth Quarterly meeting in Las Moras Restaurant at Fort Clark Springs in Brackettville Saturday, June 6, from 10 am - 1 pm.

Principal speaker will be SWTGS member Miss Charles Emily Wilson, veteran educator and civic and religious leader in Brackettville, who will detail her role in preserving the heritage of her people, the half-remembered Seminole Indian Scouts of Southwest Texas.

Born on the Ft. Clark post in 1910 in Brackettville, Miss Wilson is a descendant of slaves who fled from their masters and of free men who uprooted their families, left their homes in Florida, went to Oklahoma, Mexico, and ultimately to Brackettville where they were scouts for the United States Cavalry, whose job was to rid Texas of hostile Indians and make the area safe for settlers. In return, the scouts were promised land and citizenship.

Because these Seminole scouts were expert fighters and trackers, they conquered the hostile Indians of Texas in approximately 15 years. Because the army had no further use for the scouts, they were disbanded in 1914. Unfortunately, the government refused to honor its promises to the Seminoles, and they were forced to leave their homes on the reservation.

As a result, some returned to Mexico or left for large cities, but Miss Wilson's parents, Rebecca July and Billie Crawford Wilson, were among the majority of Seminoles who decided to stay in Brackettville. Her father worked at the fort for the quartermaster and her mother served as cook in the homes of the officers.

Her maternal grandfather was Sampson July, and her maternal grandmother was a Creek Indian. Her paternal grandfather, Ben Wilson, came from Mexico to join the scouts. Ultimately, eight men from the July family and 16 Wilsons saw service as scouts.

According to Miss Wilson, "There were only 147 of Seminole Indian Scouts in Southwest Texas during their fewer than 50 years of service, yet they produced four Congressional Medal of Honor winners and compiled a record of bravery unequalled in the history of the cavalry."


After completing her elementary, junior high, and high school education in Brackettville, she received her bachelor's degree from Tillotson College in Austin and her master's degree in education from Prarie View A&M University.

After teaching 43 years in Brackettville, Miss Wilson retired March 31, 1986.

Miss Wilson is a member of St. John Baptist Church, where she is Sunday School Superintendent, president of the Ladies' Mission, and a worker in all auxiliaries. She is also secretary-treasurer of the Seminole Indian Scout Cemetery Association, a member of the Kinney County Library Board, and a member of the Kinney County Historical Commission.

Following the meeting at Fort Clark Springs, a luncheon will be served by Las Moras Restaurant. There will be a luncheon charge of \$5.50 for members and \$6.50 for non-members. Reservations may be made with check payable to SWTGS and mailed to Nell Evins, Box 65, Batesville, Texas 78829.







### HELPFUL HINTS FOR FLOOD VICTIMS

HOW TO SAVE FLOODED CARPET

Fast action can save flooded carpet. For carpet that hasn't begun to dry out very much, chances are good for salvage. If carpet has begun to dry, check for major problems before trying to save it.

Ideally, a professional carpet cleaner can ensure the least damage -- with cleaning, drying and stretching under controlled plant conditions.

However, if professional help is impossible, follow the steps below for looselaid carpet or rugs and for wall-to-wall carpeting.

REMEMBER: The most important factors are removing debris and dirty water and drying out the carpet as quickly as possible to prevent additional damage.

#### LOOSE-LAID CARPET, RUGS

First, take loose-laid carpets and rugs outside and put them on a flat surface, such as patio or concrete driveway.

Use a garden hose with a high pressure nozzle to flush out debris and dirty water.

Then use a carpet-cleaning solution to clean the carpet and remove more soil.

Next, place the rug or carpet FACE DOWN so any stain will "wick" (move) onto the back of the carpet --rather than to the tips of the carpet surface yarns.

Dry the carpet as fast as possible. Even on a warm sunny day, speed up drying by using fans to blow air over the carpet.

Expect some shrinkage, but remember that rapid drying at least will help a carpet keep yarn strenght.

Also in cases of minimal shrinkage, you can use power stretchers to restore carpet on its original size.

WALL-TO-WALL CARPET

Leave carpet ON THE FLOOR in the first stages of clean-up, if possible -- to prevent major shrinkage problems.

Major shrinkage can occur during drying -- when wall-to-wall carpet is removed from its tacking strips.

Start the clean-up by removing as much water as possible. Use a water vacuum -- or the vacuum on a hot-water extraction unit.

Both machines are usually available from rental companies. In suctioning water, do not try to use home-type vacuum cleaners designed for routine household dry dirt and dust removal. Electrical shock can be the result.

After water is removed from the carpet surface, check for water in the pad or the underlayment.

To do that, press down hard on the carpet. If more water comes to the surface, the pad needs further checking.

Lift a portion of the carpet and check as much of the pad as you can.

If the pad seems wet throughout, both carpet and pad must be removed -- to permit carpet, pad and flooring to dry out.

Prolonged moisture on any type of wood flooring will result in buckling and other serious damage.

If the pad seems only somewhat wet, you can remove that moisture by blowing air between the carpet and the pad.

For this, remove the carpet from tacking strips at one corner and use a vacuum cleaner exhaust to blow air under the carpet -- or use a portable hair dryer or fan.

#### APPLIANCES

Do not use major appliances until checked by a serviceman. Unplug all electrical appliances, including lamps, etc. and do not replug until checked by serviceman.

Wall sockets may need to be opened and cleaned out - turn off electricity first.

Discard and replace fabric electric cords. Rubber electric cords can be used after damage is repaired and cords are completely dry.

#### BEDDINGS

Interspring mattress - cleaned by commercial renovating companies call a dry cleaner to find the name of a company. If the mattress is soaked, it may be less expensive to buy a new one.

#### BLANKETS, PILLOWS AND SHEETS

Rinse to remove as much mud as possible. First wash in cold water then in warm suds and disinfectant. (Do not wash in hot water - could make stains permanent). Repeated washing in warm sudsy water may be required.

#### CLOTHING

Rinse to remove as much mud as possible. First wash in cold then in warm suds and disinfectant.

Disinfecting products:

Chlorine Bleach - as disinfectant if fabric permits - 1 cup in washer - dilute in water before adding clothes. Do not use on wool and silk.

Pine Sol - use 1 cup in washing machine.

Roccal - commercial disinfectant safe for most fabrics even wools and silks.

Zephrin - commercial disinfectant safe for most fabrics even wool and silks. Use 2 tablespoons per load in top loading washing machine.

Clothes may be dry cleaned after dried slowly at room temperatures. Tell dry cleaner the source of stain.

#### BOOKS AND PAPERS

1) Open and partially dry

2) Sprinkle partially dry books with cornstarch or talcum powder to absorb moisture.

3) Weigh to straighten pages

4) Alternate opening and weighing until thoroughly dry to prevent pages from sticking together

5) When nearly dry can apply low heat to pages with an electric iron X-14 fungicide may be sprayed on pages to retard mold. (Available at supermarkets). Book will continue to deteriorate after drying because of flood water.

#### FURNITURE

Depend on the extend of damage and value of furniture.

-Antiques are generally worth the time and effort.

-Clean, dry and reglue solid wood furniture. Veneer furniture may not be worth regluing.

-Remove drawers, sides or any moveable parts carefully!

Clean off mud and dry slowly - not in direct sunlight.

when dry reglue and clamp. It may be necessary to consult a professional carpenter.

-For white water marks - wipe with soft cloth and turpentine or camphorated oil or solution of 1/2 cup ammonia and 1/2 cup water. Wipe dry and polish with furniture polish.

If not successful - use 000 steel wool and boiled linseed oil or mineral oil - rub with the grain, wipe dry with soft cloth and wax.

For deeper stains use ammonia on a damp cloth or cigarette ashes rubbed with the grain.

Upholstered furniture ventilate! Clean and dry. May need re-upholstering and padding.



where they will be attending college when they became trapped between two flooded dry creek beds and couldn't go on nor could they return home. Grace Hernandez and her sister were very grateful for the assistance as it would have taken several hours for the floodwaters to recede enough for them to pass. 

# WEATHER RULES FOR SAFE BOATING

by Larry Peabody National Weather Service

It's summer. For millions of Americans, and thousands of Texans, this means boating.

Many who go out on the water in small craft do so for the first time, and inexperienced skippers suddenly learn that responsibility for safe operations goes along with the fun of running a boat.

So before setting out:

Obtain the latest available weather forecasts for the boating area. Where they can be received, the NOAA Weather Radio /NWR/ continuous broadcasts (VHF-FM) are the best way to keep informed of expected weather and sea conditions. If you hear on the radio that warnings are in effect, or see flags or lights at warning display stations, don't venture out on the water unless you are confident your boat can be navigated safely under forecast conditions of wind and sea. While afloat:

1. Keep a weather eye out for: the approach of dark, threatening clouds which may foretell a squall or thunderstorm; any steady increase in wind or sea; any increase in wind velocity opposite in direction to a strong tidal

current. A dangerous rip tide condition may form steep waves capable of broaching or capsizing a boat. 2. Check radio weather broadcasts

for latest forecasts and warnings. 3. Heavy static on your AM radio may be an indication of nearby thunderstorm activity.

4. If a thunderstorm catches you



while afloat, you should remember that not only gusty winds but also lightning poses a threat to safety. --Keep below deck if possible.

- --Keep away from metal objects that are not grounded to the boat's protection system.
- --Don't touch more than one grounded object at the same time (or you may become a shortcut for electrical surges passing through the protection system).
- --Put on a life jacket and prepare for rough sea conditions (by the way, you and your entire crew should be wearing flotation devices <u>anytime</u> you are afloat, <u>not</u> just when weather threatens).

June 7 through 13, 1987, has been proclaimed National Safe Boating Week. In recognition of Safe Boating Week, and to promote safe boating the year round, the National Oceanic and Atmospheric Administration/NOAA/ and National Weather Service, along with the Sea Grant College Program, the National Safety Council, the Texas Safety Association, and the U.S. Coast Guard, offers boaters and marina operators several useful brochures to assist in preparing and protecting boats against severe weather.

To obtain one or more of these safety brochures, along with a listing of NOAA Weather Radio stations and frequencies in Texas and around the Gulf of Mexico, contact the National Weather Service office or Marine Advisory Service Extension Agent nearest you. Additional information may be obtained from the Texas Safety Association and U.S. Coast Guard. Or write or call the Marine Special Programs Meteorologist, National Weather Service Forecast Office, 830 NE Loop 410, Suite 300, San Antonio, Texas 78209, 512/822-1132. Safe boating is no accident, it is a habit. Make this week, and every week, Safe Boating Week.

# SARAGOSA VICTIMS TO RECEIVE DONATIONS

#### DEALERS TO DONATE CARS AND TRUCKS TO SARAGOSA VICTIMS

AUSTIN, Texas--Members of the Texas Automobile Dealers Association are donating more than 60 used cars and trucks to Saragosa, Texas residents to replace those vehicles destroyed by a killer tornado a week ago.

Also, three Texas motor transport companies -- Texas Auto Carrier of San Antonio and T.J. Max Inc. and Auto Convoy both of Dallas -- are transporting many of the vehicles at no cost,

TADA, which represents more than 1,400 Texas franchised new car and truck dealers, coordinated the effort at the request of state Rep. Larry Don Shaw, D-Big Spring, whose district includes Saragosa.

"Every human has some basic needs that must be met -- clothing, shelter, food and transportation," said TADA President Gene Fondren. "There has been trememdous support from the rest of the state -- from the rest of the country as well -and many of Saragosa's food, clothing and shelter needs are met. But without being transportation, they cannot drive to relief shelters, they cannot find new jobs, their attempts to rebuild their lives are seriously hampered,"

The transfer of vehicles will begin within the next few days and they will be distributed by the drawing of lots. Some of the vehicles are going to Saragosa from as far away as East Texas.

The killer tornado that flattened the West Texas town May 22 left Saragosa residents with virtually nothing but the clothes they were wearing when the storm hit.



The Chuck Wagon was very well equipped and carried a tent which could sleep sixteen men at a time. The cooks stove was built to order at a cost of thirty-six dollars with a elongated stove pipe that was used in the tent where the men cooked, ate and slept in rainy weather or when a blue northern blew up.

The food was good, even on the range, not just sow-belly and beans. A typical meal might be beef steaks, sourdough biscuits, gravy, can corn and vinegar pie.

Nelson Morris raised his own Percheron freight horses and sold some on the market. Four or six of these horses pulled his freight wagons on periodical trips to Midland for supplies. He also bred and sold mules.

His Angus cattle were raised on the "C" until they were yearlings, then shipped to his ranches in the Dakotas where they were kept until they were three years old and ready for slaughter. Then they were

shipped to one of his five packing plants.

This part of the country was still wild. The Willow Springs massacre of an ambushed wagon train had happened near here in 1883.

When Morris built his headquarters on his Chicago ranch he built near a spring and a lake which was called Baird Lake, so named for a Captain Baird who was killed by Indians about the year 1862. In 1928, Ladd Callahan in his eighties told the following story about Captain Baird.

Captain Baird was in command of a small party of soldiers on patrol. He had hired a young man named Ladd Callahan as scout because Callahan was familar with the country. When the troopers were near the lake, Captain Ladd saw a lone Indian on horseback and gave chase, while the troopers and scout hung back to watch. When the Indian realized the captain would catch him he took off his moccasins and set them in plain sight in the trail and dismounting, dove into a buffalo wallow and kept under cover. When Captain Baird dismounted to examine the moccasins, the Indian ambushed him, killing him with one shot. Captain Baird was buried near the lake and after scouting around, the troopers went back to Big Spring. because vit was found there were three or four hundred Indians camped at the nearby spring, where the present headquarters of the "C" Ranch now stands. The odds were just too overpowering.

In "A Forgotten Empire of the Pecos", Paul Patterson tells about a big cattle deal that had to do with the Chicago Ranch. The "TX" Ranch which was located on the Pecos near Horsehead Crossing sold 5,000 head of cattle to the "C". Usually the buyers made the delivery in a deal but this time the "TX" delivered the cattle to the railroad in Midland. The cattle were bunched together below the rimrock of what is now called King Mountain. They started trailing about one o'clock in the afternoon. It was such a large herd to move, they didn't stop but went on through the night, arriving at Warfield halfway between Midland and Odessa, where they rested, and moved into the shipping pens in Midland the next day, where they were shipped to the Morris Packing Plant in Chicago. The cattle followed a lantern hung on the tail end of the chuck wagon through the night drive.

Bert Rosenbaum of Indiana as a young man bought a ticket on the Homeseekers train to Pecos, Texas in 1907. On the trains he met two young fellows who were on their way to the "C" Ranch to visit the general manager. The three boys friends and persuaded became Rosenbaum to stop off in Midland with them and go to the "C" Ranch. When the trains stopped in Midland the boys went up town where they bummed a ride on the Chicago Ranch freight wagon which was preparing to take some supplies to the headquarters. When the two lads returned to the east, Bert Rosenbaum stayed on at the ranch. Morris had died in August, a few months before Rosenbaum came to the "C".

Without the information so graciously given by Clint Newlin and Bert Rosenbaum, Nelson Morris would have remained just a biography in a book, instead of a kind, warm and honest personality.

Although Nels Morris was a moneyed man throughout his life, he kept his simplicity of character. He didn't like his name publicly connected with his numerous worthwhile charities, but he gave his name to the Nelson Institute of Pathological Research, which he established. He died in Chicago, August, 1907.

# FACTS FROM OUR COUNTY JUDGE

#### Dear Fellow Citizens,

In my capacity as Kinney county financial officer, I believe that taxpayers of our county are most interested in where our county income comes from, and where it goes. This is public information and can be accurately obtained from the county auditor.

In the immediate future, budget requests for the fiscal year October 1st, 1987-September 30th, 1988 will be reviewed and considered by the commissioners and myself. There will be numerous other items budgeted from the general fund, including insurance, autopsy fund, and indigents burial fund that will make up our overall anticipated budgeted disbursements, and must be offset by estimated budgeted receipts. The current (1986-87) fiscal budget plus budget amendments and the shortages we will have in estimated budgeted receipts will leave us with only a small cash reserve.

This is of grave concern to the commissioners and to me. A lot of belt tightening must be done to comply with the state law mandating a balanced budget, while everyone seems to want a little more.

I am providing some data below for those interested reflecting the countys allocation for its part paid the Kinney County Tax Appraisal Board, as well as the county taxes received and the rate per \$100.00 value for the past five years, as well as the current and proposed 1987-88 fiscal years.

The county budgeted \$36,841.60 for its part for the 86-87 year, which was amended in the amount of \$5,545.47 for a down payment to purchase an in-house computer, totaling \$42,387.07 for this year.

The Tax Appraisal Districts new budget request is for \$44,241.00, and for all the entities is for \$104,674.00, an increase of \$19,200.00
