


### CHARLES W. STAFFORD

The arrest of a 19 year old suspect late Thursday night, June 18th, cleared up two theft cases we had been working on since we received the first report of the crimes on June 12th.

Robert Hugh Tyer of Red Bluff, Iowa was arrested at approx. 11:30 p.m. by this writer and Deputy Sheriff David Luna at a ranch miles North of 20 approx. Brackettville off Tularosa Road. We had received a report on June 12th of the theft of two saddles from the Ft. Clark Stables tack room. The victim of the reported crime was Julian H. Flores, Jr. of Ft. Clark. Mr. Flores reported two saddles the were discovered missing on the 12th but could have been taken prior to that date.

During the course of the week long investigation we turned up evidence linking Tyer to the crime scene and he became our prime suspect within hours of the report.

One of the stolen saddles was recovered at the ranch where Tyer was arrested and another saddle was recovered the following morning. the first Ironically saddle recovered turned out to belong to Debbie Herman of Ft. Clark who had not even discovered it was missing until we called her to come to the Sheriff's Office to identify it. The other recovered saddle was one of the two reported stolen by Mr. At the time of this Flores. writing the remaining stolen saddle has not been located.

Tyer has been charged with 2 counts of Class A Misdemeanor theft and bonds set in the two cases by Justice of the Peace, Alvin Hall total \$1,000.00. The cases will be tried in County Court at a later date. Tyer remains in jail in lieu of the bonds.

On Saturday morning, June 20th, we received a report of a dead body on the railroad tracks 3 miles east of Spofford and the investigation indicates that the unidentified Mexican National was sleeping near the railroad tracks and was struck on the left arm and head by an eastbound train at approx. 12:30 a.m. Saturday.

From evidence at the scene we believe that the man heard the approaching train, raised up to look and was struck by an object

protruding from the train. It appears he was killed instantly and never moved from the position he was in when struck.

Photos and other physical descriptions will be distributed to the Mexican Consul in Eagle Pass and various other law enforcement agencies on both sides of the border in an attempt to obtain identification of the deceased man.

Another incident which occurred late Saturday night left a Del Rio woman hospitalized with injuries she received when she fell from a car on Ann Street in front of the Tax Appraisal Office. The young woman had been drinking heavily and according to witnesses she insisted on riding on top of the car with a male companion. When the driver of the vehicle made a turn off Ann Street both the woman and her companion fell off, he received no


injuries but she had numerous bruises about the face and head. EMS personnel were called to the scene and the accident victim was transported to Val Verde Hospital by ambulance. The woman's male companion was arrested at the scene and charged with Public Intoxication and Resisting Arrest after became. he extremely argumentative with peace officers at the scene trying to prevent his interfering with EMS people attending the injured woman.

He was tried in County Court on Monday, June 22nd and received a \$350.00 fine plus \$88.00 Court Costs on a plea of guilty as charged.

In keeping you advised of the current situation at the county jail, we received nine (9) federal prisoners on Monday, June 22nd. and anticipate added revenue of some \$19,600.00 by the end of July. That added to the \$60,000.00 total already collected adds up to over \$80,000.00 this fiscal year we will have collected in prisoner care fees. As the old saying goes "that's better than a kick in the pants."

#### AN HERB GARDEN

There are many kinds of Gardens why no an herb garden, close to the kitchen door. They may be planted in a small plot, hanging baskets, pots, and even in old tires. A tire for each herb. This type of garden can be beautiful, as the plants have delicate blossoms in soft . lovely colors. Herbs are both annual and perennial.

Some of the annual herbs are dill, basil, and borage. If you grow dill from seed, thin the plants eight to ten inches apart. It has feathery leaves and pale yellow blossoms. Use good soil and drainage for all herb plants. Basil adds color to a garden with its green leaves tinges in purple, with small white and purple flowers. It smells similar to cloves, and the plants should be spaced about ten inches apart. Borage has a place in the herb bed also, as it has lovely blue flowers that look like the Forget-me-not, and the fresh leaves taste like cucumbers.

Some of the periennial herbs are the following: chives, thyme, mint, and sage. Chives is a timy onion of a delicate flavor. Its leaves are tubular and produces rount clusters of lavendar flowers. The clumps should be divided every two or three years, and may be used to border a flower bed. It can be planted in a pot and placed on the window sill. An upright growing herb in the Thyme with pink and lavender flowers. The leaves have the best flavor before the blossoms appear. Mint grows easily and spreads very fast, its leaves are dark green and the flowers are lavendar. This herb has many uses. Sage plants last for years if planted right. The foliage is gray with lavendar spicy flowers, but beware, the flavor is strong and should be used sparingly.



### WARNING

Commissioner of Insurance George Dale is warning the public to be careful in purchasing senior citizens life and medical insurance television advertisements endorsed by famous personalities. "Many of the ads dwell on low cost, but consumers do not realize they have purchased a policy with limited benefits until it has already been issued," Dale said. A life policy may pay no benefit if the insured dies of natural causes within two years of purchasing the coverage. The company will pay only the actual premium paid by the policyholder under the terms of the policy. In other instances, reduced benefits are paid to beneficiary during the first two years after the life policy is in effect. For example, one company will pay only ten percent of the face amount if the insured should die within the first year. This would result in a \$200. benefit paid on a \$2,000 policy. "Mississippi law policyholders a ten-day period that the policy can be returned to the company for a full refund if it is determined you do not desire to keep the coverage," Dale said. "Individuals should take the time to review the policies upon their

company if the coverage is not what they thought was being bought." He said that some of the medical insurance offered in the television ads pay a set amount for each day a person is in the hospital: however, the first three days of confinement are excluded.



"Owens of the railroad", was what they called them when the railroad was king.

For nearly one hundred years the name Fred Harvey has been connected with good food and the railroad. Shortly after landing in 1850 in New York Harvey got his first job in the Smith McNeill Cafe. He was fifteen years old and just over from London, his native home. He made two dollars a week washing dishes. But he kept his eyes open and learned the resturant business and in 1850 he established his first dining hall in St. Louis. He opened his first railroad resturant on the second floor of the Santa Fe depot in Topeka, Kansas in 1876. In the eighteen eighties and nineties he started other dining halls through Kansas, Colorado, Texas, Oklahoma, and New Mexico and on to Arizona and California.

In those days meals on trains was poor if any, but now the Harvey Girls provided service in attractive dining halls along the railroad. With their clean and pleasing appearance and good manners they were an instant success.

Harveys' Girls were recruited from good homes in the east and historians say they played a large part in railroad history and the settlement of the west. They brought culture, refinement and romance where buffalo, wild Indians, and horse stealing was common place.

Dormitories were built for the girls complete with house mothers. They were entirely protected and many were former school teachers. Even some of the local wayward men were seen escorting a Harvey Girl to church on Sunday.

It is claimed that four thousand Harvey Girls who were married, named a baby Fred, or Harvey or both.

The girls were visions in their black and white waitress uniforms and legends grew up around them and their employer.

Will Rogers once said he figured Fred Harcey and his girls kept the west in "food and wives".

One story goes that twenty thousand of the pretty Harvey Girls wound up as brides to western cowboys, ranchers and railroad men.

When the railroad business reclined, the Harvey Company moved to the airports, shopping centers and resorts. There are still resort facilities in some of the National Parks as well as other locations across the land.

But the Harvey Girls were not the only attraction of the Harvey house.

Before nineteen hundred breakfast cost fifty cents and included cereal or fruit, eggs on top of thick juicy steaks with hash browns and six large hotcakes swimming in butter and maple syrup, topped off by apple pie and coffee.

Dinner was seventy-five cents and varried, featuring a delicious entree (sometimes wild game) and served with a smile by the Harvey Girls.

The one regulation Fred Harvey insisted upon was the "coat rule. In his early days it was proper to wear dinner jackets. Harvey kept a supply of dark coats on hand and would loan his customers the use of one before he would turn him away. I guess the casual dress habits nowadays would cause Harvey to figure up some different arrangements.


One of the stories circulated was when Fred Harvey died at sixty-six his last words were "Don't cut the ham too thin."

Harvey Company became a subsidiary of Amfac Inc. and the legends and aura of romance that always surrounded the Harvey House Girls was no more.

Recently in Las Vegas, New Mexico a beautiful Harvey House has been restored and is used for community activities and features the historical dining hall.





Superintendent Bob McCall announced earlier this this month that all of the Brackett Seniors successfully demonstrated mastery of the Exit Level TEAMS Test. Mr. McCall said that there were two seniors that passed the test in May. All others had successfully mastered the test at one of the three earlier test dates. Onluy special education children are not required to demonstrate mastery in the Reading and Math portion. All other students who do not demonstrate mastery cannot receive a diploma, or go through the graduation ceremony.


