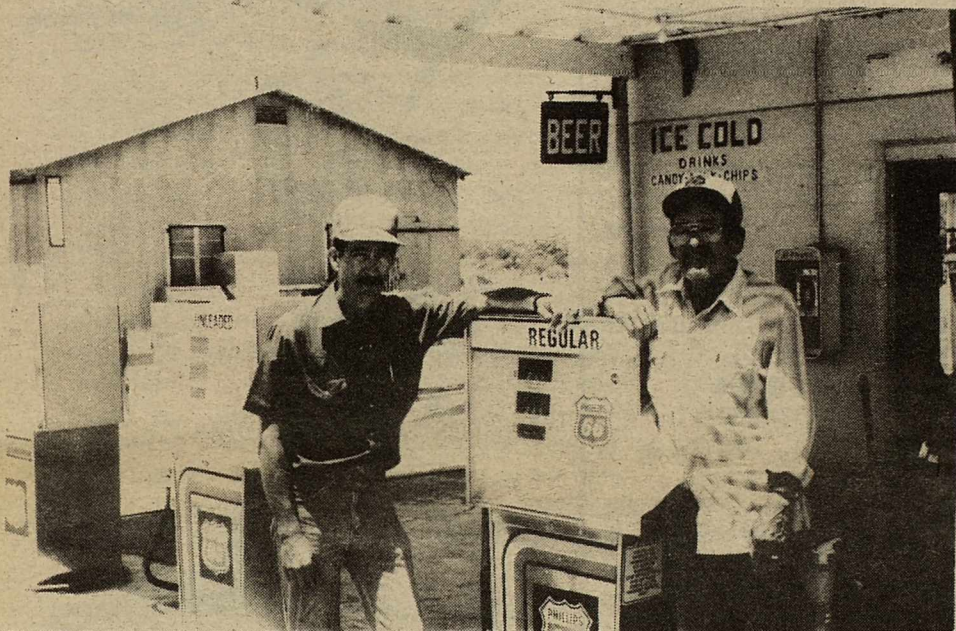

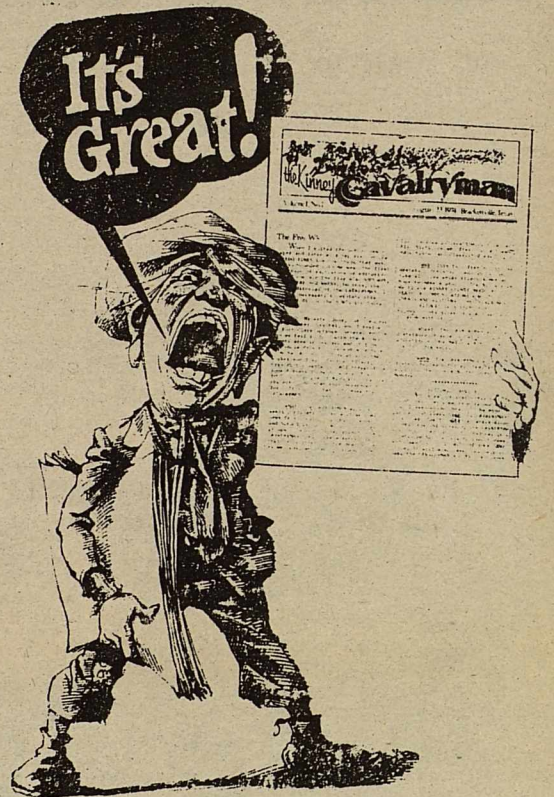
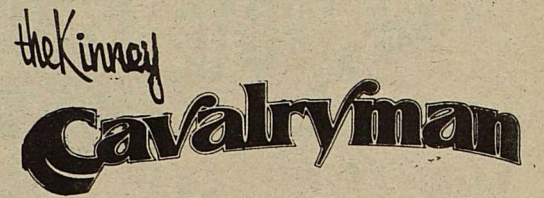

UVALDE PLAZA ANNOUNCES GRAND OPENING

Grand Opening activities are set for July 16th at a new 94,000 square foot shopping center in Uvalde, Texas developed by CBL & Associates, Inc., of Chattanooga, Tennessee and Holliday Interests, Inc. of San Antonio. Local officials and the general public will be on hand for the Grand Opening ceremonies at Uvalde Plaza.

"We will be adding approximately 34,000 square feet of retailing space to a new Wal-Mart Department Store which opened in September 1985," stated Charles B. Lebovitz, president and chief executive officer of CBL Associates, Inc.

BRACKETTVILLE, TX-St. Andrew's Episcopal Church of Brackettville, the oldest Episcopal church west of San Antonio in the Diocese of West Texas and the first Protestant church of Brackettville, will be celebrating its 120th anniversary Saturday and Sunday, July 18-19, according to the Rev. Bill Koons, vicar.

Saturday festivities will include displays of memorabilia and films on the church's history at St. Andrew's parish house from 9 a.m. till 6 p.m.; at 7 p.m. at Fort Clark Springs, the Rt. Rev. John H. MacNaughton, Bishop of the Diocese of West Texas, will be preacher at an ecumenical service. A barbecue and music by a mariachi band will follow. On Sunday a 9:30 a.m. continental breakfast in St. Andrew's parish house will be followed at 10:30 a.m. by a Holy Eucharist and Confirmation, at which Bishop MacNaughton will be preacher, celebrant, and confirming prelate. A luncheon to honor Bishop and Mrs. MacNaughton, the Confirmands, and the early pioneers of St. Andrew's will follow in the parish house.

First recorded Episcopalian services for civilians in the Brackettville-Del Rio area were held in 1864 by the Rev. T.C. Stanley, military chaplain at Fort Clark, a main cavalry post which opened in 1852. By 1867 organized services were held in the hospital tent at Fort Clark for the people of nearby Brackettville, the congregation being called "St. Andrew's" and becoming a church within the Diocese of Texas with see city at Houston with the Rt. Rev. Alexander Gregg serving as Bishop.

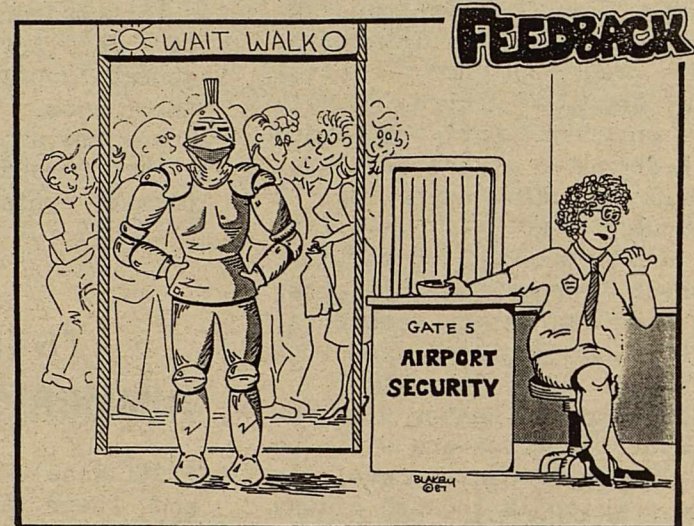
Soon after his assignment as chaplain at Fort Clark, the Rev. D. Eglinton Barr, Episcopal priest, organized a Sunday school meeting in a Brackettville store, an old picket building with a grass roof, located near the present Kinney County Courthouse. This building was in use for both Sunday school and worship in 1874 when St. Andrew's became a member church of the newly-formed Diocese of West Texas with see city at San Antonio, where the Rt. Rev. Robert B. Elliott served as the first Bishop. Under Chaplain Barr's guidance the first daily school in Brackettville was established "under the charge of Mrs. Ballantyne, a member of the Church."

In 1891 under the leadership of the Rev. Q.A. Rose, priest-in-charge of the local church, and Bishop James S. Johnston, a cornerstone was laid for a new building for St. Andrew's at the site of the present church. This building, completed and dedicated in 1891, was the first Protestant church in Brackettville. In 1927 a storm blew this building from its foundation, and the congregation, under the leadership of the Rev. Frank H. Stalknecht, priest-in-charge, voted to build a multi-purpose parish house. In 1930 Bishop William T. Capers dedicated the new parish house and deconsecrated the damaged church building. This parish house still serves St. Andrew's today.

In October 1963, when the priest-in-charge was the Rev. O. Wallace Nickle, St. Andrew's Church awarded an architectural contract for a new church on the

site of the old wind-damaged building which had been dismantled in 1932. This new building was dedicated by Bishop Everett H. Jones on March 15, 1964, and serves today for worship of Episcopalians in Brackettville.

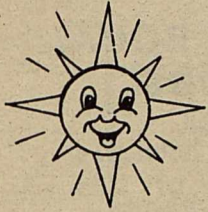

GREEN TIPS

We have had many people ask us over the last few days about fruit tree varieties. What is a good peach tree or apple tree, and can they be planted this time of the year? So I thought I'd go over the recommendations given by our county extension service and list a few trees that do well here.

For peaches: June Gold, La Feliciana, Dixieland, Red Globe, Rio Grande, and Sam Houston are all large, freestone peaches. Sam Houston and Rio Grande peaches are very popular in our area, but the problem with them is they don't bare fruit as consistently as the others. Peach crop production depends on two main factors other than unpredictable weather. One is the root stock on which they are grafted. For Texas soils, a nematode resistant root stock is essential. The root stock also determines the size of the tree, from double dwarf, dwarf, semi dwarf, to standard.

The second major factor is the chilling time required to set fruit for each different variety of peaches. These listed all meet the chilling requirements of our area.

Other varieties of peaches

include Texstar, Sentinel, and Harvester. These are medium size peaches. The smaller peaches include Spring Gold and Bicentennial. Floudaking is a large cling peach.

Another question often asked is how big the fruit gets on a dwarf tree. The fruit is exactly the same size as on a standard tree. The fruit is not dwarf, the tree stock is. In most cases the fruit quantity is as great for a dwarf or semi dwarf as a standard tree.

The advantage of a dwarf tree over a standard size tree is the amount of room needed for spacing between trees. The recommended spacing on a standard tree is 30 ft. between trees. On dwarf or semi dwarf trees they can be planted as close as 8 or 10 ft. Another advantage is the ease of harvesting the fruit. 30 ft. high trees are harder to harvest than 15 ft. high trees.

Fruit trees can be planted almost any time of the year when bought in containers or bagged and burlaped. Ideally the best time is December through Spring. If planted in late summer or early fall it enables the tree to become somewhat acclimated and allows the tree to establish a root system before the first freeze. Many times this enables the tree to put on fruit a season earlier.

Well, I've run out of space to go over apple varieties, so I'll do them next time. Good Picking!

AUGUST 17-LAST DAY TO BID IN LAND SALE

AUSTIN -- Texas Land Commissioner Gary Mauro today reminded Texans they have until August 17 to submit bids on public land included in a special sale of 257 tracts of state land being offered to the public through the Texas Veterans Land Board.

Located in 105 counties across Texas, the tracts range in size from about 10 acres in several counties to a 57-acre tract in Lamb County.

All tracts are open to bids from eligible Texas Veterans and many of the tracts are available for bid by non-veterans. The interest rate to Texas Veterans is 8.75 percent and the interest rate for the general public bidding on non-veteran tracts is 10.25 percent. Both will carry a 30-year assumable fixed-rate loan. A \$25 non-refundable bid fee for each bid submitted has been set by the board.

The Texas Veterans Land Board will finance the entire loan amount less 5 percent for both eligible Texas Veterans and the general public. There is no limit on the amount loaned.

A public reading of the bids will be held on August 17, 1987, at 10:30 a.m. in Room 831 of the Stephen F. Austin Bldg. at 1700 N. Congress in Austin.

"I want to urge all Texans that have been looking for quality land to take advantage of this unusual high-bid sale. Everybody has an equal shot at winning under this arrangement," said Mauro, who serves as chairman of the Texas Veterans Land Board.

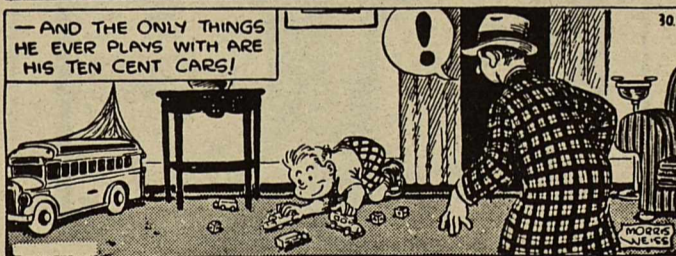
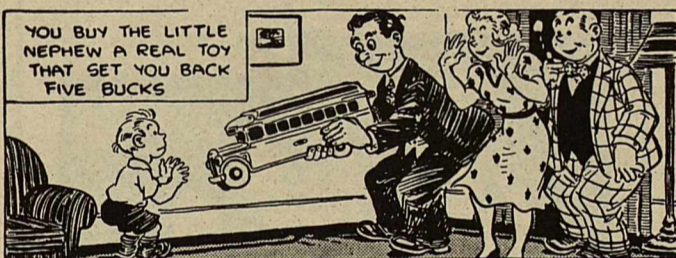
The sale will be by sealed bid only with a minimum bid set by the Texas Veterans Land Board. All bids must be received by the board by August 17, 1987, at 10:30 a.m. at which time the bidding will close. Any and all bids received after that time will be rejected. Bidders need not be present at the bid opening.

Fewer than one percent of the more than 94,000 loans made through the Texas Veterans Land Program have resulted in forfeiture because of delinquent payments.

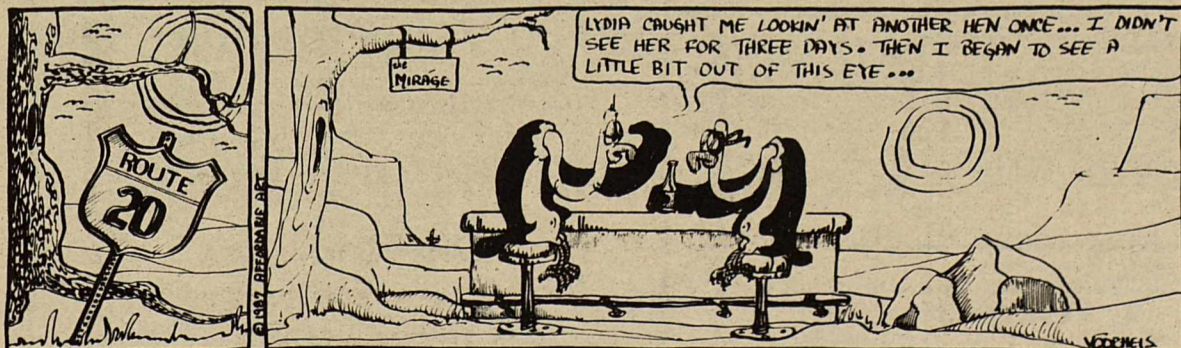
"A fair but aggressive policy toward delinquencies is necessary if we are to continue offering generous terms to our Texas Veterans through this excellent program," Mauro said.

AID'S Contagion 'Misunderstood'

If there is any good news associated with AIDS (acquired immune deficiency syndrome), it may be that the ways in which the HIV (human immunodeficiency virus) travels from one person to the next are limited.

According to the Texas Department of Health (TDH), research on the thousands of reported cases of AIDS has traced the transmission of the virus to two types of contact with HIV, sexual and "blood-to-blood."

Christie Reed, AIDS Surveillance Coordinator for the TDH Bureau of Epidemiology, said, "The contagiousness of AIDS is often

misunderstood, and nearly always exaggerated to the general public. HIV passes from an infected person to another only in blood, semen, and to a lesser extent, vaginal fluid -- not by casual contact or the environment."

Sexual transmission can be heterosexual or homosexual, but can usually be prevented by use of condoms.

Blood-to-blood transmission most often occurs when infected persons share hypodermic needles and syringes with others. Some infants born to infected mothers also have been infected.

In the U.S., blood and blood products used for transfusions and in medicine have been screened since the spring of 1985. Health care workers and others routinely exposed to blood are specially trained to use appropriate precautions.

Laboratory tests and environmental research show no evidence that HIV is spread through drinking water, in the air, or by mosquitos, as are some other viruses.

Reed said that 97 percent of the AIDS cases reported in Texas are the result of the patient having had sex with an infected person, having shared contaminated I.V. drug equipment, or having received infected blood. "That percentage would probably be higher, if we had more information about the remaining three percent. We are uncertain how a few people have contracted the disease, only because those people either refuse to disclose important details, died before enough information could be collected, or did not know if their sexual partners had been exposed to HIV."

Reed said public concern about AIDS is intense because the relatively new disease is considered always fatal. No vaccine for AIDS has been found, and possible treatments are only now being tested. "Being concerned should be different from being hysterical," Reed said. "The fact is, AIDS can be prevented. The public needs to exhibit less fear, and exercise more caution."

INCREASED TAXES EQUAL DECREASED JOBS

The Committee for Economic Recovery, a coalition of 85 organizations and individuals, today urged Governor Clements, Lt. Governor Hobby, Speaker Lewis, and all Senators and Representatives, to adopt the suggested budget cuts by the Texas Conservative Coalition (TCC) of legislators. Over the last 4 years sales taxes have risen 31% and gas taxes have tripled; if taxes are now increased another \$6 billion, as Lt. Governor Hobby and the Senate desire, the committee says economic recovery for Texas will be greatly delayed and an unacceptable number of Texans will remain unemployed!

Richard Ford, spokesman for the group, pointed out, "a study by the National Center for Policy Analysis in 1985 and another study by Texas A & M Center for Free Enterprise in 1986, plus a host of other national studies indicate tax increases, decrease jobs. California and Massachusetts had to have massive tax roll backs during the last ten years to foster their economic recoveries. Texas should cut

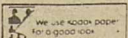

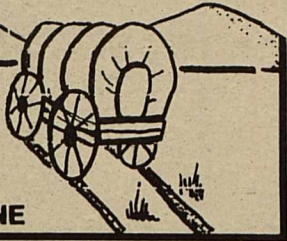

ALONG THE
TRAIL

Real de Catbrce, perhaps the biggest and oldest ghost town in Mexico, is not only a place for tourists to see a real ghost town...once an industrial center with a population of more than twenty thousand inhabitants, it gives you a chill when you walk through its quiet, empty and narrow streets.

It is located high in the mountains, twenty-five miles up a rocky, bumpy trail due west from Matchuala. This city is on the super highway to Mexico City from Laredo, Texas two-hundred and seventy miles south of the Rio Grande.

A few families live in Real de Catbrce who make a meager living acting as guides for the few tourists who come to Real. Some mines are located out of Real, and a few miners still work there.

A tourist can drive his own car, take a taxi or a small shuttle bus used to run from Matchuala.

How can such a large city become a ghost town? You might ask Don Juan Pablo Peter Flores who lived in Real all his life and has passed on the story as he knew it.

He says the Revolution ruined the town. The Spaniards were forced out of the country so they dynamited the mines, and after they were gone, Real de Catbrce was finished. Where there was once the sound of laughter, there is only silence. But that was many, many years ago.

The town was founded in 1772 when Sebastian Coronado, and Antonio Llanas discovered a large silver mine. So rich was Reals' mines that the city ranked third in production in the whole country, making a profit of 5,500,000 pesos a year which in Mexico, that long ago, wasn't chicken feed.

The production of silver was so large that a mine was established in the very heart of the city, this mine is empty too. There is a deep ravine more than three-hundred and sixty feet deep which adequately took care of the cities garbage. Also it claimed the lives of citizens who strayed too near the edge and fell to their deaths.

Now American tourists look into the deep ravine and roam around steep, cobble stoned empty streets.

Another theory was passed along by another elderly resident as to why Real de Catbrce has become a ghost town.

It seems there is a very old legend that tells of a headless horseman who drags a clanking chain on certain nights of the year.

The old lady that knew this legend claims she has seen the headless horseman with her own eyes, and has heard the clanking of the dragging chain.

Another story tells of a mysterious ball of fire that can be seen near an old cross made of grapefruit wood, just across the ravine.

This same woman always claimed she has insisted tourists stay over night to see these events for themselves, but no tourist has ever stayed over night.

When the deepening shadows fall on the empty streets and a chilly wind hits you in the face, you suddenly want to get back to civilization as soon as possible.

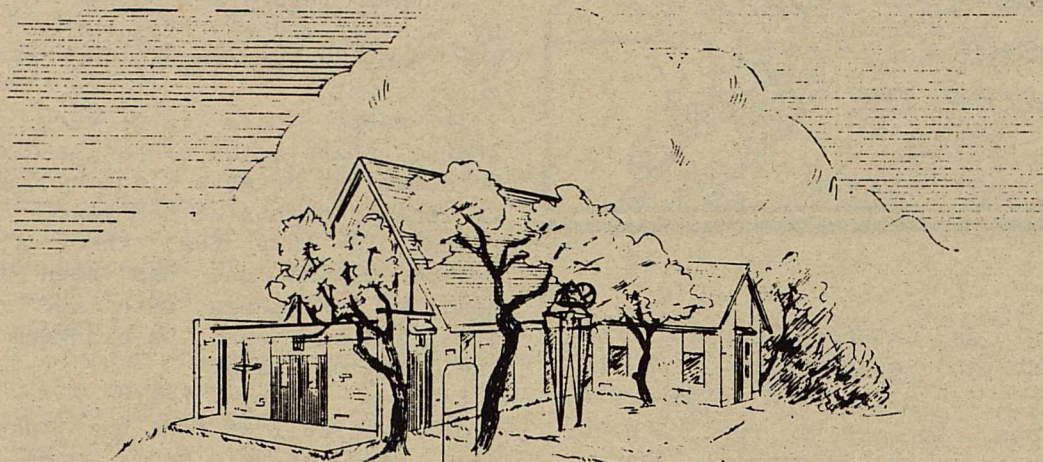

**ST. ANDREW'S CHURCH
BRACKETTVILLE - 1867**

ST. ANDREW'S may properly claim to be the oldest Episcopal church extant in the Western Convocation. It was organized, informally, and services were being held (conducted by an Army chaplain) as early as 1867. Then Ft. Clark was in its hey-day as a frontier cavalry post. However, the formal organization of a permanent church was not possible until Bishop Elliott's famous visits occurred in the 1880's. St. Andrew's first appears in the Diocesan Journals in 1888.

In 1891 St. Andrew's first building was dedicated. Forty years later it was de-consecrated by Bishop Capers and a new multi-purpose parish house took its place. Finally in 1964 the present structure was finished and dedicated by Bishop Jones.

St. Andrew's is served by the rector of St. James', Del Rio, and like its sister church in Del Rio, it represents a case where Episcopal lay-evangelism outran the traditional structure of the Church. The sketchy "bits and pieces" of history we have of Church activities in this area in frontier days can only tease the historian and testify to the faithful the fact that God did not "leave himself without a witness."

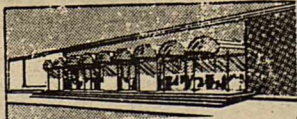

ORDINANCE # 210

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRACKETTVILLE, TEXAS:

Section 1. TRASH BURNING PROHIBITED. It shall be unlawful to burn brush, tree limbs, grass, trees, leaves, boards, planks or lumber in the City Limits.

Section 2. PENALTY. Any person convicted of violating this ordinance shall be punished by a fine of not less than \$1.00 nor more than \$200.00.

Section 3. EFFECTIVE DATE. This ordinance shall become effective immediately upon its passage, approval, and publication as provided by law.

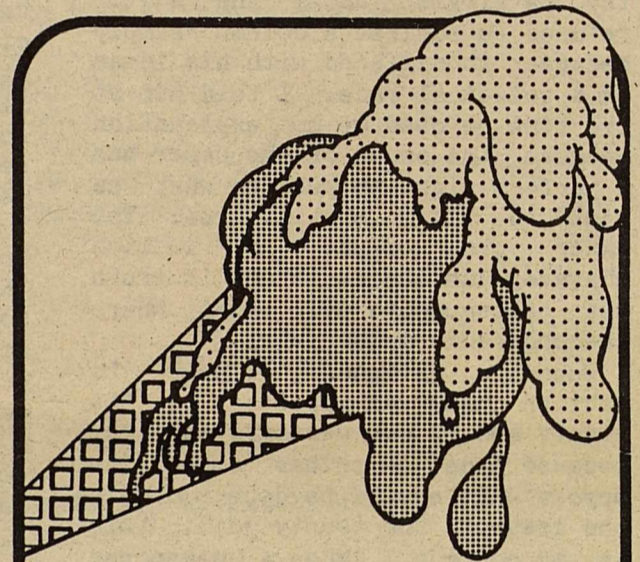

spending now and avoid the trauma of a tax roll back later."

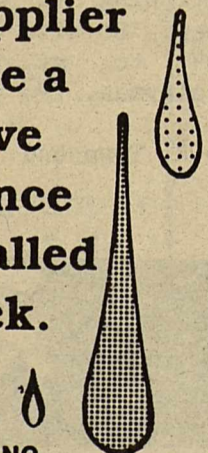

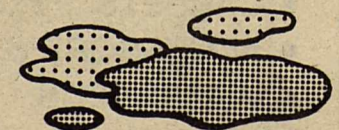

Dorthy spends her free time with her youngest son Jerry, a Junior at Brackett High School, and writing "stories, poems, or just my thoughts."

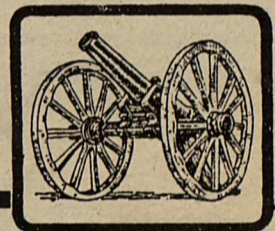

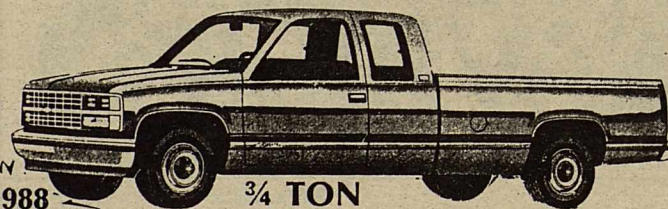
