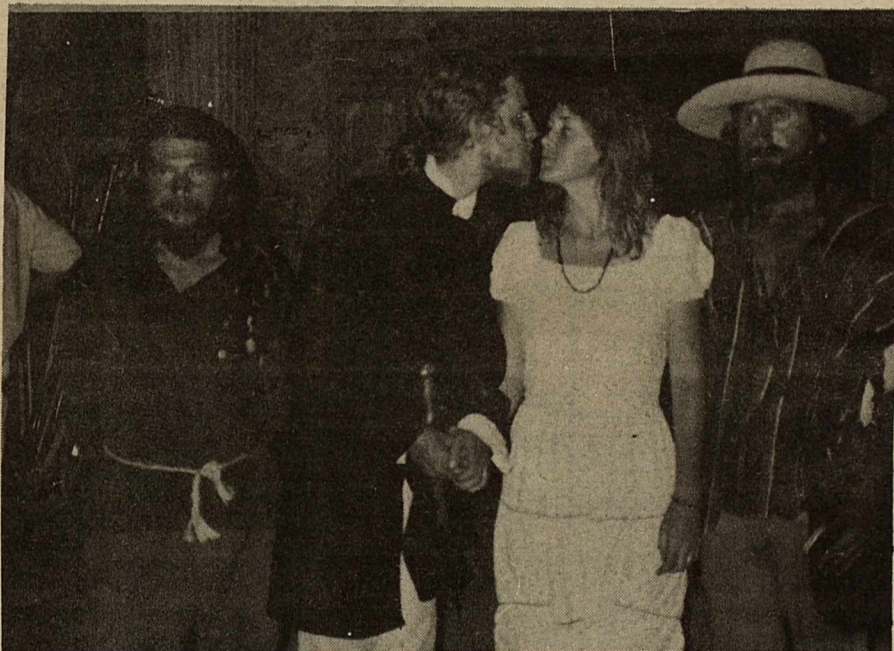

RADIOACTIVE WASTE DISPOSAL

Senator Judith Zaffirini

AUSTIN -- The residents of Kinney County, which was included in the list of "most preferred" potential sites on private land for low-level radioactive waste disposal, can now rest easier. SB 62 by Sen. Judith Zaffirini (D-Laredo), which paves the way for use of a previously-selected site in West Texas, was signed into law Monday by the governor.

Senate Bill 62 amends the current statute relative to the disposal of low-level radioactive waste, allowing the Texas Low-level Radioactive Waste Disposal Authority (TLLRWDA) to continue its federally-mandated site selection process in a safe, timely matter.

CITY ORDINANCE #242

State of Texas

Ordinance # 242

AUTHORIZING THE MUNICIPAL COURT TO COLLECT SPECIAL EXPENSES FOR SERVICES PERFORMED AND RAISING THE PENALTIES FOR VIOLATIONS OF SPECIFIC ORDINANCES FROM \$1,000.00 TO \$2,000.00 AND ALL OTHER VIOLATIONS OF ORDINANCES TO \$500.00

WHEREAS, the Governing Body of each incorporated City may by ordinance authorize the Municipal Court to collect a special expense for services performed, and

WHEREAS, Senate Bill 920 as passed by the 70th Legislature Regular Session - 1987 and signed by the Governor states that the City Council shall have the power to pass, publish, amend or repeal all ordinances, rules, police regulations that govern fire safety, zoning, public health and sanitation, and no fine or penalty may exceed \$500.00 for all other violations and that the Cities may amend the penalty clause of such ordinances; Therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRACKETTVILLE, TEXAS THAT:

I. The Governing Body authorizes the municipal court to collect a special expense not to exceed \$10.00 for services performed in cases in which the laws of the State require that the case be dismissed because of actions by or on behalf of the defendant. ie Defensive Driving Course to dismiss ticket: Failure to display drivers license; insurance ect.

II. The Governing Body authorizes the Municipal Court to collect a special expense of \$25.00 for the issuance and service of a warrant of arrest and requisites of a personal bond with all special expenses to be paid into the City Treasury for the use and benefit of the City.

III. That the Penalty clause of all City Ordinances for violations of all such rules, ordinances and police regulations that govern fire safety, zoning, public health and sanitation including dumping of refuse "...shall be fined in an amount of not less than \$1.00 nor more than \$1,000.00".

IV. That the Penalty Clause of all City Ordinances for violations of all such rules, ordinances and police regulations that do not govern fire safety, zoning, public health and sanitation shall read "...shall be fined in an amount of not less than \$1.00 nor more than \$500.00...".

V. Effective Date September 1, 1987.

VI. PASSED and APPROVED this 11th day of August, 1987.

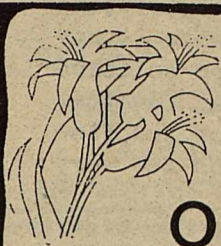

LAND OFFICE SETS ASIDE ADDITIONAL 66,000 ACRES FOR PUBLIC HUNTING

AUSTIN--Texas Land Commissioner Garry Mauro announced a joint project with the Texas Parks and Wildlife Department and the Texas General Land Office to set aside 66,000 acres of public land to provide for low-cost, family-oriented, hunter access to many diverse units of public land scattered throughout Texas.

"With the Land Office adding 66,000 acres to this innovative hunting program, all Texans who wish to go hunting will now be able to afford it," Land Commissioner Mauro said. "We're talking about the guy who can't afford the luxury of a private hunting lease. Traditional hunting fees are much higher."

Mauro pointed to a 1982 Texas A&M University study showing the average cost of a hunting lease was \$393 a year. Transportation, food, hunting supplies and other costs are additional.

The Land Office addition to the program will bring the total land set aside for public hunting to 413,000 acres, Mauro said. Half of the acreage is in East Texas timber lands, 160,000 acres are in the Trans Pecos and 28,000 acres are in the Panhandle. The acreage is composed of 47 different "units", each comprising of several tracts.

The Parks and Wildlife Department is marking each unit with 10"X10" diamond-shaped, chrome-yellow signs with the legend "Posted No Trespassing--Hunting By Permit Only."

The Type-II Permit for these public hunting grounds costs \$35 a year and will go on sale at the Austin Parks and Wildlife headquarters for a two-week trial period beginning Monday, August 10. By September 1, the permits will be available at 28 Parks and Wildlife field offices across the state and the Austin headquarters.

The hunter will be provided with a 50-page booklet with maps of each unit and the legal game for each unit. In addition, hunters under 13 are allowed to hunt free when accompanied by a permitted adult.

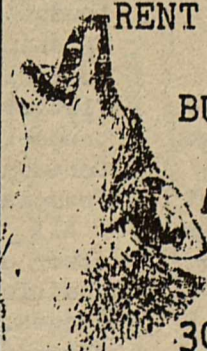

GARDENING TIPS

"CHECK LIST FOR AUGUST"

To keep your summer garden blooming, pull weeds as soon as they appear so they won't compete with water and food of the plants in the flower bed. And to continue to have blooms on your plants, always remove the faded ones so seed pots will not develop. With hot weather coming, water frequently and deeply so the roots will be strong, and to help to keep the soil moist, try using some kind of mulch.

Now is the time to order tulips, daffodils, hyacinths, and other bulbs of your choice. As soon as your bulbs arrive, place them in the icebox for at least six weeks. Prepare your flower beds early so when planting time arrives, you will be ready to plant your flower or fall vegetable garden. When planting bulbs, plant in groups as to various colors. Bulbs may be planted among other plants, in containers, and even in hanging baskets. Many bulbs will bloom for several years. When planting bulbs read the directions as to the depth they are to be planted for they come in all sizes. Add a little sand in the bottom of the hole, and twist the bulb slightly, as this prevents air pockets to form. A colorful bulb bed will add much to the garden. Be sure to check for Fall Webworms in your trees for these pests. They will be weblike nests on the end of the tree branches, remove and burn them or use a good spray. Protect your trees for it takes a long time for one to grow.

BACK-TO-SCHOOL REQUIREMENT

Parents are reminded that they should bring proof of birth (birth certificate) and proof of immunizations (Immunization Record Card) with their child to register for the 1987-88 school term.

Immunization requirements are as follows:

3 - DTP/DT/Td (Diphtheria-Tetanus-

and/or Pertussis), with one dose since 4th birthday and one every ten years.

3 - Polio, - with at least one dose after the fourth birthday.

1 - Measles - Must be given after age one.

1 - Rubella - All students age 11 and under must receive vaccine.

1 - Mumps - All students age 15 and under must receive one dose of vaccine.

Physician certification of measles and mumps disease may be given for proof of immunity in lieu of vaccine.

Any medical contraindication to a vaccine must be physician verified and submitted for the child's record to the school district.

Parents are urged to check the children's records and obtain any required immunization prior to school starting. Please obtain any needed immunization from your private physician or your local health department.

CP&L CUSTOMERS TO RECIEVE CREDIT ON AUGUST'S ELECTRIC BILLS

August's electric bills to Central Power and Light customers will reflect a credit. The exact amount of the credit depends on the amount of electricity used during July.

This one-time credit is the result of an \$18.27 million overcollection of fuel costs which occurred between December 1986 and June 1987. With interest added, the total amount refunded is \$19.35 million.

The credit will appear on the left side of the postcard bill as "Fuel Cr," and is listed with a refund factor and a negative dollar amount.

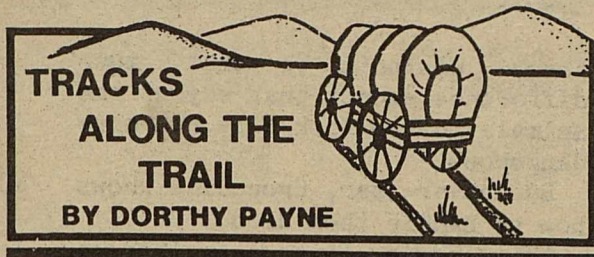
The Public Utility Commission authorized the refund last month, and CPL began issuing bills reflecting the credit late last week. The PUCT also approved the refund factors which are applied to each customer's July kilowatt-hour use to determine the credit.

The PUCT required utilities to use fixed fuel cost factors, which turn out to be more or less than actual fuel costs. Over the last four years, CPL has requested a total \$176.92 million in fuel refunds and has reduced its customer's bills approximately 20 percent.

Transmission, cotton gin and irrigation customers will receive a bill credit in August based upon historical use.



The world's first newspaper was probably *Tsing Pao*, a court journal published in China. It is said to have begun as early as the 500's and continued until 1935.



Located in the east side of Winkler County about fourteen miles northeast of Kermit, Texas is a place called Blue Mountain. It is not a mountain at all, but it is actually the southern escarpment of the Llano Estacado. When seen from the south it appears to be a long, flat mountain, hence the misleading name Blue Mountain.

On top of Blue Mountain are remains of Indian settlement but it is not certain of what culture lived there. In March, 1938, an expedition from Texas Tech and West Texas Museum excavated the shelter as deep as there was evidence of human occupation.

The shelter shows signs of prolonged occupation. It faces east and has roughly the shape of a right triangle with the hypotenuse to the front. One of the adjacent sides measure twenty-one feet and six inches, and the other forty-four feet. The front is a forty-eight foot wall. The ceiling is nearly level, the floor slopes upward toward the south at the north end. After excavation the ceiling was approximately seven feet from the floor. The south end is almost four feet from the floor. About fifty foot north of the shelter was once a spring. On the rock face above the spring, is a group of about thirty pictographs done in light red color.

On the limestone stratum along the edge of the escarpment are over one hundred mortar holes, varying from eight to nine inches and in length from seven to fourteen inches.

When the excavation was completed the findings were one whole knife; five broken knives with beveled edge; eleven scrapers; seven flint and three bone awls; six tubular beads; one flat shell bead; one round shell bead; one worked shell, five pieces of paint; four pieces of red hematite, one piece of yellow lemnite. One large sand stone metate of the flat thin variety, on it was a sandstone mano; vegetal material; thirteen pieces of pottery, three of Pueblo origin, one with hatched designs; one of a brown design and one of brown and orange. Ten pieces of cooking ware, twenty-five horse teeth, a large number of bison,

antelope and rodent teeth.

On the ceiling of the shelter near the back is a pictograph of a human hand in dark red, and on the rock face above the spring there are about thirty pictographs. There is a portion of a human hand, a female figure, a man, a plumed serpent, a horse looking over a barrier, and numerous other drawings.

The culture of this group is very elusive. Perhaps they moved on because of the lack of water. Game was probably scarce for the same reason, certainly it was not a large group and might have joined others and melted into their culture. It was concluded that the Blue Mountain culture showed no connection with the lower Pecos culture and that it is likely that is was non-Pueblo.

This place is noted for its limestone stratum along the escarpment with over one-hundred mortar holes.

DISPOSAL

"This is truly a victory for South Texas, and for Kinney County in particular because it was on the most preferred list," Zaffirini said, noting that 16 of the 20 counties in Senatorial District 21 were on the list. "Perseverance and hard work were the keys to this success.

"This bill was of special importance to private property owners across the state," she added, "If this bill had not become law, TLLRWDA would have searched for a new site on private land."

Instead, SB 62 directs the TLLRWDA to give preference to a "suitable" site on state-owned land and directs the Land Commissioner to transfer state-owned land selected for the site to the TLLRWDA. The bill includes three major safeguards: prohibiting shallow land burial as a disposal technique; requiring that waste be contained within a reinforced concrete barrier or within a containment structure made of technologically equivalent or superior materials; and requiring waste to be contained in a manner capable of being monitored and retrieved.

In the area of environmental protection, the bill required that a "buffer zone" of at least 200 acres be developed around the disposal site itself for use as a rangeland and wildlife habitat.

SB 62 also requires public utilities operating nuclear plants to provide on-site storage for up to five years' accumulation of radioactive waste and requires the TLLRWDA to report to the 71st Legislature on the volume of radioactive waste created by decommissioning power plants.

The bill was sponsored in the House by Rep. Fred Agnich (R-Dallas).

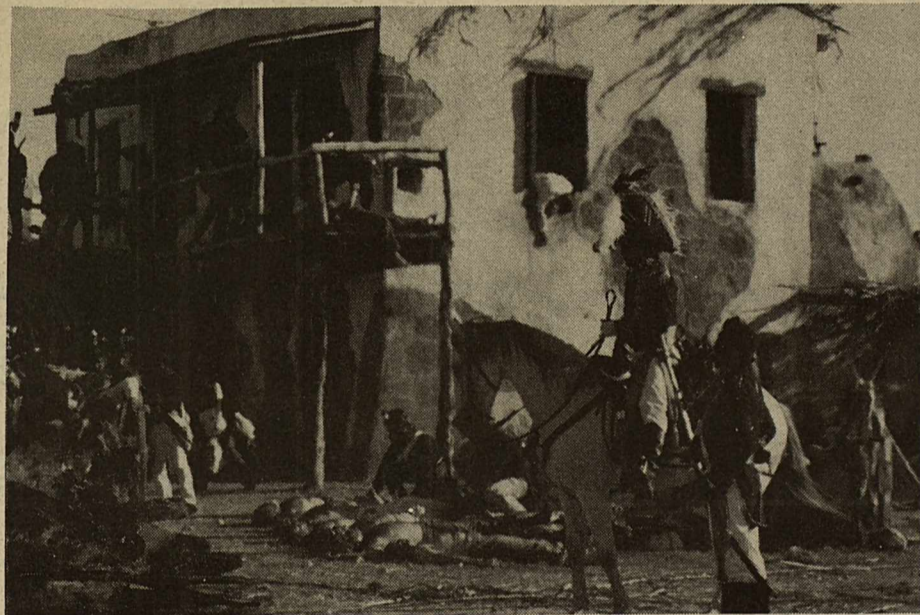

CITY LANDFILL (DUMP) USER FEES

Effective August 1, 1987, Landfill user fees for Brackettville residents who have City Utility service accounts are as follows: 50c per month will be charged for all single family connections; \$1.00 per month for commercial accounts. Those who have both single family and commercial accounts, the fee will be \$1.50 per month.

These fees are now necessary due to the fact that until 1986 the City of Brackettville received Federal Revenue Sharing funds amounting to an average of \$13,500 each year. These funds were budgeted for the Landfill expenditures of \$16,000 to \$19,000 over the past 3 years.

Further, the Landfill Easement Agreement expired July 31 this year. For 10 years there has been no cost to the City for the use of the area designated as a landfill. And there has been no cost to the people of Kinney County for using this facility. The new agreement extends the use of this landfill area for 3 years, until August 1, 1990, and will cost the City of Brackettville a fee of \$2,400 a year for this extension.

County residents who are not City Utility Customers are asked to obtain a permit to use the Landfill. The fee for the permit: \$1.00 per month, \$12,000 for an annual permit.

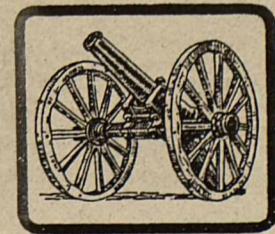


