



In 1916 in Andrews County a family named Fasken had come from Canada in 1913 and purchased the vast "C" Ranch. Since there was no railroad near, they decided to build one, in order to be able to ship their cattle to market. So they supplied the necessary land for right of way.

Construction began on the sixtysix mile short line in late 1916. This short line was to connect with the M&NW railroad who would in turn connect with the main line. The new railroad was to be called the P.B.R.R. (the Permian Basin RailRoad) and construction was to be completed by the first of the year 1917.

The M&NW bought second-hand equipment from the Texas & Pacific which included two old locomotives, a passenger coach, a mail express car, two flat cars and track. Then Fasken prepared to be able to ship his cattle directly from his own pastures.

The builders didn't wait long enough for the new railroad bed to settle before they began to lay tracks, which caused the train to jump the track now and then.

The railroad opened in 1917 and operated until 1920 when a heavy rain washed the track almost completely and the M&NW went into receivership.

The Texas and Pacific filed an application asking that the short line be abandoned, saying the operation of the line would cause a heavy loss. Permission was granted and the end came in 1926.

At the end of the track when the line was in operation a "Y" was built and each night the train was turned around so the return trip could be made. The "Y" was located in a ranch pasture which was called Thaxton.

A few miles from town the firemen had to stop the train and get off and open the pasture gate, and get back on the train after relocking the gate. He carried a pistol to shoot the many rattlesnakes he usually met on his long walk back to the front of the train.

Two more stops were made before reaching Fasken, a small town that had sprung up in the ranch pasture. The first stop was called south pasture, here the Faskens built two silos, a barn, stock pens and a

large house used for "C" Ranch workers, and the railroad workmen. At the "C" Ranch headquarters was another stop called Harvey where feed was stored.

On the initial run the train made, there was a celebration and several lots were sold, this stop was called Fasken and at its peak, Fasken had a one story depot, a general store, two residences, a school house, stock pens and a hotel. A bank was planned and several settlers were moving in but when the railroad failed all construction was halted.

The last stop on the way home was Florey where they built a post office which later became a substation for Andrews, the county seat.

When the line was flooded the train was stranded in the middle of a ranch pasture. The train stayed there until the tracks could be repaired enough to return to the home depot.

Parts of the old railroad bed can still be seen along highway "158" and farm raod "1788".

In 1962, re-application was made to build another railroad but permission was denied and so Fasken, Texas is just another ghost town, with a rapidly deteriorating railroad bed, without any rails.


We think we have come a long way in our riding ability since that day a year ago when we rode in Hondo for the first time.

For those of you who might have missed us while we were gone, thanks for your support. For those of you who were glad we were gone, well, you will just have to take the bitter with the sweet.

I want to welcome Chief of Police Johnny Fritter and Patrolman Hector Navarro to their new jobs with the Brackettville Police Department. I extend to them the full cooperation of the Sheriff's Department and we plan to work together for the common good of the people of this community and county.

Burglars and vandals struck Ft. Clark the weekend of September 19th and 20th. A 1976 Ford pickup parked in front of a residence on Colony Row was damaged Saturday night with a wing window being broken out and the windshield being badly cracked. Nothing was taken from the vehicle though the damage is estimated at \$150.00.

In another case just down the street on the same night, burglars entered the residence of Pat & Franny Owens prowling through the two story residence and taking personal property valued at over \$3,900.00. The property taken included sterling silver tableware, keepsakes, and other items of value too numerous to list here.

The investigation into both these cases continues at the time of this writing and there is a suspect in the burglary case.

Another act of criminal mischief occured near the clubhouse of the Golf & Tennis Club on Ft. Clark Saturday night. Evidence at the scene of the crime led to the identification and apprehension of 5 young perpetrators of the crime. I met with the 3 girls, 2 boys, and their parents on Monday and an agreement was reached whereby the 5 young people will work at the golf course every week-end until the amount of damage has been worked off. This will give them time to reflect on their wayward ways and

allow them to feel the results of their actions instead of their parents having to shell out hard earned money to pay for damages. Old fashioned punishment maybe, but sometimes old fashioned ways are still best.

Daniel Rivera, 19, a Del Rio man attending classes at SWTJC in Uvalde was arrested in Uvalde last week on a warrant for Violation of Probation - DWI and was returned to Kinney County to appear in county court to answer those charges. On Monday this week we were notified by the Val Verde County S.O. that they held arrest warrants on Rivera charging him with two counts of burglary and habitual criminal with the bond set at \$100,000.00. After he refused to plead to the local VOP charges he was transported to Val Verde County to stand trial there.

I guess all of us have a tendency to become wrapped up in our own little world sometimes and get to the point where the only things that are of importance to us are those things that are directly related to us individually. We get so wrapped up in our own interests that we take for granted things that other people do for their friends, community, and fellow citizens. safety, welfare, and health your concern and we thank you for it.

And, while I am thanking people, I also want to express my gratitude to those many friends supporters who gave so freely of their time and money in assisting me to get out periodic issues of the Sheriff's Corner to the public during the interim it was not appearing in the Cavalryman. TAXES NO LONGER TO BE COLLECTED ON FOOD STAMP PURCHASES

AUSTIN, Tex. -- State Comptroller Bob Bullock said Friday changes in the states sales tax law will bring Texas into compliance with federal regulations on food stamp purchases.

Bullock said that Texas law exempts all food stamp purchases from the state's sales tax starting October 1, 1987.

The exemption will cost the state about \$5 million in lost revenue in 1988 but will prevent the federal government from witholding a projected \$808 million in annual assistance to 1.4 million Texans.

Last year's reauthorization of the federal food stamp program added new language that prohibits states from receiving food stamps if they collect taxes on food stamp purchases.

Although most food items are exempt in Texas, the state does collect tax on candy, soft drinks, diluted juices and other foods.

Falcon intends to improve the Cable system for much better viewing of its customers.


The Brackettville office will be closed as of September 30th. The headquarters and office will be located in Pleasanton, Texas.






She does it with the help of Bobcat Goldthwait. (Gosh, with all this gold 'Goldberg and Goldthwait' it has to be a good movie, right?)





HERE'S TO YOUR HEALTH

DIABETES

Diabetes is the name for a lifelong disease. As of yet it can usually be controlled, but has no cure. It affects the body's ability to use food for energy, growth and development.

Through normal digestion, the foods eaten are changed to a form of sugar called glucose. The blood carries glucose to the body's cells, where, with the help of insulin (a hormone produced in the pancreas), it is transported into the cells for use by the cell for growth. If there is too much glucose available for the cells' immediate needs, it is stored in the form of fat. In diabetes, this normal process is prevented by a lack of insulin.

Diabetes develops if the pancreas produces no insulin, or if that which is produced cannot be used effectively by the body cells. Blood glucose cannot be transported into the cells without insulin, and therefore it accumulates in the blood. Some of the excess glucose will be eliminated by the kidneys in the urine. The presence of sugar in the urine and in the blood are classic signs of diabetes.

WARNING SIGNS OF DIABETES

Type I - Usually children, young adults

Frequent urination, abnormal thirst, weight loss, irritability, unusual hunger, weakness, fatigue, nausea, vomiting.

Type II - Adult onset

Overweight - obese drowsiness blurred vision tingling, numbness in hands & feet skin infections slow healing of cuts (especially on the feet) itching

If you experience these symptoms, it is important that you see a doctor to be tested for diabetes immediately.

Who Gets Diabetes?

People who are overweight People of Mexican heritage People with diabetic relatives People over 40 years of age Women are more at risk than men.

Diabetes as a major health problem

There are nearly 6 million known diabetics and nearly as many who are as yet undiagnosed.

- * More than 1/2 million people develop diabetes every year.
- * One out of every 20 people has diabetes
- Only 1/2 that many have been diagnosed
- Diabetics are 25 times more prone to blindness than non diabetics. Diabetes is the leading cause of new cases of blindness in people between the ages of 45-65.
- * Diabetics are 17 times more prone to kidney disease than non diabetics.
- * Diabetes is responsible for almost 1/2 the amputations in people over 45.
- * Diabetics are twice as prone to heart disease and stroke.
- Diabetes increases the chance of birth defects.
- * Complications of diabetes is the 3rd leading cause of death by disease in the United States.

STATE BOARD OF INSURANCE

The State Board of Insurance has received reports that some insurance agents are falsely portraying themselves as Medicare representatives to gain entry into the homes of older Texans.

According to members of the board's newly appointed Citizens Working Group on Medicare Supplement Insurance, the practice may be on the increase in the sale of such coverage.

It is a violation of federal law for an agent to say that he or she is from Medicare or another Federal governmental program. The practice is a felony, with penalties of up to five years in prison and a \$25,000 fine for such

misrepresentation.

In addition, such conduct, if proven, could lead to revocation of an agent's license to sell insurance in Texas.

Consumers are urged to report agents who try to sell them Medicare Supplement policies after saying they are from the government.

Reports of these violations should be sent to the Complaints Division, State Board of Insurance, 1110 San Jacinto, Austin, TX 78701-1998.

It also is a violation of the board's advertising rules for insurers to disguise Medicare Supplement advertisements and supplemental materials as mailings from the federal government.

Older Texans who receive such mailouts are encouraged to send them to the State Board of Insurance for investigation.

The board also has a tollfree telephone hotline, 1-800-252-3439, for answering consumer questions. A complaint, however, cannot be investigated formally until it has been reduced to writing.



EMS Week is September 20-26

According to the Texas Department of Health (TDH), the time between an injury or sudden illness and the start of competent medical treatment often decides the severity of an emergency. Needless delay can even cause the victim's disability or death.

Even so, studies show that as many as one quarter of victims of accidents or sudden illness underestimate the seriousness of their situation--they do not recognize that an emergency exists. According to TDH, if the victim or a witness can not decide if an injury or illness is an emergency, the victim should get medical help immediately. And the fastest way to receive medical attention is to call an emergency medical service (EMS). The purpose of EMS is to reduce the time between trauma and treatment of victims.

"Thousands of Texans owe their lives and current health to EMS teams, licensed by the Department of Health. These specialists ensure speedy medical assistance and emergency transportation to trauma victims around the clock," said Gene Weatherall, chief of the TDH Bureau of Emergency Management.


To honor EMS personnel and the services they provide daily, Gov. Bill Clements has proclaimed Sept. 20-26 Emergency Medical Service Week in Texas.

The observance coincides with national EMS Week, sponsored by the American College of Emergency Physicians, and marks 20 years of EMS in Texas. A highlight of the Texas observance is the Statewide EMS Conference to be held in Austin Sept. 25 and 26 at the Austin Hilton Inn.

TDH regulates more than 1,100 EMS firms in Texas. The department's Bureau of Emergency Management certifies EMS technicians and their trainers, develops tests, and approves EMS courses. It also licenses EMS vehicles, including ambulances, helicopters, and fixedwing aircraft. The bureau currently certifies nearly 38,000 persons to practice emergency medical service, including about 24,000 members of EMS firms and about 14,000 law enforcement and fire personnel and others.






