



MAKE YOUR VOTE COUNT IN CITIZEN OF THE YEAR

FARM LOAN APPLICATIONS TO BE ACCEPTED

Applications for emergency farm loans for losses caused by freeze, wind, excessive rain, sleet and hail March 28 through July 13, 1987 are being accepted at the Farmers Home Administration (FmHA) office located in Uvalde, FmHA County Supervisor Edmund L. Persyn, Jr. said today.

Uvalde, Kinney, and Real Counties are three of 40 in Texas recently named by Secretary of Agriculture Richard E. Lyng as eligible for loans to cover part of actual production losses resulting from the freeze, wind, excessive rain, sleet and hail March 28 through July 13, 1987.

Edmund L. Persyn, Jr. said farmers may be eligible for loans of up to 80 percent of their actual losses or the operating loan needed to continue in business or \$500,000, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest rate is 4.5 percent.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production and be unable to secure credit from other sources to be eligible for an FmHA emergency loan," Edmund L. Persyn, Jr. said. Farmers participating in the PIK or Federal Crop Insurance programs will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until October 3, 1988 but the farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season," Edmund L. Persyn, Jr.

RANEY ATTENDS STATE CONFERENCE

COLLEGE STATION--Kinney County, County & District Clerk Dolores Raney, joined some 450 other officials for the 16th Annual County and District Clerks' Seminar at the College Station Hilton on February 2-4, 1988. "Charting Our Course for the Future" was the theme of the conference.

"County and district clerks can prepare themselves to cope with future challenges by participating in professional seminars such as the one provided at Texas A&M University. Staying abreast of current information about different laws and computer technology insures an efficient way of operating the county and district clerk's office" explained Mrs. Raney.

Legislation was enacted during the 70th regular legislative session, requiring county and district clerks to complete 20 hours of continuing education every two years. "This law went into effect January 1, 1988," she continued.

This education program is sponsored by the V.G. Young Institute of County Government of the Texas Agricultural Extension Service in cooperation with the County and District Clerks' Association of Texas. Persons who attended all sessions were awarded 2.0 CEU's (20 hours) by the Office of Professional Development at Texas A&M University.

The three-day seminar included topics such as "The Mechanics of Appeals," "Case Management," "Fundamentals of Computer Technology" and others.

The FmHA office in Uvalde is open from 8:00 to 5:00 p.m. Monday through Friday.

The meeting begins at 10 a.m. in Room 309.

The purpose of these 4-H committees is to develop high-quality opportunities in each major

project area for members and leaders. The committees are food and nutrition, horse, clothing, shooting sports, sheep and goats, beef, swine, small animal, agronomy, and natural resources, according to Mrs. Gloria Schwarzlose, district director-home economics for the Texas Agricultural Extension Service.

These committees plan and develop project guidelines, determine

training needs for leaders and members, gather resource materials, conduct training activities such as camps and workshops, conduct related contests, and determine awards, Mrs. Schwarzlose said.

A special feature of the food and nutrition meeting will be a talk by Dr. Eleanor Young, Department of Medicine, University of Texas Health Science Center, who will speak on "Food--Its Impact on Health."

There will also be a tour of the health science center.

A business meeting will be conducted at 1:30 p.m. by Donna Davis of Uvalde, chairman of the committee.

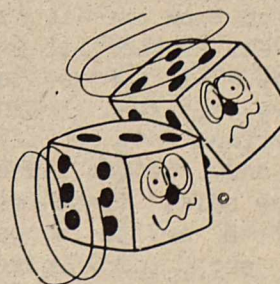

The Civil War had many names including, "The war between the states", "the war of rebellion", it could also have been called "the great railroad war".

The final outcome of the war between brothers was mainly influenced by "the iron horse" on both sides, the north and the south.

As a result both the north and south spent alot of time blowing up each others railroads.

General Herman Haupt, a West Point graduate, was general manager of construction on the new Trans-Continental Northern Pacific Railroad, and took care of its problems. One of the worst problems both sides faced was keeping the bridges open over the many rivers. The Civil War proved to be a training ground for railroad men of the future especially in the settlement of the west.

Soldiers of the Army of the Rappahannock, under the command of Major General Irvin McDowell and his aide-de-camp Colonel Herman Haupt, built a noted railroad trestle over the Potomac Creek in Virginia. It took nine days to build the trestle and it contained more than two million feet of lumber, cut from woodlands near the site. The soldiers were poorly equipped, didn't have the proper tools, very little food and the weather was rainy. The finished trestle was a wonder and a marvel especially for the European officers who had come to the United States to witness the Civil War. The structure was against all military science. It was made of round sticks cut from the woods with the bark still on them. The legs of the trestle was braced with round poles. It was four stories, three of trestle and one of crib work.

The total height from the deepest part of the stream to the rail was nearly eight feet. It carried ten to twenty heavy railroad trains from both directions and survived several storms and floods. When Lincoln saw it he said, "That man Haupt has built a bridge across Potomac Creek, about four-hundred feet long, and upon my word. Gentlemen, there is nothing on it but beanpoles and cornstalks".

A substitute truss bridge was

built to replace this "beanpole and cornstalk" bridge when it was needed over Potomac Creek. It was completed early in 1863 and installed without delaying a single train, although traffic was heavy during construction.

This railroad built a special car for President Lincoln. It was finished in time to carry his body for burial in Springfield, Illinois when he was assassinated.

Truly, Bill Whitworth is an "Unsung Hero".

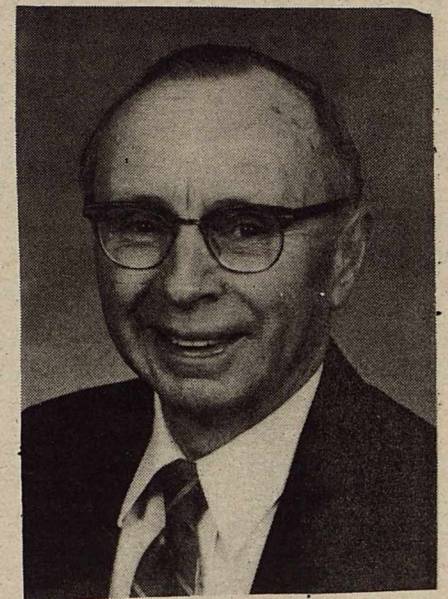
HISTORICAL SOCIETY TO MEET

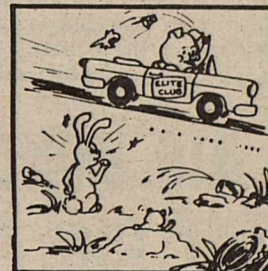

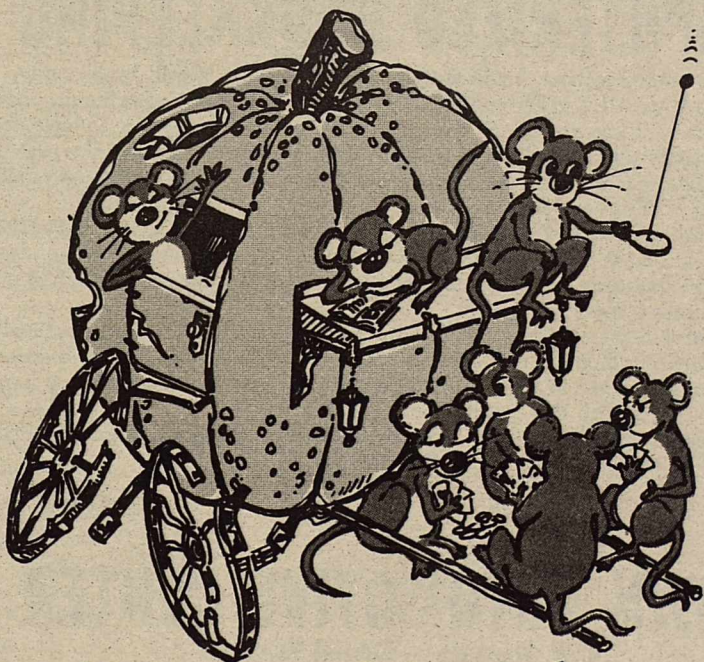
PINEAPPLE BRAN MUFFINS

- 1 can (8 oz.) Dole Crushed Pineapple
- 1 cup all-bran cereal
- 1/4 cup milk
- 1 egg, slightly beaten
- 1/4 cup vegetable oil
- 2 tablespoons light molasses
- 1 cup flour
- 1/3 cup sugar
- 2 teaspoons baking powder
- 1/4 teaspoon salt

Drain pineapple well, reserve 1/4 cup juice. Combine reserved juice, cereal and milk. Let stand a few minutes to soften cereal. Stir in pineapple, egg, oil and molasses. Combine flour, sugar, baking powder and salt. Add to pineapple mixture. Stir just to combine. Spoon batter into 6 well greased muffin cups. Bake in 400°F. oven 20 to 25 minutes until tests done. Serves 6.

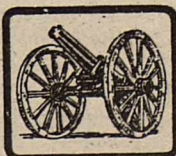

1988 TEXAS BREAST SCREENING PROJECT

Based on the proven benefits of mammography, the Texas Division of the American Cancer Society launched a state-wide effort that became known as the 1987 Texas Breast Screening Project. The purpose of the project was to offer low cost, low dose screening mammograms to the women of Texas.


In the spring of 1987 the project began in Texas. Twenty television stations did week-long specials on the importance of breast cancer screenings; and particularly, the importance of mammography examinations for asymptomatic women over the age of 35. Women from all over the state were urged to call the American Cancer Society to receive information on how they could receive a low-cost, low-dose screening mammography examination. Five-thousand telephone bank volunteers handled nearly 110,000 calls. Nearly 300 mammography centers participated and it is estimated that 70,000 examinations

will be done. Final results will be available this fall, however, so far 200 breast cancers have been detected.

Public awareness of the importance of early breast cancer detection increased dramatically. According to the Texas Poll, awareness increased from 59% in 1986 to 74% in 1987. Researchers with the Texas Poll summarize the project as follows:

"The Texas Division of the American Cancer Society should view the apparent impact of the mammography program with considerable pride. It must be rare indeed that such relatively dramatic changes can be demonstrated in the mass public in such a relatively short period of time."

To build on this success, the Texas Division will again conduct a Texas Breast Screening Project. Monday, February 22 thru Friday, February 26, the phone bank will be open 5-11 p.m., just call Val Verde Memorial Hospital, 775-8566 for more information.

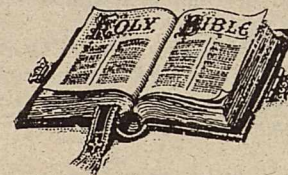

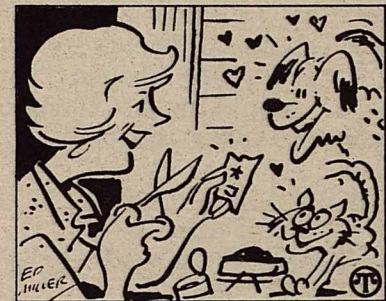
