#### JUDITH ZAFFIRINI HONORED IN SAN ANTONIO

AUSTIN--State Senator Judith Zaffirini (D-Laredo) was honored by the Texas Chapter of the National Association of Housing and Redevelopment Officials (NAHRO) at a luncheon in San Antonio April 18 for her work during the 70th Legislature to support and promote the development of low-cost housing in the State of Texas.

NAHRO officials recognized Zaffirini's successful sponsorship of House Bill 1387 in the Senate which provides for participation in the national consolidated supply purchasing program. The Consolidated Supply Program (CSP)

assists public housing authorities in operating public housing projects efficiently and economically and to assure the availability of products that have the durability required for safety, security, and economical maintenance, in order to withstand the heavy use expected in lower-income housing.

According to NAHRO State President Michael Hanratty, Senator Zaffirini's "sponsorship and advocacy of legislation to permit



Brush fires are becoming more and more frequent with this hot, dry spell we're having. In the past two weeks we've been on several brush fires.

Three of our fire fighters went to Juneau to assist the DelRio fire department in yet another very large range fire, along with Brackettville was Uvalde, Eagle Pass and Comstock fire departments and Val Verde County had heavy equipment out there also. Rough, no very rough, country and strong shifting winds are making it very difficult for fire fighters to bring this one under control.



We think it's great to share a laugh At a mama cow and her awkward caugh. We bravely draw to an inside straight As often as wives make husbands waight.





For example, this past weekend there were four fires reported at different locations in the county with one in the extreme northern part of the county, one in the extreme southern part of the county, one in the central part of the county, and one in town. The firemen were really hopping there for awhile. The fire that was reported off Hwy. 277 in southern Kinney County was started when a generator on a travel trailer being used by a hunter exploded and caught fire, this in turn started a large grass and brush fire which was put out by ranch workers at the scene. A 5 year old girl sleeping in the trailer was rescued by her father who was near the scene when the generator exploded, he stated that had he been seconds later she would have perished in the blaze. As it was, he suffered burns to his face, hands, and chest in the rescue with his hair, eyebrows, and eyelashes being scorched by the blaze. The trailer was a total loss being burned to the ground in minutes. A Del Rio ambulance and EMS responded to the call and transported both father and daughter to Val Verde Hospital for treatment.

Burglars struck the Kountry 'N west of Brackettville the night of Saturday, April 16th. Forcible entry was made by removing an air conditioning vent from the rear of the building exposing a small hole. The person who entered the building through that hole is believed to be of small stature due to the small diameter of the opening. Items taken in the burglary were valued at approx. \$290.00. The case is currently under investigation.

Two of the suspects in the Aggravated Robbery at Fritter Park on Easter Sunday were returned to Texas from Tennessee on Thursday, April 21st by Texas Ranger Johnny Allen and myself via a twin engine Department of Public Safety plane piloted by Mike Ashcraft of Dialer Parent Cant \_ Midland.

and Angela Ann (Pope) Cagle, also 18, both of North Carolina were magistrated before Justice of the Peace Alvin Hall on Monday with their bonds set at \$50,000.00 each on the Aggravated Robbery charges and \$5,000.00 each on Unauthorized Use of a Motor Vehicle charges. Angela Cagle is being held in Val Verde County Jail due to the fact that we do not have the facilities here to hold a female prisoner over an extended period of time. District Attorney Tom Lee has advised me that the case against the Cagles and their crime partner William Bruce Chandler, will be presented to the Grand Jury on May 6th.

We have been kept busy responding to and investigating criminal activities and disturbance calls over the past few weeks, with most calls being of a minor nature and being handled with no criminal charges being filed. We have also received paperwork necessary for the confiscation of 2 vehicles we are holding related to drug charges against the owners/drivers, there is one remaining vehicle that we to start forfeiture proceedings on within the next few days. This fairly new policy of hitting drug smugglers and dealers where they hurt (their pocketbook) should be an added deterrent to drug involved crimes though it will in no way stop the trafficking in

I would like to remind everyone that we have a School Board and City Council election coming up on May 7th. Voters should educate themselves on the qualifications of the candidates running for election and then take the time to go vote for the candidate of your choice on election day. Voter apathy only allows unqualified candidates to be elected to offices that are of vital importance to our local government. All of us need to educate ourselves as to the qualifications of the various candidates, examine and discuss the issues and what the various candidates have to offer the community if elected to the office they seek, and then we need to make our choice and get off our duffs and go vote. This is the only way we can maintain a workable county, city, and school government. THINK ABOUT IT!

In this wheel we talk about the children. We try to bring the children closer to their church, we talk about child abuse, we talk against alcohol and drugs. No alcohol or loud talks are allowed on the sacred grounds. Peyote is not used in this wheel. I am a Cherokee, my people are not peyote people. Peyote was given to the Comanche, from there it went to the Plains Indians.

This year we had a little more than 200 people. Among them were Ordained Ministers, doctors (M.D.), nurses, anthropologists, teachers and some very spiritual people. They all came in Peace and left with Blessings.

Anyone wanting to know more about the Medicine Wheel can come to my home and visit me or the next time I have another Medicine Wheel, please feel free to come and see how we pray. Our prayers are for unity and love and respect for one another.

#### A PUBLIC DECLARATION

TO THE TRIBAL COUNCILS AND TRADITIONAL SPIRITUAL LEADERS OF THE INDIAN AND ESKIMO PEOPLES OF THE PACIFIC NORTHWEST

Dear Brothers and Sisters,

This is a formal apology on behalf of our churches for their long-standing participation in the destruction of traditional Native American spiritual practices. We call upon our people for recognition of and respect for your traditional ways of life and for protection of your sacred places and ceremonial objects. We have frequently been unconscious and insensitive and have not come to your aid when you have been victimized by unjust Federal policies and practices. In many other circumstances we reflected the rampant racism and prejudice of the dominant culture with which we too willingly identified. During the 200th Anniversary year of the United States Constitution we, as leaders of our churches in the Pacific Northwest, extend our apology. We ask for your forgiveness and blessing.

As the Creator continues to renew the earth, the plants, the animals and all living things, we call upon the people of our denominations and fellowship to a commitment of mutual support in your efforts to reclaim and protect the legacy of your own traditional spiritual teachings. To that end we pledge our support and assistance in upholding the American Religious Freedom Act (P.L. 95-134, 1978) and within that legal precedent affirm the following:

- The rights of the Native Peoples to practice and participate in traditional ceremonies and rituals with the same protection offered all religions under the Constitution.
- 2) Access to and protection of sacred sites and public lands for ceremonial purposes.
- The use of religious symbols (feathers, tobacco, sweet grass, bones, etc.) for use in traditional ceremonies and rituals.

The spiritual power of the land and the ancient wisdom of your indigenous religions can be, we believe, great gifts to the Christian churches. We offer our commitment to support you in the righting of previous wrongs: To protect your peoples' efforts to enhance Native spiritual teachings; to encourage the members of our churches to stand in solidarity with you on these important religious issues; to provide advocacy and mediation, when appropriate, for ongoing negotiations with State agencies and Federal officials regarding these matters.

May the promises of this day go on public record with all the congregations of our communions and be communicated to the Native American Peoples of the Pacific Northwest. May the God of Abraham and Sarah, and the Spirit who lives in both the cedar and Salmon People be honored and celebrated.







There has long been several theories raised by scientists as to when the first Americans came from Asia. One method of dating is called the Radiocarbon dating which places man's first presence in the new world between ten thousand to nine thousand B.C.

Crude stone tools found, places man about forty thousand or more years ago in the Pieistocene geological period when most of the land was covered by glaciers.

Traces of these big game hunters were found in the Guadalupe Mountains of Texas. Other finds near Lubbock further confirm the dating.

Prehistoric mammoth, camels, and huge bison were living in these mountains along with a rare antelope with four horns.

Their clothing was probably animal skins, but these early Americans didn't need many clothes as the climate was mild.

The mountain caves show evidence of having been used by the early hunters.

Stone was used for tools such as points, knives, scrapers, drills, choppers and a beautiful chipped lance. A lance with a beatifully chipped point seems to have been the main tool used for close quarter killing. A spearthrower made a wood and a dart was also used. This weapon was called Atlatl.

After these hunters came, the basketmakers lelft more of a mark of their culture for later day scientists. Also about this time these people started to develop pottery and communicate with neighboring tribes. After 1200 the pueblo people made a great change in these early Americans.

Somewhere between 1500 to 1600 a great change came over these people, changing their way of life completely.

The Spanish came into the Southwest, bringing the horse, and by theft and trade the Apache acquired the horse too, giving them the means to raid and pillage other Indians and Spanish alike.

Some tribes developed a very elaborate food production. In their midst a wide variety of food stuffs can be traced. Everything was utilized as tools or other uses.

Metals were used to grind corn or mesquite beans into flour and corn meal. Of course these tribes had fire by now.

Bows were usually made of hard woods and had about a 40 pound pull.

They buried their dead in a flexed position or in baskets after cremation.

Pictographs, petroglyphs were found in this period. Points were used in ceremonies and jewelry began to appear.

These early Americans began to trade with other people on both the East and West coast. Even reed cigarettes were found.

The Indians of the desert at the valley below the mountains were inhabited by a former type of peaceful Indian tribe. These Indians formed and further developed a more civilized way of life, and a more peaceful way of a daily existence.

When other cultures began to appear in the 1800's they acquired more and more skills from other people. Some of their arts and crafts are widely known.

There are some theories that the invention of the colt revolver in the hands of the Texas Rangers played an important part of the settlement of the West.



# CENTRAL POWER & LIGHT

Central Power & Light Company's share of support to the taxing entities within the company's 44-county service area amounts to \$22.7 million for 1987, making the company one of South Texas' largest ad valorem taxpayers, according to Floyd Anderson, the company's tax manager.

Of the \$22.7 million total, approximately 50 percent went to school districts with the balance being distributed among other taxing entities such as city and county governments and water, drainage, fire, hospital and road districts.

According to Kevin McMahon, CPL manager in Del Rio, CPL paid \$19,144 in ad valorem taxes in Kinney County. Major recipients include the Brackettville Independent School District receiving \$9,696 and government receiving \$6,640. cities in Kinney County also realized \$1,890 in taxes from CPL with the other taxing entities receiving the balance.

In addition to ad valorem taxes, CPL supports local governments by payment of gross receipts tax and sales tax, where applicable.
