JAIL DOORS BEING REPLACED



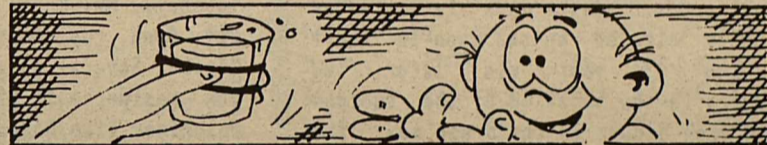

CHAMBER OF COMMERCE SIGNS




Has everybody seen our Chamber of Commerce signs at the east and west end of town? If you haven't, drive by and take a look.

## SHERIFF'S CORNER

Two illegal aliens were apprehended in Spofford Friday night May 20th after breaking into and burglarizing a residence there. The owner of the home found that it had been broken into after returning from Eagle Pass. He located one of the burglars in the brush at the rear of his home and held him at gunpoint until Sheriff's deputies arrived.

Chief Deputy David Luna and Reserve Deputy Ben Vasquez responded to the call within minutes and upon their arrival found another suspect in the heavy brush near the residence. The second suspect was a 13 year old illegal alien, the first was 20 years old. The homeowner reported that a .20 gauge shotgun had been taken along with other personal property items. After the two were first apprehended they denied knowledge of the burglary but evidence found in their possession and statements made later under interrogation cleared up the case in short order. The 13 year old later led investigators to the location of the shotgun which had been hidden in the brush near the house. At the time of this writing the juvenile is being held in the Juvenile Detention Facility in Del Rio and the adult is in jail in Brackettville. It is anticipated that the juvenile will be released to Immigration authorities for deportation with no official charges being filed due to his age. The adult will be formally charged with Burglary of a Habitation, a 1st Degree Felony.

On Saturday night, May 21st, we "busted" another beer party on Ft. Clark involving young people from both Brackettville and Uvalde ranging in ages from 15 to 20 years of age. The beer in their possession was confiscated and they were transported to my office for a meeting with yours truly where they were advised of the various aspects of the law concerning consumption and/or possession of alcoholic beverages by minors. As is our current policy, first offenders are released without being officially charged though their names, dates of birth, and phone numbers are logged in our file in case of subsequent violations. Second offenders are filed on and appear in court for trial. Thus far we have had no second offenders and we recently obtained convictions and a stiff fine on an adult charged with providing alcohol to minors. Hopefully this recent conviction and fines will make others think twice before providing alcohol to our minor young people. We ask for assistance from parents in our efforts to curb consumption of alcohol by minors and maybe by working together we can save a young mind or life.

District Court was held Monday, May 23rd, with a large jury panel being called in for three criminal cases and several civil suits that were heard before District Judge George

Thurmond. The cases were settled without the need of a jury so the panel was released.

The three criminal cases heard involved two possession of marijuana cases and one involuntary manslaughter case. The results are as follows:

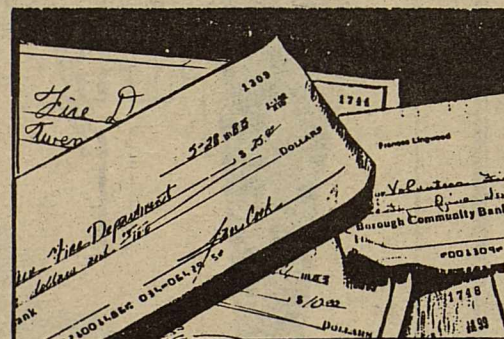
- 1) Josue Jimenez-Salazar - 3 yrs. TDC-Felony Possession of Marijuana.
- 2) Javier Ruiz Garcia - 5 yrs. TDC & \$500 fine-Possession of Marijuana excess of 50 lbs
- 3) Laureano Galindo - 4 yrs. deferred adjudication & probation-160 hours community service-Involuntary Manslaughter.

The involuntary manslaughter case stems from a traffic accident on Hwy. 2523 in northwest Kinney County where three members of the same family were killed when their car ran into an overturned cattle truck driven by Galindo.

Both Salazar and Garcia are being held in the county jail until such time that they can be transported to TDC by this department.

A house fire was reported to the sheriff's department at approx. 11:10 p.m. the night of Tuesday, May 24th. The fire occurred at the Pat Owen residence on Colony Row on Ft. Clark. Several neighbors joined the owner of the residence in fighting the fire until the Volunteer Fire Department could arrive at the scene where it was quickly brought under control. The quick actions of the neighbors involved is credited with preventing a much larger, destructive fire. It is believed that an electrical short in a reading lamp in the living room started the fire. At the time of this writing there is no official estimate of the damage. Both Chief Deputy David Luna and myself were at the scene to handle crowd and traffic control.

**LIBRARY NEWS**

Kinney County Public Library and the Texas State Library invite the children of Kinney County ages 3-12, to encounter trailblazers and stargazers in the 1988 Texas Reading Club Program, beginning June 7th.

This year's theme is "Trailblazers, Stargazers." It is about people who do new things, go new places, experiment, explore, and create. Through the reading club the participants will meet these people in books, films, and activities.

The following are rules & regulations for this year's program:

**1) Eligibility of Participants:**

Must be a county resident age 3-12. Must register for the program and apply or update library card. Children visiting relatives or friends who live in the county may participate in the program but may not apply for a library card. If the relative or friend with whom they are visiting gives written permission for the child to borrow library material under his/her library card a Visitor's Permission to Borrow Library Material Form must be signed. (Ask for forms at the Library) In compliance with fire regulations the first 20 children will be accepted in each age group.

**2) Registration Dates:**

May 31st - June 6th from 10 am - 5 pm. If a child does not register on the above dates and there is still vacancy, the group head will decide if the child is accepted.

**3) Dates of Program:**

Children age 3-5 will meet Tuesdays, June 7th, 14th, 21st, 28th, July 5th, 12th, from 10:30 am to 11:30 am.

Children age 6-8 will meet Wednesdays, June 8th, 15th, 22nd, 29th, July 6th and 13th, from 1 pm to 3 pm.

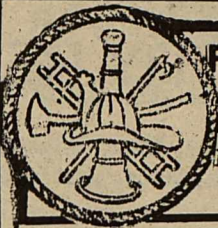
Children Age 9-12 will meet Thursdays, June 9th, 16th, 23rd, 30th, July 7th and 14th, from 2 pm to 4 pm.

All groups will meet July 22nd from 12 noon to 1:30 pm for certificate presentation and party.

**CONSERVATION NOTES**

BY TONY HUFFMAN

It doesn't take any college education, ranch experience, or a crystal ball to determine the biggest range problem in Kinney County right now. Folks, it's dry! If that comes as a surprise to some of you, then you are either living where it's raining or you haven't been outside lately. Now I know a few people who claim to have gotten good rains, some who got a rain, and many more that say "what rain". Most people in the hills north of Brackettville have had a couple of rains, while people along Hwy. 90 east of Brackettville will confess to a rain, maybe two and the rest of the county, well when they talk about rain in inches, that's how far apart the drops were.

Kinney County, like most of Texas, has a bimodal rainfall pattern. That is to say that the rainfall amounts peak twice during the year. The time of year that we normally receive the heaviest rains is May and June in the spring, and September and October in the fall. With an average of 21.12 inches per year we would normally receive 6.5 inches in the two spring months, and 4.75 inches in the two fall months. That means that over 50 percent of the average annual rainfall occurs during a 4 month period. Not only do we get 50 percent of the rain in 4 months but 80 percent (16.6 inches) of the rain occurs in the warm months April through October.

So far now, it's dry and there is not much grass growing and the brush can even use a drink. The ranchers are getting, or are already, in a bind because the grass that's left from last year is gone and no rain produces no new grass for the livestock. It's time to make adjustments in the ranch operations. The tendency to delay adjustments while "hoping for another rain" often results in damage to the grazing land on the ranch and sometimes severe economic losses to the livestock producer.

There are some adjustments that livestock producers can make during years of low forage production to keep livestock numbers in balance with available forage. Improve grazing distribution in the pasture to increase efficient use of available forage. This might be done by rotational grazing systems, fences, changing salt and mineral locations, waterings and brush control to name a few.

Market calves, lambs, kids, steers, and stocker animals early in the season. This eases the forage requirements on the breeding animals and thereby the stress on the grazing land. Although selling the young early, at lighter weights, will mean less gross income, it could still provide you with a greater net income if you are spending money to feed.

Cull the breeding herd more closely and heavily than normal. Ship cows, ewes, and nannies to market that are dry, poor doers, poor mothers and getting up in years.

Other ways of easing the pressure on your ranch that may work if feasible, is to lease additional land. However, finding lease land is tough and finding leased land with surplus forage may be even tougher.

It's important to protect the land from overgrazing during droughts. Soil without vegetative cover reaches higher temperatures than covered soil. This leads to drying the soil out several feet below the surface which means that it takes more rain to recharge the deep moisture in the soil profile. Cover on the surface retards runoff from rains allowing more water to "soak" into the ground. Cover on the surface also prevents erosion from the rain drops hitting the soil surface and dislodging soil particles allowing the soil to be moved off in the runoff from the rain. Losing soil means losing fertility, growth medium, and water holding capacity. The displacement of soil also pollutes streams, ponds, lakes, and roadway. Rangeland that is overgrazed takes significantly longer to recover when it does rain than areas where cover still exists.

For some of you it is time to make adjustments now. For the fortunate few who have had a rain, they might hold on till the next rain, if it rains soon. But as we enter the "wettest month of the rain cycle-- June" keep an eye on the grass, the temperature, and the rain gauge. With rainfall being what it has been since last fall and if we get no rain in June, we could be in for a rough time going into this fall with no forage reserve at all.

Since I wrote this several days before it was due to be published and because lately there have been clouds on the western horizon in the evenings, maybe just maybe, we will have rain before you read this. We are all hoping and praying.

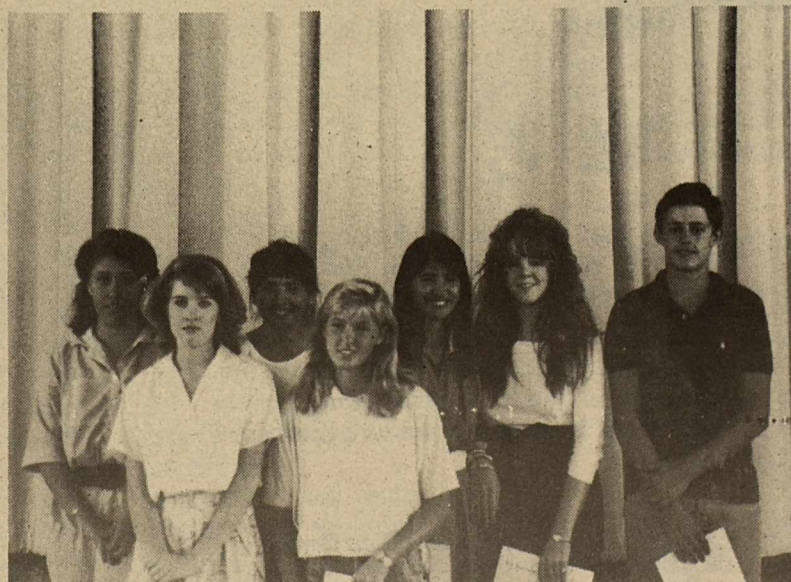

## TRACKS ALONG THE TRAIL BY DORTHY PAYNE

Long forgotten, Camp Grierson lies in the rolling hills about fifteen miles southwest of Big Lake, Texas. This camp was once an important military outpost on the lower Butterfield Trail from San Angelo to Fort Stockton. The camp was only in existence from 1875 to 1882.

Camp Grierson had water as had most of the camps and forts. The Springs at Camp Grierson were discovered by Andrew Geddes in 1875 while he was on a scouting expedition for Col. William Shafter.

The water was good water and had been used by the Indians who once lived there.

Later, when found again by Capt. Benjamin Grierson, he named them Grierson Springs after himself.

Grierson was well known on the Indian frontier. His first command had been at Fort

Concho from April 23, 1875 until July 20, 1882 and actual attacks by the Indians were less and less frequent. Travelers were only in danger of renegades or lack of water.

Col. Grierson converted the area stage stands into small outposts for Fort Concho. Some of the corner stones of the buildings weighed several hundred pounds.

In the beginning, Camp Grierson was made up of about a half a dozen buildings. The main one contained four rooms about twelve foot square and was probably the headquarters for officers of the post.

Further up the canyon the Grierson Spring is barely a trickle at times.

Actually there are two springs connected by a tunnel. The springs flow water mostly through the winter. The road leading to the old camp from the northeast goes down the side of the plateau on almost solid rock. The flat rocks in this old road still show the marks made by the steel rims of the stage coaches and army wagons of long ago, about a hundred years or more ago to be exact.

These marks are about all that is left of the old outpost to be seen, or maybe if you look you might find an old army button or two.

## HORTICULTURE WORKSHOP


