NEW ELEMENTARY PRINCIPAL HIRED





Western dances were great events in the southwest. They were usually held in the local hotel, schoolhouse or courthouse. The hall was usually decorated with cedar boughs and sagebrush. All the furniture was moved out making plenty of room to dance.

When the crowd gathered the announcer would mount a chair and welcome everyone to the event. These dances were looked forward to by the ranchers, and often guests came from as much as 150 miles away.

The Maxwell family from Ft. Sumner gave an annual ball and attracted guests from miles around. These dances brought young people together and were held to celebrate any occasion, such as a wedding, engagement, christening or birthday.

People didn't demand anything choosey, just a hall and music furnished by a violin or two and a couple of guitars. Sometimes the dance was held in a house with a dirt floor where everyone had to stop ever so often to

sprinkle down the dust.

Once in a while a cowboy would pass through with only the working clothes he was wearing. Everyone would look around until they could find some clothes for him to borrow to wear to the dance.

Some of the square dances have been handed down through the years. We are all familiar with the usual ones we danced to, but here is an old square dance of 1883:

Caller, let no echo slumber, Fiddler sweating like a steer, Hoofs a-pounding on the lumber, Making music the stars could hear, Hug the girls up when we swing'em, Raise them plumb offen their feet, Balance all, you saddle warmers, Seat your little sage hens, And let'em blow.


A good caller was worth his weight in gold, and alot of reffort was spent in getting his services, no matter where he could be found or was available.

The dances lasted all night. Children were put to bed on pallets and food and coffee were always available, furnished by the ladies. And ofcourse the men had to go check their horses every now and then.

Sometimes I think we had more fun with uncomplicated amusement than in this day and

My uncle played the fiddle at dances all over the country and became in great demand, sometimes traveling horseback for long distances.

STATEMENT OF INTENT **TO CHANGE RATES**

GTE Southwest Incorporated, in accordance with the Rules of the Public Utility Commission of Texas, hereby gives notice of the Company's intent to implement a new schedule of rates in Texas, effective July 6, 1988. This proceeding has been previously docketed by the Commission as Docket No. 5610.

The proposed changes in rates will affect approximately 970,500 of the Company's Texas customers who represent all classes of customers subscribing to the Company's local exchange and foreign exchange services within the State of Texas, as well as all entities subscribing to the Company's billing and collection services within the state. The proposed changes in rates are designed to increase the Company's intrastate revenues by \$81,407,000, or approximately 11.8 percent annually.

Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission as soon as possible. A request to intervene, participate, or for further information should be mailed to the Public Utility Commission of Texas, 7800 Shoal Creek Boulevard, Suite 400N, Austin, Texas 78757. A complete set of revised rate schedules has been filed with the Public Utility Commission at Austin, Texas, and is available for public inspection in each of the Company's Business Offices in the State of Texas. A summary of the Company's rate filing has also been sent to the Mayor's office of each affected Municipality.



Brackett schools support the enforcement of the law and encourage families to require teenagers to have a license before they drive.


City, County, and State law enforcement officers do not enjoy citing persons for traffic violations; however, I have been told they are going to be writing tickets to violators.



BLOOD DONORS EARN CHANCE FOR FREE AIRLINE TICKETS

Blood donors should not take a vacation from giving blood this summer, and they can earn a chance for a free trip when they donate. By giving blood in July, donors can earn a chance for a vacation while helping to save lives in their own community.


Southwest Airlines is offering a pair of tickets to one lucky donor in July. All donors who come to give blood during the onemonth period at one of the two San Antonio locations of the blood bank or at a mobile drive set up in the San Antonio service area of the South Texas Regional Blood Bank will be automatically entered in the drawing. The tickets are good for anywhere Southwest Airlines flies in the continental United States. The name of a lucky winner will be chosen at a drawing at the blood bank Monday, August 1.

Blood donations generally tend to decline during the summer months since children are out of school, families are on vacation, and more outdoor activities and events are planned. Hospital patients cannot take a vacation from receiving needed blood transfusions, and continue to need the generous support of South Texas blood donors on a regular basis. Southwest Airlines has offered the free tickets as an incentive to help encourage blood donors not to forget to give blood during the summer.

Blood donors should be between the ages of 17 and 72 (17-year-olds need written parental consent), weigh at least 110 pounds, and be in good general health. Names and dosages of prescribed medications should be brought with donors when they come to give blood.

The downtown location of the blood bank is at 318 McCullough at Broadway. A second location is in the Medical Center area at 7940 Floyd Curl Drive, Medical Center Tower II, Suite 260. For hours and more information, or to set up a mobile blood drive with a group in a South Texas community, call 22-DONOR in San Antonio or 1-800-292-5534 from outside the city.





U.S. Border Patrol Agents made a major drug bust Friday morning, June 24. The bust came about after an eastbound vehicle was stopped on the east side of Brackettville on Hwy. 90 for suspicion of transporting illegal aliens. The vehicle fit the profile for a smuggler vehicle, and after the stop was made a strong smell of marijuana was detected and a resulting search turned up 18 bundles of marijuana wrapped in clear plastic and burlap. The total weight of marijuana was 325 lbs. Roverto Martinez, 33, of Del Rio was arrested at the scene. The Drug Enforcement Administration out of Eagle Pass was contacted and the case will advance under their jurisdiction.

Local Border Patrol Agents were again involved in a local crime investigation after receiving a call about illegal aliens in a hunting camp on the Vrana Ranch approximately 9 miles east of Brackettville off Hwy. 90. We received a call from the agents after they had 7 illegal aliens in custody on the ranch believed to be the perpetrators of a burglary of the hunting camp. Chief Deputy David Luna and myself went to the scene to investigate and found that entry to the property had been made by cutting a large hole in a high fence surrounding the camp. The burglars had then forced open the front door by breaking a hasp and had entered the mobile home. Evidence at the scene indicated that the illegal aliens had been in and around the camp for at least. two days, eating and sleeping there. The only items of property belonging to the camp that the "wets" had in their possession at the time of their arrest were some foodstuffs. We contacted the owner of the property who lives near San Antonio and advised him of the crime and the resulting damage. He declined prosecution due to the small amount of damage and the fact that all property taken was recovered. The illegal aliens were processed and deported by the Border Patrol.

A major "bust" of local minors at a beer party occurred Friday night at approximately 11:30 p.m. 9 miles north of Brackettville on Hwy 334 (Campwood Road). Chief Deputy David Luna investigated a report we had received about the party and a total of 16 minors were arrested at the scene and brought to the Sheriff's Office for further investigation into the matter. There were 14 boys and 2 girls ranging in ages from 15 to 20 years. Three (3) cases of beer were confiscated and the minors were identified then released on their personal recognizance after being advised of the serious nature of minors consuming or in possession of alcohol. Warning tickets will be issued to the violators and letters will be sent to their parents advising them of the incident. Future violations by those ticketed will result in charges being filed in Justice Court.

This latest incident again brings to mind the reactions of some parents to the efforts oflaw enforcement officers trying to do their jobs in enforcing the drinking as well as driving license laws. reactions range from full cooperation with peace officers to outrage of the parents directed against us for daring to bother their little darlings. It is the middle and latter range of reactions that disturb me. We go out of our way , far above the call of duty, to try and steer our young people in the right direction. We admittedly turn our heads at minor infractions of the law as long as there is no danger to the public. We do this for adults too. We don't want a hardcore police force in our community and county. We want our citizens to be able to enjoy living in a rural community where everyone knows everyone else, and where you might see an old mother hen with a brood of chicks cross Main Street downtown every once in a while, and where some of the sights might also include a goat or two crossing the road. This applies within reason until public safety gets involved, and then we must in good conscience, take steps to stop the illegal activity. Yet we often get critized and condemned by the parents of youthful offenders when we finally say, "No More".

I have always believed and have publicly stated on more than one occasion that "law enforcement begins at home". Parents are not dumb. They know if their children are drinking, and they know that it is illegal for them to do so if they are under 21 years of age, unless in the company of their parents. The parents also know it is illegal for their children to operate a motor driven vehicle on public roads unless licensed by the state. Yet they take no action to control

the drinking habits of their beloved children nor prevent them from driving without a license, even when they are bound to be aware of the dangers of mixing alcohol, youth, and the driving of automobiles. Yet it is the peace officers who get critized, either for NOT doing our jobs, or FOR doing our jobs. Kind of a "damned if we don't" situation.

Come on ,Folks, let's get realistic about this! Take control of your children. If they aren't licensed to drive, then don't allow them to drive the family vehicles. If you don't want them drinking, then take action at home to get it stopped. Then if you can't gain control of the situation call on us, and we will do everything in our power to assist you in the best interest of the child and public safety. Peace officers are not baby sitters and should not be expected to do YOUR job. We have made several "busts" of minors drinking or in possession of alcohol over the past few months, and we have issued both verbal and written warnings to unlicensed drivers. And, sad but true, we have been critized and scolded by some parents for "picking" on their children. In my opinion a hardcore police crackdown is not the happiest state of affairs, but if we don't receive assistance from parents soon we may have no other choice. And, by the way, parents allowing unlicensed minors to drive are in violation of the law also, and if a hardcore crackdown becomes necessary they will also be cited. Let's all try and cooperate with each other in our community and county in the best interest of ALL of us, not just for a few SPECIAL INTERESTS. THINK ABOUT IT!!
