



Reye's Syndrome

Reye's Syndrome is a very serious disease that you should know about. people develop Reye's Syndrome as they are getting over a viral illness, such as the flu or chicken pox. Reye's Synusually affects drome people from infancy through young adulthood; however, no age group is immune. Although Reye's occurs when generally someone is recovering from a viral illness, it develop 3 to 5 days after the onset of the illness. Its main targets are the liver and brain, it is noncontagious, and too often it is mis-diagnosed as encephalitis, meningitis, diabetes, poisoning, drug overdose or sudden infant

Early diagnosis is crucial. An individual should be watched during the next two to three weeks following a viral illness for these symptoms, usually occurring in this order:

*Relentless or continuous vomiting

*Listlessness (loss of pep and energy with little interest in their environment)

*Drowsiness (excessive sleepiness)

*Personality change (such as irritability, slurred speech, sensitivity to touch)

* Disorientation or confusion (unable to identify

*Combativeness (striking out at those trying to help)

*Delirium, convulsions or loss of consciousness

Reye's Syndrome should be suspected in anyone who vomits repeatedly. Phone your doctor immediately if these symptoms develop. Voice your concern about Reye's Syndrome. If your physician is unavailable, take the person to an Emergency Room promptly. Two liver function tests (SGOT, SGPT) can be done to determine the possibility of Reye's Syndrome. There is a 90% chance of recovery when the syndrome is treated in its earliest stages by physicians and nurses experienced in the treatment of Reye's.

Studies have shown that using aspirin or aspirincontaining medications to treat the symptoms of viral illnesses increases chance of developing Reye's Syndrome. If you or a member of your family have a viral illness, do not use aspirin or aspirincontaining medications. In fact, you should consult your physician before you take any drugs to treat the flu or chicken pox, particularly aspirin or antimedicines. nausea Antinausea medicines may mask the symptoms of Reye's Syndrome.

The National Reye's Syndrome Foundation (NRSF), the U.S. Surgeon General, the Food Drug Administration, the Centers for Disease Control recommend that combination and aspirin products containing aspirin not be taken by anyone under 19 years of age during fever-causing illnesses.

Aspirin is part of the salicylate family of medicines. Another name for aspirin is acetylsalicylate; some drug labels may use the words acetylsalicylate, acetylsalicylic acid, salicylic acid or salicylate instead of the word aspirin. Currently, there is no conclusive data as to whether other forms of salicylates are associated with the development of Syndrome, Until further research has answered this question, NRSF recommends products containing any of these substances should not be taken during episodes of viral infections.

The NRSF is a non-profit, tax-exempt organization with affiliates located in 44 states. The NRSF has pioneered the movement to disseminate knowledge about the disease in an effort to aid in early diagnosis and also provides funds for research into the causes, cure, care, treatment and prevention of Reye's Syndrome

FEDERAL CROP INSURANCE REQUIREMENTS

If your application is accepted, and if you also have an interest in insurable crops in the county, you must purchase at least the Catastrophic (CAT) coverage for these crops in order to be eligible for the CRP Payment.

LANDLORD - TENANT PROVISIONS

Unless the farm operator signs a voluntary release of the acreage offered, that farm operator must share in the CRP contract.

ACTUAL BID PROCEDURES

IF YOUR WISH TO SUBMIT A BID THE FOLLOWING ARE THE STEPS IN THE PROCESS:

- 1. Come to this office and delineate the bid area on a photograph.
- 2. Meet with NRCS (formerly Soil Conservation Service) so that land eligibility and predominant soils can be determined and documented.
- 3. CFSA will determine the bid cap and provide you a copy.
- 4. After reviewing bid cap information, applicant submits sealed bid. (Must be in whole dollar/acre).

AFTER THE BID PERIOD IS OVER, THE SEALED BIDS WILL BE OPENED AND THE BID RATES WILL BE COMPARED TO THE BID CAP THAT WAS PREVIOUSLY DETERMINED. IF THE BID EXCEEDS THE BID CAP OR IS NOT IN WHOLE DOLLARS, THE BID WILL BE REJECTED. IF THE BID IS EQUAL TO OR LESS THAN THE BID CAP, THE BID WILL BE SENT TO THE NATIONAL LEVEL.

The backbone of the Coyote offense lies in the backfield that will be adequately staffed by sophomore Oscar Baeza and his freshman brother Fernando. While Oscar brings more size strength and speed to the field.,

Fernando utilizes his quickness and excellent field vision to make big plays.

Look for Oscar to start at fullback in front of Fernando at the tailback position. Ronnie Rivera is a sophomore transfer from Big Spring who Avery hopes will contribute to the offensive backfield.

The lineman and ends will primarily be used as blockers for the prominent Coyote running game. "Our lineman are not extremely big, but they are tough and have good blocking techniques," said Avery. "We will not be

Clayton and Harrison will provide the necessary experience and size to apply pressure on the offensive backfield. Avery hopes to utilize the size of James Green along the line as a substitution.

Fernando Baeza will be the headhunter of the Coyote defense at middle linebacker. Grant Key and Oscar Baeza will start at positions. the corner Ronnie Rivera will seek to find playing time at one of positions. the corner Freshman Colt McCook will start at safety where Avery hopes he will use his speed and natural instincts to create turnovers.

Coach Avery looks forward to this season because it will give him and his youngsters an opportunity to surprise the district.

Contracts were awarded on four of the five base operations expected to be utilized during 1995 High Plains Enhanced Boll Weevil Diapause Program. Award of the aerial spray contracts was completed Wednesday, August 30.

Contracts were awarded for base operations in Post, Seminole, Lamesa and Big Spring. According to Lubbock-based Plains Cotton Growers the successful bids ranged from \$5.20 to \$4.90 per gallon of chemical applies.

The following is a list of the successful bidders and the base unit from which they will operate:

Post Unit - Payne Flying Service, Katy, TX. Seminole Unit - Kubin Air, Bovina, TX. Lamesa Unit - Hogg Flying Service, Lamesa TX. Big Spring Unit - Southwest Spraying, Clovis, NM Crosbyton Unit - Not Yet Awarded

The awarding of the aerial contracts sets the stage for the 1995 program to begin spraying operation around Sept. 26. Already field maps and trap lines are being readied for the effort which is set to fight the boll weevil in some 2 million acres of cotton.

All aircraft used on the program will be equipped with a parallel-swath guidance system from Satloc, Inc., of Casa Grande, Arizona. Satloc's satellite-based global positioning system (GPS) was specified as a requirement for the 1995 contract to provide record-keeping and tracking functions for program operations.

Trap catches are on the rise throughout the area as migrating weevils renew their yearly push onto the High Plains. Five mild winters in a row have the allowed the pest to get a toehold above the Caprock threatening cotton in many counties that have historically never seen any type of weevil activity before.

PCG's Enhanced Program, approved overwhelmingly by producers referendum last April and backed by the Texas Boll Weevil Eradication Foundation, is expected to treat up to five

million aggregate acres for diapausing boll weevils in 1995.

The goal of the 1995 program is to reduce overall weevil numbers prior to their entering overwintering habitat, reducing the number that could survive the winter and still have the potential to reinfest cotton in 1996.
