


## CONGRATULATIONS CHEERLEADERS AND CASS

# REFLECTIONS BY PRESTON TAYLOR, PASTOR FIRST BAPTIST CHURCH

Two big red roosters happened to be among our family holdings during my boyhood days on a small Arkansas hill farm. Most all the chickens got along fine together. Not so with the red roosters. They tangled and fought constantly. Why? Who knows. They just did.

To keep peace in the world is a dream that keeps fading away. Peace agreements are made and broken. Harmony disappears and hard feelings erupt. And yet we are encouraged to be on the side of those who strive for peace.

Would you care to talk about the harmony the peace and the beauty of your family life? Strife may break out between the husband, wife and children over a dozen important or little issues — from property divisions, toys, relics, money or work assignments. Throw up your white flag and surrender. Stop the selfishness and the determination to have your own way.

How are the relationships in school life? Do students go to class with the purpose of learning? If not, confusion and chaos sets in. Parents play a vital role in keeping peace within the educational institutions, too. 






The next time I made the trip to the little house out back I had a hammer, a tin can lid and a handful of nails clutched in my hot little hands.


#### VACATION BIBLE SCHOOL




This week I'll review 2 new movies, "Action Jackson" and "Moving"!



OVER 30 YEARS OF DEPENDABLE SERVICE



A tragic accident which occurred on a ranch in west Kinney County off Standard Lane at approximately 1:30 p.m., Friday afternoon, July 8th claimed the life of a 21 year old Uvalde man. The young man was identified at the scene as Jose Reyes, III. He was officially pronounced dead at the scene by Justice of the Peace Alvin Hall acting as Coroner at approximately 2:30 p.m.

Information obtained from the father of the dead man, who was an eyewitness to the tragedy, determined that the two were attempting to start a maintainer (motor driven road grader) by pulling it with a tractor. The father was operating the maintainer and the deceased was operating the tractor when the blade of the maintainer hung on a large stump stopping the maintainer. The tractor immediately flipped over backwards, rotating on its rear axle. It fell on top of the younger Reyes crushing him with its heavy weight. Members of the Kinney County Volunteer EMS unit and Fire Department responded to the scene to assist but it was too late. It is believed that young Reyes was killed instantly. At the time of this writing funeral arrangements are pending at Rushing-Estes Funeral Home in Uvalde.


A series of local thefts occurring at several area hunting camps were cleared last week with the arrest of a 31 year old San Antonio man. Larry Allen Carroll was arrested at a remote cabin in the rough countryside of a north Kinney County subdivision on Thursday afternoon, July 7th after we obtained a "hit" on his name which we had run through the ICIC/NCIC computers. Chief Deputy David Luna and I made the arrest at the cabin without incident and transported the man to the county jail where he was booked on outstanding criminal warrants from both Bexar and Guadalupe County. warrants were for drug and weapon charges. The man and his female companion came under investigation when we received a complaint from a local businessman that he suspected the pair of taking personal property from hunting camps under his control while they were working for him. During questioning of the man, it was determined that property had been taken and much of it was recovered. The cases continue under investigation, and no local charges have been filed against the pair at the time of this writing. Carroll was transferred to Bexar County on their charges on Monday, July 11th.

A Pre-Trial Hearing has been set for Friday, July 15th, for the two male suspects in the Easter Sunday Aggravated Robbery of a Laughlin AFB woman at a roadside park approximately 6 miles east of Brackettville. The female suspect in the case was No-Billed

by the Grand Jury and released some time ago. The two male suspects, William Bruce Chandler, 21, of South Carolina and Ricky Eugene Cagle, 19, of North Carolina have been in jail in lieu of bonds since the time of their arrest in April of this year.

Work continues on the county jail with the cell door and lock system being about 95% completed, we hope. The renovations have gone on longer than expected due to various problems associated with the suppliers of items needed by the installers of the project. County Commissioners have also approved other renovations and repairs to be done while we are involved with this project, and all work should be completed and the jail in full operation by Ausust 1st. We will have upon completion of the work a new teletype system, new cell door and lock system, and new floor tile and paint throughout the cell blocks. Even with the work being done and having to close down half the jail while doing it, we have taken in \$115,388.00 in prisoner care fees through June of this fiscal year. We anticipate an additional \$20,000.00 income through September and should have collected a total of \$135,000.00 for Fiscal Year 1987-88 which is approximately 3 times that estimated for the year. With all work done and in full operation, we hope to do even better next year.




#### TIGER MASCOT


