## GRANT RECEIVED BY LOCAL TEACHER

A local teacher's idea for a program to help parents prepare their pre-school children for school success has earned the Brackett Independent School District a \$34,000 grant from the Meadows Foundation.

The two-year grant will allow the teacher, Dr. Patricia Seawell, to provide a program of classes directed at the parents of young children in Brackettville. The program, entitled ENRICH-PLUS (Every Night Reading in Children's Homes---Parents Learning Useful Strategies) will emphasize the vital role parents play in their children's academic success.

The classes will stress the relationship between children's oral language development and their subsequent reading abilities. Parents will be provided with specific enrichment strategies that research has shown to be effective in promoting school success.

These parent classes will be offered beginning in September. Each session will be six weeks in duration, with classes meeting once per week. Both day and evening classes will be offered.

Brackettville parents interested in attending one of these free sessions should phone the Brackett Independent School District offices, 563-2491, and leave their names, telephone numbers, and ages of their children for Dr. Seawell. They will be contacted once a class schedule has been made.

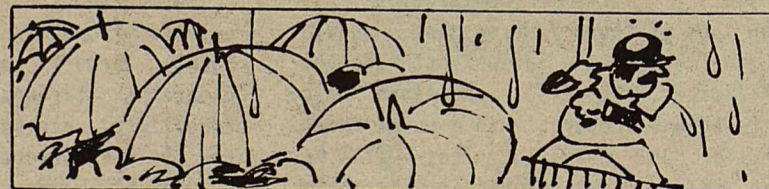

HEAT STRESS WARNINGS CAN SAVE LIVES

Listening to the "heat stress" or "heat index" readings meteorologists often give in their summer weathercasts could help prevent situations leading to dehydration and sun stroke.

In recent years, meteorologists have begun using the terms, "heat stress" or "heat index" to describe the relationship between temperatures and humidity, according to Dr. Clift Price, Associate Commissioner for Personal Health Services at the Texas Department of Health.

"The television and radio reports are helpful in planning outside activities," he said. "Humid heat can especially be deadly for the very young, the elderly, persons with heart or respiratory problems, and those taking medications."

Dr. Price explained that the heat stress index is a numerical table by which the National Weather Service rates the degree of discomfort a person may feel at a given temperature and humidity. Although the table does not allow for the variables of wind and shade, which Dr. Price said, can greatly influence an individual's tolerance of heat and humidity, the index reading is useful in helping persons take needed precautions against dehydration and sun stroke.

A heat stress index reading of 105 is considered very dangerous, Dr. Price warned. High temperature alone is physically tolerable to most people, but in combination with humidity, it can cause an individual's cooling mechanism, perspiration, to work overtime. "If one fails to replace the fluids and salts lost through perspiration, dehydration can occur," he said.

Symptoms of dehydration are muscle cramps, nausea, dizziness, headache, and low blood pressure. If fluids are not replaced, heat stroke can ensue, causing sudden weakness, severe headache, loss of

consciousness, brain damage, even death, if the victim is not quickly treated.

"To avoid danger of overheating, people should dress in light-colored, loose-fitting clothing. They should drink more than their normal intake of water, and be sure to have water available if they need it. They should seek good ventilation. And as important as anything else, they should remain aware of their own physical conditions and the weather conditions," Dr. Price explained.

He said some 200 people in the U.S. die as the result of hot weather during an average year. "Since severe drought conditions already have developed nationwide this year, it is possible that heat waves will take a heavier-than-normal toll of lives--if people fail to be cautious," Dr. Price said.

To determine the current heat stress rating, using the National Weather Service index (below), find the index number in the column below the current humidity (horizontal line on top) that is directly to the right of the current temperature (vertical line at left).

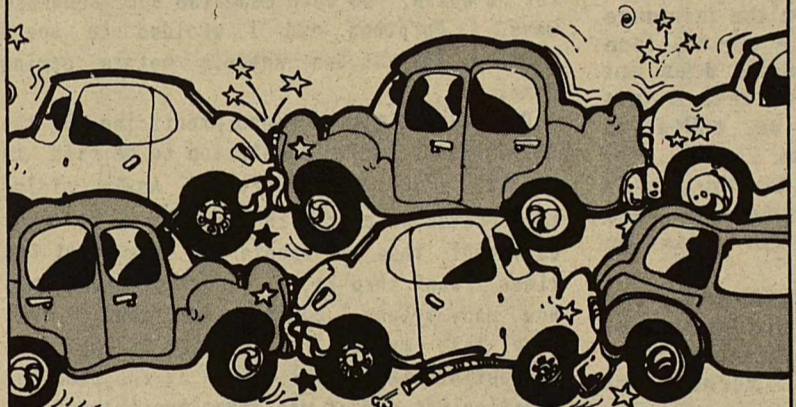

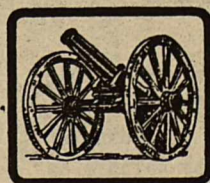

## COMMISSIONER'S COURT UNOFFICIAL MINUTES

The July 5th Special Emergency Meeting started at 4:35 with a quorum present.

It was approved to purchase from Uvalde Equipment while on sale a John Deere Lawnmower.

Jail improvements are discussed as to what has been done so far and what is still needed and where to get funds. There are floor tiles coming up on the east wing (bank side), of all the showers, one not working so it's not included in the figures. Approval to repair floor and showers (with ceramic tile up to 5ft.), to accept bid from Frank Gomez to paint jail with County supplying paint was made. Motion to get three prices for paint was made and approved.

Judge Seargeant states that Mr. Crumley has drawn a sketch of the swim park and was advised by an architect that we should fill pool to 3-4 inches on shallow side to see if it leaks. If it does not leak or settle after a week, it's possible to repair the pool without spending too much money.

The new budget for 1988-89 was discussed minutely and suggested to be put on regular meeting of July 11.

The Commissioners went into executive session at 5:25 p.m.

These are not official minutes but a synopsis only. Regular Commissioners meetings are held second Monday each month and are open to the public.

Commissioner's Court convened with a quorum present at 9:00 a.m.

Judge Seargeant states a memo will be sent to each department for a list of inventory of County Property in their control.

A motion to approve the tax appraisal budget as presented was approved after a discussion of salaries, computer software and other allowances.

Judge Seargeant would like a resolution to Congress to be signed stating Kinney County would like to participate in the joint U.S. and Mexican Border Commission for Border Cleanup. Kinney County has 15 miles on the Rio Grande.

Election judges and alternate judges are appointed from each precinct. A motion was made to accept these appointees and absentee judges appointed. Motion was approved.

A motion for the County Attorney to sign a tax deed for an old family plot of property bought and being paid for by Gilbert Martinez was seconded and approved.

A committee of persons from all precincts were appointed and a suggested letter authorizing the committee to use whatever materials that are available to the public to update voter rolls for this coming election was approved by the court.

Approval was also made for the Treasurer's report and the months bills.

Attorney Shahan informs the Commissioner's that there will be two Workman's Compensation Courses to be held, one in Austin on July 20 and one in San Antonio on July 31. He suggests that it would be nice if someone from Kinney County could be there.

Rental of the Civic Center for the Christmas Holidays was discussed with a suggestion to advertise for three or four weeks during the month of August for people interested in using the Civic Center December 25 or December 31 to submit a bid.

Several suggestions for use of the Civic Center by the Community have been turned in, most suggesting a youth program. Skating was another suggestion. Discussion was on insurance in case of injuries if a skating program was developed, costs for electricity to keep the Center open, who would be liable and who would pay. Would some organization be willing to take on this project (like the Episcopal Church did with the County pool) ?? There are parents who have signed a list stating they would help out with a youth project.

Mr. Nick Fohn from the State Health Department was present to discuss a policy procedure for on-site sewage facilities which will be mandatory September 1, 1989 by the State Health Department. A policy procedure titled Construction Standards for On-Site Sewerage Facilities was accepted and approved by the Commissioners and has been in affect since January 1, 1988 by the Division of Water Hygiene.

James Crumley requests consideration for additional office space mainly for storage. Just looking down the road as new equipment will be needed in the future and they will need room to house it. Commissioners recess to take a look at offices to see how it could be arranged to make more room.

Payments for K.C. Ambulance Services are backlogged and long overdue. The Court spoke with Secretary in charge of billing and she explained procedure to Court. First thing needed is a medical release form to be signed so a bill can be sent to the insurance companies. If this cannot be signed, then the patient is billed. If patient does not pay after a certain length of time, it was suggested that the patient be called to remind them that the bill is due.

The minutes of the June Commissioner's meeting and the July 5th meeting were read and approved after two minor corrections on phrasing of sentences.

It was motioned and approved to add funds to the cemetery budget for running of water lines, completion of fence and other improvements as needed. Because of cemetery acquisition of land is pending litigations the Commissioners suggested we look for other land to use.

These are not official minutes of the meeting, only a synopsis of what transpired. All the public are welcome to attend the Commissioners Court meetings, as it is our funds being discussed and our welfare. Meetings are the second Monday every month at 9 A.M.

On Friday the 15th, at 12 Noon, Robert Cole of San Antonio crossed the center line of Highway 90, 8 miles west of town and collided head on with Mr. & Mrs. McDonald of Campwood. The McDonald's were not seriously hurt, but Mr. Cole was trapped in his car suffering from massive lacerations of the head, arms and hands along with a broken ankle. Mr. Cole was pinned in by his leg which was smashed between the floor and the dash.

Realizing that the man was trapped, Del Rio was called, because we didn't have the necessary equipment required to extricate this man from his battered auto.

At 12:15p.m. Kinney County EMS is on the scene and begins treating the man. At 12:47 the Del Rio EMS arrives to assist and transport. At 12:53 the Del Rio Fire Department arrives with their "Jaws of Life" extrication tools. By 12:58 the man is freed from his car. Near death after almost one hour of being trapped in his car, Mr. Cole was then rushed to Del Rio.

When a person is badly injured their survival depends a lot on the first hour or what we call the "Golden Hour". If the patient can be transported to a medical facility for treatment within that first hour, then their chance for living is greatly increased.

**HATCHERY & RESEARCH CENTER OPEN**

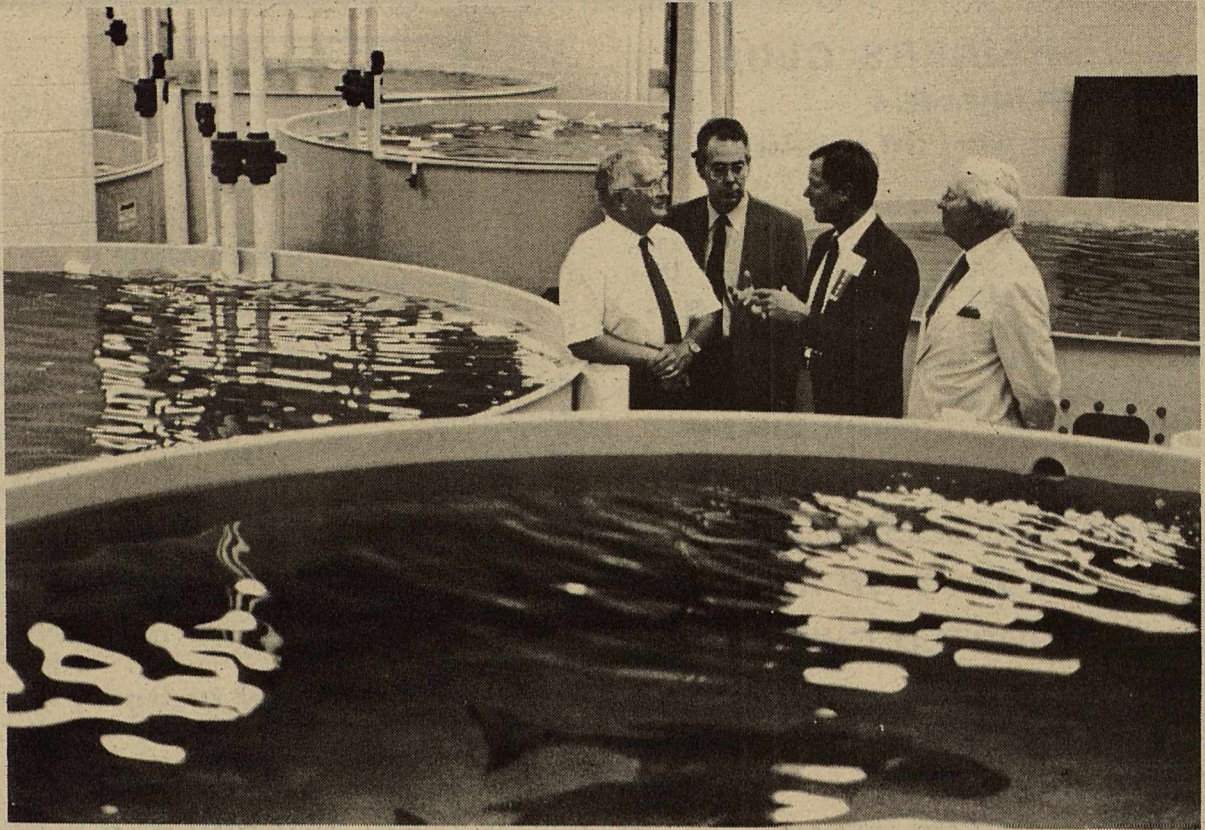
The new Ben F. Vaughan Jr. Hatchery and Research Center was dedicated by Gov. William P. Clements Jr. Friday, June 17. Clements noted, "This day marks a milestone -- a milestone not only in our efforts to improve fishing in the Gulf, but to conserve and enhance our natural resources for future generations. It signifies the fulfillment of many dreams and even more work. And yes, it symbolizes the strides we can make as a team."

The new hatchery doubles the capacity of the GCCA/CPL Marine Development Center, making it the largest salt water hatchery along the Gulf Coast. The center is located on the grounds of Central Power and Light Company's Barney Davis Power Station in Corpus Christi.

CPL made 69 acres of land available to the Marine Development Center, 30 acres and 10 rearing ponds for the original John Wilson Hatchery in 1982, and an additional 39 acres for the expansion. The expansion was completed at a cost of \$4.3 million, provided by the Gulf Coast Conservation Association.

The new 14,000-square-foot-structure was made possible by a major gift to the GCCA by the family of the late Ben F. Vaughan Jr. of Corpus Christi. GCCA sought and received matching funds from the Federal Aid to Sportfish Restoration Fund.

"The cooperative effort between industry, individuals, a conservation organization and government is one that benefits everyone in Texas," noted Tom Shockley, CPL president and chief executive officer. "We are pleased to be partners in finding a constructive solution to threatened fish species."



The marine development complex is comprised of the John Wilson Hatchery, the Perry Bass Fry Building and the Vaughan facility. An additional 24 rearing ponds have been constructed to handle fry from the hatchery. In a year of nearly ideal conditions, it is estimated that the center could produce 20,000,000 gamefish fingerlings for Texas' nine bay systems.

Gov. Clements officially opened the hatchery on Oct. 20, 1982, and production efforts concentrated on restoring redfish

populations. Since its opening the center has distributed more than 35 million fingerlings to Texas waters.

The hatchery expansion will allow Texas Parks and Wildlife Department scientists and technicians to research and produce additional fish species, such as speckled trout, tarpon and snook. TPWD operates the hatchery and distribution program and shares research responsibilities with the University of Texas marine fish researchers.

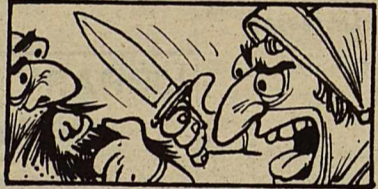

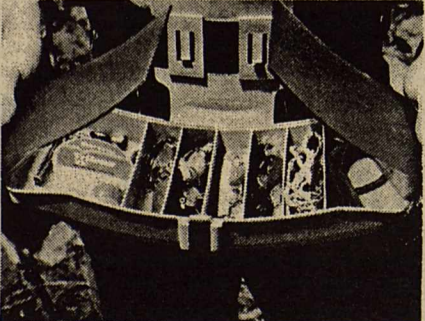



# PUBLIC NOTICES

## FREE & REDUCED LUNCHES AVAILABLE FOR BRACKETT STUDENTS

Brackett Independent School District will again participate in the Federal School Lunch Program. Elementary school students may buy a breakfast ticket for 50 cents and a lunch ticket for \$1.00. Junior High and High School students may buy a breakfast ticket for 50 cents and a lunch ticket for \$1.00. Extra milk may be purchased for 20 cents at all schools.

Children from families whose income is at or below levels shown on the chart are eligible for free or reduced price meals. Reduced priced lunch is 40 cents for all students Pre-kinder thru twelfth grade.

To apply for free and reduced price meals parents are asked to fill out an application as soon as possible. It needs to be filled out, signed and returned to the school. Applications are available at all school offices from 8:00 a.m. to 4:00 p.m.

All questions on the application must be complete. Please print. If information is missing, the child will be denied benefits. For an application to be accepted it must include: 1 - the total household income, 2 - the names and social security numbers of all family members 21 years of age and older, and 3 - the signature of the parent or guardian.

The information on the application will be checked by school officials during the school year. Proof of income will be required. If your child is approved for meal benefits, parents must tell the school when household benefits increase by more than \$50.00 per month, \$600 per year, or when household size decreases.

Applications for benefits may be made anytime during the school year if income decreases or family size increases. No child will be discriminated against because of race, sex, color, national origin, age or handicap. If parents believe they have been discriminated against, write immediately to the Secretary of Agriculture, Washington, D.C. Parents who do not agree with the school's decision on benefits are entitled to a fair hearing. This hearing can be set up by calling or writing Bob McCall, Superintendent, Brackett Independent School District, Brackettville, Texas 78832, Tel. (512) 563-2491.

Information on applications will be treated confidentially, and assistance with filling out the application may be obtained by coming to the school offices.

## Cook (And Say It) In Italian

Remove vegetables from marinade and alternate on skewers. Cook 4 inches above hot coals, or from broiler until vegetables are tender, turning often and brushing with remaining marinade. Makes 6 servings.

In the Mojave Desert there are some ground figures from the past. These mysterious figures of giant size have been puzzling scientists for years.

The only way to see them is from a plane. Why were they constructed before the age of the airplane? If they couldn't be seen from the ground, how did their makers know what they were doing?

Two figures of a horse about 20 feet long were discovered near Yuma. One has since been destroyed to make way for gravel and rock quarries.

In 1984 near Parker, Arizona, the figure of a fisherman with a spear partly fashioned from turquoise was found. This figure was believed to be 500 to 1000 years old.

These designs are called geoglyphs by some scientists. Medicine men of some of the Indian tribes have used the figures in some of their ceremonials. This region of the desert has been called "tierra del muerto", (land of the dead). The giant ground figures have been visited by many who are fascinated by their mystery.

"The Singer Design" near El Centro is a twisting line with branches that are more than a mile long. Broken quartz lies along the design; also flakes of chert, agate, jasper and basalt. Near this site three parallel lines of rocks run a half mile. But what do these lines stand for?

Every time the Indians used the sites they added something. Some of the rocks were put there one hundred years ago, some several hundred years ago.

So far 275 geoglyphs have been discovered in the southwest. There are figures of humans, serpents, shamans, lizards, mountain lions and also abstract geometric designs. They are from 150 to 5000 years old and run for 165 miles along the Colorado River at Needles, California to Yuma, Arizona. They were made by scraping aside the jet black stones and exposing the lighter soil underneath. Some of the rock alignments are believed to be 10,000 years old.

More and more designs are being found. Also more and more are being destroyed by vandals, motorcycles and dune buggies, or military encroachment.

The designs are primitive work and many myths have grown up in the areas they are found.

Similar figures and designs have been found in Peru and other localities.

Some of the designs do point to the solstice positions of the sun and moon, making more mystery. But perhaps we will never know all the answers. At least one rock alignment along the Gila River measures the summer solstice sunrise and archeologist and at least ten others could be of the same nature.

In the Mojave Desert near Parker, Arizona, there is a design called the rattlesnake. It

has two basalt eyes which the Indians claim can glow at night. It is more than 180 feet and is believed to be two hundred years old. Nine baby snakes can be seen alongside.

Most of the designs were first seen accidentally by pilots flying over the desert which led to further exploration. Perhaps because they might not be completely solved the giant designs in the Southwest are more fascinating.

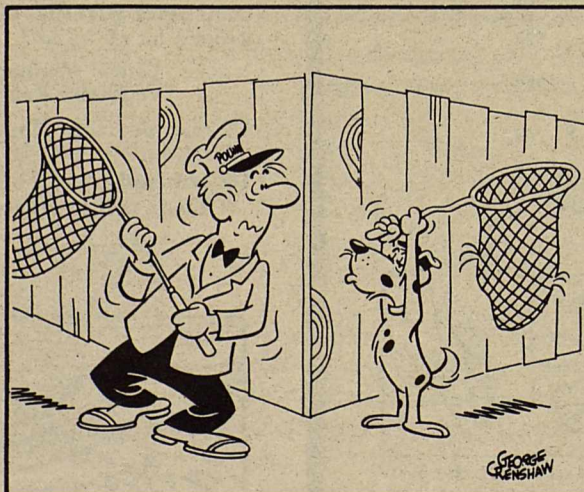

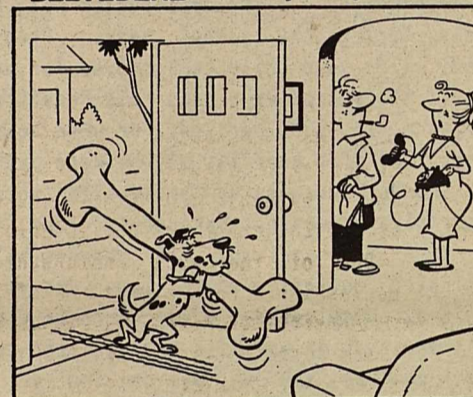

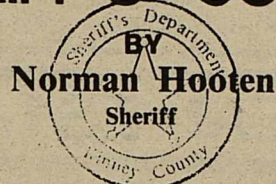

## SHERIFF'S CORNER



A major accident occurred Friday afternoon, July 15th on Hwy. 90 approximately 7 miles west of Brackettville near the Pinto Creek roadside park. The head-on collision involved an eastbound Suburban occupied by two persons and a west bound passenger car occupied by the driver only. Witnesses at the scene stated that the passenger car suddenly swerved into the path of the oncoming Suburban as they approached each other on the roadway. The impact knocked the left front wheel off the Suburban and totally demolished both vehicles. The driver of the passenger car was pinned in the wreckage for over an hour and was finally cut out of the car by Del Rio EMS and Fire Department personnel using the "Jaws of Life". EMS and Fire Department units from both Brackettville and Del Rio responded to the call and I was assisted in traffic control at the scene by Chief of Police Johnny Fritter and Highway Department personnel. The injured man was transported to Val Verde Memorial Hospital for treatment and it is unknown by this writer the extent of his injuries.

One of the most unpleasant, sometimes depressing, and always painful duties and responsibilities of being sheriff is the process and service of mental health warrants and the subsequent transportation of the mental patient to a State Mental Health Hospital. It is extremely hard on family members of the victims of mental problems. Such a process occurred Monday, July 18th, when Chief of Police Johnny Fritter and I had to pick up and detain a person on such a warrant. Quite often these victims are confused, frightened, and angry and really do not understand why they are being picked up and detained, and they place the blame for their confusion and fear on family members and peace officers having to detain them. The look in the victim's eyes most often touch the heart of the most hardened peace officer who is exposed every day to pain, injury and death. The man was detained overnight in the county jail on an Order of Protective Custody and was transported to the Kerrville State Mental Health Hospital on Tuesday, July 19th, by Chief Deputy David Luna and Chief of Police Johnny Fritter.

I received a call about a dead body floating down the Rio Grande River late Tuesday afternoon, July 19th. Border Patrol agents flying the river on routine patrol first spotted the body at 5:30 p.m. approximately 17 miles down river from Del Rio. This put it in Kinney County and I was called. When I arrived at the Canal Headgates on the Rio Grande River located on Rancho Rio Grande in south Kinney County the body was being kept under observation by two Border Patrol agents on the ground. We watched the body float down river until it veered off into the canal. We then went to

the Headgates to wait for it. As it hung up on the headgates it was lifted from the water by a worker there using a large crane with a bucket. The body appeared to be that of a 20-25 year old Mexican National male approximately 5'7", 130 pounds, with medium length black hair. He was dressed in a tan shirt and brown pants. His pants legs were rolled up and a pair of white tennis shoes were tied to his belt loops indicating that he was wading in the river at the time of his death. Drowning was most likely the cause of death, and the condition of the body indicated that it had been in the water for two or three days. Justice of the Peace, Alvin Hall responded to the scene at my request to act as Coroner. The body was later transported to Del Rio by Cox Funeral Home. It will be held for as long as possible while we attempt to identify the body and notify the next of kin. The Mexican Counsel has been notified and is working with us in trying to get the body identified.

### FFA

Five Brackettville FFA members traveled to San Antonio to attend the 60th annual Texas Future Farmers of America convention.
