


T. D. H. DIRECTOR OF RADIATION CONTROL VISITS BRACKETT





Parents who "buckle up" themselves and their children could save much more than a price discount during back-to-school activities this fall.

Back-to-school means new tennis shoes and notebooks and more cars on the road. Driving through mounting bottlenecks and snarled traffic with the number of vehicle exceeding holiday loads requires every precaution. "Buckling up before driving to the next shopping center or sale can be a major defense against being injured or killed," said Carla Baker, statewide coordinator for the Safe Riders Program at the Texas Department of Health.

The proper use of child safety seats is especially important during this potentially dangerous driving time. "Most accidents happen close to home in town, during peak traffic," said Baker.

Although use of child safety restraints has increased slightly sine last year, the 1988 figures are still below 1986, according to the latest Texas Transportation Institute survey. After reaching a peak of nearly 60 percent in 1986, the rate of compliance with the state's 1984 child safety seat law declined to 49.9 percent in 1987 and has risen to 51.9 percent for 1988.

"Many parents see that their children have new clothes and books but then neglect them when they ride in a car or truck," said Baker. "School-age children should be buckled up securely even if the destination is a shoe store only three blocks away. And little brother and sisters--state law requires all children under 2 to ride in a safety seat. Because young children are more apt to be seriously injured in an accident, it's best for them to ride in a safety seat until age 4," Baker said.

A growing list of statistics continues to prove the wisdom of older children and adults using safety belts. Almost four out of five occupants who escaped serious injury in accidents on Texas roads in 1987 wre wearing seat belts, according to the Texas Department of Public Safety. There were three times more fatalities in accidents where occupants did not wear safety belts.





Bear grass grows in New Mexico, parts of Arizona and in West Texas, near Midland.

In the last few years the harvesting of bear grass is a strong economic activity. Bear grass makes better brooms than broom corn, mainly because of the lower expense. It is harvested in the United States, shipped to Mexico, and shipped to market in the United States.

The bear grass plant is a hardy one and if harvested right will continue to grow. "Palmilla" is the Spanish name of this plant, which is often mistaken for yucca or agave, when in fact is is a member of the lily family.

The leaves are cut with battery powered clippers, sorted and tied together into bundles. When the bundles arrive in Mexico, they are shredded, pounded, cut and baled and shipped to broom factories in the United States.

When the Apache roamed the southwest they used this plant to make baskets and covered their wicki-ups with bundles of bear grass.

In Arizona, the Papagos still use bear grass to make baskets. It was also eaten when fresh and tender.

In the late spring, cattle and wildlife eat the flowering stalks, and will also eat the tough leaves when nothing else is available. When flower stalks produce seeds in May & June, harvesting is stipped. In three months a harvested plant can fully recovery.

Up till just recently the broom industry was made only out of broomweed. Since the emerging of bear grass as an ingredient in the making of brooms, the plant has come into its own.

Mexico was quick to see the possibility of a new market, and since the plant can be harvested over and over, the expense is very nominal.

Experts believe that by continually harvesting of the plant will upgrade the quality.

United States Forest Land is part of the harvest. All leaves green or dead are cut, the useable ones shipped to market and the unsuitable ones are scattered as a layer to hold moisture and make way for the growth of new plants.

At least 10 percent of the plants are not harvested for grazing and other reasons.

The Forest Service pulls a harrow along service roads to scatter the seeds when the plants flower in May & June.

So next time you sweep your kitchen, stop and think about the lowly bear grass that is used to make your broom.

We are waiting there to bring them back home. Sometimes this involves the patient having to spend the night in Houston, in which case the parent and child is put up in a Motel Room. There is never a charge of any kind to the parent or the child from the time they leave their home until they have returned. transportation, food and lodging costs are paid by the Fort Clark Shrine Club or the Alzafar Shrine Temple.

The next time you see shriners in a parade in their various types of vehicles or clown uniforms, don't say look at those silly old men in their funny red hats making a fool of themselves. Even though we are, and having fun doing it. Say a little prayer that if there is a crippled child there in need of help that the parent or guardian will see our float advertising FREE HELP and will contact a shriner, or call toll free 1-800-237-5055. KINNEY COUNTY INDIGENT HEALTH CARE

Kinney County is an active participant in the Texas Indigent Health Care Program that was established under the Indigent Health Care Act of 1986. Under the program any individual or families that qualify receive aid for medical care.

The applications for Indigent Health Care in Kinney County are available through the Kinney County Attorney's Office in the Kinney County Courthouse, Brackettville, Texas. Any documentation and verification information is retained with the application and is not available to the general public for its use. Verification may be done by the County without the direct knowledge of the applicant.

Approved applicants will have their cases reviewed every six (6) months. documentation and verification is done The documentation that the that time. applicant may be asked to provide may be any of the following: automobile registration; checking account record; Civil Service retirement check; federal income tax return; identification; mail addressed to you or another member of your household; military allotment checks; notice of assistance benefit or check; paycheck or paycheck stubs; pension award letter or check; private retirement check; proof of date of birth; property tax notice or receipt; railroad retirement award letter or check; savings passbook; account self-employment bookkeeping; sales and expenditure records; Social Security award letter or check; Social Security number(s) for household members; statement from boarder, roomer or renter; Texas Driver's License or other official identification; unemployment compensation award letter or check; Administration award letter or check; voter's registration card; Worker's Compensation award letter or check. If the applicant refuses to provide information that is requested the application is denied. The County has fourteen (14) days to review

The program is open to all Kinney County residents. Residents of other counties within the State of Texas must apply with their particular county. Persons who intentionally misrepresent information to receive benefits they are not entitled to receive are responsible for reimbursing the county for the cost of benefits they were ineligible to receive, and may be subject to prosecution under the Texas Penal Code.

SHERIFF'S CORNER

In 1982, shortly after I first became Sheriff, I started this column as a means with which to keep the citizens and taxpayers of Kinney County informed of the primary activities of the Sheriff's Department, local law enforcement problems, and other items of interest and concern affecting our community and county. And, with only a few exceptions, this column has appeared in this paper every week for the past six years.

Sometimes the information contained in this column does not please some people and they take offense, sometimes disputing the facts presented here. I have never asked the readers of this column to take my word blindly on the information, facts and figures printed in the Sheriff's Corner. In fact, I invite people to find out for themselves. Check it out, every item presented for your information in this column is backed up by documented facts.

As with every election year, candidates for various offices and their supporters start making claims that they can do a better job running the particular office than the other fellow. Quite often information to back up their claims is either distorted or, in some cases, downright false. I have always attempted to keep the Sheriff's Corner free of politics and use it as a medium to present known documented information to the citizens and taxpayers of Kinney County. You have a right to know the TRUTH! There may be some who will think that this week's column is slightly political, but it is in reality a presentation of true documented facts concerning the operation of the Sheriff's Department and County Jail to counter false and misleading information being presented to the citizens, taxpayers, and voters of Kinney County by a special interest group searching desparately for a way to discredit me as Sheriff in order to gain support for their cause.

Therefore, I have presented below a re-cap of the Cash Receipts and Disbursements for the past fiscal years for our TOTAL county law enforcement operational costs. These facts and figures were taken directly from the annual auditors report submitted to Kinney County by the firm of Coleman, Schuler, and Elley, 601 Cantu Road. (Box 420098), Del Rio, Tx. 78842. Mr. Bill Schuler is the auditor who handles the auditing for Kinney County. His phone number is 775-9538.

The income figures shown are from the federal prisoner program only, no other income such as Sheriff's fees, fines, etc. are included. The operational expenses shown are for the total operational costs of law enforcement in Kinney County including salaries, auto travel and maintenance, jail operations, etc. I have excluded the Constable's salary from this total as I do not feel it should be charged against the operational costs of the Sheriff's Department & County Jail. The four fiscal years shown are for FY83-83,Fy 84-85, Fy 85-86 and FY 86-87. FY 87-88 figures are not shown as this fiscal year is not over yet and a final audit has not been made. As you will see, the income generated by the federal prisoner program has allowed us to operate our TOTAL law enforcement operation for a total cost to the county for the past four fiscal years of \$106,787.36 or \$26,696.84 per fiscal year. Without the federal prisoner program implemented and maintained by me, it would have cost the county taxpayers at least \$125,000.00 per fiscal year or a total of \$500,000.00 for the past four fiscal years. CHECK IT OUT! These are documented facts, not political, coffee shop rumors!

Average annual cost to county for total Sheriff's Department and County Jail operations: \$26,696.84 per year for four years. As I said before, without the federal prisoner program the average cost to the county per year for the same operations would be AT LEAST \$125,000.00 per year. Therefore by having the federal prisoner program (which is at the descretion of the Sheriff) we have saved the county taxpayer approx. \$100,000.00 a year for the past four years. Check the records for the financial condition of the County immediately prior to and during 1982. You will find that the county was deep in debt and on several occasions county employees had to wait on their paychecks until the county could borrow the money to pay them with. That is no longer a factor and in fact, the county has thousands of dollars in surplus.

Just for your information, I have also included a re-cap of the cost of feeding prisoners at the county jail for the past three fiscal years and this fiscal year thrugh July.



BANK FRANCHISE TAX ALLOCATIONS

AUSTIN, TX.-- State Comptroller Bob Bullock on Tuesday, August 23, 1988, set checks totaling \$51.2 million in bank franchise tax allocations to 2,070 Texas taxing units.

This year's allocation is 21 percent lower than last year's allocation of \$64.9 million because of last year's poor economy, according to Bullock.

"Although most state industries have seen an economic upturn, banking and finance haven't shown signs of recovery yet. Tax revenues from these industries won't improve until the businesses stabilize," Bullock said.

Bullock said the allocations represent franchise taxes paid by banks that do business in Texas. Banks must file a report with the Comptroller's Office by March 15 each year.

The bank franchise tax rate is the same as the state's corporate franchise tax rate -- \$6.70 per \$1000 of taxable capital and surplus, with a minimum tax of \$150, according to Bullock.

The Texas Legislature authorized the bank franchise tax in 1984, and the tax was collected for the first time in 1985.

Bullock said that a portion of the tax goes into the state's general revenue fund, but most of it is allocated to local tax jurisdictions, such as cities, counties, and other local taxing units such as school, water, and hospital districts.

Dear Editor,

I am deeply disappointed in the Kinney County Chamber of Commerce for their underinformed endorsement of the proposed disposal site for radioactive NORM materials in Kinney County. Their letter in the August 18th issue of The Cavalryman cited as the reasons for their recommendation a slide presentation provided by the corporation making the proposal and the promise of 25 fulltime jobs at the site.

Realizing that the unanimous approval of this project by the Chamber could impact favorably on the opinions of area citizens, the Chamber members should have assumed the inferred responsibility of a more serious investigation. It is pitifully obvious that a slide presentation prepared and offered by the factions who will profit from the operation of the facility would present only those points favorable to their position. Before publishing their approval of this project, the Chamber should have reviewed information from other sources presenting opposing viewpoints. Additionally, an intelligent body of people would insist upon examining data covering such issues as the precise nature of the waste materials involved, scientific information regarding the hazards presented by those materials statistics dealing with the economic and health effects of disposal sites on communities where they currently exist, and the exact nature of the jobs that would be created by this project.

The Chamber indicated in their letter that the 25 new jobs made available by the construction of the site would be attractive to our young people, who have little incentive to remain in Kinney County as working adults. It would be naive to believe that these projected new jobs would each be filled by local residents, most particularly by young people without prior experience or the appropriate educational background in this industry. Corporations traditionally fill new installations with their existing staff in order to eliminate potential errors caused by inexperience and to safeguard company policies.

As recognized community leaders, our Chamber of Commerce has a moral obligation to make a much more intelligent investigation of all relevant facts before issuing a blanket endorsement of an issue that is as "hot", both politically and radioactively, as a disposal site for radioactive waste materials in our community.




