FANS RESTRAINT REQUESTED

The Brackett Independent School District Board of Trustees responded to a complaint by Booster Club President Manuel Pena regarding profanity, and derogatory remarks directed toward student athletes, coaches, and officials by asking school officials to visit with persistant offenders and urge them to exhibit the same good sportsmanship in the stands that the coaches encourage on the field.

Crowd control at contests is the responsibility of the host school that fails to protect officials, coaches, and players from excessive abuse. School officials are empowered to have uncooperative individuals removed from the school property and banned from further attendance at athletic events. Bob McCall, Superintendent of Brackett Independent School District, stated that the situation is 100% better than last year. "Personally, I don't like to hear student

athletes encouraged to take 'cheap shots', or hear individual students demeaned from the stands because of mistakes made on the field or court. Coaches and officials expect to get some abuse," McCall stated, "but coaches wives really shouldn't have to be subjected to disparaging remarks and student/athletes certainly should not have to listen to remarks about their abilities. Profanity has no place at any school event."

It is difficult to draw the line between what is appropriate and what is not. If everyone would remember that each student and coach on the field has a family in the stands, and then make an effort not to say anything that would be offensive, the problem would solve itself. With the type of poor sportsmanship by players and fans that we see everyday on T.V., it is difficult not to model that behavior. Pro and college athletes and fans are not good role models for athletes or fans at the high school level.



EFFECTS ON AIR QUALITY

Uranium mill tailings are notorious for their emissions of cancer-causing radon gas. The Nuclear Regulatory Commission declared in 1980 that uranium mill tailings constitute the single largest source of routine radiation emissions from the entire nuclear fuel cycle (Federal Register, 1980,65523). In 1978 the Los Alamos National Laboratory wrote that the only way to contain radon emissions from the piles is to cover them with 12 feet of clay -- but even then, the emission levels would be 300% above background levels. Los Alamos--not a rabid environmental group, but a central part of the nuclear establishment--suggested that the only real way of protecting public health would be to evacuate areas around uranium mill tailings piles and zone the areas as unfit for human habitation (Los Alamos Scientific Laboratory, 1978.)

Those reputable studies suggest ominous consequences for South Texas as the uncovered uranium mill tailings piles continue to grow in size in several locations. The Department of Energy (DOE) Susquenhanna study has already documented radon and gamma emissions from the abandoned Susquehanna mill tailings (U.S. Department of Energy, 1987, pp.66-67, 94-97). It has been ten years since DOE was required to cover the piles, and they have still not begun the on-site work. Discussions with DOE officials indicate that

nationally the Susquehanna site is a low priority for restoration. Perhaps this is partly due to a low level of officially expressed concern to date.**



You ever notice how politics and election campaigns seem to bring out the worst in some people? They seem to get caught up in a vicious frenzy similar to the feeding frenzy of sharks. They start striking out in all directions with no regard to right or wrong or the truth, all they are interested in is victory, at any price and by any method. They lose sight of the real issues and become caught up in their desparate vicious frenzy attempting to discredit the opponent. This seems to be particularly true when the candidate is not qualified for the job he or she seeks and his or her supporters cannot present logical, valid reasons why he or she should be elected. Their tactics kinda adds emphasis to the old saying "cream always rises to the top and dregs always float to the bottom".

Many years ago, 1966 to be exact, I was a rookie deputy sheriff in Dallas County, Iexas. I was not a rookie law enforcement officer as I had begun my career in law enforcement as a state game warden in 1963. But after a few nights on patrol in deep East Dallas I realized I was indeed a green rookie when it came to patrol procedures in a metropolitan area such as Dallas County.

I learned more about jail safety and security, the safe handling and transportation of prisoners, law enforcement in general, and patrol procedures in particular in six months with the Dallas County Sheriff's Department than many peace officers learn in a 20 year career. Not because I was smarter than some of those other officers, but because of the sheer volume of law enforcement activity in a densely populated area such as Dallas County.

My patrol seargeant and training officer was a grizzled veteran of 20 years service as a Dallas County Deputy Sheriff. He has seen it all, the good, the bad and the ugly. He had earned his stripes in the mud and blood of a hands on street cop who loved his work. To this day I still benefit from his training. He strongly believed, as I do, that the letter of the law has to be tempered with common sense depending on the circumstances of each individual case. Some of the worst cops I have ever seen were those who believed in enforcing the law by the book with no variance to the right or left. Technically and legally they might be right, morally they were wrong. All GOOD peace officers, prosecutors, and judges are concerned with justice. Therefore those of us in law enforcement who attempt to temper the letter of the law with common sense will sometimes turn our heads at minor infractions of the law as long as there is no danger to the public. A GOOD peace officer can often obtain better results with a friendly warning than with a citation to court, especially when dealing with our young people.

During the many years that have come and gone since I was a rookie deputy sheriff in Dallas County I have been exposed to the good, the bad and the ugly side of human behavior on a daily basis while serving the public as a law enforcement officer. I have seen good peace officers destroy their carrers, their marriages, and in some cases their lives by the abuse of alcohol and the use of drugs. I have lost a close personal friend or two to drug abuse, watching them slowly destroy themelves with hard drugs, becoming zombies dependant on their daily fixes, refusing all assistance offered by friends and slowly losing all self-respect, begging, borrowing, and stealing from friends and strangers to feed their habits. I have on many occasions had to handle young people, including teenagers and in some cases preteens, strung out on drugs. It sickens the soul to see what alcohol and drug abuse can do to the body and mind of an otherwise productive citizen. Anyone who knows me, both peace officers and citizens, knows that I would never turn my head to alcohol abuse or the use of drugs, never in a million

During this past summer we received several reports that local teenagers were having beer parties and smoking dope. We worked several raids on beer parties attended by local people, some of them under age for alcohol consumption and/or possession. We detained several of those young people and called their parents to come pick them up at the county jail. We confiscated several cases of beer and a few bottles of wine coolers. Not one case involved hard Tiquor, and not one case involved drugs of any kind. We issued warning citations and attached them to letters mailed to the parents to make them aware of the dangers involved. WE HAD NO REPEAT OFFENDERS! Did we make our point and get the job done? I think so and so do the parents and kids involved.

There have been 3 or 4 drug busts in Kinney County over the past year or so, all involved drug dealers or users passing through the County enroute to other destinations. I am currently a member of the Steering Committee of the Tri-County Drug Enforcement Task Force consisting of Val Verde, Edwards, and Kinney Counties. We have compiled all available information on suspected drug dealers and users in our respective counties and meet once a month to update information and evidence. We have a roving undercover agent who works the 3 counties and I am pleased to report that he indicates that Kinney County does NOT currently have a major drug problem. There is some indication of "social use" of drugs by a few, but NO indication of major drug abuse or drug dealing in our county. We are compiling information and evidence on suspected drug users in our county as it becomes available, but this has to be done with correct and proper documentation and procedures. The fact that we only had 1 rape and 2 aggravated assaults in Kinney County during 1987 indicates a very low level of that type crime, the fact that we had a low

level of drug arrests in our county and none on locals indicates a very low level of drug activity in Kinney County. Any PROFESSIONAL law enforcement officer knows that

I took my stand on drug dealers and drug users in 1981-82 at the risk of my own life, I still remember 1982! Do you?

REFLECTIONS

Have you made plans for your funeral? Not a bad idea. The Word of God says that no one should brag about what he will do tomorrow because no person really knows what will happen in the future. Furthermore the Bible declares: "It is appointed unto man once to die." Death is inevitable. Each of us should therefore make preparations so that we may die sensibly. How?

Get your personal documents in order. Your family will be spared weeks of anguish and turmoil in arranging papers, if you will take a little time and get these matters updated. All legal documents such as insurance, wills bonds and stocks should be easily located and clearly understood. A lawyer and funeral director will be good friends to help in these arrangements.

What about your burial? If your partner or children discuss the general features of the funeral before that time arrives, major problems can be avoided. Where will the funeral service and burial take place? Where will the remaining family members live?

What about the future of the children?

A patient was being visited by me in a hospital one day. That individual said: "Pastor, if you are called upon for my funeral, please know that all preparations have been made - it will only be a transitional step to heaven." Those were good words to hear. Spiritual preparation for death must also be made in advance. Are you ready to die?

ORDINANCE # 259

AN ORDINANCE TO ESTABLISH FEES FOR THE DISPOSAL OF TIRES AND BULK METALS SUCH AS REFRIGERATORS, WATER HEATERS, STOVES AND ETC. AT THE CITY LANDFILL.

WHEREAS, a fee for disposing of tires will be \$1.50 per tire thru size 720. Sizes larger than 720 wil be \$2.75 per tire.

WHEREAS, a fee for disposing of appliance will be \$3.00 per appliance.

WHEREAS, a fee for disposing of scrap tin/metal or wire will be \$2.00 per pickup load.

WHEREAS, the City Council of the City of Brackettville has established and set fees for disposing of items listed above; THEREFORE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRACKETTVILLE THAT:

The fees for disposing of items listed here within this ordinance will be effective October 10, 1988.

AN ORDINANCE RELEASING THOSE PORTIONS OF HOLMES ALLEY ABUTTING LOTS, 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, AND 14, BLOCK 85, BRACKETT ADDITION TO THE CITY OF BRACKETTVILLE, KINNEY COUNTY, TEXAS, TO THE ADJACENT PROPERTY OWNERS.

WHEREAS, the dedicated right-of-way for HOLMES ALLEY abutting those lots described in the caption hereof is from 55.50 feet in width; and





Wild horses are the most interesting creatures, in many ways in the Southwest. Originally wild horses appeared in Louisana, Texas and Mexico and by 1850 had spread into New Mexico, Arizona, California, Colorado, Oregon and even into Canada. Captain Zebulon Pike, the explorer, wrote of seeing many thousand wild horses as he traveled in the year 1806.

Today wild horses are called a pest, but it is sad about this, they belong in the picture of the great Southwest.

During the Baer War, the British Army bought many wild horses in America and shipped them to Africa for Cavalry mounts, although many of them died on the way there.

Later, many were killed and processed into soap, fertilizer, dog food, glue and chicken feed. In spite of all this there are still wild horses in the West and Southwest.

These horses are not native American. Many thousands of years ago there was an eleven inch tall specie called the Eolippus, another horse the size of todays horse also lived here in ancient times. But by Christopher Columbus' time horses were again in the Southwest.

Our modern wild mustangs come from tame horses that were brought from Spain by early explorers in the Southwest. The very first horses were brought to Mexico in 1519 by Fernando Cortez, a famous Spanish military explorer.

In his ships were eleven stallions and five mares. Then a Spaniard, Hernandez de Soto, who discovered the Mississippi in 1540 brought a few European horses, and started West. Some of these horses managed to escape and wandered away. They became wild and their colts grew up to be even wilder.

At first, the Indians of that period were afraid of the wild horses but soon made herds of the wild horses as we still see. Soon the wild mustangs were as important to the Indians as the steam engine to the white man.


The word mustang probably came from the Spanish word "mesteno" meaning strayed or wild.

Sometimes mustangs are called broncos, slick ears, slicks or mavericks, meaning that they have not been ridden or earmarked or branded. A true bronco is any mustang that goes against mans effort to tame him. The

The Immunization Practices Advisory Committee (ACIP) lists persons with cardipulmonary or metabolic disorders (diabetes) among the highest priortiy target groups for annual influenza immunizations.

The trivalent influenza vaccine for the 1988-89 season is A/Taiwan, A/Sichuan, and B/Victoria. The ideal time to receive your vaccine is on or before four weeks prior to the onset of influenza season.

Tetanus-diptheria vaccine is recommended as a booster dose every ten years for all adults who have completed a primary series.



DIPHTHERIA FORGOTTEN. BUT NOT GONE

The Td immunization for tetanus also protects against another deadly disease - diphtheria. Years ago, diphtheria deaths were part of everyday life. Today, reports of diphtheria are rare, but this disease still exists as a serious threat to the unimmunized. One out of every 10 people who get diphtheria die from it.

Diphtheria is passed from person to person through "droplet infection" or by breathing in the diphtheria bacteria after an infected person has coughed, sneezed or even laughed. It can also be spread by handling used tissue



or drinking from a glass used by an infected person.

Diphtheria in its early stages may be mistaken for a severe sore throat. Death from diphtheria occurs when a gray coating forms in the throat and across the windpipe causing suffocation. Death may also occur from heart failure caused by the toxins or poisons produced by the bacteria.

For adults, diphtheria is easily prevented with a Td shot - a combination vaccine that protects against both tetanus and diphtheria. Many adults received their first diphtheria immunization in childhood as DTP vaccine, but they still need booster doses of Td vaccine.

Do you remember the Bexar County diphtheria outbreak of 1971? We had 102 cases and three deaths.

You may receive your Td vaccine at the Adult Wellness Clinic in Brackettville, October 25, 1988, from 9:00 a.m. to 4:00 p.m.

TETANUS -- A 50-50 CHANCE AT LIFE

Tetanus, or lockjaw, is a dangerous disease which gives unimmunized older persons only a 50 percent chance of surviving it, even with the best medical care. Everyone, regardless of age, needs to be vaccinated, since everyone is susceptible without it.

Tetanus occurs when soil contaminated with the tetanus bacteria gets into any break in the skin. Small scratches, burns and slivers that often go unnoticed can cause this disease as well as deep puncture wounds. Early signs of illness are stiffness in the face and neck, progressing to stiffness in the jaw (hence the common name, lockjaw), back and abdomen.

Tetanus is easily prevented with a Td shot - a combination vaccine that protects against both tetanus and diphtheria. Persons who have never received tetanus vaccine, or are unsure if they have, should start with the three shot series as soon as possible. The second shot is given about two months after the first and the third shot is given about six months to one year after the second. Many adults received tetanus immunization in childhood as DTP vaccine. After completing the initial three shot series, a booster shot is required only every ten years throughout life. A simple way to remember the booster is to receive it on your mid-decade birthday - ages 15, 25, 35, etc. (The Td immunization sometimes may be given after only 5 years if you receive a serious wound prior to the date of your next booster.)

You may receive your Td protection by seeing your private physician or attending the Adult Wellness Clinic in Brackettville, October 25, 1988, from 9:00 a.m. until 4:00 p.m.
