

## BUSTAMANTE VISITS BRACKETTVILLE

#### BUSTAMANTE MEETS WITH "CARE"

Approximately 100 people met at the Parish Hall of St. Mary Magdalen Catholic Church to greet Congressman Albert Bustamante to ask his advice and help to resist the toxic and radioactive waste sites from entering Kinney County and nearby areas.

Bret Trant, President of Care, related that CARE was organized to stop the construction of the proposed NORM (Natural Occurring Radioactive Material) waste site in Kinney County for many reasons and that approximately 1200 signatures have been collected by petition with many petitions still out.

CARE representative, Madge Belcher Keys explains that the proposed site is 1/2 mile from Spofford and that the two principal companies involved are Texcor, now located in Brackettville and BFI (Browning-Ferris Industries). One of the primary concerns for CARE is that Texcor has never constructed nor operated a site of any kind much less one with dangerous materials. Ms. Keys goes on to state that BFI has a track record, but not a very good one; that they have had many anti-trust violations in the last few years and that CARE is concerned about the violations that have taken place by BFI or their subsidiaries. She continues to inform Congressman Bustamante that there is only one other NORM site in the US and then provides the dimensions of the proposed site with the precautions that should be taken.


# COMMUNITY THEATER PLAYS COURTROOM DRAMA







In the Southwest in the late 1600's, the merging of the Pueblo and Navajo Indians produced the chief blanket.

The Navajo's had no chiefs in their tribal system, so evidently other tribes that traded with the Navajos kept back these unusual blankets for their chiefs.

Warmness was a factor but the chief blanket when wrapped around the body flowed with the movement of the wearer. It was usually draped over the shoulders and pulled together in front, forming a design in front and back.

The earliest chief blanket on record was found in a Navajo grave dating to 1775.

The first blankets were mostly brown and white stripes. Some of the colors have been traced to old unraveled army uniforms, but native vegetable dyes followed quickly due to a brief supply.

Weaving was sacred to the Navajo and religious ceremonies were centered around it.

Chief blankets began with garments designed for women, made in the shape of shawls or dresses in narrow stripes of brown and white. The blankets were woven in the shape of a rectangle, crosswise instead of longwise, with the worp threads parallel to the short side. In the middle were woven narrow stripes of indigo, which probably came from the Pueblo Indians. Mexican indigo was brought by mule train to the villages of the upper Rio Grande.

Red color was made from a ground powder from the cochineal beetle from Mexico. In womens blankets there were usually wide bands on both sides and in the middle. Men's blankets began to be made with black patterns also

When the art was adapted by the Navajo from the Pueblos, the Navajo women became the principal weavers. This was due to the fact that the Navajo men preferred to live a life of hunting and battle.

Every Navajo little girl expected to know how to weave. But about 1900 every Navajo women was not required to be a weaver.

Chief blankets are still made but rarely. The chief blankets still in existence are very rare and still highly prized and certainly not used as rugs to walk upon.

#### REFLECTIONS

All of us have seen and heard wild geese as they fly overhead. They grab our attention as they "squak and talk" to one another.

The long-distance wild geese fly in a V fromation. Maybe that's the easiest letter in the alphabet for them to learn!

While in flight the goose that leads the flock frequently "hands the Baton" to one behind him and lets that one take the lead

for a time.

It's a known fact that the bird in front creates a wind break or vacuum for the others behind. Hence, the flock of geese are able to fly nearly 75 percent further as they go together because of the wind movement that each one makes.

Cooperation makes a big difference in life for us, too. Our town can learn the worth of cooperation. Homes can learn this lesson. Schools get along much better when harmonious relations are practiced. Churches function better through cooperation and the national government would, too.

Yes, the Canadian geese set a noteworthy, "high" example for me and for you. Even some of us "old buzzards" could learn a few good lessons from the graceful, high-flying birds.

#### BUSTMANTE

Congressman Bustamante intercedes with questions as to whether an application has been made yet?, whether the Health Department or State Water Resource has been in? He continues to query whether Kinney County's State Representative or Senator has been spoken to yet and what are they doing? A reply from the audience is that they are working on it, they're talking about legislation.

Congressman Bustamante explains that the way to proceed at this time is to get your information from your agencies that control these areas for licensing purposes. He states, "I'll work with you, I'll write letters to the Texas Department of Health and Texas Water Commission. I can get the EPA to give me some reports that will be useful to you as you move forward against this". The budget of these agencies is controlled by your State Representative and State Senator and they ought to be at the very far front in getting you this information, just as you have local authorities, Mayor, County Commissioners and should let them be ombudsmen at this end, he explains.

One of the committees in Bustamante's office is energy and the environment and they have been hearing a lot of news throughout the country of toxic waste. The armed services committee deals with nuclear reactors and what it's going to cost to clean up all these sites. Congressman Bustamante reports, "We've been looking at all of it, because the environment will be the #1 issue in the next Congress. All of us are . concerned NOW about the environment." He again states that he understands Cares concern and that he will work with them, starting by getting the EPA to give him a report so that the President of Care can have it at his disposal. He concludes with "Brackettville is one of my favorite places to visit." He's answered with "It is our favorite place to LIVE. (SJH)

#### CARE FOR THE FUTURE

At a Saturday, Nov. 5, meeting of the Texas Board of Health, held at San Antonio, CARE representative Madge Belcher Keys spoke for the sizable CARE delegation in attendance. Ms. Keys conveyed to the board the overwhelming adverse attitude in Kinney County, and in the entire region, toward the propose Texcor NORM/NARM site at Spofford. She explained the hazards to public health which may be expected when radioactive materials are introduced into a populated area. She also described the resulting economic damage, including devaluation of real estate and losses in the hunting, tourist, ranching, and retirement living industries. Board members expressed appreciation for the CARE presentation, and were impressed by the size of the delegation.

A story by medical reporter Don Finley, in the San Antonio Express-News on Sunday Nov. 6, covered the Board proceedings. The Texas Board of Health serves as a panel of health professionals to advise and guide the Texas State Department of Health.

#### STATE COMPTROLLER

AUSTIN--State Comptroller Bob Bullock on Friday sent checks totaling \$10.6 million to 221 counties and 438 cities that tax mixed drink sales.

The checks represent the counties' and cities' share of the state's 12 percent mixed drink tax collected during the third quarter of 1988.

Texas cities and counties each receive a 12.5 percent share of the tax collected on mixed drinks sold within their boundaries under the law that legalized the sale of mixed drinks in the state.

Of the total \$43.9 million in state collections, counties received more thatn \$5.4 million, slightly up from the amount received in the third quarter of 1987. Cities received more than \$5.1 1million, up from the \$5 million received last year during the third quarter. The \$33.3 million balance was deposited into the state's general revenue fund. \$33 million were deposited in the third quarter of 1987. Kinney County received a \$1,548.18 remittance.

The mixed drink tax is collected by the Alcoholic Beverage Commission. City and county rebates are sent out quarterly by Bullock's office.

The school district is responsible for children from the time they board the bus in the morning, until they disembark at the regular stop in the evening. Parent's do need to make arrangements for meeting their young children and for safe trips to the bus stop in the morning.



Louisiana 1987---The Department of Justice announces action on an EPA complaint, filing charges against BFI for 2800 violations at its Livingston toxic dump.


Baltimore, MD---BFI Solley Road dump is shut down after being cited nine times in five months for mishandling waste.

# LIBRARY IN DANGER OF LOSING STATE FUNDS

Increased funding from Kinney County is absolutely essential if the Kinnney County Public Library is to properly serve the needs of our growing community according to Mr. Tony Ramon, President of the Kinney County Library Advisory Board. Mr. Ramon is urging all Kinney County residents to help the library at Commissioner's Court on Monday, November 14, 1988 at 9:00 a.m. at the Kinney County Courthouse.

The operating budget of the Kinney County Public Library is derived from two sources: Kinney County and the San Antonio Area Library System (SAALS), an agency which allocates the state money. Funding received from SAALS is dependent on the level of financial commitment from Kinney County. An increase in County funds would result in continued State support.

SAALS provides Collection Development funds to our library according to the total amount of local tax-based dollars spent on library books and materials. The following breakdown of the proposed budget for 1988-89 is:

Budget adopted by Kinney County \$25,000.

Fixed expenses (salary & fringe benefits) Utilities Other

\$20,525.47 4,465.00 9.53

\$25,000.00

The proposed budget provides only \$9.53 to cover the cost of all books, materials and supplies that are necessary to operate the library. The state funding of 10% would be determined from the \$9.53 if it were spent to buy a book.

A recent evaluation by SAALS urged that the amount of local money spent for books and materials be increased from the current level of 5%. Mr. Ramon and fellow board members ask that local residents attend the Commissioner's Court on November 14, in support of the library. "Saving State funding so that our library will grow with Kinney County is essential," according to Mr. Ramon.

# TEXAS AUTHOR TO BE HONORED

Saturday, November 19, at 2:00 p.m. at the Kinney County Library, residents of Brackettville and of Fort Clark and Kinney County will have an opportunity to meet Roy L. Swift, author of a recently published book in which Brackettville and Fort Clark are

prominently involved. Mr. Swift spent many years and traveled thousands of miles in research, and his book "Three Roads to Chihuahua" is the happy result of his efforts. The author has many friends in Brackettville, and also has relatives in Del Rio.

Mr. Swift's book details the adventures and romance and struggles which resulted from the production of silver at the Mexican mines in Chihuahua, and the trade routes which were explored and used to supply the mines. The last and most used of the "Three Roads" passed through this area, extending from Indianola on the Gulf Coast through San Antonio west thrugh Kinney County, then onward to Presidio and south up the Rio Conchos to Chihuahua.

Because the early development of Fort Clark and of Brackettville was closely involved with the Chihuahua Road, the New World Study Club invites area residents to a reception at which Mr. Swift will tell of the origins of his book, and of the years of effort involved in writing it. The author wil be happy to autograph copies of his book at this event.

Mr. Swift is a fourth generation Texan, who returned to Texas in 1973 after successful career with the Social Security Administration at Baltimore, Md. He has been active in the Texas State Historical Association, the Texas Historical Commission, and the Baptist Church.

The public is invited and urged to come to the library to meet the author and to enjoy this rare opportunity with the members of the New World Study Club.
