

## NEW AUXILIARY AIR FIELD NEAR SPOFFORD FINALIZED



T-37 aircraft with 150 flights, mostly touch and goes, on a busy day," stated Lt. Young.

A question was asked by Sheriff Norman Hooten as to the type of security will be there, 24 hour guard or guards just at night?
"There really isn't anything out there to guard, as far as security goes, it will be fenced off with six foot fences and notices posted that it is an Air Force Installation," Lt. Young answered. "The only thing I was thinking about was we've always got a problem with unattended airfields. Sometimes dope dealers land and dispose of the equipment," Sheriff Hooten stated.

Attorney Shahan asks, "in relation to Sheriff Hootens' question, will there be a locked gate out there?" "There will be a locked gate there and the only people there will be the pilots working the flight patterns and the supervisory units that talk to the aircraft in the patterns or let them know if their landing gear is down."

Laughlin Air Force Base graduates between 300 and 330 pilots a year.

Three guests were at Commissioners Court Monday morning, March 13th. Major Noel Phetteplace, Bill Hagemeier and 1st Lieutenant Mike Young, Public Affairs Officer for Laughlin Air Force Base were here to explain what an auxillary airfield is and how important it is for pilot training.

Basic pilot training is done at Laughlin with pilots just entering the air force service. The basic program is to train them to fly in all sorts of conditions and to be able to fly both left-hand turn patterns as well as right-hand turn patterns while landing and taking off from airfields. Lt. Young explained, "The problem we have in our training aircraft (t-37's) is the pilots sit side by side. The student pilot always sits on the left seat. When they execute a right hand turn it's different than when you execute a left hand turn, sort of like driving a car." Because of this problem, an airfield where pattern training can be conducted is necessary. Laughlin is already busy using three runways with the I-38's (mainstream aircraft, so it's not considered safe or practical to conduct that training there.

Lt. Young reports, "Right now we're operating out of an airfield in Maverick County, but because of some bird strike problems with the meat packing plant there, there is a mutual need for us to move elsewhere."

The land that has been decided to acquire is near Spofford in Kinney County. The purchase of the land was closed last Friday. The next step is the opening of the bids for construction. Construction will probably proceed in about 60 days from the opening of the bids. "We should be operating out of the auxillary field by next spring as it should take approximately 300 days to complete the project," reported Lt.Young.

The airfield will be an uncontrolled airfield with minimal facilities consisting of a fire station and a runway supervisory unit which is a mini-control tower. An uncontrolled field has no radar. "This will be a daytime operation from sun-up to sun-down in




#### PASSION PLAY



#### TRACTS ALONG THE PECOS

On the morning of Nov. 11, 1833 the "Amos Wright," a two masted ship left the New York Harbor, bound for the south with Captain Monroe in command. His passengers were fifty-nine emigrants, men women and children and their belongings, including such equipment as utensils, farm machinery, saw mills, horses, wagons, etc.

Most of the emigrants were Americans, a few English and Germans. All were dedicated to one thing, to establish a settlement in the Texas wilderness. They were members of the Rio Grande and Texas Land Company, under the leadership of Dr. John Charles Beales. Beales had come during the early days of Texas colonization and married Dona Maria Dolores Exeter, widow of another Englishman. Her deceased husband, Richard Exeter, an American, along with his partner Stephen Julian Wilson acquired a land grant from the Mexican State Coahuila and Texas. This grant was 45,000,000 acres and was to be the home of one hundred families.

When Exeter died Beales took his place as partner in the deal. They cut up their grants into blocks. After much planning and resolution problems, Beales finally sent a friend, William Henry Egerton, to look over the part of the tract near the Rio Grande. They finally settled on a stream called Los Moras, eighteen miles above where it met the Rio Grande.

After seeking backers in New York, he came up with such names as Silas Stillwell as President, and Charles Edwards as secretary. On the executive board were James L. Curtis and other men who were interested and put up the money for the establishment of the new settlement. Beales became the general agent in Texas.

Meanwhile, the "Amos Wright" emigrants had landed at Aransas Bay in the pouring rain. They pitched their tents on Copano Beach near present Bayside, Texas. It took five or six days to unload the ship. Finally they began the cold miserable overland trip, going through San Antonio. They traveled by ox carts, and there they bought more wagons and oxen. The caravan of twenty wagons and carts set out for Presidio del Rio Grande.

After Medina Creek the traveling became dusty, and rough, and not much water. When they reached the Nueces, they only had to cross and up to the Beales Grant, and on March 4, they came to the Rio Grande. At last Las Moras Creek was reached and the people started to settle in. Some explored the Las Moras Creek to its head springs and went on to climb Los Moras Mountain to look around the Countryside.

On March 27, 1834, the church cornerstone was laid and celebration of the start of the new town of Dolores was begun.

Beales had named the settlement after his wife. They took an oath of allegiance to Mexico. They set up a sort of a government and court system and went back to partying.


Beales gave each colonist a labor (177 acres) of land and a town lot 60X90. The colonists were not satisfied because it didn't seem enough. Beales thought the Los Moras was too small, the location too remote, and the soil would have to be irrigated.

There was no rain from March until September, but the river was good enough for farming, the trees were oak and pecan and walnut. The oak was too hard for the tools they had. So cutting trees was tabu for everyone. Other differences came up. Beales had gone back for more settlers and left a German named Ludicus in charge. Community labor took lots of their time and they didn't have enough time to take care of their own property. Rations were held up if community work was not done, causing more unrest. Then came the drought, but the settlers held on because Beales had promised to send back food.

A herd boy became lost and wandered around for three days before finding his way back home. Indian signs had been found, showing Comanches were coming closer. One thing followed another and the people began to be more restless and they lost faith with their leaders. Still the money did not come and people loaded their wagons to move to San Fernado. Soon after they left, a band of Lipans came and stole what they wanted, causing more people to leave down to San Fernando.

Beales brought more colonists and food, but they met with the same hardships and some left. Some went to Matamoras to go back to New York, some joined Houstons army in Texas and some returned to Copano. The John Horn family went back with the group wno were bound for Matamoras. They camped on the way by a lake. There they were massacred by Indians. The Comanches captured Mrs. Horn, her two children and a Mrs. Harris, but that's another story.

The Colony's secretary and another man stayed in Dolores, but finally buried the machinery and equipment and went to San Fernado. But there they were arrested as rebels and their property was taken. Because of politics and Texas laws, Beales didn't recover his property marking the end of Dolores, the ill-fated settlement on Los Moras Creek.

# PROTECT YOUR RIGHTS

#### RENDER YOUR PROPERTY



You must file a rendition if you own tangible personal property used to produce income—such as the machinery and equipment used by a business.

The appraisal district may require any taxpayer to file a rendition by sending the taxpayer a written notice and a rendition form.

The advantages of filing a rendition:

 You give your opinion of your property's value. If the appraisal district places a higher value on your property, it must notify you in writing of the higher value and explain how you can protest that value to the appraisal review board.

 You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.

 You can also file a report of decreased value, to notify the appraisal district of significant depreciation to your property in 1988. The district will look at your property before assigning a value in 1989.

The deadline for 1989 renditions is March 31. You can get an extra 30 days if you ask for it in writing before the March 31 deadline.

File renditions with your local appraisal district at the address shown below.

#### BRACKETTVILLE REACTS TO POISIONED FRUIT SCARE

The finding of cyanide poisoning in tested fruit distributed to Philadelphia has had little reaction here in Brackettville.

Super S Grocery Manager, Leroy Sanchez, already had all Chilean fruit off the shelves and thrown out before his headquarters office phoned. Mr. Sanchez stated, "It will hurt sales. The Chilean fruit alone was to occupy 8ft of space for the Easter Week specials. I don't think we need to worry about the poisoning here, but I feel it's better to be safe than sorry."

The U.S. Food and Drug Administration issued the warning against eating the fruit Monday after traces of cyanide were found in two seedless red grapes shipped from the South American country to Philadelphia.

Cyanide was found in grapes that had a ring of crystalline dust around puncture holes. A third grape had the ring, but the cyanide had leaked out.

Tests were ordered after an anonymous threat to poison Chilean fruit was telephoned to the U.S. Embassy in the Chilean capital of Santiago.

Reaction to the scare at Brackett Independent School Cafeteria was nil. Mrs. Kathy Crowder, Cafeteria Manager, reported that she does not have a problem with the Chilean fruit as it very rare that she has it. "Canned apricot 1/2's are used, but not very often," she said. "Right now the only fresh fruit is Texas grown oranges," she continued.

B & S Grocery does not carry Chilean fruit either, so there is no worry for customers to be afraid of purchasing fruit

Mr. Sanchez states, "Fruit lovers can still purchase apples, oranges, grapefruit and canteloupes from the U.S."

A homestead exemption lowers the property taxes on your home by lowering its taxable value. For example, if your home is valued at \$50,000 and you receive a \$5,000 homestead exemption, your home will be taxed as if it is worth only \$45,000.

You qualify for a homestead exemption if you owned your home on January 1 and used it as your primary residence on January 1. It doesn't matter whether your home is a house, a condominium, or a mobile home.

Exemptions are available to all homeowners to lower their school taxes. Additional exemptions are available to homeowners who are disabled or age 65 and over. Other exemptions may be offered to homeowners by school districts, counties, cities, and special districts.

Who should apply? If you received a homestead exemption on your home in 1988, you won't need to re-apply unless your chief appraiser requires it.

If you became 65 or disabled before January 1, file a new application to receive the additional exemptions.

If you haven't received an exemption on your present home, or if you've moved to a new home, make a new application for 1989.

File your homestead exemption with your local appraisal office at the address shown below.

The deadline for applications is May 1, 1989. Contact your appraisal district before then if you need more time to file.

#### TEXAS WEATHER STATIONS TO REMAIN OPEN

Washington--The Commerce Department has shelved a plan to close 9 national weather service stations in Texas and will keep the stations open, US Senator Phil Gramm announced today.

Gramm said the Weather Stations that will remain open are in Abilene, Austin, College Station, Del Rio, Gavelston, Port Arthur, Victoria, Waco and Wichita Falls. No other stations in Texas were initially targeted for closure, he noted.

The Senator said the proposed closings were called for by Federal officials primarily because of a comprehensive modernization program under way at the Commerce Department that will provide improved weather warning system & may ultimately lessen the need for as many regional offices.

"I am pleased with this policy reversal since I believe that no weather stations in Texas should be closed until we have adequate substitute technology that will warn Texas of weather problems," Gramm said.

"We in Texas, more than most other people in the country, are frequently subject to eradicate weather behavior, and we need to be prepared for any weather conditions at all times," he said.

#### **CENTRAL POWER & LIGHT**

The South Texas Project Unit 2 became the second commercial nuclear power reactor in Texas to be put into operation this past weekend. Initial criticality occurred at 9:24 p.m. Sunday, March 12.

"A year ago, Unit 1 made energy history when it achieved the first atomic chain reaction at a commercial nuclear power plant in Texas. With Unit 2 also reaching this milestone, CPL is even closer to realizing our goal of greater fuel diversity,: said Richard Verret, vice president and chief engineering officer of Central Power and Light Co. "STP will lessen our dependence on natural gas for producing electricity and help us maintain stability in our fuel costs."

Verret added that when both units are operational, the low cost of nuclear fuel used at STP is expected to save South Texas electric customers some \$100 million annually in fuel costs. It will also contribute to the nation's energy independence from foreign fuel sources, he said. One thimble-sized pellet of uranium fuel at STP has the energy

equivalent of 157 gallons of regular gasoline.

Unit 2 is scheduled to be operated at just under 5 percent of its 1.25 million kilowatt capacity for about two weeks. After this time, STP officials are expected to apply to the Nuclear Regulatory Commission for a full-power license. Following receipt of the license, there will be a gradual increase of power with additional testing until full-power operation is reached. It is estimated that Unit 2 will reach full power by June.

The initial self-sustaining chain reaction results from the continous splitting or fissioning of uranium atoms. The fission process starts when a neutron strikes an atom, splitting it into smaller particles and releasing other neutrons. These neutrons strike and split other atoms, again releasing neutrons that continue the chain reaction.

As the fuel fissions, it creates heat that is used to convert water in a separate system into steam for generating electricity. The rate of fission, and thus, the amount of heat produced, is controlled by the plant's operators.

Since commercial operation in August 1988, Unit 1 has generated about 3.35 billion kilowatt hours, which is equivalent to 1.71 million tons of coal, or 6.16 million barrels of oil.

STP Units 1 and 2 are among the nuclear units with operating licenses in the United States and are the first in Texas.

CPL, Houston Lighting & Power Co., City Public Service of San Antonio and the City of Austin are co-owners of the plant.


#### **HUMMINGBIRDS** MEAN SPRING
