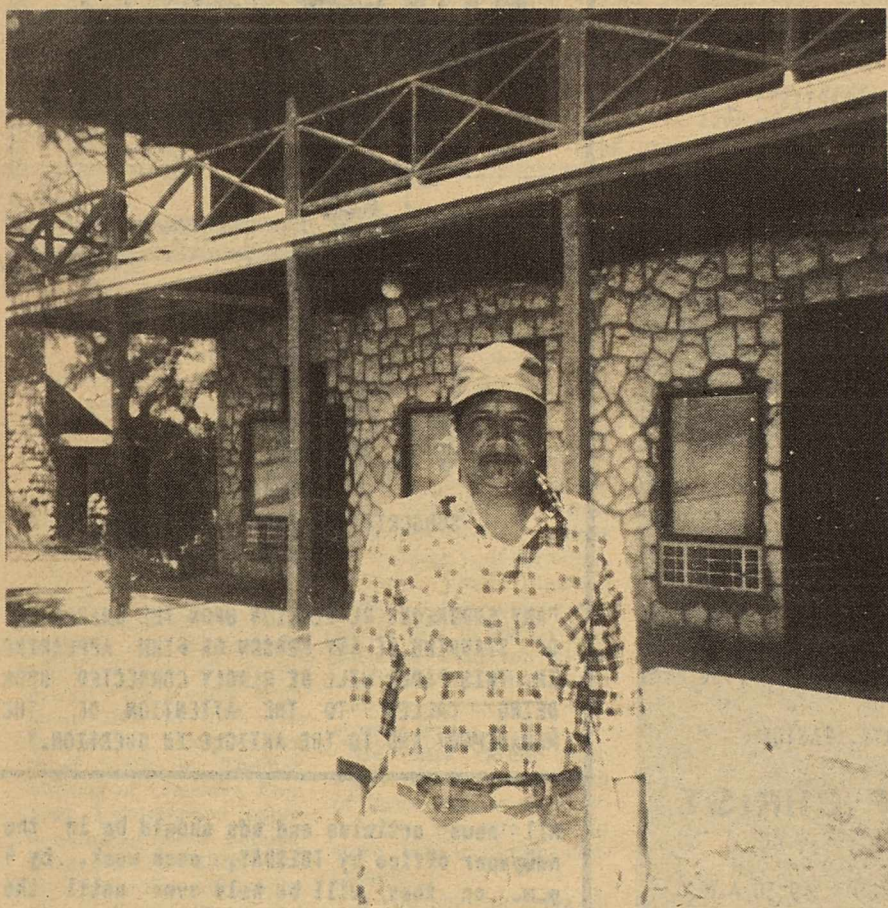

### LOCAL MAN SAVES CHILD'S LIFE

Ramon Falcon of Bizzell Construction Company saved the life of 4 year old Steven Dodge on Tuesday, April 4, when he grabbed the boy as he was about to fall headfirst beneath the wheels of a runaway van.

"To my knowledge, he pulled the car out of gear," Ramon said of the service van Grandfather Larry Dodge uses to stock the motel rooms at Fort Clark Springs. Ramon was working on a window at the newly remodeled Bullis Hall Motel, when he saw the van rolling down the street, across Ft. Clark Road, towards a parked vehicle with young Steven dangling out the door with a slippery grip. "I ran out and pulled him out from between the door and the car," Ramon said. "I grabbed him by the arm, and tried to stop the var." Fellow workers Gilbert Gallegos and Joe Guerra came to the rescue and stopped the runaway van before it smashed the boy or another car.

"He got scared, and tried to crawl out of the car," Dodge said. "He was just about to fall beneath the wheels. Those guys working there saved his life."

Young Steven suffered only a scratch on the back of his leg, and the scare of a lifetime. "He was scared out of his wits!" Dodge said.

### CHAMBER OF COMMERCE

After a discussion about the invited speaker, Astronaut Charles Duke, being a financial backer of TexCor, whether or not he should be allowed to speak (not on TexCor) and about CARE stating that the Chamber of Commerce would have to have CARE's approval of a speaker, the two representatives were asked to leave so the Board could make some kind of decision.

The Chamber Board of Directors, not wanting to be coerced by CARE decided to totally cancel their Chamber of Commerce Banquet (which is one of the main fundraisers for the year.)

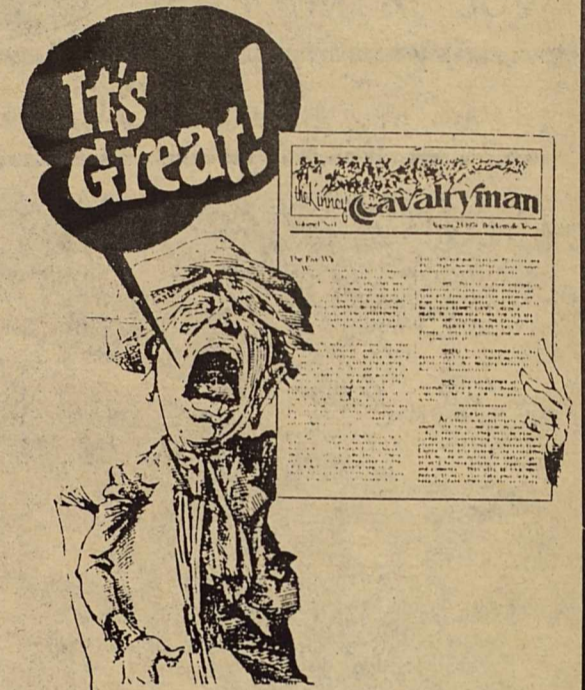

**BEEF STROGANOFF (MICROWAVE)**

| 1 tbs. oil   | 1 tsp dry mustard                    |
| 1 lb boneless beef sirloin<br>steak cut in thin strips | 1 tsp salt                           |
| 8oz fresh mushrooms(sliced)                            | 1/4 tsp pepper                       |
| 1 med. onion (sliced)                                  | 1 cup sour cream                     |
| 1/4 cup water  | 2 cups hot cooked<br>noodles or rice |
| 2 tbl flour  |                                      |

Stir oil and meat in 2 qt. casserole until beef is coated. Cover and microwave on high until meat is no longer pink (4 1/2-5 min.). Remove meat; reserve meat and juices. Add mushrooms and onion to meat juices. Cover and microwave until mushrooms are tender 5-6 minutes. Shake water and flour in tightly covered jar; stir into mushrooms. Sprinkle with dry mustard, salt and pepper. Microwave uncovered to boiling, (30 sec.). Boil until thick, (1 min). Stir in reserved meat, then sour cream. Microwave uncovered until hot about 1 min. Serve over rice or noodles.

**About Antiques**

In the 16th century, books were costly and had to be handled with great care. Marking one's place by folding down a corner of the page was unheard of. Hence the need for bookmarks.

Queen Elizabeth I made her own needlework bookmarks. In Victorian times, handmade bookmarks were popular gifts, many of which were made of embroidered or decorated leather, silk or punched paper. Woven silk bookmarks were popular from about 1850 to 1880. The best known examples are those made by Thomas Stevens of Coventry, England. Lithographed paper bookmarks were popular from 1885 to 1920. The most collectible ones today are by Louis Prang and Company.

Religious verses, literary quotations and flowers have always been mainstays on bookmarks, but between 1880 and 1900 advertising was the fashion. These bookmarks, made of stiff cardboard, were given away to promote such products as ladies' corsets, pianos, foods, and medicines. From 1900 to 1914, insurance companies and publishers used bookmarks for advertising and for patriotic messages.

In the 1870s, when celluloid was developed as a substitute for ivory, celluloid bookmarks became popular. They could be cut into special shapes and printed with colorful decorations. More expensive bookmarks were made of thin copper, chrome or silver.

**Ms. Fix

As the weather gets warmer and you start to sort through your clothes, you may find you need to store your winter clothes.

Before you store your clothes for the summer months, you need to do some preliminary work. First, you should launder or dry clean your garments.

Store your cleaned clothes in a cool place in a sturdy box or plastic bag, garment bags or clean trash can. I find that an old suitcase serves well as a storage spot.

Be extra careful with leather or fur because both of these fabrics need to breathe. Be sure not to store them in airtight containers.

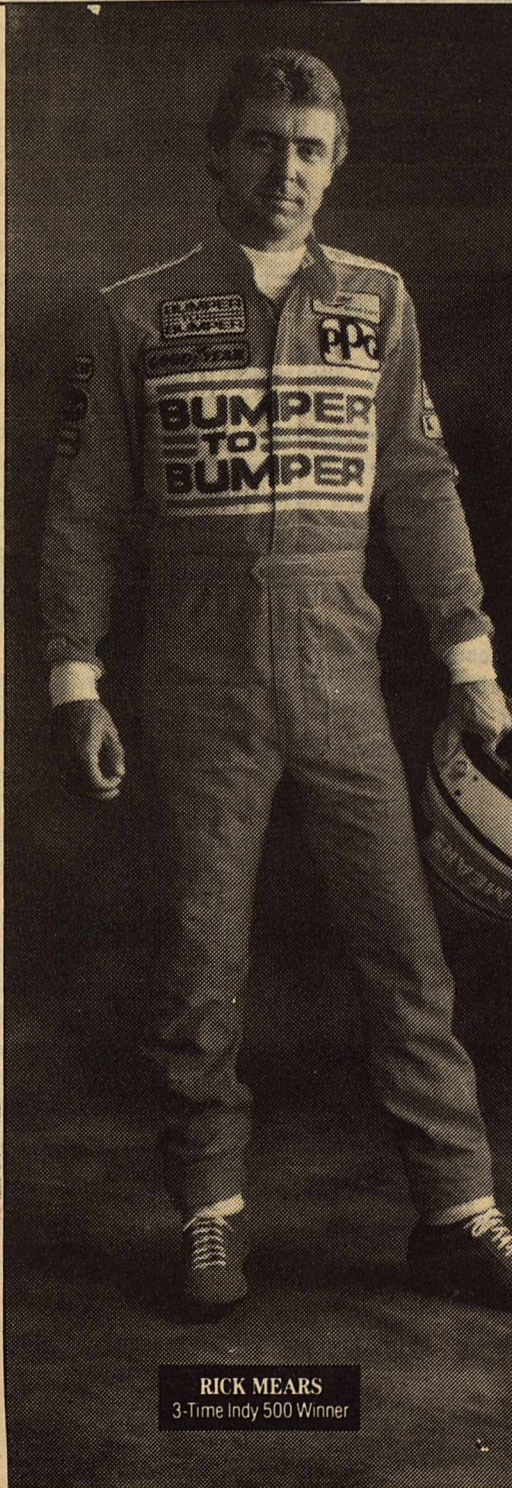
If you plan on using an entire closet or attic as a storage place, be sure to clean the entire area by vacuuming the floor and walls.

To keep moths and other insects away from your garments, sprinkle moth balls or flakes inside the storage containers or the floor of the closet or attic.

Cedar chests or cedar closets are great for storing garments as long as they don't have gaps and openings that will allow moths to get in.

If you are short on storage space, you can take your garments to a dry cleaner you can trust. Be sure to keep track of every item you take to storage.

## CENTRAL POWER & LIGHT

Central Power and Light Company residential customers paid among the lowest electric rates in Texas during 1988, according to the company's recently published annual report.

"CPL had the lowest residential rates of the nine investor-owned utilities in Texas for 1,000 kilowatt-hours of electricity for seven months during 1988," Kevin McMahon, CPL's manager in Del Rio, noted.

The report also highlights major activities for the company during 1988, including the commercial operation of the first unit at the South Texas Project Electric Generating Station, preparing for a rate case, and improving customer service. At the end of the year, the company was serving almost 540,000 customers in 44 South Texas counties.

According to the report, the average annual residential use of electricity by CPL customers increased 5 percent, from 10,369 to 10,925 kilowatt-hours. The rising cost of natural gas, the company's primary generating fuel, caused the price of a kilowatt-hour to increase slightly from 5.90 to 5.97 cents.

The CPL report states that for the fourth quarter of 1988, CPL had a net loss of \$3.3 million, compared to net income of \$42.6 million for the same period in 1987. Net losses in November and December 1988 were the first since the fuel crisis in the early 1970's.

The Public Utility Commission of Texas' delay in issuing a decision regarding an accounting procedure caused the losses, according to the report. However, CPL notes a PUCT order granting the company's request for deferred accounting would allow CPL to recover most of the costs it could not recover during the last months of 1988.

Significant activity was recorded on both STP units during 1988.

"Throughout the year STP achieved one milestone after another, culminating in the commercial operation of Unit 1 in August and fuel loading of Unit 2 in December," said Tom Shockley, CPL president and chief executive officer. "When STP Unit 2 begins commercial operation later this year, STP will place us in an excellent position to defend against future fluctuations in our energy supply." On March 28, 1989, Unit 2 was granted a full-power operating license from the Nuclear Regulatory Commission. It is scheduled to begin commercial operation in June.

Preparing for a rate request to recover its investment in STP was one of the major activities of 1988 for CPL. The case was filed with the PUCT Feb. 15 of this year. As outlined in the report, the company's filing requests a four-step rate relief plan to moderate the impact on customers. If approved, the first step would increase rates approximately 16 percent in 1990. Negotiations between CPL and intervening parties continued throughout 1988 to settle the rate case and other regulatory proceedings related to the company's investment in STP.

Shockley pointed out in the report that a reorganization and early retirement program reduced the company's work force by 11

percent in 1988. The company also implemented new programs that centralized operations, allowing the utility to serve customers more efficiently, he said.

"These efforts translate into savings for our customers," Shockley noted. "Even with the proposed rate increases our rates are expected to remain competitive within the state into the 1990's and beyond."

### MOTHER SEEKS PROTECTION FOR CHILDREN FROM GERALDO AND OTHER TABLOID TALK SHOWS

Lynda Beams, a Fort Worth mother of two, wants to shield children from talk shows that often deal with sexually explicit subject matter. The Geraldo Show and the Oprah Winfrey Show air at 4 to 5 p.m. each weekday. Many children are home from school and unsupervised at that hour.

Beams was spurred into action when flipping through the channels, she caught references to bestiality on Geraldo. She spent several weeks writing letters and formulating petitions which have generated thousands of signatures. The petition asks that airing times be changed to an hour when children are in school or the evening when parents are home.

Beams is rallying support throughout the Metroplex and the state. Resolutions are being adopted and petitions are circulating through PTAs and churches of all denominations. Many mothers, grandmothers and people from all walks of life are cheering her on. She has received letters of encouragement from Mrs. George Bush and Mrs. Dan Quayle.

Beams has studied transcripts and topic lists from the two shows and says these publications are proof of objectionable material. "Geraldo is wading in the waters of verbal softcore pornography," Beams said, "and these waters have risen in the short time that I have been working this project."

Beams cites Gerald's March 22 show titled "Sex Surrogates" in which one guest, a sex therapist, spoke of having sexual intercourse with 350 clients while maintaining a relationship with a boyfriend. Among Geraldo's other topics: 'Satanic Breeders: Babies for Sacrifice', 'Women Who Can't Say "No"', 'What Men Want from Women in Bed', 'Breast Obsession', 'Unlocking the Doors of Great Sex', 'Transsexuals & their Families', 'Male & Female Strippers' and 'Male Prostitutes and Married Men'.

KDFW-TV/Channel 4 Dallas, which airs Geraldo, said that station's position is to run the show at 4 p.m. and include advisories for parents if it contains material unsuitable for young viewers.

"The advisories are a red flag, a come-on to children and are ineffective for absent parents," Beams states. She believes fewer children would watch the shows if the advisories were withdrawn.

The transcript list for Oprah Winfrey indicates lower percentage of topics focused on sex and violence. But a sample of inappropriate topics includes: 'Teacher-Student Affairs', 'Witches', 'Relatives in Love', 'Addicted to Sex', 'Self-Abuse & Mutilation', 'Profiling Prostitutes', 'Sex Slaves', 'Men Who Dress as Women' and 'Wives Who have Affairs'.

"The topics alone are shocking," Beams states, "but only when one reads a transcript or views a show in its entirety is the full impact of the destructive influence realized."

The Texas PTA has supported her efforts and published an article about the cause in the PTA Communicator, a newsletter distributed to 8,000 members across the state.

"It sort of falls under our jurisdiction because we have a position on trying to remove pornography or inappropriate material from children's view," said Sandy Kibby, the State PTA's legislative chairwoman.

"I am not a psychologist," Beams states, "but I do not think it is that difficult to rearrange the mind of an adolescent."

"It is very important that everyone concerned about this vital issue continue this fight to protect our children from the influences of people who have lost sight of the good in this world." She is asking that those concerned contact their PTA and sign the petition.

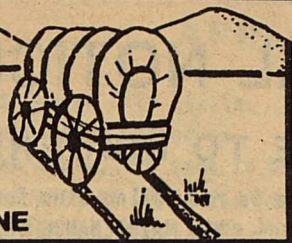

**TRACKS  
ALONG THE  
TRAIL

Persimmons and Opossums always go together. Although "possum" are very common, this is one of the queerest and least known of all our American animals. Very few people know that the twelve or fifteen baby possums born in one litter are so tiny they would not fill one teaspoon. They are less than a half inch long when they are born.

When the babies are born they crawl at once along the underside of their mothers body and there they crawl in a soft, warm, hairy pouch she has there, made of a fold in her skin, like a pocket in an apron. The muscles at the top of the pouch can close like a drawstring. Inside the pouch are twelve to fifteen tiny milk glands ready for the newborn babies. They feed here for six or seven weeks, then move to the top of the mothers back where they cling.

The mother carries them around, teaching them how to live in nature. Sometimes she has a new litter of babies the same time the first litter is riding on her back.

Only the possum has given a phrase to the English language. "Playing possum." This is a protection to keep enemies from killing this creature. They can play dead so realistic, even a dog is fooled and will finally leave the "dead possum" alone. After a while Mr. Possum will get up and go home when he sees the coast is clear.

Possum hunting is a favorite pastime in the southwest. Sometime about mid-night the hunt begins and lasts until frosty dawn. Four or five people might make up the hunting party, with lighted torches to light the way. If you can tree him and shake him out of his tree, he can be taken home and fattened up before he is roasted along with sweet potatoes in the same pan. Because he is so easily caught, he has been called the poor mans pork.

There are about twenty species of possum known. The Virginia possum and the Texas possum are most common in Texas and the southern part of the southwest. The Texas possum has the longest tail almost as long as his body.

All possums have a prehensile tail. Their tails can coil around something and hold it like an extra hand, just like a monkey. Their tails appear to have no hair, about one third of the tails of this specie are black.

The possum doesn't like the cold. They eat all their food to store up fat to protect them from the winters cold. They eat enough harmful things to offset the things they destroy. If they can find a persimmon tree and shake down the fruit, a possum is in heaven because the persimmon is their favorite food.

If you ever decide to taste a persimmon to see why the possum likes it so well, be sure and don't pick one that isn't ripe if you don't want to "pucker".

**MEMORIAL FUND OVER  
\$4,000**

LAUGHLIN AIR FORCE BASE, TEXAS — More than half the money needed for a permanent memorial to the F-111 pilot killed in the April 1986 Libyan Raid has been raised.

According to officials of the Laughlin Heritage Foundation, a total of \$4,262 had been received as of Tuesday. The bronze bust of Major Fernando Ribas-Dominicci and the dedicatory plaque will cost just under \$7,000.

"Individual donations have been from the \$1, \$2, and \$3 range to the \$20, \$50, and \$100 range," said Foundation Chairman James Long.

"An Airman First Class at Wueschheim Air Base, Germany, sent a check for \$5, while a retired lieutenant colonel, whose son is stationed at Lakenheath, United Kingdom, sent us a \$20 donation. Several retired general officers also sent in donations," added Long.

The non-profit foundation agreed to raise the \$7,000 it will cost for a bronze bust of Major Ribas and a plaque marking the dedication of Ribas Plaza planned for May 26.

Laughlin base personnel will construct the pedestal on which the bust will rest in front of the T-38 static display already in place at what is now Plaza Drive.

A native of Puerto Rico, Major Ribas had many close ties to del Rio and her sister city of Ciudad Acuna, Mexico. He was married to the former Blanca Linda Berain, daughter of a prominent Ciudad Acuna businessman, Rolando "Lando" Berain.

The Berain family of Ciudad Acuna has donated to the project. Other corporate donations have come from the Del Rio Rotary Club, Del Rio (Host) Lions Club, Del Rio Chapter of the Air Force Association, the Texas State Chapter of the Air Force Association, and the Amistad Flight Order of Daedalians.

Laughlin organizations that have contributed to the project include the Top Three Council, Air Force Sergeants Association, Company Grade Officers Council, and the Directorate of Operations Complex. The 492nd TFS, "Mad Hatters", from Lakenheath, U.K. also sent in their contribution to the project.

Major Rivas, a member of UPT Class 77-05, graduated from Laughlin in May of 1977 and was assigned to Cannon AFB, New Mexico, where he served until 1983. He was with the 48th Tactical Fighter Wing, Lakenheath, U.K., when he was killed in the raid on Libya.

Mrs. Ribas now lives in Austin with their son, Fernando. Both will attend the formal dedication ceremony being planned for May 26, the Friday before Memorial Day.

Cannon AFB, N.M. will provide an F-111 "Missing Man" fly-by for the memorial dedication.

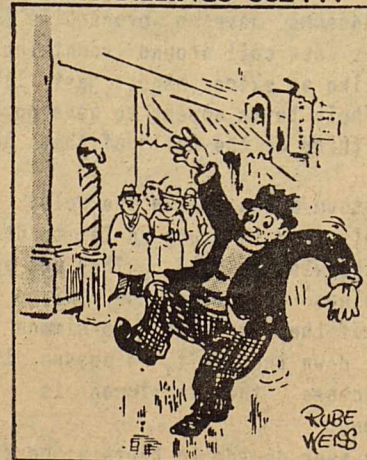

### APPLE BLOSSOMS IN BRACKETTVILLE

It may be just inside City Limits, but Brackettville has a beautification project being worked on. There are 100 dwarf trees in bloom, most of them apple, and soon to be more.

Lenny Mahefky has part of his 3 planned acres planted with this mini-orchard. At present, there are Anna's, Dorsett Gold for pollination, 1 Granny Smith and an Oriental Citrus that had to be pleaded with for ownership. Last Saturday, Lenny stated he was on his way to get some more Granny's, some Keefer Pears, peaches and plums and would have them planted late that night.

He has his own irrigation system of gravity fed water from a small tank at the top of a slope where his orchard is planted. The water feeds through PVC pipe with a separate spout for each tree. He's putting up an eight foot deer fence so they don't eat him out like two years ago. There will be an 8ft. gazebo in the center of the three acres when he's done.

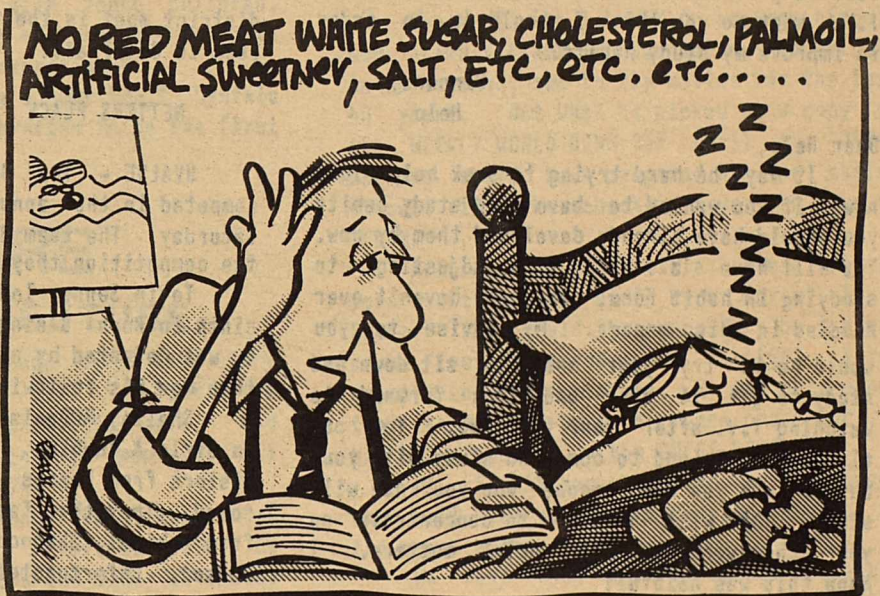
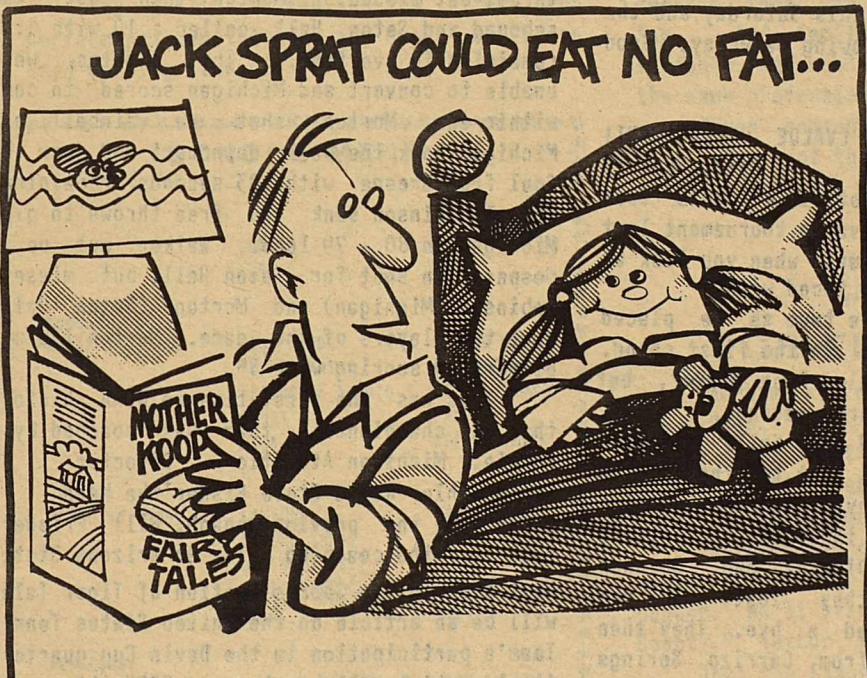
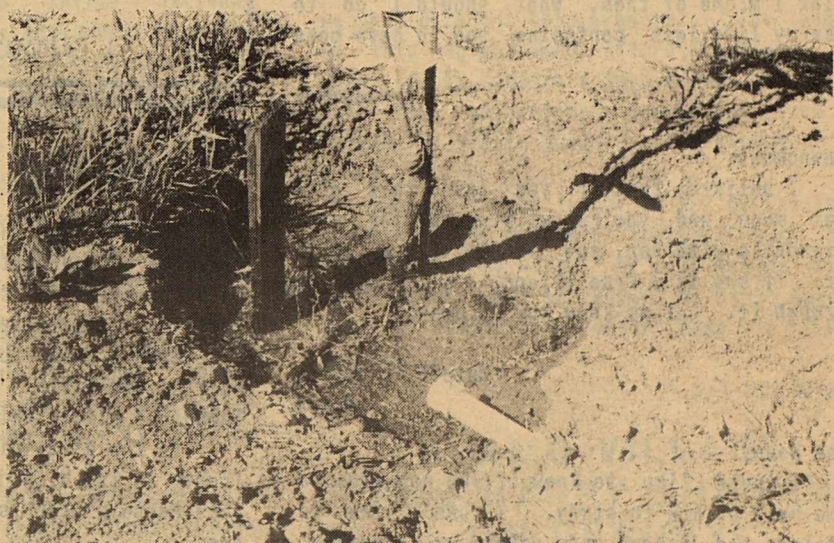
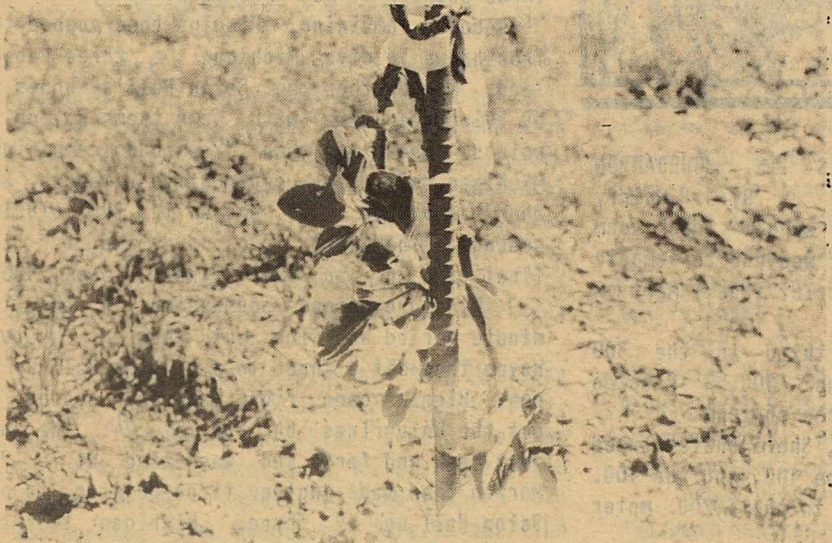
Each dwarf tree is planted 10ft. apart (though they can be planted as close as 5ft.) and will grow to approximately six-seven feet tall. A grown person can pick from the top of the tree.

Lenny had the soil tested before planting the trees and the results show that the soil is abundantly rich and needs sulphur to cut it down some. He had to add 5lbs of sulphur to each tree.

Lenny belongs to the South Texas Apple Growers Association and has gone to Texas A&M in Uvalde with Dr. Shreves to learn some horticulture. Mrs. Bess Fritter has gone to some of these meetings also. She too has a mini apple orchard.

Lenny bought his apple trees at Love Creek Ranch in Medina owned by Baxter & Ann Adams.

Watch for the blooms, Brackettville, as these trees grow, because not only are they pretty, but the fruit they bear will be available to the public via a fruit stand that Lenny would like to have someday. But that's down the road from now.

## Ask Dr. Lamb

by Lawrence E. Lamb, M.D.

**DEAR DR. LAMB:** I am a 50-year-old woman and have been suffering from constant mild abdominal pain and bloating for eight months. I have had every test possible from an upper GI series to a lower GI series for the colon, plus endoscopy and two CAT scans of the abdomen and pelvic area which have shown nothing.

I do have a hiatal hernia, but I was told it has nothing to do with my problem. I went to two gastroenterologists. The second one suggested an exploratory operation, which is the last thing I would have done.

**DEAR READER:** It is important to know what is causing excess gas formation. At least it is important to rule out certain medical problems. Diseases of both the pancreas and gall bladder may be a cause for excess gas accumulation.

Unfortunately, the cause of excess gas accumulation may not be found. That is especially true when it is caused by intolerance to one or more foods. The gas formers are rather well known, such as beans and the cabbage family, but there may be intolerance to other common foods that a person would not expect to be the cause. Coffee, tea and colas can be a cause.

About half of the people who see a gastroenterologist, as you have done, seek help for excess gas formation. The most common mechanism is the fermentation of undi-

gested carbohydrates by bacteria that live in the colon. These are not necessarily harmful bacteria but the presence of undigested food residue. Fermentation of fiber, such as bran, that is promoted to improve colon function improves, the gas is not trapped and distention does not occur. Everyone forms some gas.

If you have tried everything else, you might as well try an elimination diet I have described in my new Special Report WS95, *Gaseous Distention*, which I am sending you. If you can't identify what the problem is, you might want to try charcoal. It is available as Charcoaid or Charcocs which you can take as you finish eating. It helps lots of people. It may decrease the absorption and action of other medicines you may be taking. Antacids are not useful for gaseous distention.

You can request their store forms that are good in your area by writing to Procter & Gamble, P.O. Box 432, Cincinnati, Ohio 45299. You cannot request forms that appear in the newspaper, newspaper inserts or

home mailers. You can, however, request more than one form, but it is limited to one of each offer they have. You must request them one month prior to expiration date.

I might also suggest since you're having trouble locating forms that you contact the store managers in your area and ask them to put out the refund forms they have. You can ask them to request more forms from the salesmen who service their stores.

Why not everyone add the Nestle phone number to your list of toll-free numbers? It could come in handy someday.

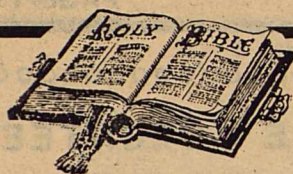

**Dollars & Sense

Don't be surprised if it takes more time than the IRS says it will to complete your tax forms this year.

According to the New York State Society of Certified Public Accountants (NYSSCPA), the estimates included in your 1988 tax instruction booklet are not necessarily accurate.

Roxanne Coady, CPA and head of the NYSSCPA's Tax Division, estimates that at least one or two items on each tax return her firm files must be researched.

"We research items, and sometimes the client has a situation where he or she will save enough money to offset the cost of the research," she says. "Other times, it's necessary to do the research in order to prepare an accurate return."

Another variable affecting preparation time is the client's record-keeping system.

"If a client comes in with records in a shoebox (and sometimes they do), then of course it will take more time than the given estimates to complete the tax forms," says Coady.

While the nature of today's complex tax system makes completing tax forms a laborious process, there are things you can do to help shorten the process.

Coady recommends keeping well organized records. Prepare a list of income and deductions, so that your financial information will be easy to work with.

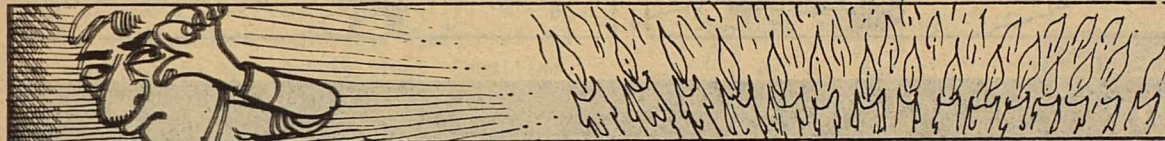
Picker cautions against assuming you have a simple tax situation when looking for a CPA to hire.

"When you call CPA's to explore their billing rates, don't just tell them you need to have a simple tax return done," he says. "Tell the CPA about any complications you might have, so that he or she can provide a more accurate rate estimate."

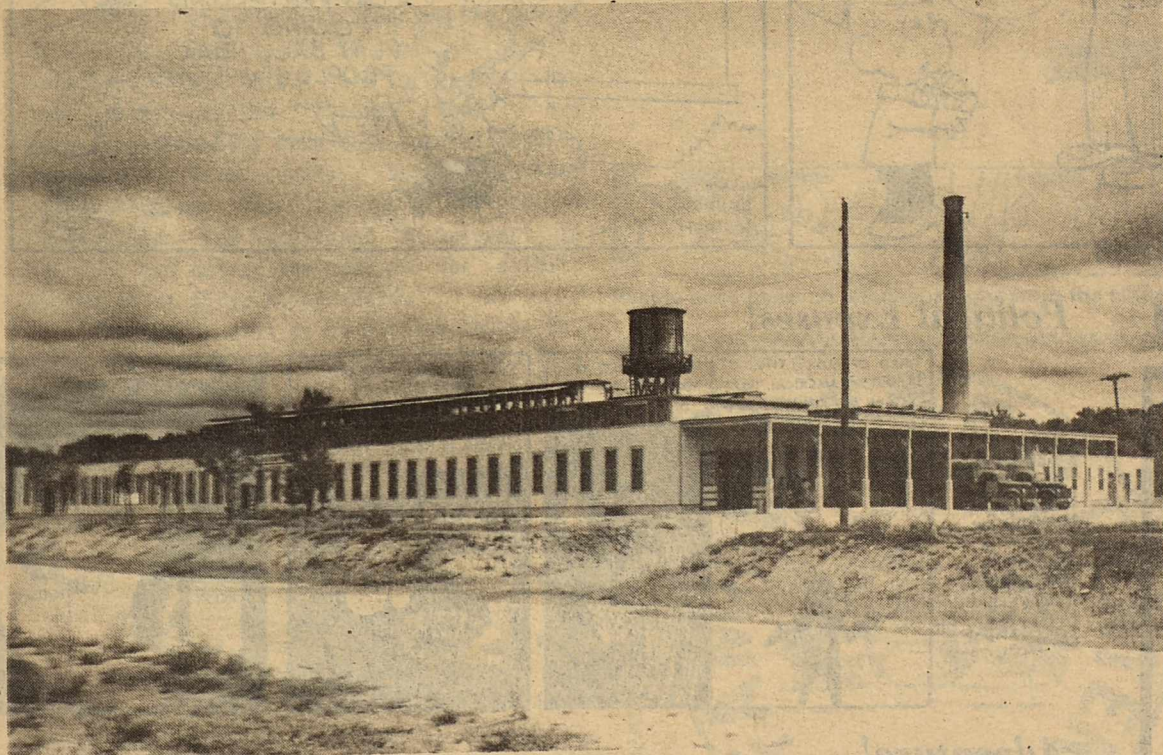

### BULLIS SWORDS

BULLIS SWORDS ADDED TO SPECIAL DAY AT FORT CLARK SPRINGS  
by Penny Nixon

The controversial swords of frontier legend John Lapham Bullis will be on display for one day at Fort Clark's Old Guardhouse Museum after a surprise offer by the San Antonio Museum Association last Friday. The ornate ceremonial swords will be on display for one day only on Saturday, April 22, during the Ft. Clark Cavalry Trooper's Reunion and Wainwright House dedication ceremony scheduled the same day. The Museum Association's offer to bring the swords came after weeks of negotiations following an Associate Press Wire Service story stating the Museum Association had refused to lend the swords, even though they were in a storage box in the basement of the Witte Museum.

After the publicity, the Museum Association quickly retracted their resistance to a loan, promising "to work something out." Their next offer came in a March 15 letter to Fort Clark Springs Public Relations Officer, Penny Nixon, for a 24-48 hour display at a cost of over \$850 dollars for security guards, expenses, transportation and standard loan fees. "Naturally, all of these arrangements would once again need to be approved by our Acquisitions Committee, the Collections Committee of the Board, and at the full Board of Trustees meeting in April," Keeper of Collections, Richard Casagrande said in the letter.

"That's why the call offering the swords for display on April 22 came as such a surprise," Nixon said. "I'm impressed at how fast they worked through their own bureaucracy to help make this special display possible." Area rancher, businessman and philanthropist, Mr. Sterling C. Evans of Castroville, has expressed an interest in helping to defray the cost of the exhibit, estimated at \$574, Nixon added.

The swords will be on display in the Ft. Clark Old Guardhouse Museum from 9 a.m. to 5 p.m. on April 22, under the watchful eye of two Museum Association security guards. Mr. Arthur Cavazos, Director of Public Relations for the Museum Association, will address the cavalry troopers lucheon with a program on the Bullis swords, and upcoming exhibits planned for the Witte, and other museums in San Antonio.

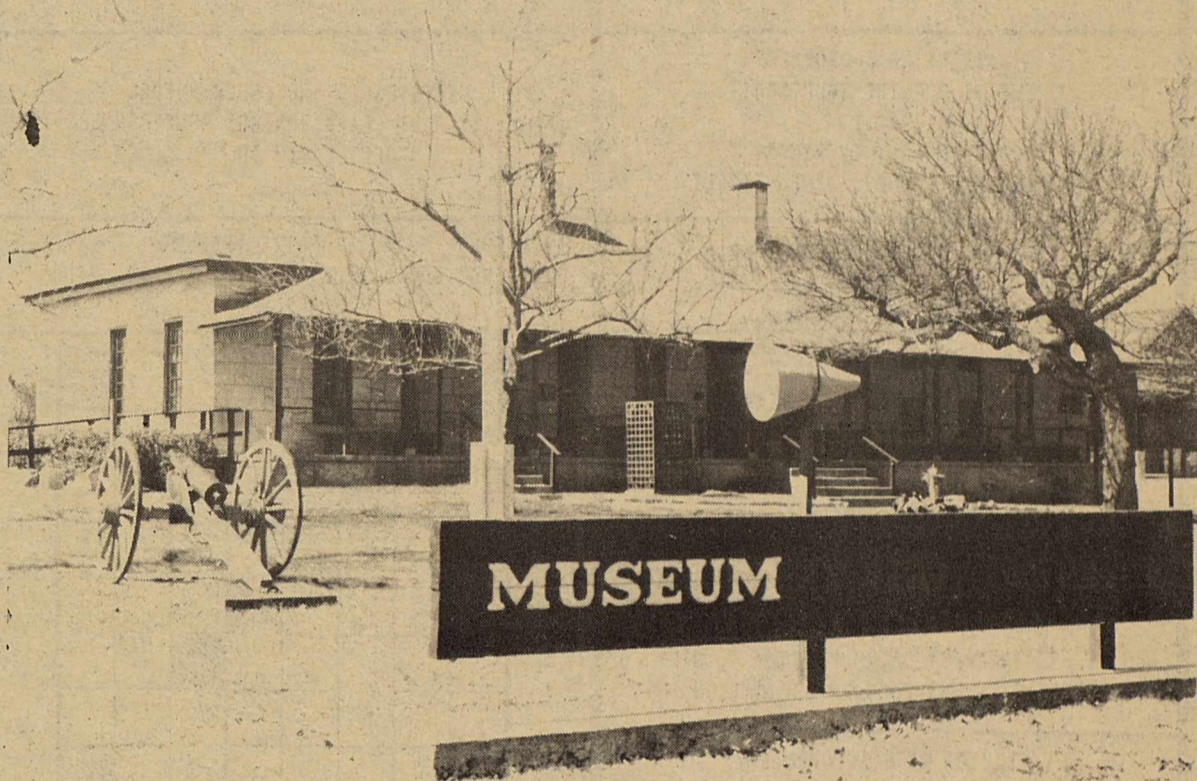
The swords, one gold and one silver, were presented to Bullis by the citizens of western Texas and Kinney County. The first sword, came about by the editorial efforts of

newspapers in Bandera, Uvalde, Castroville and Fort Clark urging citizens to present Bullis a lasting token of their appreciation upon hearing of his transfer to Indian Territory, Arizona. Not to be outdone, the citizens of Kinney County raised enough money to buy Bullis an additional sword, "of scarcely less beauty" as a token of their gratitude.

After spending the greater part of his military career in Indian skirmishes in Texas, Arizona, New Mexico and Mexico, Bullis returned to Fort Sam Houston, where he served as paymaster. He was made a Brigadier General by President Theodore Roosevelt in

1904, solely on his military record, the only time in history that a major has been appointed to a brigadier-generalcy on merit alone. Bullis retired later that year, and lived in San Antonio until his death in 1911. His daughters donated the swords, valued at \$100,000 each, to the Witte Museum, where they are currently stored.

"To my knowledge, those swords haven't been out of the box for at least the past 15 years," Nixon said. "I hope this is the beginning of an effort to find a permanent display home for the swords of the man widely credited with bringing peace to the Texas frontier."



