





## CHAMBER OF COMMERCE BOARD MEETING

The Chamber of Commerce meeting was started with the presentation of the new board members. Two resignations were turned in; Chap Traylor, who is unsure of where he'll be because of employment and Wanda Schwandner in order to devote more time to her family.

The minutes are read and approved. It is reported that there was a loss on the Frontier Fair and that the Parade prizes had not yet been paid out.

Sondra Meil reports that the Golf Tournament is the biggest money maker of the Chamber of Commerce, that they usually hold it twice a year, but did not have one last fall. She states that the Tournament will be held May 6 & 7, that there will be a Calcutta bar-b-que on Friday night at 6:30. There will be an entry fee of \$14. per person and Ms. Meil has mailed invitations to 110 in area. Mr. R. C. Hirsch asks,"What has been done as far as publicity as comments about the fairs publicity was that it was not adequate? Ms. Meils answers,"110 flyers have been sent to 10 Area Clubs."

Suggestions for a "dutch treat" dinner with no public and no tickets to sell to be held to install the new Board Members and to give out the awards to the Citizen of the Year and Student of the Year. It was suggested to have it April 27th and Sondra Meils is to co-ordinate the school and restaurant. Mr. Stan Conoly asked if letters were to be sent to members to inform them of the dinner and suggests that the Chamber should charge people. R. C. Hirsch motioned to minimize donations from those in attendance to defray costs of scholarship and plaque. It was approved.

Debbie Trant suggested that ads be put in 2 newspapers with a cut-out coupon with an RSVP for non-members to attend. R.C.Hirsch suggested offering some valid ideas for programs when asking for people to join the Chamber of Commerce.

A question was brought up about who the scholarship check was made out to. The response was that the \$500 Scholarship check is made out to both the student and the college for endorsement.

Wanda Schwandner stated she hopes that the new board can heal some of the Communities hurts. There was a motion to have Dr. Seawell to give the awards at the dinner and a motion to have a buffet dinner rather than a sit-down dinner.



On an October afternoon in a dried pea field you're liable to hear a friendly, and clear call of "Bob-bob-white, Bob white," when Papa bird and his family are feasting and getting fatter and fatter. In the Southwest, no other game is more popular with outdoorsmen and no meat more delicious.

Bob White is a beautiful part of the fields and meadows in the crisp autumn. He is such a favorite with Oklahoma people he was made their official state bird.

His famous whistle tells us his name, "Bob White". If an enemy is near he gives a shrill whistle of warning. After the enemy passes on, the whistle becomes a gentle "Cooeee-coo-eee," but if one bird in the covey becomes lost the parent bird whistles a loud, "Bob-bob-White."

The Bob White is a large bird, nine to eleven inches long, and if he finds enough to eat he is fat and meaty. His color blends with his surroundings for protection. Usually he is reddish brown on top, gray below, and flecked with black and white, with a black patch on his breast. He has a small head and bill, the female bird is slightly smaller. The Texas Bob White is more gray than brown on his upper feathers.

Some people say the Bob White knows to the exact hour when bird season opens, so he can hide. When he isn't hiding from the hunters he and his family can be found almost anywhere in the Southwest. You can be walking along and Bob White can rise in front of you, and before you can catch your breath he and his family can be a quarter mile away. Even if you think you're ready with gun in hand, the loud whirring sound the birds make is the only method of defense the Bob White makes for defense. Bob Whites are ground birds, running and walking and rarely perch on trees. This is when the bird dog is used to scent the birds and "point' out their location.

Well trained pointers and setters are valuable and most hunters will argue whose bird dog is the smartest and best. In my childhood, there was always a bird dog or two who belonged to my father who was an ardent sportsman.

Bob Whites are friends of gardeners and farmers because they eat great amounts of insects and weed seeds.

There are arguments against killing the birds, but if you have ever eaten a mess of Bob White meat you would probably vote yes. After all its no worse than wringing a chicken's neck or slaughtering a steer.

After the Bob White fights and wins his mate, he is loyal to her and only her. They build a well hidden nest of grass and leaves, usually in May. She lays as many as twenty eggs, with each egg fitting in the nest like oranges packed in a box. If you find a nest and handle the eggs she will abandon it, because she is so shy and suspicious. Both

parents take turns keeping the eggs warm. Papa bird is very proud and is a good father all his life. If the mother bird is killed or dies Papa will raise the babies alone. If new eggs are laid before the first brood are hatched and raised, Papa will raise the older ones while his mate takes care of the eggs and new babies.

If you come up on a mother bird and her chicks, she will flutter near you and pretend to be lame to lure you away from her chicks, the father bird will do the same thing and after the danger is past they will all join together again.

Their roosting habits are very odd, the entire covey of parents and young huddle in a tight circle, heads out and papa stands guard all night, just like a human family.

These endearing traits are very sentimental, but not enough to make birds on toast taste bad.


Next Wednesday night, April 19, Rev. Walter Johnson will speak at the First Baptist Church. Service time is at 7:00 p.m.

# **COMMISSIONERS' COURT UNOFFICIAL MINUTES**

Commissioners Court met on April 10, 1989 with a very large agenda. After a call to order and a quorum established, the minutes of March 13th and March 20th were read and approved.

Bonds for the Tax Assessor/Collector and Librarian were approved.

The County Treasurer reported on the Life insurance of Blue Cross and Blue shield that the retired County employees and Officials had. Blue Cross and Blue shield will not carry life insurance on County retired persons. Those that have been paying their monthly premiums will be refunded.

Payment of the Treasurer's Seminar expenses was approved.

The County and District Clerk requested the lease or purchase of a new copier. No decision was made at this time. The County Clerk will check on prices.

A discussion was held on the need for additional office space. The Justice of the Peace and the Texas Dept. of Health need space. There were several suggestions. One was to lease a building and one was to try to build a building to accomodate several needed offices. Building a building now would be difficult since money is short.

An Executive session was held to discuss pending litigation, personnel and salaries, County Agent and the purchase of real estate. When regular sessions resumed,

decisions were made. The consideration of a vehicle for the

Constable was tabled.

A discussion was held on repairs needed on the County Agent's Office, Courthouse roof, and gutters, and the swimpark roof. It was decided to try to repair these with County employees help. This would help not having to spend money right now for a contractor to do these repairs.

A request to pay for two Senior Citizens to go to an annual meeting in Austin was approved. A line item adjustment was made. The four Commissioners gave up some of their seminar money so Kinney County could be represented.

A request for a \$500.00 amendment to the Tax Collector/Assessor office was made for postage. Since alot of work has been and is still being done to update the Voters' Registration list, this was needed.

Sheriff Norman Hooten requested that he needed an additional \$22,000.00 added to his

budget to be used for postage, prisoner care, and Auto repairs. His budget line items were amended by \$3,168.00 and an additional \$13,500.00 was added for prisoner care.

Discussion for transferring County Cemetery and indigent burial program's responsibility from Roberta King to another office was had. This was tabled.

Commissioner Rose Mary Slubar Commissioner Ruben Fuentes are to try to set up guidelines for Cemetery and to check on prices of markers for unmarked graves. This is to be presented to Commissioners Court at the next meeting for approval.

Since the City of Brackettville no longer digs graves, it was suggested that local contractors be contacted for this service.

A discussion for a partial refund of the rent paid by the Chamber of Commerce for the Fair was held. No motion was made.

Roof repairs on the Civic Center was decided to be done by County employees under the supervision of the Commissioners. Money is not available at the time for contractual repairs.

The request for the purchase of 3 motor fans for the civic center was tabled.


A public hearing was had on Septic Tanks and passing order adopting State regulations for On-site sewer. No citizens were present. Discussion was had about redistricting of precincts due to over balance in all precincts. No decision was made.



Meeting was adjourned.





# CITY COUNCIL MEETING

The City Council meeting was called to order at 4:34 p.m. Monday, April 10th. After the approval of the minutes of the last regular meeting and special meeting and the financial reports, Mayor La Gioia reports that at the special council meeting, Councilman McClure requested an increase in council members salaries, but he explained that an increase was given last year to all council members and the two incoming council members will start with equal salaries.

Mayor La Gioia states that CP & L has requested a public hearing but that it won't be for awhile yet. "I'm still waiting for information on it, then a definite date will be set."

Mayor relays a request from the Brackett Volunteer Fire Dept. for 4 pair of fire gloves at \$25. each, totaling \$100. Chief Reyes reports that this will bring them to 10 pair of gloves and usually 10 firemen go out on fires. It was approved to purchase the gloves.

Maintainer repair expense was discussed. Gus Ramirez reports that the cost of the motor alone is \$3343.82 plus the expense of the oil pump. Parts Service Supply Co., Inc., in Eagle Pass quoted a \$1546. for parts originally and have stated that they made an error twice uping the quote to \$2500. and then to \$3343.82. Mayor La Gioia states that they will not accept that bid. He made a suggestion that they could possibly rent the County's maintainer for the same costs. Fire Chief Reyes suggested that the Mayor look over a list, the fire dept. has, of used maintainers and other equipment that the state has for sale.

Mayor La Gioia comments that there have been complaints on the water & gas meters not being read correctly. "Customers feel they are being overcharged or undercharged", he says. He reports that the city is trying to start a meter change out program, but first have to make sure the meters are pretty accurate. "We'll take a meter, change it out, send it out to be calibrated and replace it. Then have the customer sign a paper letting them know that it's the same meter we took out," he says.

He also reports that the gas meters are at ground level with only 2 feet of clearance all around, the meter readers need to get on their stomachs to read the meters, and that something needs to be done.

Gus Ramirez is getting Videos to explain how meters run and how to read your own meters. The city is also going to set up meters in the office so that people can be shown how to read their own meters, when they come in.

"We were turned down on the planning grant because we could only come up with 10% matching funds," reports the Mayor. The planning grant would have helped with the streets, drainage, utilities and housing.

The city is checking into whether the digging of the grave is part of the funeral package or a separate deal. The maintenance on the equipment is not cost effective right now. Councilman Burks asks what criteria will be used to determine a person as indigent? As there is none at present, the city tabled the issue until a criteria to determine indigent individuals can be made.

Before going into executive session, Mayor La Gioia reports that a fire hydrant was hit head on by a vehicle across from the school. Mac McClure stated it was a Chevy? and Chief Police Chief Johnny Fritter reports that it has not yet been located. The mayor reports that there is a fire hydrant leaking on the corner of Third and Ann Street, that Gus Ramirez will order some materials, a cut-off and will work on it at night while everyone is asleep. The people will be notified a week ahead of time. Mayor La Gioia also reports that the New Border Patrol building will be coming in soon as they're supposed to sign the papers soon. Also that some low income housing will be coming in if everything goes through. "We have quite a bit we're working on ," he says.

At 5:28 p.m. the regular session resumed with the mayor stating they would give a letter of commendation to Police Chief Johnny Fritter. He also states that it was decided

to give David Martinez, David Tillery and Gus Ramirez raises, each at a different time frame.

The city will be advertising for a City Manager/Administrator in the Texas Municipal League magazine.

The Mayor requested reimbursement for travel expenses incurred when acting as City administrator. It was approved.

The city council salary increase was defeated with a motion and aprroval to leave it as is and not raise it.

# CHAMBER OF COMMERCE MEETING STATEMENT BY JIMMEY '

BALLEW

The following is a statement, submitted by Jimmy Ballew, that the newspaper requested, in reference to the Chamber of Commerce meeting on March 30,1989.

"When we arrived for the meeting, the bank door by which meeting attendants usually enter was locked. I knocked on the door and was told by a Chamber of Commerce officer that we would not be allowed to attend the meeting. We brought to her attention parts of the Chamber of Commerce by-laws that allow Chamber members to attend all meetings and speak on the subject being discussed, but we were still refused entry. We waited outside on the curb with other Chamber and/or CARE members who had also been denied entry.

After a while the officer came to the door and said that another member and I could come inside. While in the meeting, we discussed the speaker who had been engaged for the annual banquet. We had heard, prior to the meeting, that he was an ex-astronaut and also a Texcor investor who had waived his usual speaking fee for the banquet. We were then told that he had indicated he would not speak on Texcor or the proposed radioactive waste site. However, that was not my major concern, as I feel that the people of Kinney County have already heard and learned a great deal about this issue, and he was not going to change anyone's mind. Instead, my greater concern was that this man's presence as speaker at our Chamber of Commerce banquet might be misconstrued as evidence of local support for a radioactive waste site when application is made for a license in Austin. I did not want to see the Chamber of Commerce used as a pawn in this way.

While in the meeting the other member and I stressed that CARE had no desire to hand-pick a speaker for the banquet. A speaker with no connection to this controversy could have been found, and we offered our assistance as Chamber members in finding one. Having voiced our opinions, we

were asked to leave, so we returned to the curb outside to wait with the others.

A short while later the five board members in attendance emerged and announced that the banquet had been cancelled. Those of us still waiting again stated that we did not wish to have the banquet cancelled but only that another speaker be engaged. It was my impression that some of the board members were receptive to this idea. However, upon reading the next week's newspaper, I learned that the banquet had definitely been cancelled.

I would like to stress that at no time during the approximately 1 1/2 hours I spent inside and outside this meeting did I see or hear any Chamber or CARE members be disruptive or behave in any manner deserving of the rude treatment received. I appreciated being allowed to enter and voice my opinion on the subject, but I do wish that all Chamber members desiring to do so had been allowed to enter the meeting.

However, on an optimistic note, I do feel that the business of the Chamber of Commerce be conducted in a more positive manner from now on.

In an interview with Stan Conoly he stated he concurred with Jimmy Ballew's statement. He also added that he did not want the Chamber of Commerce dinner cancelled and feels that it is a community event that should be continued.

A note from the Editor:

In the article printed in last week's paper about the events of the Chamber of Commerce meeting, several Care persons were concerned. The information for the article was received from a Chamber member. The article was not intended to offend either of the organizations. If this was the case, we apologize.

Printed below is Article 6, titled "Meetings" of the By-Laws of the Chamber of Commerce. A Care/Chamber Member requested that it be printed.

	ARTICLE 6
	MEETINGS
Section 1.	The board of directors may provide for a regular meeting of the association each month, and special meetings may be ordered by the association or by the board of directors or by the president.
Section 2.	Each member of the association shall be given notice at least ten (10) days prior to ever regular or special meeting, which notice shall be in writing. With the notice shall also be given a brief statement of the business to be considered.
Section 3.	The annual meeting of the association shall be held in April of each year or as soon thereafter as practicable.
Section 4.	Ten per cent (10%) of the members in good standing shall constitute a quorum for the transaction of business at a regular or called meeting of the association.
Section 5.	Ever member shall be entitled to speak and vote on any subject brought before the association for consideration. Each membership is entitled to only one vote. At the discretion of the chairman, debates may be limited.
Section 6.	The directors shall submit any matter to the membership upon written request of (10%) of the members in good standing.

# LETTERS TO THE EDITOR

#### Dear Editor:

The following letter is neither dictated by, nor the established opinion of; my employers, friends or relatives.

The topic I wish to address is the manner in which individuals and organizations of this community have addressed the TexCor proposal. I have and remain an outside observor of the progress of this project and do not discuss the specifics with either side. I therefore state no official opinion on the project itself, but recent events encourage me strongly to address the methods utilized to mold community opinion. The statement "a litte knowledge is a very dangerous thing" applies directly to this topic.

Politics usually becomes a major factor in any matter only when knowledge is either lacking or nonexistent. Unfortunately politics is essential to our system. Public opinion is vital but no organization whould be established to form public opinion unless it is devoted to the study and finding of facts utilizing personnel who are strictly and reputably educated, trained and practicing in fields directly related to the topic of study. I would offer as a suggestion that an organization addressing this project specifically request a study from some of the following professional fields:

1. Environmental Engineer (certified by a State Board)

2. Geologist

3. Specialists in the fields of Science/Radioactivity

These personnel would not have to conduct an all-encompassing design project, but could be hired to establish facts about the materials to be stored, methods that are applicable as well as information on site selection factors. The professional fields mentioned above require a minimum of 4 years of intense study in these specific fields and some require a minimum of an additional 4 years apprenticeship under those with previous registration by the state. It is foolish to believe that this type of knowledge can be gained through personal study in a time frame that is not at least as encompassing as mentioned above.

A few priorities that should be addressed in any project are:

- 1. Safety
- 2. Aesthetics
- 3. Economics

These priorities would surely be addressed by the personnel above.

Your next question would be in referrence to cost. I would be surprised if anyone in this community has even ventured to obtain any information as to the cost of a study utilizing any of of these professionals. Universities might be willing to assist you at a more reasonable cost than others and would offer a variety of personnel from many fields. It is possible that TexCor might even assist in some of the financial

obligations although I am making no commitment for them nor am I suggesting that this is an obligation they should fulfill. As I stated earlier, this would merely require that these people study the aspects of this specific project.

Many of the opinions I have seen stated in the papers are based upon innuendo and misrepresentation. Statements inferring that TexCor cares nothing about the community or that they are going to kill babies in the future are not only libellous but inflammatory and highly unethical. Many opinions are based on press stories of occurrences at other locations that may or may not be in any way similar to this project. One of the basic rules of any study, scientific or otherwise, is that a proper frame of reference must be set so that findings are not corrupted by facts that are totally irrelevent.

I realize that you probably feel that I am very long-winded but I now wish to address the occurrence that brought me to write this letter. I wish to directly address these three entities: CARE, the Kinney County Chamber of Commerce and Don Parks. recently became aware that a speaker of renowned stature and obviously performing a great favor to such a small community as and later Brackettville was scheduled cancelled due to pressure on the Chamber of a person or persons of the CARE organization. I greatly resent the fact that such an organization or person of any kind would refuse me or any other person of this community the chance to learn from this speaker no matter the topic, his personal convictions or what his investments might encumber. There is no greater method of destruction than to refuse a community the right to gain knowledge; hardly indicative of CARing. The Chamber shows that the only aspect that matches their immensity of


