HYPNOTIST VISITS BRACKETTVILLE

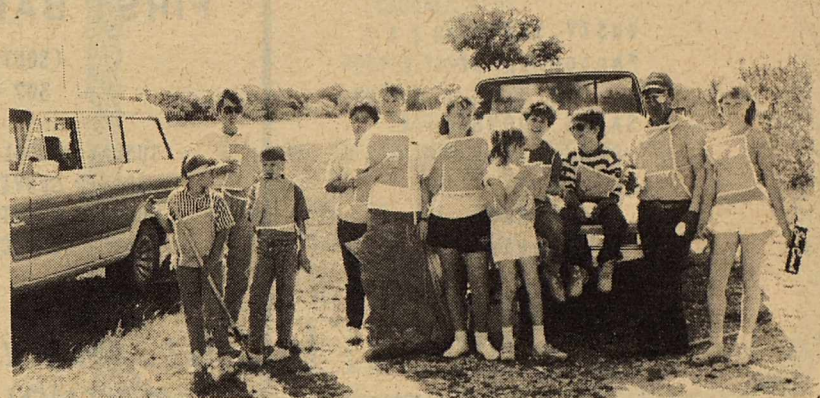

Contributions raised in 1985-86 were invested during this fiscal year (September 1, 1987 - August 31, 1988 in Texas as illustrated:

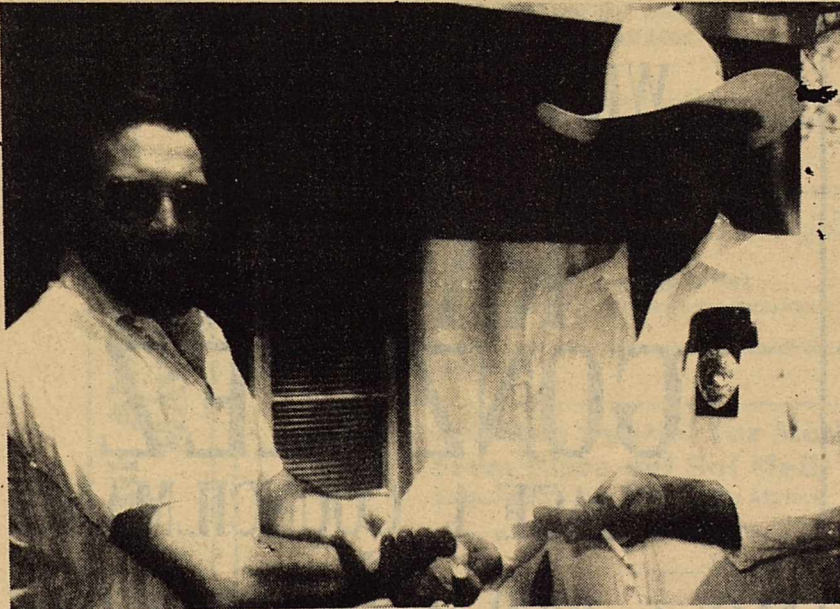

"The American Cancer Society is currently sponsoring research investigations in 10 major Texas hospitals, medical schools and universities totaling more than \$7.8 million," said Starzel. "Because so much promising research is taking place here, the national American Cancer Society allocates additional funds to Texas," she said.

"Programs that help people are our priority. We keep a tight control over our administrative costs and keep them within acceptable limits, as this breakdown indicates," Starzel commented.

American Cancer Society volunteers deliver patient service programs like Reach to Recovery, support groups, transportation to treatment centers; education programs for the public, including films, pamphlets, teacher resources and the Great American Smokeout; and professional education programs and materials for the medical community. "Volunteers keep our costs down and enable the American Cancer Society to conduct an impressive array of local programs and services in communities throughout Texas," Starzel comments.

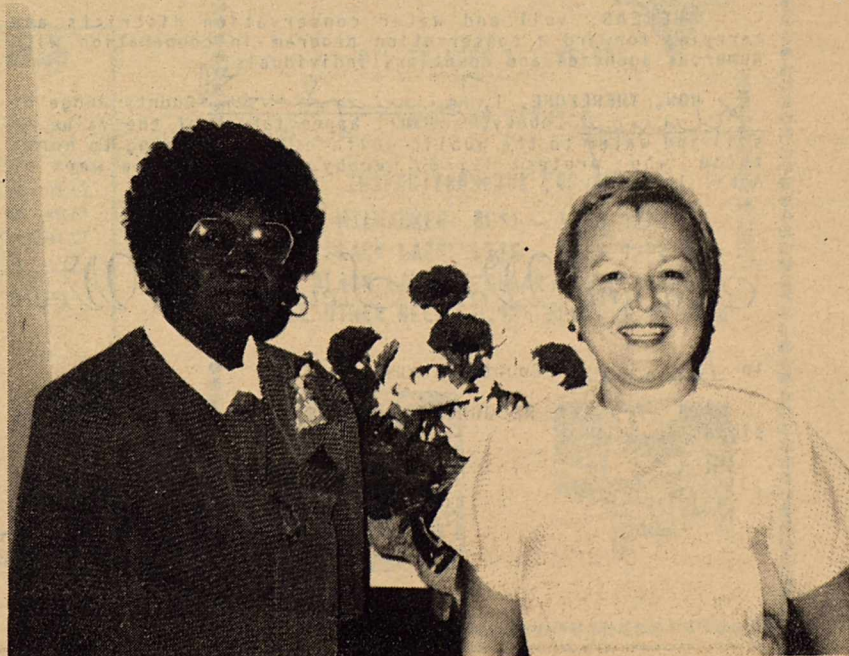

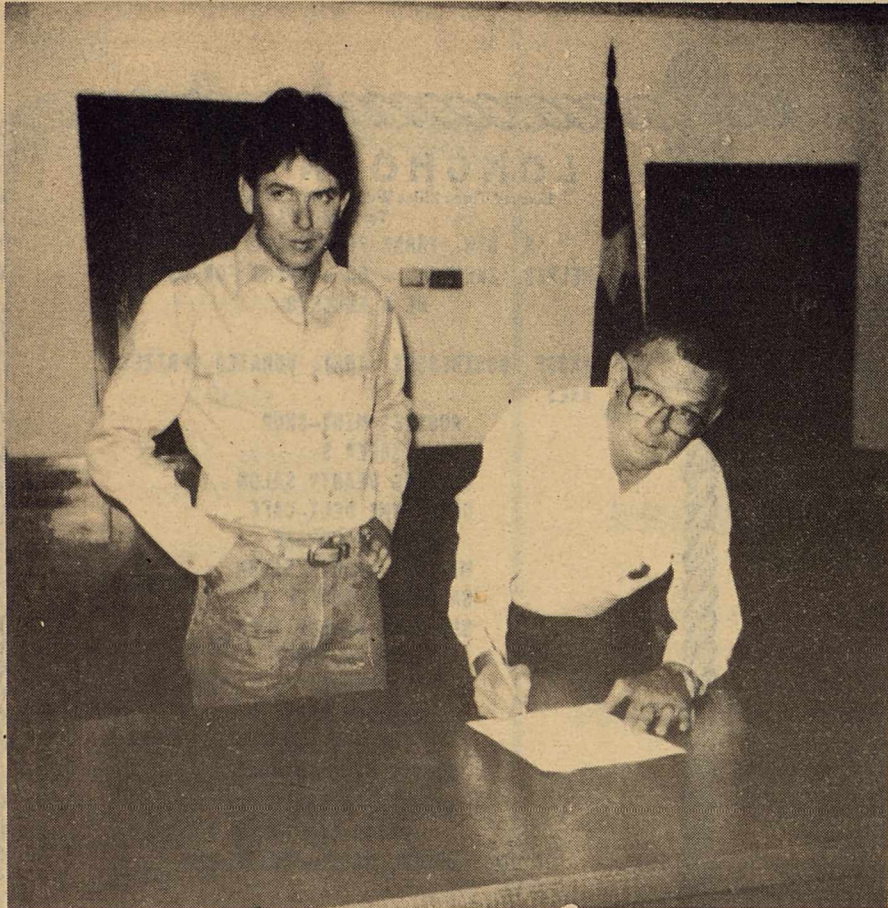
TOUR HEARS LOCAL HISTORY

The group of 22 left early Sunday morning for the Big Bend area. Earlier in the day, the group received a special tour of Fort Clark Springs by historian Charles G. Downing.

SOIL AND WATER STEWARDSHIP WEEK

APRIL 30 - MAY 7, 1989

Theme: "Renewing The Living Earth"

The West Nueces-Las Moras Soil and Water Conservation District has announced they will join in the national observance of Soil and Water Stewardship Week to take place on April 30-May 7, 1989 according to an announcement by Mr. Bret Trant, Chairman of the District.

The theme of this year's observance is vital if we are to maintain the productive capabilities of our basic natural resources of soil and water. Together we must work for the good of all to utilize, conserve and properly manage those resources in our care. Participation in Soil and Water Stewardship Week activities offers an opportunity to reflect on the nation's natural renewable resource problems and consider actions to resolve them or reduce their impact.

The West Nueces-Las Moras SWCD was organized in 1956 for the purpose of offering farmers, ranchers, and the local community a voluntary conservation technical assistance program through which individuals could seek and request conservation assistance to meet their individual land's capabilities and needs.

"Basically it is the district's responsibility to provide technical assistance when requested relative to proper soil use and treatment, erosion control practices, solve drainage problems and assist farmers and ranchers with crop, range and pastureland management," said Mr. Trant.

The National Association of Conservation Districts has sponsored Soil and Water Stewardship Week in the United States since 1955, in cooperation with the nation's nearly 3,000 soil and water conservation districts. Informative material on the Soil and Water Stewardship Week theme each year is distributed through local conservation districts to clergymen interested in participating in the celebration.

Information and materials for the 1989 observance of Soil and Water Stewardship Week can be obtained in this area from The First Baptist Church, St. Mary Magdalene Catholic Church, The Community Church, St. James Episcopal Church and St. John Baptist Church.

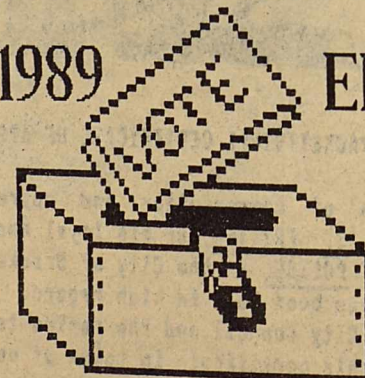

CENTRAL POWER AND LIGHT COMPANY

Central Power and Light Company's share of support to the taxing entities within the company's 44-county service area amounts to \$27 million for 1988, making the company one of South Texas's largest ad valorem taxpayers, according to Floyd Anderson, the company's tax manager.

Of the \$27 million total, approximately 50 percent went to school districts with the balance being distributed among other taxing entities such as city and county governments and water, drainage, fire, hospital and road districts.

According to Kevin McMahon, CPL manager in Del Rio, CPL paid \$20,154 in ad valorem taxes in Kinney County. Major recipients include the Brackettville Independent School District receiving \$10,319 and county government receiving \$6,976. Two cities in Kinney County also realized \$1,912 in taxes from CPL with the other taxing entities receiving the balance.

In addition to ad valorem taxes, CPL supports local governments by payment of gross receipts tax and sales tax, where applicable.

SABERS RETURN

THE SAGA OF THE SABERS:
RETURNING TO FORT CLARK FOR ONE DAY

One hundred years ago, in the wide and raw land that is now Uvalde, Medina, Bandera, Kerr, Real, Edwards, Kinney and Val Verde Counties, Fort Clark's Lt. John L. Bullis rode with four woolly privates of the Ninth Cavalry in advance of a main company of soldiers. In a land raked and burned by Indian violence, they rode in search of warriors. In the afternoon, they discovered three Indians driving a large herd of stolen cattle. Bullis and the scouts attacked at once, capturing the herd, and scattering the Indians. But the Indians returned, now a force of 28 braves, driving a second herd of cattle. Bullis and his scouts turned, attacked again, and battled for half an hour, until the Indians were chased into hiding. Quickly gathering both herds of stolen cattle, they returned to their company.

Lt. Bullis inspired the famed Seminole Negro Indian Scouts to their most daring deeds by leading the charge. Huddled around their fires at night, the Indians spoke of Bullis as "The Whirlwind," who struck fear and disaster without warning.

When the Texas frontier between San Antonio and Brackettville's Fort Clark had been deemed safe from further Indian attacks, the Army transferred Lt. Bullis on to the hostile country of Indian Territory, Arizona. Widely regarded as the man who brought peace to the Texas frontier, the people of the area were shocked and saddened to hear of Bullis's transfer. The newspapers of 1882 fully expressed the wide-felt regret at Bullis's departure. It was the "Quill" of Castroville that proposed raising a fund to present First Lt. Bullis with a sword, as testament of the people's gratitude. Other newspapers, the Bandera "Bugle," the Uvalde "Hesperian," the San Antonio "Express," and the "Fort Clark News" soon joined the drive, raising money and esteem for Bullis.

Constructed in Boston, word soon spread of the sword's beauty. A continuous battle charge of soldiers and Indians was being etched lengthwise down the golden blade, with etches of the Goddess of Liberty, the American Eagle, a camp scene in the Chenati Mountains and a portrait of Bullis also planned. It would read: "Bullis, the friend of the frontier," and "He Protected Our Homes - Our Homes Are Open to Him. Presented to John L. Bullis by the people of Western Texas."

Not to be outdone, the citizens of Kinney County, home to Bullis during his dozen years at Ft. Clark, raised funds to present the legendary soldier with an additional sword. Shortly after completion of the first sword, it was joined by a second of scarcely less beauty. Silver, with a seed pearl hilt, it said: "Presented by the People of Kinney County as a token of their undying gratitude."

After Gen. Bullis's death on May 26, 1911, the swords continued to hang in his magnificent San Antonio home. Later, as his daughters grew older, they gave the swords to the Witte Museum. In the shuffle during the

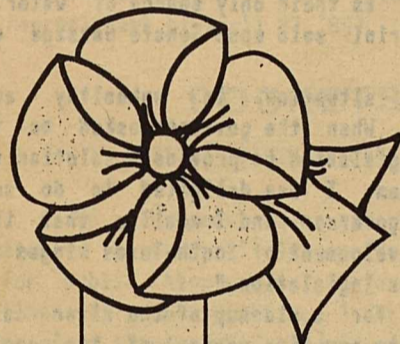

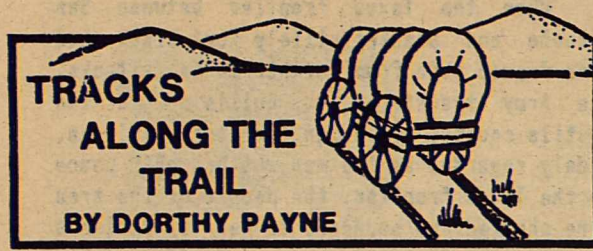

The bats that fly in and out of the Carlsbad Cavern were the clue that betrayed the location of the cave to explorers. Bats are valuable mainly because they eat billions of mosquitoes, they have almost wiped out the species of mosquito that causes the disease of Malaria.

These little animals are characters in many ghost stories and scary legends. They are supposed to be favorites of witches and devils. This is because of their odd appearance, harmless as they are they still look scary.

Bats are not birds, they are flying mammals, and they feed their young from milk glands. Instead of feathers they have a thin tough membrane over long arms and fingers that connect with the body and lower legs. Another membrane connects the two hind legs.

In Ceylon bats are used by men when they are in love. There, a bats blood, if placed near the mans sweetheart, is supposed to insure the girls love. In Siam, the girls do this to the boys. In Sumatra the men collect and keep bats tongues as a charm to prevent their women from talking to much.

All the superstitious stories told about the bats has caused man to shoot them and despise them, but the bat is really a timid, harmless little creature who is not much afraid of man. Of course his appearance and actions doesn't help people accept him as a friend.

One Saturday afternoon recently Mr. Ed Ward of Fort Clark called me. He said, "Preacher, I sure missed going to Church today." (pause).

Then my response was, "Did you really want me to pick you up and take you to Church today?"

The handicapped man answered, "I sure did. I stayed dressed for you all morning thinking you would get here after while."

When that good man heard me say, "Mr. Ward, today is Saturday, not Sunday, I saw over the telephone the shock on his face."

The habit of being in God's House three or four times a week ought to spring up in our lives like buffle grass does after a four inch summer rain. If all who profess to be Christians would attend Church, every building in the country would have to build balconies, put in new pews, and extend the size of the "meeting house" three times over again.

We ought to be in God's House because Jesus loved the Church and died for her life. The cross of Jesus where Jesus was nailed and where His body bled and died two thousand years ago says to us that He loves His church.

SENATE APPROVES BILL TO CLEAN UP RIO GRANDE

The Texas Senate today passed the Colonias and Rio Grande Cleanup Bill, Senate Bill 2, co-sponsored by Senators Judith Zaffirini (D-Laredo), Hector Uribe (D-Brownsville) and Tati Santiesteban (D-El Paso). The bill addresses the problems of the colonias along the border and duplicates the language of S.B. 1545 by Zaffirini, which would hasten cleanup of the pollution of the Rio Grande River.

"Future development of the border and expansion of the maquiladora industries hinge on a cleanup of the Rio Grande," Sen. Zaffirini said. "The river is polluted, at times unsafe even for swimming. This bill would allow us to use the already-existing Water Loan Assistance Fund to pay for a joint wastewater treatment plant for Laredo and Nuevo Laredo."

The pollution of the Rio Grande comes principally from the Mexican side of the river: Because of the absence of a sewage treatment plant, Nuevo Laredo discharges 25 million gallons of raw sewage into the Rio Grande each day, creating a bacterial count the Texas Health Department once measured at 110 times the safe limit even for swimming.

"Nearly 700,000 Texans in 38 cities between Laredo and Brownsville rely on the Rio Grande as their only source of water," Sen. Zaffirini said upon Senate passage of the bill.

"That situation is unhealthy and untenable. When the governor asked me to sponsor legislation to provide a solution to this problem, I was delighted to do so. Both the governor and I realize that the economic development of South Texas hinges in part on this legislation."

Plans for a cleanup of the river call for Texas to pay five percent of the cost, the United States to pay 45 percent and Mexico to pay 50 percent of the projected \$44 million cost of the Laredo-Nuevo Laredo facility. That project is prioritized because of the condition of the river near Laredo. It will be followed at some future date by projects at Eagle Pass-Piedras Negras, Del Rio-Acuna and McAllen-Reynosa.

Both former President Ronald Reagan and President George Bush committed federal funds to this project. Texas Gov. Bill Clements has committed to the project because of its implications for economic development.

EAGLE PASS PROCESSING INC.

Apparel Manufacturer Opens 88,000 sq.ft. Plant

Eagle Pass Processing Inc., a wholly owned subsidiary of the Lee Co. of Meriam, Kan., will open a support operation and manufacturing production line for denim jeans in Eagle Pass.

The company plans to complete remodeling of the 88,000 square foot Texas Apparel Building on Highway 277 and begin operations by May 1. The Eagle Pass plant will act as a service support operation for a Lee-owned plant across the border in Muzquiz, Coahuila, and operate its own production line for basic fashion jeans, said Tony Ahnemann, vice president of resources for the Lee Co.

The plant will open with 100 experienced sewing machine operators and will employ 350 workers at total employment, bringing significant relief to the area, which is experiencing 38 percent unemployment, said Arthur Pine, executive director of the Eagle Pass Chamber of Commerce and Maverick County Development Corp.

More than 2,000 people already have applied for the available positions, said Rafael Chancey of the Texas Employment Commission.

BULLOCK REPORTS

COMPTROLLER OF PUBLIC ACCOUNTS

News Release

AUSTIN, Tex.-State Comptroller Bob Bullock on Wednesday cautioned taxpayers to beware of tax consultant scams that may be costing corporations millions of dollars in unnecessary franchise tax refund filing fees.

"If someone says there's an 'inside track' to faster or bigger tax refunds from us, that's a bald faced lie," Bullock said.

Bullock said unscrupulous consultants approach businesses with claims of "secret insider information" about the Texas tax refund procedure and promises of faster, bigger tax refunds.

The consultants base their fees on a percentage of the estimated refund and often require taxpayers to pay up front after showing the taxpayer faulty or incomplete claims that overstate the refund due.

"By the time we've processed the claims and notified the taxpayer of the error, the 'consultant' is long gone with the taxpayer's money," Bullock said.

Bullock said taxpayers can get all the free information they need about possible refunds by calling the Comptroller's toll-free tax assistance lines, 1-800-252-5555.

To the Editor:

LETTER TO THE EDITOR

I agree with other correspondents writing that there are opinions on opposite sides of most issues, including the TexCor-BFI proposal for a dump for radioactive waste in Kinney County. I have, however, been around a while and do not recall encountering the idea that no one is entitled to form an opinion except as a result of locally sponsored laboratory or field research. Heretofore, it has always been my belief that knowledge may be legitimately and properly obtained from qualified authorities through their published papers, articles, and essays. I have also sometimes relied upon the useful nature of some of the information to be gained from attending lectures or sermons or courses of study. I suspect that most ministers would be offended if their congregations considered it necessary to verify the scriptures by going to Israel to examine the empty tomb. Builders, too, tend to rely on the published tables and performance characteristics of materials and design basics, instead of repeating the tests from which these were developed.

I guess I am in the same positions as TexCor when that entity recently submitted a Houston Post article to you for reprint. The apparent source of the article, a Mr. Jim Martin who is employed by the American Petroleum Institute, is entitled to his point of view which could be predicted since he is spokesman for the industry which creates the pipe scale dealt with in the article. Mr. Martin cites several sources, but in no way rules out the possibility that health problems may be produced by pipe scale radiation. Of course, the article does not deal with uranium mill tailings, or with the other waste materials which would be placed in the TexCor dump. Mill tailings, which exist presently in Karnes County in huge amounts, are described as "...lakes of radioactive dirt and sulfuric acid." (Texas Senate Committee on Health Services - Feb. 1, 1989)

It is certainly to be expected that opinions will vary on nearly any subject. In even the most learned scientific circles one can find individuals on every side of this question of radioactivity and its effects. All agree, however, that ionizing radiation (Alpha, Beta, Gamma, and e-ray) damages living cells. "Any radioactive track can, in principle, deposit enough energy to cause a mutation." (Dr. Arthur C. Upton, Chairman New York Univ. Dept. of Environmental Medicine.) Disagreement exists about the duration, the extent, and the expanded effect of this radiation. A growing body of opinion holds that "There is no safe threshold for radiation exposure." (Linus Pauling, Nobel Prize Chemistry, Nuclear Physicist). Most significant for the current discussion is "Any amount of unnecessary radiation exposure, however small, has some increased risk of adverse health effects." (U.S. Dept. of Energy, National Geographic Mag., April 1989.) Of great local significance is the opinion of Dr. John Gofman, co-discoverer of u-233 and of Plutonium. He has concluded after prolonged investigation involving human beings exposed to various levels and periods

of radiation, that "Radiation effect is steepest at the lowest levels." "Is there a threshold below which radiation will have no effect? Few scientists think so any more." (National Geographic Mag., April 1989.)

In recent months I have endeavored to set forth my opinion clearly, as do other correspondents and columnists in these pages. I have pointed out long-accepted facts relating to radioactivity, and to its sources, its duration, and its short and long term effects on living organisms, especially the young. I have called attention to regulatory failures and concealments by governments which, coupled with human error and with corporate misbehavior, have generated an awful procession of health hazard exposures to defenseless people throughout the nation and the world. I have indicated that reliance on today's promises has never been and can never be any guarantee for the future. I have called attention to predictable unreliability extant in even the most advanced technologies and in the materials utilized. I have discussed the fact that scientific "truths" change constantly, and that real human tragedies (Thalidomide babies, e.g.) have resulted from public reliance on those so-called truths.

In the above process, I have demonstrated that this local controversy is not local at all, but instead is a part of a perilous problem which is global in extent. No on-site study, however intensive, can negate or by-pass the basic uncertainties, problems, and dangers involved in the who subject of radioactive waste. With this in mind, I can see no justification for a project which will introduce into a populated area a huge quantity of waste materials which are admittedly so hazardous that they should not be left where they created and are now located. Critics may not agree, and may ridicule and protest, but none have yet produced any proof that the scientists quoted, the situations or events described, or the conclusions drawn are wrong. No evidence has been presented to assure that this dump will be absolutely and forever without any degree of danger, that it can never leak or otherwise physically fail, and that no human being will ever sicken or die as a result of its existence. In the absence of such evidence, prudence dictates against creation of the dump. The whole populace should never be placed at risk for the economic benefit of a very few. Only a fool submits to unnecessary risk, and only the uncaring will request such submission.

None of this is new. Centuries ago an English poet wrote: "No man is an Iland, intire of it selfe; every man is a peece of the Continent, a part of the maine; if a Clod bee washed away by the Sea, Europe is the lesse, as well as if a Promontorie were, as well as if a Mannor of thy friends or of thine own were. Any mans death diminishes me, because I am involved in Mankinde. And therefore never send to know for whom the bell tolls. It tolls for thee." John Donne, 1573-1631.



WHAT IS THE MISSION OF OUR CHAMBER OF COMMERCE

In the Rules and By-laws as now written, the purpose, or mission of our Brackettville Chamber of Commerce, as stated in Section 2, is to advance the Commerce, Industry and General Welfare of Kinney County. Section 3 reinforces this statement when it emphasizes that eligibility for membership in the organization based on an interest in the "economic" well-being and the wealth and prosperity of Kinney County.

Economic well-being and general welfare are rather broad terms but it seems that they apply to all persons who reside in the county, or who may have an investment in real estate or a business enterprise. It also appears reasonable to understand that what ever action the chamber takes must be governed by a realization that majority interests must be served and satisfied. Representing the will of the majority is usually the most certain assurance of acting on behalf of the beneficiaries for their general well-being and economic concerns. This must include consideration for environmental factors.

In the recent confrontation between

CARE representatives, some of which are also members in good standing of the Chamber, it appears that the Chamber initially violated its own rules on the right of members to attend both regular and special meetings.

Article 6, Meetings, Section 2, states that each member should be notified 10 days in advance of called meetings, and informed of the business to be considered. Section 5 states that every member shall be entitled to speak on any subject brought up for consideration, in addition to having the right to vote.

It may also be true that some representatives of CARE expected too much if they were not Chamber members, and yet demanded admission to the meeting to voice their concerns over the planned speaker. As members, they were acting on their stated rights.

As for the Chamber's action in cancelling the annual banquet, that action was not necessary. It appeared to be a sad over-reaction that manifested itself when the board realized that its choice of speaker represented a conflict of interest in the

county-wide controversy over the proposed radioactive waste dump. The choice of speaker was unfortunate in this case as opponents, who appear to constitute a clear majority of the people residing in the county, did not see how this served the general well-being or economic interests of most of the people. The Chamber could have replaced the speaker without cancellation of the annual banquet. This action was not requested by the opponents to the speaker.

It is hoped that our Chamber will strive to live up to its adopted purpose, on behalf of all of the people, which is most often assured when the majority will is recognized and acted upon. To this end, communication must be improved.

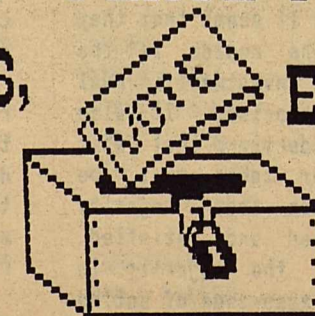

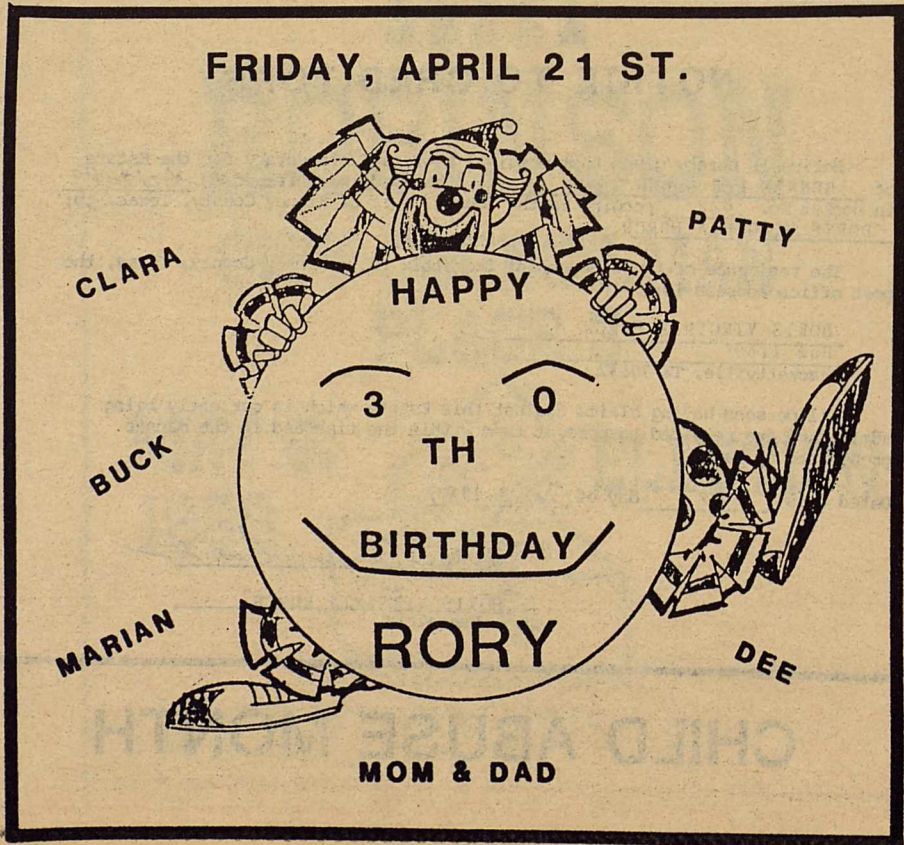

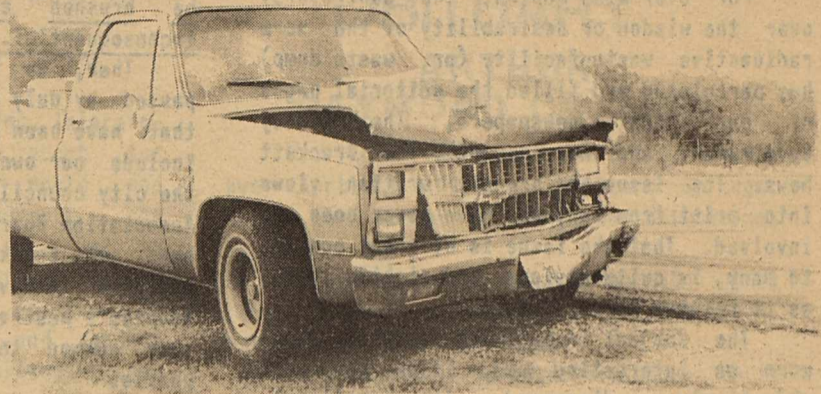

DEMOCRACY--ALIVE & WELL IN KC

For over nine months, the controversy over the wisdom or desirability of the new radioactive waste facility (or, waste dump) has percolated and filled the editorial pages of our local newspapers, The Kinney Cavalryman, and more recently The Brackett News. The issue has brought written views into print from many who have never been so involved. That the issue is of great concern to many, is quite obvious, and rightfully so, as it relates to our future.

The subject is becoming somewhat shopworn as interesting news. It has now been objectively discussed in emotional, economical, and scientific terms to the point that there seems little more to be said. Analytical dialogue appears to have run its course, because recent letters to the editors appear to be gravitating toward the undesirable lower level of questioning one's character or motives. The time has come, when we should all look at the evidence as best we can, and render a verdict based on our judgment of what is perceived to be right or wrong in the matter, as it may effect the future of our people and property. Decisive action should follow comprehensive dialogue!

The will of the majority is the cornerstone of our democratic formula for resolving controversial issues that confront us. The success of this concept relies on the acceptance of the verdict by those who are identified with the minority faction. Those in the majority camp must assume a greater responsibility for positive action and results on developments that clearly are in the best interest of all. When the system works in this fashion, the outcome is generally more favorable to both sides. Only then, can a spirit of cooperation prevail, and progress be realized on sound developments that will benefit most of the citizens of our county.

Now then, consider the evidence at hand. What is the majority view? In a recent press release, Senator Judith Zafferini, who represents our collective interests, declared that an "overwhelming" majority of our representative organizations, and residents have registered clear opposition to the waste facility. She concluded this after many months of investigative review and

discussion. This public stand by her cannot be brushed aside as inconclusive or inconsequential.

Then, we know of fourteen resolutions passed by duly elected representative bodies that have been published in opposition, to include our own county commissioners court, the city council, and the Fort Clark Springs Association Board of Directors. On the other hand, the Brackettville Chamber of Commerce postured in favor of the project, but then adopted a neutral stand, after realizing that they seemed to be out of step with the people.

The "Care" organization, created of necessity to speak for those who are not involved in government, other than as taxpayers, and voters, produced a petition with nearly 1400 signatures indicating opposition to the dump. This came about mainly from local contacts, with most rural residents not on record with their views.

By comparison, the evidence indicated a clear minority in favor of the project. No major organization, other than the promoters, have voiced approval of it. What over-riding evidence can be produced to change our perception of overwhelming opposition to the dump?

Finally, the question must be asked: "What statistical or factual evidence has been presented in all that we have heard or read that any kind of radioactive waste dump will truly benefit the surrounding economy, property values, environmental conditions, or the sense of well-being and progress in the area?"

The promoters, with the help of some who may or may not have a direct or indirect financial interest, have painted a rosy picture devoid of negatives. The care group has done much to educate us on the detrimental aspects. They have also presented case histories of similar facilities in other locations with very disturbing evidence of sorry negative consequences. The promoters have not been able to refute such documented cases, have they?

The challenge is this, to the advocates of the waste dump, show us one instance, one example, one such facility, that has a proven track record as an economic boon for the community at large, where such an operation

has existed for more than five years. convince us that state and federal authorities are supervising hazardous waste storage facilities to assure local citizens of permanent safety, normal economic growth, and a healthy environment. At this point, you seem to lack such evidence. Why should we take a chance on adverse results on the basis of your promotion which is in your financial interest but doubtfully in ours?

In conclusion, sufficient doubt has been created in the hearts and minds of a majority of Kinney County residents and surrounding areas. That a radioactive waste dump not be imposed on us by a minority with financial gain as their prime motive. This issue can only be laid to rest when the promoters realize they have erred and they bow out with grace and respect for our wishes.

As a newly elected member of the board of directors, Brackettville Chamber of Commerce, it is my sincere hope that positive action will be taken by the newly composed board to induce new business and small industry of an acceptable variety to make their home in Kinney County. We must build on our present assets, enhancement of tourism and our hunting activities, expansion of our retirement and family recreation complex at Fort Clark Springs, and an enviable environment offering clean air and water supply. We have a good beginning for a healthy economy in the future without taking chances on the quality of life.

It will be my personal goal to represent the personal ambitions of the majority to the best of my ability, on the highest plane of integrity and moral responsibility that divine guidance brings.
