

Borden County Landfill TO CLOSE

The Borden County Landfill will be closing as of October 7, 1995, if the EPA (Environment Protection Agency) does not approve a proposed rule change that will delay the implementation of Subtitle D for two years. The Borden County Commissioners' Court regrets having to take this action, but because of the high cost of the tough, stringent environmental standards dictated by the EPA Subtitle D this action was necessary.

Major EPA SUBTITLE D Regulations

- 1. Drilling and testing of groundwater monitoring wells
- 2. Financial assurance for thirty years after closing
- 3. Methane gas monitoring
- 4. Leachate disposal
- 5. Endangered wildlife assessment by qualified biologist
- 6. Stormwater runoff control
- 7. Benchmark surveying of site
- 8. Daily cover of waste
- 9. Permit modification to meet Subtitle D regulations by licensed engineer

If the EPA approves the rule change, the Borden County Landfill will remain open until the Subtitle D regulations take effect. This will allow the citizens of Borden County approximately two years use of their The EPA will announce the decision on the landfill. proposed rule change in 30 to 45 days (October 1, 1995).

The Borden County Commissioners' Court encourages anyone who would like to assist in getting the rule change approved to write or call their U.S. Congressman and/or U.S. Senator.



Southland Blanks Borden County 21-0

The Borden Coyotes' varsity team visited Southland, Friday, September 22, and were held scoreless by the Eagles. The Coyotes were unable to get much offense going and failed to reach the end zone. The Coyote defense played tough and held the Eagles to only 21 points.

The score at the half was 14-0 after Southland completed a 40 yard TD pass and a one yard plunge into the end zone.

It looked like Borden County would get into the end zone after Fernando Baeza ran 16 yards to the Eagle 5 yard line. The Coyotes were stopped short of the goal line in the next 4 plays. This was the only penetration of the 20 yard line for the Coyotes and they came up empty handed.

The Eagles scored their third TD early in the 4th quarter to make the score 21-0.

Oscar Baeza led the Coyote rushers with 13 carries for 51 yards and he had 15 tackles on defense.

Fernando Baeza carried the ball 16 times for 44 yards. He led the defense with 24 tackles.

Colt McCook completed 5 passes out of 12 for 53 yards.

Ryan Grant caught two passes for 25 yards. and

Grant Key had 11 tackles on defense.

Borden County managed 148 yards of total offense. The Coyote defense played well all night long. They held Southland to 262 total yards. The Eagles benefited from big plays that produced scores from 40 yards and 50 yards out.

The Coyotes played hard the entire game and never gave up. Although they played good defense against the speedier Southland offense, they could not seem to get any type of offense going of their own.

Junior Varsity Falls to the Southland Eagles 39-18

Borden County The junior varsity football team played host the to Eagles, Southland Thursday, Sept. 21. This was the second game for the JVs of the season and their home opener. Both teams entered the contest fresh off of shutout victories in the previous Mistakes week's play. proved to be the difference on a cold and rainy night as the Coyotes came up on the short end of a 39-18 final score.

The game started with the Coyotes choosing the wind to open the game and allowing the Eagles to start with the ball. After holding Southland to 2 yards on 3 plays, Borden County got the ball in good field position. The first of several Coyote mistakes happened on 4th down when they fumbled to thwart any opportunity in this drive.

Again, the Coyote defense held and forced a second Eagle punt. On this chance, the Coyote offense drove the ball 50 yards for the initial score of the game. The touchdown came by way of Clint Scott, as he followed the good blocking of the

The Coyotes scored again in the fourth period, this time by Robert Stamper who followed blocks by Lee Pepper and D.J. Smith to the end zone. The PAT failed over making the score 34-6.

Others seeing action were John Harding, James Bond, Georgie Vasquez, Ross Aten, Ryan Sanders and Carson Blagrave.

Coach's Comments:

The Pups played well and endured the elements. Everyone received plenty of playing time and had fun even though the coaches were freezing. front line, fullback, and quarterback to score on a 30 yard run with 9 seconds left in the 1st quarter.

In the 2nd quarter, the Eagles tied the score at 6-6 with a 50 yard TD run. The extra point failed.

At this time the wheels fell off the wagon for several minutes when the JVs gave the ball to the Eagles at the Coyotes' 18 yard line. Five plays later the Eagles had a lead of 13-6 that they did not relinquish.

The Coyotes fumbled the ball away on their own 22 yard line on the next series. Again, 5 plays later, the Eagles increased their lead to 20-6 with 45 seconds left in the half.

The Coyotes proved to be gracious hosts as they fumbled the ball away on heir own 8 yard line. Two plays later, the Eagles increased their lead to 27-6 at the half.

Borden County got the ball to start the 2nd half, but could do nothing with it and were forced to punt for the first time of the year. They would have taken over on downs near mid-field, but a late hit penalty enabled the Eagles to continue a drive that would not stop until they reached the end zone upping their lead to 33-6.

The Coyotes took over at their own 17 yard line and Clint Scott scored his 2nd touchdown on a 63 yard run behind a super play fake and great blocking. This cut the Eagles lead to 33-12.

The Coyote defense held the Eagles on downs, but a "roughing the punter" penalty allowed the Eagle drive to continue and it did not end until Southland reached the end zone for their final score of the game reaching a 39-12




