



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF Brackettville


















TRACKS
ALONG THE
TRAIL

The highest water fall in Texas is Capote Falls, which is located about fifty or sixty miles northwest of Presidio, in Candleria, Texas. After obtaining permission from the owner of land, on which the falls is located, we drove from Marfa to Big Bend National Park and up river to Candleria, Texas. Here we turned onto the private road of the ranch. After passing through miles of petrified wood and lava flow, we arrived at the ranch headquarters.

The temperature at the time was 109 degrees in the shade, and our gracious hostess supplied us with a

much appreciated, cool drink of water.

We then drove up the creek bed as far as our four-wheel drive would take us, because of the narrow canyon walls, and the immense boulders in the creek bed we were forced to go the rest of the way by "shanks mare".

We had walked, and scrambled up the creek, and over boulders for about three and one half miles when we finally heard the sound of the falls. After a little more wading we saw at last the allusive Capote Falls.

The falls are very beautiful, and drop from the top of the cliffs to the bottom of the canyon floor in two stages.

Since the heat of the summer day was so intense we decided to go for a dip just to cool

off. At the bottom of the falls is a pool, which is formed by the overflow of the falls, from there the water then flows into a stream. The canyon walls are solid rock, with tops that look like drapes. The word "Capote" means "skirted" in Spanish which described the canyon walls perfectly.

About sundown we walked and scrambled back down the creek to our vehicle. We decided to camp there for the night. While we were eating our evening meal, I felt as if I was being watched closely by someone or something. I turned and saw there on a ledge of one of the many cliffs was an old billy goat watching us. He looked like a little old man with a long white beard. I suppose we were a curiousity to the old fellow also.

We broke camp the next day and drove down river to the Hot Springs.

As we need to try and restore our tired and aching muscles.

PROTECT YOUR PETS FROM COLD WEATHER

The cold weather we have been experiencing puts us in the mood for the Christmas holidays. We do not need, however, to forget our pets and special care, such as shelter and adequate

nutrition, should be given to protect family pets from wintertime hazards during the extremely cold months.

Winter temperatures in this area are not at such extremes that animals accustomed to staying outdoors will be hurt. If your pet can seek shelter that keeps out chilling winds and covers frozen gound, it should be adequately protected.

Animals that are very young or very old should probably not be kept outdoors. Healthy animals can tolerate cold weather. More food may be needed because pets need more calories to produce body heat. The daily water supply

should also be checked to make sure it is clean and does not stay frozen for long periods of time.

Along with cold weather care, pets should be checked for internal and blood parasites such as heartworms and vaccinations are up to date.

WINTERIZE YOUR LAWNMOWER

Now is also a good time to winterize your lawnmower. Here are some winter maintenance tips for lawnmowers that may lead to more efficient operation this spring.

- --Operate the engine until it runs out of fuel or drain the fuel tank and carburetor. Gasoline left in the tank or engine, will evaporate and leave varnish and gum which may clog small carburetor openings and lines.
- --Drain and replace crankcase oil while the engine is warm. Use fresh oil as recommended in the owner's manual.
- --Remove, clean, regap and replace the spark plug.
- --Clean the entire mower, including the engine cooling fins.
- -- Clean or replace the air filter.
- --If you store the lawnmower outside, it would be a good idea to cover it with a waterproof sheet.



#### EPA

United States Attorney Timothy D. Leonard and United States Environmental Protection Agency (EPA) Regional Administrator Robert E. Layton Jr., announced today that a Federal Grand Jury in Oklahoma City returned a forty-eight count indictment charging two former city employees of Enid, Oklahoma with violations of the Clean Water Act and making false statements to the government.

Raymont T. Brittain, former Superintendent of Public Utilities, and Robert C. Coble, former Water Pollution Control Plant Supervisor, have been charged with thirty counts of violating the Federal Clean Water Act and eighteen counts of falsifying federal reporting forms. The indictment charges that the two men were responsible for the discharge of raw sewage from the Enid sewage treatment plant into Boggy Creek. Each count carries a possible prison sentence of up to one year and/or a fine of up to \$25,000 per day of violation.

The indictment further charges that Brittain and Coble falsified the discharge monitoring reports which provided documentation to the EPA for determining the city's compliance with the limits set in the plant's waste water discharge permit. these violations are punishable by a sentence of up to five years and/or a fine of up to \$10,000 per violation.

If convicted, the application of the alternative Fines Act can collectively increase the total fines to \$7.5 million. In addition, each faces a total of 120 years in prison.

The indictment is the result of an investigation led by Special Agents of the Environmental Protection Agency's Office of Criminal Investigation and was jointly investigated by the Federal Bureau of Investigation, with assistance from EPA Region 6 Water Management Division and Environmental Services Division, and attorneys from both the United States Attorney's Office and the EPA.

# REFLECTIONS BY PRESTON TAYLOR FIRST BAPTIST CHURCH


Do you like the Christmas story? Most people do. Gifts, decorations, music, tangy meals and even ugly sights and sounds are a part of this season. What does it really mean?




