EMERGENCY FARM LOANS

Applications for emergency farm loans for losses caused by tornado on May 17, 1989 are being accepted at the Farmers Home Administration (FmHA) office located in Uvalde, FmHA County Supervisor Edmund L. Persyn, Jr. said today.

Kinney, Edwards, Uvalde, Val Verde, Maverick, and Zavala Counties were recently named by Secretary of Agriculture Clayton Yeutter as eligible for loans to cover part of actual production losses resulting

Persyn said farmers may be eligible for loans of up to 80 percent their actual losses or the operating loan needed to continue in business or \$500,00, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest rate is 4.5 percent.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FmHA emergency loan," Persyn said. Farmers participating in the PIK or Federal Crop

Insurance programs will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be August 1, 1990 but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season," Persyn said. FmHA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens and to farming partnerships, corporations or cooperatives in which U.S. citizens hold a majority interest.

The FmHA office in Uvalde is open from 8:00 a.m. to 5:00 p.m. Monday through Friday.

4-H REACHES YOUTH IN MANY WAYS

Today's 4-H program is noted for its flexibility, a feature that makes it the largest youth serving organization in the country.

4-H is flexible because it is organized in different ways, for different needs, in different places. Organization may take the form of community or neighborhood club, a project club, a special interest group, or special activity. Young people may take part in 4-H through any or all of these.

The community 4-H club is associated with an area known to local people like a small community, a particular section of a town, or other area. The number of 4-H members in a club may range from five or six to more than 100. This type of 4-H club continues from year to year. Boys and girls belong to the club, enrolling in projects according to their interests.

4-H projects offer an opportunity for youth to make critical decisions to aid in later life. Through planning and carrying out a project, youths learn to apply these decisions to real-life problems.

In a project involving raising any animals, the member must do the following:

--compare and contrast animals as the basis for deciding which to keep or cull, to breed or to buy. Basic training of this nature is done in livestock judging.

--identify characteristics of individual animals that qualify or disqualify as certain breeds or species.

--learn nutritional ration ingredients needed for health and growth and identify animal parts and their functions.

--use previous experience and subject matter learned to recognize health problems and courses of action needed to be taken.

--identify errors through recognizing and correcting mistakes such as incorrectly identifying the breeding cycle or gestation period of an animal can cause a loss of productivity and money.

4-H offers parents, as well as youth, an opportunity to grow, to develop, and to learn. So, actually, 4-H is for parents, too. If you are interested in the 4-H program in Kinney County, call or come by the Kinney County office of the Texas Agricultural Extension Service located on the 2nd floor of the county courthouse.



The Cavalry Officers' uniform of the 1880's was typical as pictured. The grayish, or very light tan hat, was not used except during this period, and not during earlier periods, as shown in numerous movies. The coat is nearly the same color, blue almost black, as the navy P coat of world war II and later periods, and made of wool. Current Army dress blue coats are the same color. The trousers are sky blue, with a Cavalry yellow one and one



half stripe on the sides. Note the embroidry on the coat. This uniform was for all seasons. worn with long handles, made of wool.

ILLEGAL **IMMIGRATION**

Update on the latest activities of the Commission for the Study of International Migration and Cooperative Economic Development legislation. This commission was created by an amendment I authored to the Immigration Reform and Control Act of 1986 (IRCA), to address the international economic aspects of illegal immigration into the United States: the poor economic and political conditions in other countries around the world that lead people to come here illegally in search of a better life, and what might be done to alleviate those

Addressing the illegal immigration dilemma through economic development, trade, and investment has been a strong interest of mine since I came to Congress. A view of the immigration problem as simply a domestic problem in the United States is an incomplete view.

Most recently, on December 7-10, the Commission conduced a bi-national conference on U.S.-Mexico border industrialization at the Woodlands, Texas. there could not have been a more opportune time to address this issue given Mexico's recent efforts to open its domestic improve its international competitiveness, and spur its domestic economic growth. Because the U.S. and Mexico are so interrellated economically, there are tremendous opportunities to help improve the Mexican economy, as well as our own, through trade, investment, and economic development policies.

Because of your continued interest in implementation of IRCA, I want to inform you of recent measures to address some continuing problems. Congress recently passed legislation allowing states to use State Legalization Impact Assistance Grants (SLIAG) reimbursement funds for public education and outreach to assist with adjustment of status to permanent residency and for public education to reduce employment discrimination. And the Immigration Subcommittee will soon consider family unification legislation intended to help prevent spouses and minor children from being separated from eligible immigrants legalized under IRCA.



Before the 19th century and during much of it the yellowstone area was Indian country. The Bannock, Blackfoot, Flathead, Nez Perce, Ute, Crow, Shoshone, Piegon, and the Paiute Tribes lived all around the area know as yellowstone.

They moved back and forth through the area, hunting and fishing but they would not stay in the area because of the weird bubbling mud holes, hot springs and roaring spouting water.

Only the sheepeaters lived in the area permantely. They were branched off from the Shoshone tribe. They lived in the northern part of the area because that was where the mountain sheep lived.

In 1871 they moved to the Gardner Wind River Reservation in Wyoming. The impressive features eight hundred feet deep Sheep Eater Canyon and Towering Sheep Eater cliffs were named for this tribe.

Coulter was the first white man to see the park but since he, a rough illiterate man he was not believe when he told about the Park. In all the local papers they called the park Yellowstone - "Colters Hell" and for several years it was considered a figment of Colter's imagination.

The trappers that passed through Yellowstone were noted for their tall tales so they weren't believed either, Jim Bridger elaborated on the truth, saying if he would be called a liar he might as well accomadate his listeners.

Through expeditions and photographs people began to listen especially about the Hayden and Washburn expeditions and the United States Army Corps of Engineers survey.

Finally on March 1, 1872 a park bill was promoted by members of the two expeditions and western Congressmen and passed both houses of Congress and was signed by Ulysses S. Grant with the following words; "Dedicated and set apart as a public park of pleasuring-ground for the benefit and enjoyment of the people" and the first National Park was born. I have been to the Park twice, once in 1924, and again in 1961. This amazing jewel of a place should be seen by everyone if possible.

CITY OF BRACKETTVILLE

The City of Brackettville's landfill (Dump) will be closed Monday, Tuesday and Thursday starting January 22, 1990. Winter hours for the landfill on Wednesday, Friday, Saturday and Sunday are 8:00 A.M. to 5:00 P.M. and the summer hours are 9:00 A.M. to 6:00 P.M.. LOW-INCOME HOUSEHOLDS MAY BE ELIGIBLE FOR ENERGY ASSISTANCE

Austin- Some low-income Texans may be eligible for help in paying heating bills this winter through the Home Energy Assistance Program, according to Texas Department of Human Services Commissioner Ron Lindsey.

Lindsey said the one-time payment is available to many low-income households. Applications for energy assistance were mailed to households that received food stamps, Aid to Families with Dependent Children, or Supplemental Security Income in December. Other low-income individuals may request an application by calling the toll-free number 1-800-252-8060 during the enrollment period of January 22, through February 28.

Eligibility is limited by gross income and resources. Aid is available for a one-person household having less than \$589.49 gross income per month. The gross income limits are \$781.49 for households of two people, \$973.49 for three, \$1,165.49 for four, \$1,357.49 for five, and \$1,549.49 for six.

Households are eligible if the cost for heating is included in the rent payment or if the household pays a portion of its home energy costs.

Energy assistance checks are sent directly to the people who are eligible for assistance. However, the checks are made payable to the energy provider.

People receiving one of these energy assistance checks should mail it or take it in person to the energy provider business office with their regular energy bill. The check can be cashed only by the energy provider. If the HEAP check is more than the energy bill, the additional amount will be credited to the person's account for the next month's bill. If the energy bill is higher than the check, the person is responsible for paying the difference.

FIRE DEPARTMENT


The Brackett Firemen responded to two calls this week. One was on Sunday, January
