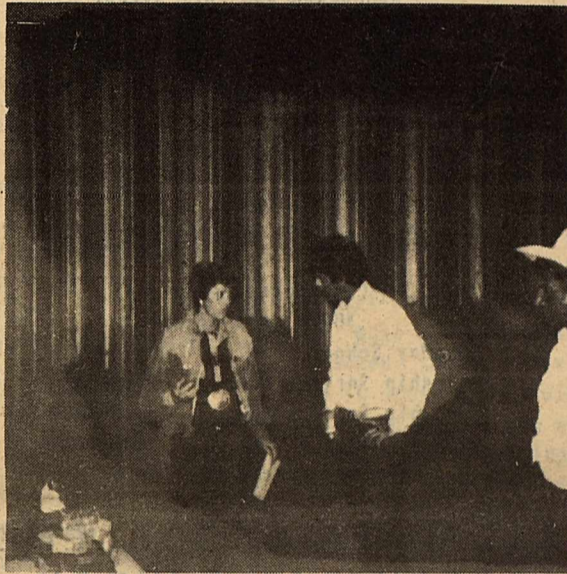

UPWARD BOUND FIELD TRIP

On March 10, Saturday, the Upward Bound group went to the Mo Ranch at Hunt Texas to take part in a confidence course that they offer.

The Brackett group left Brackettville at 5:30 AM and joined the rest of the other U.B. kids and counselors in Uvalde. They all, left there at 7:00 and arrived at Mo Ranch at 9:00 AM.

At the ranch, they met with the ranch employees and proceeded with the confidence course.

First the kids had to learn to trust one another. Individual's trust in the group was accomplished by a trust fall- which is where a person stands and falls into the groups arms. This was a very difficult accomplishment. From here the group proceeded to get each other over a wall of wood called the Berlin Wall and across what was called the pit of lava. For the pit of lava the kids used a rope and for the wall they could only use their brains. This made up the low elements of the confidence course.

After lunch the group proceeded to the high elements which is more for the individual confidence. In the individual high elements no one is forced to participate. All of the individuals use protective gear which they were taught to use by the Mo ranch employees. Every precaution is taken so that if there is a slip or fall the individual is protected.

There were three elements in the high confidence course. One contained 2 telephone poles, about 8 yards apart, with 3 cable ropes running between them. One cable was for walking on while the other two were at waist level and used for balance. To get to the wires, the individual climbed an inclined pole from the base of one upright pole to part-way up the other pole. The individual then climbed the rest of the pole and proceeded to cross on the wires. Safety harnesses were attached to the individual at all times. The confidence measure task was in crossing the wires and relying on the group members below, who were controlling the safety harness.

The second confidence task involved the same situation except that there was only one waist high rope for balance.

The 3rd task involved a trapeze. A person climbs a pole and then jumped from the pole to a trapeze. The individual then swung on the trapeze and then were let down by safety harnesses.

This confidence course is designed to be used by all age groups using some modifications in some elements.

The group returned to Uvalde then proceeded to their own towns. The Brackettville group arrived home at 9:00 PM.

## LIBRARY NEWS

Have you ever wondered how our beautiful Kinney County Public Library came into being, and who were the public-spirited persons who made it possible?

HISTORY OF KINNEY COUNTY PUBLIC LIBRARY  
PART ONE

In 1958, when Mrs Glee Utterbach became President of the Kinney County New World Study Club, she suggested members bring books to share with one another. The Study Club had raised funds to purchase the old frame Baptist Church of use as a meeting place, and it became their "Bookshelf." Mr. Raymond Fuentes built bookshelves, and members brought their books. This informal arrangement continued for eight years.

In 1966 Mrs. Charlotte Goleman volunteered to classify and catalog the books the Study Club had collected. Mrs. J. Lee Ballantyne moved that the book collection be opened to the community as a public library to be operated as a Club project. Miss Elsa Sauer seconded this motion. The School librarian provided counsel and advice on how to design a filing system and which items should be purchased for the new library. Other volunteers were Mrs. Leo Glasgow, Mrs. Bob Walkup, and Mrs. Laura Seargeant.

Brackettville now had a Public Library, which was open three days each week from 3:00 p.m. to 6 p.m., operated by volunteers. During the year, as community interest and needs grew, the Study Club made an appeal for volunteer help and book donations. The Lions Club built two more large bookcases and a book drop for the old building.

In 1973 Mrs. Goleman, Mrs. Joe York, and Mrs. Richard Getz, San Antonio Library Super-

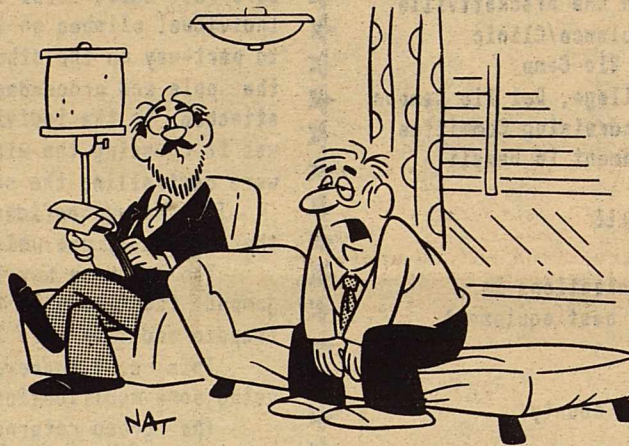
visor, attended a Kinney County Commissioners' meeting, and discussed the needs which could be met and the benefits which would be brought to the community by having their public library affiliated with the Texas State Library System and the San Antonio Area Library System. The Commissioners voted to grant \$50.00 per month to pay utilities, postage, and other supplies for our Library, in order to qualify it for membership.

### NOTICE OF TARIFF CHANGE TO CENTRANET® SERVICE

GTE Southwest Incorporated gives notice of its proposed tariff changes to CentraNet® service, which is a Central Office-based service that provides PBX-type features to multi-line business customers and is currently being offered in all company wire centers where such facilities exist to provide the service.

The Public Utility Commission of Texas approved a generic tariff for CentraNet® service up to 100 lines in Docket No. 7652. The proposed tariff revision would establish specific rates for CentraNet® service involving 101 to 400 lines. Other proposed revisions involve the rate applicable to changes, additions, or deletions to the data bases and a new rate is proposed for additional trunks.

The names of the three CentraNet® packages have changed from Standard, Premium, and Deluxe to CentraNet® 1000, CentraNet® 2000, and CentraNet® 3000, respectively. Direct Call Pickup has been added to the three CentraNet® packages while Multiple Call Park and Shared Speed Call 30 have been added to CentraNet® 2000, and Speed Call 30 and Call Forward Busy/No Answer Split have been added to CentraNet® 3000. Flexible Night Answer and Automatic Route Selection also have been added as new optional features.

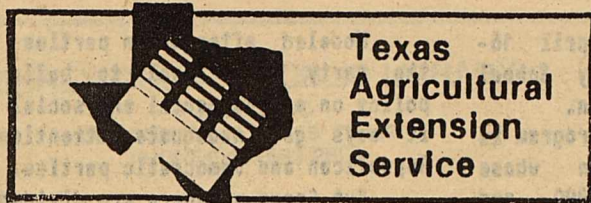
The proposed changes and new service offerings have been assigned Docket No. 9251, and pursuant to Section 43(d) of the Public Utility Regulatory Act will become effective June 23, 1990. Rates for service will be applicable to customers who subscribe to the service as well as existing customers. Therefore, there will be no effect on any other rates of the company. The company's gross annual revenues will increase by approximately \$399,600, or less than one percent annually.

The proposed rates are on file with the Public Utility Commission of Texas, and are available for public inspection at the offices of GTE Southwest Incorporated. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. The deadline to intervene in this docket is 3:00 p.m., April 9, 1990.

**GARDENING TIME!!**

Well, gardening time is upon us. Vegetable gardeners planning on producing a bumper crop should begin their spring preparations by instituting a soil insect control program.

There are many factors that we as gardeners simply have no control such as rainfall or lack, humidity, and other environmental factors. But there are a number of things the home gardener can do to help insure vegetable production in the garden. Site selection is important but so is an insect control program.

The initial step to defeating soil insects is mixing insecticides into the soil at a depth of 4-6 inches at least two weeks before the garden plot is planted. If you choose not to do this step, soil insects can reduce vegetable quality and yields.

Destructive soil insects include wireworms, white grubs, seed corn maggots, cabbage maggots, mole crickets, sowbugs, slugs, snails, and cutworms. Some destroy plant seeds, roots, tubers, and underground stem parts while others cut off young plants at or near the soil surface.

Diazinon 25 percent liquid concentrate or Spectracide 6000 applied as a 5 percent granule provide the best results for controlling soil insects. Broadcasting 5 percent Seven bait over the soil surface can help control cutworms or sowbugs if they become a problem after the garden has been planted.

Garden sites planted for the first time or those previously in grass or weeds are more likely to harbor damaging numbers of soil pests. Before treating with an insecticide, inspect the garden site by taking soil samples at several locations to a depth of 5 to 6 inches. Remove one square-foot section of soil from each location and record the number of soil insects present. As a general rule, an average of one or more soil insects per sample suggests the need for an insecticide treatment. Always thoroughly read and follow all label instructions before applying insecticides. Reference to commercial and/or trade names is made with the understanding that no discrimination or endorsement by the Texas Agricultural Extension Service is implied.



Southwestern Bell Telephone Company hereby gives notice that it has filed an application requesting the PUC to declare Southwestern Bell's intrastate Billing and Collection market subject to significant competition and to authorize the following form of pricing flexibility: detariffing of the rates, terms and conditions of the Billing and Collection services now offered in Section 8 of Southwestern Bell's intrastate Access Service Tariff. Approval of the application as filed would result in all tariff sheets in Section 8 (Billing and Collection) of Southwestern Bell's Intrastate Access Service Tariff being cancelled, and the service thereafter being provided on a contract basis. Through this application, using procedures established by P.U.C. SUBST. R. 23.27, Southwestern Bell seeks to obtain uniformity of rates, rules and regulations for intrastate and interstate Billing and Collection services.

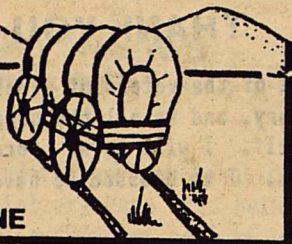
Approval of this application would remove all rates, terms and conditions applicable to billing and collection from Southwestern Bell's Intrastate Access Service Tariff. Intrastate billing and collection service would continue to be subject to PUC regulatory oversight only to the extent that (1) Southwestern Bell would be required to maintain current price lists at the Commission for the service, and (2) the revenues or losses from the service would be subject to the regulatory treatment specified in P.U.C. SUBST. R. 23.27(p). Further, under procedures established by P.U.C. SUBST. R. 23.27, the PUC's General Counsel, the Public Utility Counsel or any affected person could seek a subsequent review of the rates, terms and conditions of this service.

## TRACKS ALONG THE TRAIL BY DORTHY PAYNE



After he graduated from West Point in 1852 as a second lieutenant Phillip H. Sheridan was sent to Fort Duncan on the Rio Grand near Eagle Pass, Texas. In 1855 either as a visit or on duty at Fort Clark he was asked to tell his fellow officers in the mess hall how he liked Texas. His reply was, "if I owned Texas and Hell I would rent out Texas and live in Hell."

In the 1850's Texas was sparsely populated and was the butt of rude humor. Judge Richard B. Levy of Texarkana, said Albert Sidney Johnson heard about the famous quotation while stationed in Texas as a colonel of infantry, Judge Levy himself was stationed at Fort Clark during the Spanish-American War and frequently heard the quotation while there.

The saying was not generally quoted until after the Civil War when Sheridan was a general. The story gives that General Sheridan made the remark while on an inspection tour when he was commander of the southwestern Military Department. But long before Sheridans time Texas had been associated with Hell in southwestern humor.

After David Crockett of Tennessee was in Congress in 1834, he wrote in his autobiography; "I put the ingredient in the cup pretty strong, I tell you, and I concluded my speech by letting them know that I was done with politics for the present, and that they might go to hell and I would go to Texas. So "Hell and Texas" became a mild cuss word term and took its place in southwestern vocabulary in the 1830's

## AMERICAN GREENS FORMULATE PLATFORM FOR NATIONAL PARTY

NEW YORK (AP)- A variety of activities on environmental, energy and social issues are drafting a political program to create a national Green political party as early as next year, organizers say.

Modeled after Green parties in Europe, the party would seek to build nationwide policy on environmental and social issues that it says get inadequate attention from the Republican and Democratic parties.

But Green planners are divided on whether there new party should make an early run at national office, traditionally almost impossible for American third parties, or first concentrate its efforts on capturing local and state offices.

The Green Committees of Correspondence, a federation of about 200 groups nationwide, mailed a 36-page list of proposed stands to 3500 people this fall, said Jim Richmond, coordinator for the group's national clearing-house in Kansas City, Mo.

The Greens, as they call themselves, plan to ratify the final platform at a September 1990 meeting in Boulder, Colo. Meanwhile, the 200 groups are planning regional meetings to debate stands on 19 issues, including land use, water, social justice, energy, health, education and finance.

"It's activists and just regular folks of all stripes who are concerned what direction this planet is headed in," Richmond said of the 4-year-old group.

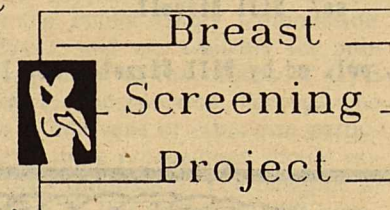
"The centerpiece is to rethink our relationship to the earth," said John Rensenbrink, professor of political science at Bowdoin College in Maine, another organizer.

A handful of people guide the group, which opposes the concept of hierarchy. Decisions are made by committees of representatives, and a national leadership probably will not be chosen until the U.S. Greens jump into politics, he said.

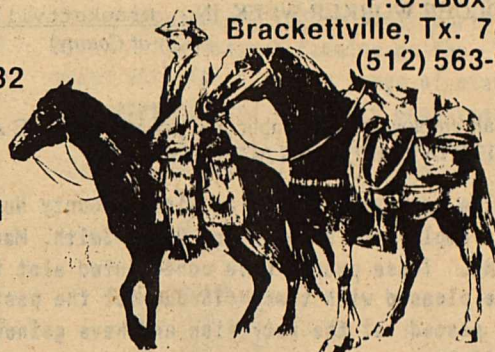

**PRODUCTIVITY APPRAISAL**



**MAY LOWER THE PROPERTY TAXES  
ON YOUR FARM, RANCH, OR TIMBERLAND**

Texas law provides farmers and ranchers, and timber growers with a way to lower their property taxes, known as productivity appraisal.

If you qualify, your agricultural land will be taxed on its capacity to produce crops, livestock, or timber, instead of its value on the real estate market. Productivity appraisal can lower the taxable value of your land, and lower your property taxes as a result.

If your land has never received productivity appraisal, you must apply to the appraisal district no later than Monday, April 30, to get

tax benefits for 1990. If you miss this deadline, you may still be able to apply, but you will pay a penalty. Check with your appraisal district office.

If your land already receives agricultural or timber appraisal, you normally don't need to reapply unless the chief appraiser requires you to. If an annual application is required, the appraisal district will notify you by mail.

**HOMESTEAD EXEMPTIONS**



**MAY LOWER YOUR HOME'S  
PROPERTY TAXES**

A homestead exemption lowers the property taxes on your home by lowering its taxable value. For example, if your home is valued at \$50,000 and you receive a \$5,000 homestead exemption, your home will be taxed as if it were worth only \$45,000.

You qualify for a homestead exemption if you owned your home on January 1 and used it as your primary residence on that date. It doesn't matter whether your home is a house, a condominium, or a mobile home.

Exemptions are available to all homeowners to lower their school taxes. Additional exemptions are available to homeowners who are disabled or age 65 and over. And, if you receive the over-65 exemption, you also qualify for a ceiling on school taxes. Other exemptions may be offered to homeowners by school districts, counties, cities, and special districts.

Who should apply? If you received a homestead exemption on your home in 1989, you won't need to

re-apply for 1990 unless your chief appraiser requires it.

If you became 65 or disabled before January 1, file a new application to receive the additional exemptions.

If you haven't received an exemption on your present home, or if you've moved to a new home, make a new application for 1990.

File your homestead exemption with your local appraisal office at the address shown below.

The last day to file for applications is April 30, 1990. Contact your appraisal district before then if you need more time to file.

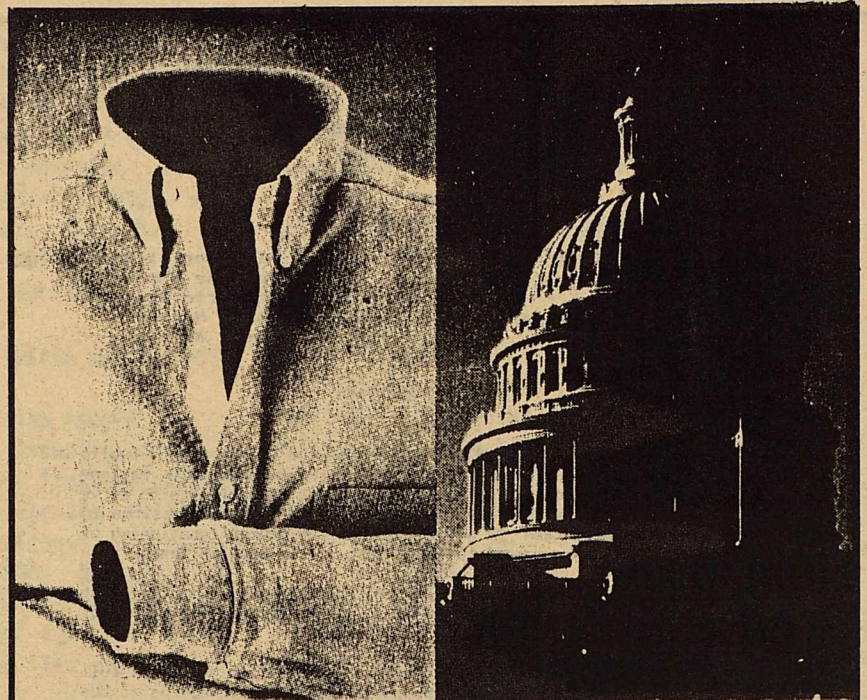

This trooper in the foreground is wearing the winter O.D. uniform with dress cap. At this time, leggins with leather to the inside, not boots, were issued to enlisted mounted personnel. Other than the leggins and breeches, this uniform was standard enlisted issue except for minor changes until the mid 1950's, when the army green was adapted. The enlisted brown garrison belt was discarded at the beginning of World War II. In the background, the wooden two story building was typical of enlisted barracks design and structure when stone or brick was not used. At the beginning of the buildup for World War II,

thousands of buildings near to construction and design as this one, were built as temporary for the duration of the war. However, if you have ever been on Fort Sam Houston, or Lackland AFB, you can view many of them still in use.
