





PUC GRANTS CPL RATE INCREASE

The Public Utility Commission today authorized Central Power and Light Company to collect a \$105 million stipulated increase, subject to refund pending final determination by the commission.

The increase is the first step of a twostep, \$264 million settlement of CPL'S rate case. The agreement was reached in February between CPL and substantially all intervenors in the case. On March 16, a PUC administrative law judge recommended approval of the increase. The now rate represents a 13percent increase over current bills on a systemwide basis. Today's vote was 2 to 1 in favor, with Commissioner Jo Campbell dissent-

"The commission's implementation of the first-step rate increase preserves the settlement that the parties have worked so hard to reach. It signals what we hope is the beginning of the end to a long, complicated and expensive rate case," Said Bob Carey, CPL president and chief executive officer.

A residential customer using 1,000 kilowatt-hours of electricity a month will see about a \$10 increase on the monthly bill. Winter bills will increase from the current bill of \$62.41 to \$73.51. Summer bills will go from \$68.61 to \$79.34. The increase becomes effective today (March 21).

Final commission approval on the merits of permanent rates for the first-step increase is not expected until later this year.

With approval of the stipulated firststep increase, two new programs for industrial and commercial customers become effective.An economic development rider gives discounted demand charges for new or expanded loads in certain industries of 600 kilowatts or more. Another program, called the Commercial Average Monthly Payment Play or CAMP, allows commercial customers in certain rate classes to average their electric bills over a 12-month time frame.

Also being put into effect is an economy service rate for residential customers who use 500 kilowatt-hours of less a month. The new rate will allow those customers to pay rates similar to what they pay now.

Implementation of the new rates also extends the summer billing season for residen-

tial customers to eight months, instead of six, to track more closely the actual use of air conditioning and heating in South Texas. The summer season starts with meters read Feb. 19- March 19 and concludes with meters read Oct. 19-Nov. 19.

The settlement package calls for the \$105 million increase in March 1990 followed by a 120 million, 13 percent, systemwide increase effective January 1991. CPL must file a second rate case this spring and gain PUC approval before the second-step increase can be implemented. Base rates would then be frozen through 1994, except in the case of specific, unusual circumstances. Fuel costs would continue to be adjusted as necessary according to PUC regulation.

"Approval and implementation of the full settlement would save millions of dollars of rate case expense over the coming years," Carey said. "It would also mean stable, predictable rates for our customers."

In February 1989, CPL requested a \$464 million, four-year phase- in of rates to recover its investment in the South Texas Project nuclear plant and other costs of doing business. Both units of the 2,500 -megawatt plant are in full operation.



NOTICE OF TARIFF CHANGE TO CENTRANET® SERVICE

GTE Southwest Incorporated gives notice of its proposed tariff changes to CentraNet® service, which is a Central Office-based service that provides PBX-type features to multi-line business customers and is currently being offered in all company wire centers where such facilities exist to provide the service.

The Public Utility Commission of Texas approved a generic tariff for CentraNet® service up to 100 lines in Docket No. 7652. The proposed tariff revision would establish specific rates for CentraNet(R) service involving 101 to 400 lines. Other proposed revisions involve the rate applicable to changes, additions, or deletions to the data bases and a new rate is proposed for additional trunks.

The names of the three CentraNet® packages have changed from Standard, Premium, and Deluxe to CentraNet® 1000, CentraNet(R) 2000, and CentraNet® 3000, respectively. Direct Call Pickup has been added to the three CentraNet(R) packages while Multiple Call Park and Shared Speed Call 30 have been added to CentraNet(R) 2000, and Speed Call 30 and Call Forward Busy/No Answer Split have been added to Centra Net (R) 3000. Flexible Night Answer and Automatic Route Selection also have been added as new optional features.

The proposed changes and new service offerings have been assigned Docket No. 9251, and pursuant to Section 43(d) of the Public Utility Regulatory Act will become effective June 23, 1990. Rates for service will be applicable to customers who subscribe to the service as well as existing customers. Therefore, there will be no effect on any other rates of the company. The company's gross annual revenues will increase by approximately \$399,600, or less than one percent annually.

The proposed rates are on file with the Public Utility Commission of Texas, and are available for public inspection at the offices of GTE Southwest Incorporated. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. The deadline to intervene in this docket is 3:00 p.m.,

April 9, 1990.

Texas Agricultural Extension Service

If you had peach blossoms that withstood any late cold weather, have you thought about doing any thinning? Despite conclusive evidence that thinning is beneficial for all peaches and absolutely necessary for early peaches, it is one of the most unpopular task a homeowner does. Trees can be loaded down with peewee sized fruit of limbs broken down under the weight of unthinned fruit.

Peach thinning increases fruit size, improves fruit color, reduces limb breakage, allows better pest control, and contributes to tree vigor.

Timing is the key element in peach thinning. The earlier that peaches are thinned, the greater the dividends. Bloom thinning is best for most midseason of late peaches. Remember. After pit hardening, thinning doesn't do much good.

Thin mid and late season peaches in the

dime size fruit stage, You will find a bigger, healthier, crop or fruit with less tree problems.

First, homeowners should not grow tomatoes unless they can be placed in an area that receives sunlight for a least six hours a day. Tomato plants placed between tall shrubs, under trees, or between building imply will not produce a crop.

Second, good soil is essential for good growth and high yields. Often, poor soil can be improved with liberal amounts of organic matter and by proper fertilization.

If only a few tomato plants are to be grown, a space at least two feet square should be prepared for each plant. The soil should be worked to a depth of at least 12 inches. Liberal amounts of organic matter and a small amount of fertilizer such as 10-20-10 or 12-24-12 can be mixed into the soil where the plant is to be grown. Variety selection is of utmost importance and is one of the keys to growing tomatoes successfully. There are many varieties that resist many of

the common diseases. President, Celebrity Big Set, Carnival, or the small fruited Small Fry of Cherry Grande are excellent for this area.


When you buy p;ants, check for suspicious spots on the leaves which could be one of the many foliage diseases that are common on tomatoes. Short, stocky, darkgreen plants are best.

When the transplants are set in the garden, they should be planted somewhat deeper than they were originally growing. Plants grown in peat pots or peat blocks should not be removed, but rather the entire container planted. Whatever you do, do not disturb the root system. Mix two teaspoons of a complete fertilizer in a gallon of water and apply a cup in the hole prior to planting.

For best results, set transplants out on cloudy days or late after noon. The pants should be protected from adverse weather conditions such as high winds or excessive heat for a week or two after planting. You should cage of stake almost all varieties for better harvesting. Any method to keep the fruit off the ground is desired as to prevent fruit rot.




Southwestern Bell Telephone Company hereby gives notice that it has filed an application requesting the PUC to declare Southwestern Bell's intrastate Billing and Collection market subject to significant competition and to authorize the following form of pricing flexibility: detariffing of the rates, terms and conditions of the Billing and Collection services now offered in Section 8 of Southwestern Bell's intrastate Access Service Tariff. Approval of the application as filed would result in all tariff sheets in Section 8 (Billing and Collection) of Southwestern Bell's Intrastate Access Service Tariff being cancelled, and the service thereafter being provided on a contract basis. Through this application, using procedures established by P.U.C. SUBST. R. 23.27, Southwestern Bell seeks to obtain uniformity of rates, rules and regulations for intrastate and interstate Billing and Collection services.

Approval of this application would remove all rates, terms and conditions applicable to billing and collection from Southwestern Bell's Intrastate Access Service Tariff. Intrastate billing and collection service would continue to be subject to PUC regulatory oversight only to the extent that (1) Southwestern Bell would be required to maintain current price lists at the Commission for the service, and (2) the revenues or losses from the service would be subject to the regulatory treatment specified in P.U.C. SUBST. R. 23.27(p). Further, under procedures established by P.U.C. SUBST. R. 23.27, the PUC's General Counsel, the Public Utility Counsel or any affected person could seek a subsequent review of the rates, terms and conditions of this service.

"Nutria", which is a Spanish word for otter, is the trade name for the reddish brown fur of a large semi-aquatic rodent known as the "coypu". He has partially web hind feet and a long naked, round scaly tail. He is ratlike in looks and beaverlike in size, sometimes called the "beaver rat". In fact in times past he was exhibited in traveling shows as a giant rat. He weighs about ten pounds and is twenty inches to two feet long.

Mrs. Nutria has several young at a time and carries them on her back when swimming. Her teats are far up on her side so the babies can lunch while their mother is in the water.

Actually the copyu is is more related to the porcupine than to the beaver. Its fur is a good imitation of beaver fur and was sometimes dyed and sold as beaver years ago when beaver hats were in style. It was used for coat linings, the making of hats and in later years in the canning of cat food among others.

The "coypu" was imported into the United States to eat the plant growth in the canals and bayous of Louisiana. But they didn't stop at eating the plants but ate turtles, game fish and soon became more of a pest after all. They multiply so fast they traveled over land and spread over the country side. I have seen them as far north as northeastern Oklahoma.

They were Imported originally from South America and as many as fifty thousand pelts in a single year were brought to market.

They are hunted and sold in Louisiana to the catfood canneries. they will eat a groove around the trunk of a tree. The tree will finally die. Here on the fort when the "coypu" showed up in these parts several trees were killed by coypu. They are generally called "nutria" but nutria is really the name of their fur.





LIBRARY NEWS

HISTORY OF THE KINNEY COUNTY LIBRARY
PART TWO

Now in 1973, our Kinney County Public Library was able to provide requested books borrowed from libraries nation—wide through the Interlibrary Loan Service of the San Antonio Area Library System. Mrs Goleman, at her own expense, became a certified librarian by attending workshops and taking required courses, and served daily with no pay. Other Study Club volunteers were Mrs. "Dude Knott. Mrs Frenchie Breaux, Mrs. Edith Bersey, and Mrs. Laura Seargeant..

The Kinney County Public Library was now open 20 hours a week. Al Seargeant, Frenchie Breaux, Leo Glascow, Colonel Aulgur, and Carl Gant donated time and skills, building more bookshelves and taking care of odd jobs around the Library. Every month Mrs. Frankie Vevert brought books donated in Del Rio.

The Kinney County Commissioners established an Advisory Library Board with Charles Ward as President, Mrs. Clara Laman as Vice-President, and Mrs. Goleman as Secretary-Treasurer. This Board met each month and developed a constitution, by-laws, and policies for Library administration.

"Friends of the Library" was organized during a meeting of 23 business and civic-minded persons. George ("Top") West was elected President, Mrs. Goleman was Vice-President, and Mrs. Marion Wills was Secretary-Treasurer. Shortly afterward Mr. West moved away, and Mrs Goleman was now President. Nat Mendelsohn of Fort Clark Springs offered to make a personal donation of \$1000 to the Library if the "Friends" would match it. he matching money was raised.

In 1974 the San Antonio Public Library gave our library a 16 mm. projector and began sending packets of up to twenty films for children and adults each month. A special order catalog was made available for the members of our community wishing to order specific films. Classes from the Brackett Independent School District across the Street came every day to enjoy requested films.

In 1975 Mrs. Goleman became ill, and Else Sauer, retired after many years as a teacher and Principal of the Brackett Elementary School, volunteered to assume the administrative duties of the Library. A former English and History teacher, she provided outstanding guidance and help to the many students and adults who came to the Library in search of information.




