The most spectacular Confederate victory during the Civil War took place at Sabine Pass in Texas. Lt. Richard Dowling and forty-six others captured four hundred sailors and soldiers and turned back an invasion force of four thousand troops without losing a man.

Dowling went to New Orleans as a boy with his Irish parents. When his parents died of yellow fever, he moved to Texas, married, and was living in Houston when the Civil War began. He joined Capt Frederick Odlums Davis Guards as a Lieutenant. The guards were all Irishmen, stevedores, laborers and section hands.

Confederate Major General John B. Magruder knew the Federals were planning to invade Texas and stop the shipments of cotton into Mexico to be traded for guns and ammunition.

Only a small Confederate force was assigned to Sabine Pass. Five miles above the pass the Davis Guards were completing Fort Griffin. Four of their six guns were old United States Army guns.

The Federal invasion fleet lay off Sabine Pass. Magruder ordered the Fort destroyed and the men to withdraw. Capt Odlum left the decision up to Lt. Dowling and Dowling decided to stay and fight.

The way the fort lay extending into the channel, both channels could be defended. However, if Federal forces could get past the Fort, they could land troops and gain control of the coast and the invasion of the interiors of Texas and Louisiana would be a snap.

The Federal fleet of twenty-two vessels of different classes shelled the fort on September 8, 1863 without doing much damage. Dowling's men had yet to fire a shot. In the afternoon the Federals commenced firing again. This time Lt. Dowling ordered his men to return fire. This part of the battle lasted about forty-five minutes. The gunboats "Sachem" and "Clifton" were disabled blocking both channels.

The Federals were driven off by forty-two Irish Militiamen equipped with only six pieces of artillery. The Yankee army of four thousand men in twenty transports were defeated and three hundred soldiers and sailors were taken
prisoner without a shot being fired to rescue them.

The Canfederate Congress described the invasion force as five gunboats and twenty-two transports with 25,000 men. All the Confederates who fought there were given medals.

The "Clifton" was repaired and used for a few months until it ran aground. The "Sachem" became a Confederate blockade runner and was later sold lock, stock, and barrel at Vera Cruz.

After the war, Dick Dowling became a saloon owner in Houston. He died of yellow fever in 1867. He was only twenty-nine years old. He is buried in St. Vincent's Cemetary.

 LAWN WEED CONTROL

One of the best means for controlling weeds in a home lawn is to maintain a dense, vigorous growing stand of turf grass through proper fertilization, irrigation and mowing. Thin, weak turf encourages the invasion of weeds. Sometimes, even the best kept lawns will have some weeds. Sometimes, oven the best kept lawns will have some weeds. The homeowner can control problem weeds with herbicides labeled for home turf grasses.

Effective use of herbicides (weed killers) to control weads in a lawn depends on: proper identification of the weed, selecting the right herbicide, treating weeds when they are immature and actively growing, applying herbicides labeled for use on home lawns be used to control weods in lawns. Indiscriminate use of industrial strength weed killers often results in tree and shrub damage or death.

Glyphosate herbicides are non-selective contact spray vegotation killers. Roundup, Doomsday, and Kleonup contain varying amounts of the active ingredient glyphosate. These herbicides are slow acting, as much as two to three weeks, on stubborn perennials. Never hoe or mow the top of prayed vegetation as this will lessen the effectiveness of the product.

Post emergent selective materials are applied shortly after weeds are visible and when used according to the label will not damage turf. Post emergent broadleaf weeds can be controlled with $w, 4-0$, MCPP, dicamba, or a combination of these herbicides. Weeds should be immature and actively growing for best results. Do not use 2, 4-0, MCPP or dicamba on St. Augustine in hot weather (above 85 F ). Dicamba should not be sprayed next to shrubs or under drip lines of trees.

Pre-emergent herbicides such as Balan, Dacthal, or Betasan can be used to control grassy annual weeds, but only if the chemical is applied prior to germination of the weed seed. September and February are the most common times of application. Do not use on any area that you may be planning on reseeding as these will inhibit grass seed germination.

If you are unsure about a product and its use and cannot find answers on the label, check with your nursery operator or my office before you use the herbicide.

The Kinney County Extension Office is located on the 2nd floor of the County Courthouse and is open from 8:00 a.m. to 5:00 p.m.

## PECAN NUT CASEBEARER

The pecan nut casebearer is one of the most damaging insect pests of pecan in the State of Texas. Each year thousands of dollars are lost to this pest. Casebearers emerge, mate, and begin laying eggs for the first generation each year about this time. The first generation generally causes more damage than the later generations because one worm destroys many of the small nutlot's wich are avallable
at this time of the year. The pest is not difficult to control and there are a number of sprays registered for control but application must be timed properly.

Recently, Entomologists at Texas A\&M University have developed a model which predicts the date on which casebearers should begin to cause damage. Since pecan nut casebearers (and other insects) are coldblooded, the temperature of their surroundings regulates the rate of growth and development. Using temperature data and this model, we have been accurately predicting the dates casebearers have begun causing problems for the last five years.

This year the weather has been cooler than normal, but a fow trees around town have been seen showing signs of casebearer activity. If you have not already done so, check trees for white eggs on the tip of the nutlets and spray if necessary. Recommended insecticides for homeowners include Diazinon, Malathion, or Sevin. Continue checking trees until about May 30th. Trees sprayed now will probably need a second application in about two weeks.

HOME LANDSCAPE MAINTENANCE SEMINAR

Brackettville and Fort Clark Springs residents will have an informal opportunity to ask questions and listen to comments in a program dealing with home landscape maintenance on May 22, 1990, beginning at 10:00 A.M. The seminar will be held at the Conboy residence at Fort Clark Springs. Topics for discussion will include:
-- Variety selection of fruit and nut trees for home yards
-- Disease control on fruit trees and ornamentals
-- Watering practices for home landscapes The program is open to all homeowners in Kenney County and absolutely free of charge. Speakers for the seminar will be Dr. Mark Black, Extension Plant Pathologist, and Dr. J. W. Stewart, Extension Entomologist, both from the Extension Research Center in Uvalde. Homeouners are welcome to attend, ask questions, and enjoy the program. If you need more information about the seminar, call or come by the Kinney County Extension Office located on the second floor of the County Courthouse.

PROBLEMS WITH FLEAS AND TICKS?
Have you had any problems with fleas and ticks lately? Most pet owners have, and you probably do, even if you don't have a pet. With the relatively mild winter weather we had, there has been a large carry-over in flea populations across the state.
flea populations can build up very quickly and can maintain generations indefinitoly if not treated. For effective flea control, it is important to remember one thing: treat the pet, indoors, and outdoors at the same time. If any one of these areas are left untreated a breeding ground for nev populations will occur.

INOOORS: Thoroughly vacuum all carpats and other floor coverings such as hardwood flooring, vinyl tile, etc. The vacuuming should oxtend to baseboards and furniture. Remove and vacuum cushions and bottoms of sofas and chairs. Dispose of the bag as fleas may get out and reinfest the premises. Apply about one gallon of spray per 800 square feet of carpeted
area. This rate is necessary to get the chemical down into carpet fibers where all the stages of fleas are living. Lightly spray along baseboards and in all cracks and crevices. Apply a very light mist to upholstered sofas and chairs and to the bottoms of furniture. Make sure you spray where pets normally rest. Reapplication may be necessary in a week or 10 days. Insecticides suggested for control include:

INDOORS - Dursban, pyrethrins, ronnel and commercial mixes
OUTDOORS - Sevin, Dursban, Diazinon, Malathion
OUTDOORS: Prior to applying insecticide treatments, pick up all animal droppings, since this provides another source of food and larvae. Thoroughly treat entire premises, especially in areas such as crawl spaces or under shrubs where pets may spend a lot of time. Reapplication will probably be necessary within three weeks for effective treatment.

PETS: Pets may be treated by a veterinarian or they may be treated by the owner. Thorough treatments are a must. If dusts are used, ensure the insecticide reaches the skin, particularly in long haired dogs and cats. There are other preparations such as sprays, dips, and shampoos which are equally effective. Your pet may need to be treated on a weekly basis for two to three weeks to achieve overall control, but you must be treating indoors and outdoors at the same time.

A more complete list of commonly recommended insecticides for flea and tick control is available through Alan $L$. McWilliams, Kinney County Extension AgentAgriculture, Second Floor of County Courthouse.

## LOCAL HEALTH CENTER LEADS WAY

United Medical Centers is one of approximately 600 Community Health Centers throughout the county celebrating the 25 th Anniversary of their existence since they started in 1965 as a pilot program in tuo small centers in Mississippi and Massachusetts. They are doing so by marking May 13-19 as Community Health Center Weak. UMC provides basic health, laboratory, $X$-ray and pharmacy services in each of its 3 clinic sites in Maverick, Kinney and Val Verde counties. In addition, UMC administers other programs including Women, Infants and Children (WIC), Family Planning, Early Childhood Intervention (ECI), Drug and Alcohol Abuse, AIDS Education, Maternal Infant Health Improvement Act (MIHIA), State Primary Care and other complimentary services which support its clinical program.

According to George Kypuros, Administrator and CEO of United Medical Centers, many persons afs Snavare of the work of aphyicians; other
medical personnel and volunteers at the centers. Nor are they aware that the clinics, located primarily in center cities and remote rural areas, serve patients who are uninsured, umemployed, or working poor, who simply have no other access to health care -- at any price.

Centers range in size from small, single physician practices, to large facilities with dozens of personnel and patient caseloads of more than 60,000 . The centers are an integral part of the medical community's task of reducing the appallingly-high infant mortality rate, and reaching out to the homeless, victims of substance abuse, and those afflicted with AIDS.

The cost of center operations are made possible by Federal and State grants, Foundation grants, as well as by a mix of payments from patients thru medicare, medicaid and private insurance, as well as payments, on an income-related sliding scale, from the majority who have no insurance. Those who can pay, do pay.

In recent years private sector contributions have become a virtual necessity in helping local centers provide services to the growing number of persons who can't afford health care.

## YOU CAN PROTECT YOURSELF

The only sure way of avoiding AIDS is to abstain from sexual intercourse and intravenous drug use.

If you have been in a mutually monogamous relationship with someone since 1977, and both of you have avoided intravenous drug use, you are safe from AIDS.

If you wish to establish a monogamous relationship with someone, you may want to determine that you are both free of the AIDS virus by having an AIDS test. However, in order for the test to be meaningful, you both must have avoided risky behaviors for the previous six months. If both of you test negative, neither of you will get AIDS as long as you both continue to avoid risky behaviors.

## TAKE PRECAUTIONS

You can improve your chances of avoiding AIDS by reducing the number of partners you have sex with, and by using condoms together with a spermicide. Condoms should be used correctly. This means using the condom during the entire act of sexual intercourse. Spermicides containing the chemical nonoxynol-9 may add a measure of safety.
