## **Public Notice**

TO ALL FORMER AND CURRENT INTRASTATE WIDE AREA TELECOMMUNICATIONS SERVICE (WATS/800) SUBSCRIBERS:

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant,' and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

#### Claim Forms And Additional Information

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m.-4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P. O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. REQUESTING A WATS REFUND INFORMATION PACKAGE DOES NOT OBLIGATE YOU IN ANY WAY.

All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding.

#### BY ALAN L. MCWILLIAMS

We could sure stand another shower or two to get things going again. Weeds are plentiful on pastures in Kinney County. Ranchers are experiencing stomach worm problems with sheep and goats. I have visited with a number of them this past week who are all busy deworming their livestock.

Along with the hotter temperatures, the summer season in Texas usually brings, there often comes special lawn problems like drought, weeds, insects and disease. Drought is a concern to home lawns in that turf grass cannot grow and spread without proper moisture.

Dry spots, thin turf and weeds can result from improper watering, fertilizing and mowing practices. Follow recommended procedures before applying a chemical to correct lawn problems.

Drought stress most often occurs in midsummer and shows up as wilted discolored turf. Adjust watering schedules to wet the soil to a depth of four to six inches and water only when grass shows symptoms of moisture stress. Also, raise mowing heights one-half inch to improve drought tolerance in mid-summer. A sign of drought stress is the presence of footprints after you walk across a section of dry yard.

Water-lacking turf will not spring back and tends to stay bent and crumpled. lack of nitrogen or iron often creates a lawn problem. Grass with a nitrogen deficiency may have a pale color and be heavily infested with weeds. A light application of a nitrogen fertilizer will improve the lawn's appearance.

Grass leaves that have yellow stripes parallel to the leaf margins may be deficient in iron. A foliar application of iron sulfate at six ounces per 1,000 square feet will usually solve this problem.

If a St. Augustine lawn has symptoms similar to nitrogen or iron deficiency but does not respond to applications of either material, you might suspect St. Augustine Decline. Close examination of infected turf will show green and yellow blotches on the leaves. Continue good maintenance practices where this problem exists. Also, Floratam or Raleigh are newer varieties of St. Augustine that are resistant to St. Augustine Decline and may be sprigged

into the infected area.

Leaf spot diseases are generally a problem when lawns are under stress and increase with high temperatures, drought, heavy shade and close mowing. While proper mowing and watering will reduce these problems, fungicides maybe required to prevent serious damage.

White grub s feed heavily on lawns during mid-summer as do inch bugs. Their damage resembles injury. If turf does not respond to applications of water, suspect these insects. Both pests damage St. Augustine, but only the white grub damages bermuda grass lawns.

They both can be controlled with insecticides. Water the lawn thoroughly prior to applying an insecticide for control and follow with a night watering. You may have to drench the lawn after and insecticide is applied for grub control, since grubs feed in the soil.

If you would like more information, I have a number of homeowner's publications dealing with turf and lawn maintenance.

Three buildings of primary interest are the completion of Filipone Building, preservation of the Milipont Building's front wall and recognition of Carver School.



#### **MAMMOGRAMS**

WHY SHOULD WOMEN HAVE A SCREENING MAMMOGRAM?

One out of ten women in the United States will develop breast cancer sometime in her life. It is currently estimated that over 37,000 women die each year as a result of breast cancer.

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50% five year survival rate. Conversely, a woman diagnosed as having breast cancer before a lump can be felt has a 97% 5 year survival rate and a 90% 10 year survival rate.

A mammogram can detect a cancer this small, even before it can be felt.

WHO SHOULD HAVE A SCREENING MAMMOGRAM?

The American Cancer Society has established guidelines for mammography. Those

guidelines have been adopted by the American Academy of Family Physicians, American College of Obstetricians and Gynecologist and The American College of Radiology. The guidelines for mammography are as follows:

1. 35-40 year old asymptomatic women should have a baseline mammogram.

2. 40-50 year old asymptomatic women should have a mammogram every one to two years depending on breast type and risk factor until age 50.

3. Asymptomatic women over 50 years of age should have annual physical examination and annual mammogram.

4. Asymptomatic women under 50 years of age with significant high risk factors should be examined at appropriate intervals. Risk factors listed below are an example.

a. Previous breast cancer-yearly examinations.

b Family history of breast cancer mother, sister, or daughter examination should be done at age 30 with follow-up as recommended in 2 above.

5. Symptomatic women at any age.

a. Breast mass, palpable by patient or physician.

b. Nipple discharge.

c. Skin change.

d. Unexplained breast pain.

6. Symptomatic women will not be seen at the screening Clinic. A woman with any of the above symptoms should call her physician or make an appointment for a complete breast study at the Regional Braise Care Center in Odessa.

WHAT IS A SCREENING MAMMOGRAM?

A screening mammogram is an x-ray of the breast on women who have no symptoms of disease (asymptomatic).

A screening mammogram utilizes extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find very early cancers in unsuspecting women.

HOW CAN A WOMAN GET A SCREENING MAMMOGRAM?

The Regional Breast Care Center of Women's & Children's Hospital and Odessa Radiology Group are co-sponsoring a Mobile Breast Screening program.

The Mobile Breast Screening Unit will be in most towns in West Texas.

The Mobile Breast Screening Unit will work by appointment as well as non-appointment. You may make your appointment by calling your local clinic or the Regional Breast Care Center at 915-334-8888.

WHAT HAPPENS AFTER A WOMAN HAS MADE AND APPOINTMENT

When the Mobile Breast Screening Unit is in your city please report approximately 5 minutes prior to your appointment time for registration.

The charge for the screening mammogram is \$60.00 depending on location and payment must be made at the time of service. The clinic accepts cash, check, Visa, Mastercard and American Express.



The word "Jimson" is a corruption of Jamestown and because Jimson weed is very plentiful around Jamestown the weed was called "Jimson."

In Colonial Virginia James was pronounced "jeems," that was the usage the settlers brought with them when they came from England. In the early spring this weed covers the tiny island on the James River.

Jimson weeds' botanical name is "Datura Stramonium" and was also called Thornapple, devils trumpet, stinwart and stinkweed. It belongs to the night shade family, is highly poisonous, the drug "stramonium" is made from its leaves. It is thought to have come originally from tropical Asia.

Jimson weed is used in certain medicines, tonics and compounds for heart ailments. The Algonquin Indians and the Aztecs of Mexico used it as a ceremonial intoxicant.

Robert Beverly in his "History of Present State of Virginia" published in 1705, tells of the effect of eating Jamestown weed had on some of the British soldiers sent over to suppress Bacon's rebellion in 1676. It took them eleven days for the effect to wear off. They made such fools of themselves they were confined until the effects were gone in case they would hurt themselves or each other.

The "Sage of Monticello" Thomas Jefferson wrote in his "Notes on Virginia," about a case of Dr. Bond whose patient, a young girl, put a seed of this plant into her eye, which dilated the pupil so much she could see in the dark but in the light was almost blind.

# EQUALIZATION PLANS WILL CAUSE HUGE LOCAL PROPERTY TAX INCREASES

Any of the school funding plans considered at the state level will cause local property taxes to increase. There are some differences in the proposals regarding mandates, but all of the plans require a property tax rate above one dollar (\$1.00) per \$100.00 valuation.

The original bill that Governor Clements vetoed last week would have required all districts to adopt a tax rate of \$1.18 in four years to receive maximum state funding. The Master's Plan released Friday, June 1, 1990, would have required a local property tax of \$1.25 for maximum state aid.

Superintendent Bob McCall of Brackett Independent School District noted that Brackett ISD would have suffered big property tax increases under either plan and will probably have to increase taxes under any plan that might be implemented. He also stated, "Brackett is being penalized for operating in a frugal manner. While property taxes in Brackett ISD have risen from .79 to .8576 over the past five years, the average property tax state-wide has risen from .72 in 1985 to\$1.05 in 1989."

The current compromise plan that may be passed by the legislature will require a local tax increase of .16 in 1990-91 and an overall increase to .41 by 1992-93 in order to receive maximum state aid. McCall said that he did not feel that any of the plans addressed "school equity." The court and the legislature have failed to address the issue by changing the method of funding from the local level to the state level. Right now local property tax payers are being forced to pay for programs mandated at the state level. Local school boards are give no choice but to raise taxes to pay for the new programs in order to maintain state accreditation.



### Health & Nutrition by Judith Sheldon

SNACK YOUR WAY TO GOOD HEALTH: Yes, calories do count, and no matter when you eat, it's important that you keep your intake of saturated fats low and complex carbohydrates relatively high to keep your weight and your cholesterol count at healthy levels.

An interesting sidelight, however, is found in a report from the University of Toronto cited in a recent issue of the Reebok Aerobic Information Bureau newsletter. Researchers have found that breaking up your daily caloric intake into several mini meals, instead of your customary three square, could lower cholesterol levels significantly. Some of the people in the study lowered theirs by as much as nine percent nibbling their way through the day. The key to this interesting phenomenon may lie in the way a large meal affects the production of insulin. When you eat a lot at once, you produce a lot of insulin. Smaller meals require less insulin.

On a related note, diabetics who either produce little insulin, or have to have insulin injections daily, usually do better on the smaller, but more frequent, meal schedule as well. Small, but frequent, meals may also keep your weight down. The body converts food into energy more efficiently when it has a smaller quantity to work with.


PUTTING YOUR MIND TO IT: The University of Texas Health Science Center at San Antonio, along with researchers at the Mind Science Center at San Antonio, established a joint project to study the effect of daily mental exercise on adults age 18-55 with chronic asthma. As part of the research, they'll be asked to do a brief daily mental exercise which includes relaxation techniques, and creating positive thoughts and emotions, with audio tapes to guide them.

Incidentally, between five and 10 percent of Americans suffer from asthma. According to the American College of Allergy and Immunology, there's been a case rise of 22 percent since 1970. It makes one wonder how much of that might be attributed to the increase in the air pollution factor.

MISCELLANY: A number of American couples will be involved in a unique scientific study, to wit, testing the effectiveness of condoms which have been stored for some 10 years. (Forget about volunteering for the test. As they say in show business, don't call them — they'll call you if, for some reason, you're on their contact list.)




