**TRAIN DERAILMENT IN KINNEY COUNTY**

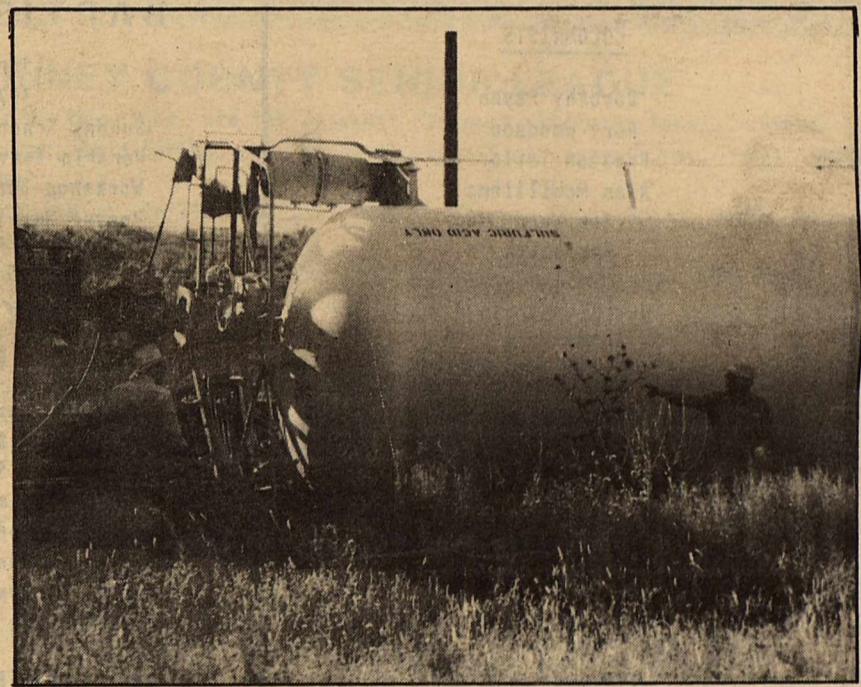
Saturday, at approximately 5:25 a train that was west bound, derailed 7 miles East of Spofford on FM 1572, in Kinney County. The train had 27 cars, 19 were empty and 8 were loaded. Four of the cars contained hazardous materials. Three of the cars contained sulfuric acid but had no leakage, and one contained naphtha compound and this car had a minor leak.

The derailment was caused by a cuppler coming loose. The train slowed down for a curve and the back end of the train hit the front end causing the cars to derail.

No one was killed or injured in the derailment.

FM 1572 was closed until the Rail Road clean-up crew arrived. The Brackettville Volunteer Fire Department and the Kinney County Ambulance Crew stood by at the scene.

The scene was investigated by Sgt. David Morgan, DPS From Del Rio Texas, and L.K. Burgess, DPS, from Brackettville, Texas.

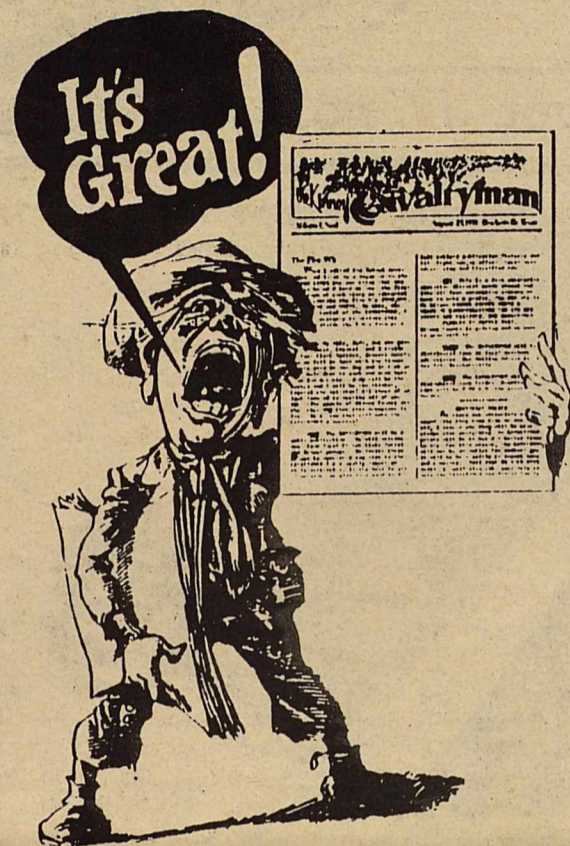

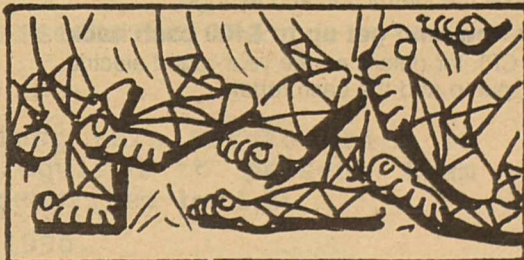

### REALITY OR FICTION?

The following story is fictitious, but could become a real life event each and every day.

The peace and quiet of a small southern town was shattered one sunny afternoon when a twenty-two car freight derailed.

A local officer on duty nearby realized what had happened and immediately radioed the sheriff's office for assistance. They in turn called the fire department who in turn called for E.M.S. help.

The first to arrive on the scene made their way to the beginning of the devastation. They included the fire chief, assistant fire chief and rescue lieutenant, who were closest to the scene along with the local sheriff.

As far away as two miles they could see the devastation that lay before them. Box cars smashed, tank cars tossed about like children's toys, ripped open and leaking chemicals.

Between them the men only had three radios for communication. The sheriff and his assistant moved back along the tracks to assess further damage. Meanwhile, the fire chief and rescue lieutenant and the assistant fire chief entered the train engine to assist the engineer

and retrieve the waybills (bills of lading) to determine what chemicals they were dealing with. While they were assessing the situation, other emergency procedures were being implemented according to the county emergency plan. Once the fire chief, sheriff and rescue dispatchers were informed of the situation, a call was sent out for mutual aid to all area fire departments, rescue squads and law enforcement.

When the county emergency management director was informed of the situation, he then called for the regional emergency management director who notified the appropriate state agencies.

Railroad officials were also called to ascertain what was on the train, possible damages and help. It was an estimated two hours before the first state and railway assistance could arrive.

Back in town the situation was worsening. The waybills indicated one tanker was carrying Ethylene Oxide; four were carrying glycol and the other two carried JP4 (aviation fuel). The most dangerous was the 27,000 gallons of Ethylene Oxide, chemical label number 1040. The waybills also told the men it had a flash point less than 0 degrees F. It is transported as a gas; but at less than 51 degrees F becomes a liquid and smells like ether. Once it escapes, it is half again as heavy as air with vapors 1.5 with a liquid spill it forms a vapor cloud that moves closer to the ground. It has a flammable limit range of 3 percent to 100 percent and can burn with concentrate in the air.

Checking the D.O.T. book, the men found that it is reactive with alcohol. (Glycol is a type of alcohol). The vapors may ignite with a spark and may flashback to the source. The container can explode from the heat.

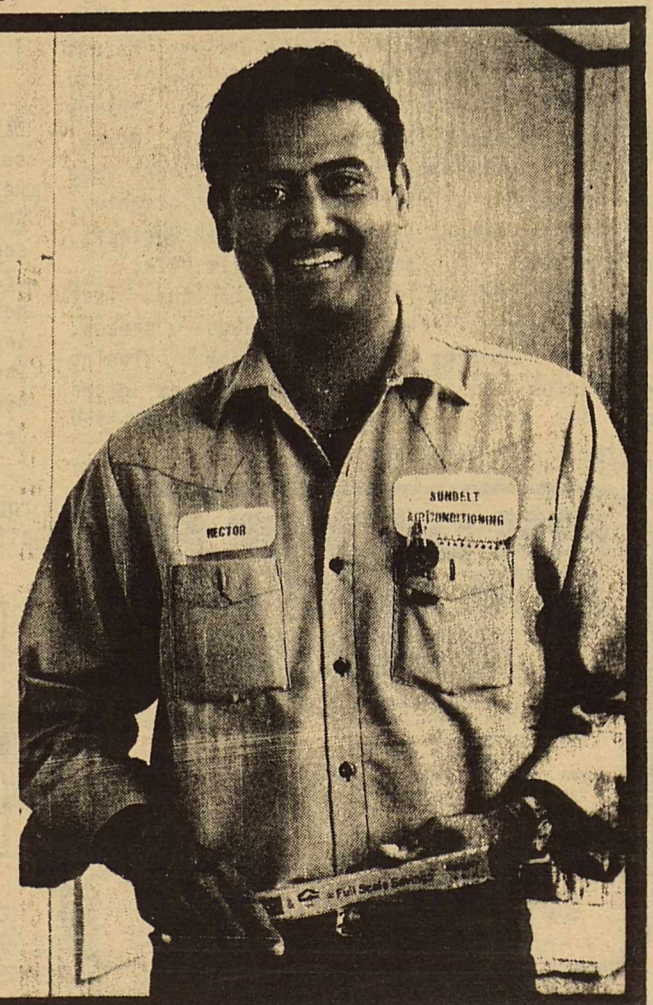

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

#### Claim Forms And Additional Information

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m. - 4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P. O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. REQUESTING A WATS REFUND INFORMATION PACKAGE DOES NOT OBLIGATE YOU IN ANY WAY.

All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding.

belly." Slanderous words can pierce like a knife, wounding the heart and poisoning the spirit within us.

It is so easy to get caught up in a conversation about someone, especially when there is a little truth to the rumor. However, we are charged in the book of Ephesians in 4:29 to "Let no corrupt communication proceed out of your mouth, but that which is good to the use of edifying---." It is very difficult to rekindle a friendship that has been destroyed by gossip.

Friend, the sins of the tongue are every bit as deadly to ourselves as they are to others. Jesus gave us a strong warning when he rebuked the Pharisees (who were the religious leaders of the Jews) when he said, "But I say unto you, That every idle word that men shall speak, they shall give account thereof in the day of judgment. For by thy words thou shalt be justified, and by thy words shalt be condemned." (Matt 12:36,37) Isn't it a fearful thing that right now, God is recording every word that we speak, reserving it unto the day of judgment!

Don't think you can impress God by going to church and singing songs or worship and saying a few prayers, when all the while you plan to have a gossip session in the lobby on the way out! God dealt with that in James 3:10 saying, "out of the same mouth proceedeth blessing and cursing. My brethren, these things ought not so to be."

Do you want to stand before God as a murderer because of those you have destroyed with the sins of your tongue? Remember, God said in Revelation 22:15 that the murderer will remain outside heaven with the whoremongers and sorcerers and idolaters.

If this message has spoken to your heart and you know you have been guilty of causing pain to yourself and others through your words, then ask God to forgive you. He will help you make a new start and begin a life of encouraging your fellow man with the Word of God.

The statewide conference, along with the local forums that precede it, represents an opportunity for Texas to take the lead in addressing the needs of an aging population in a changing society," Cook said.

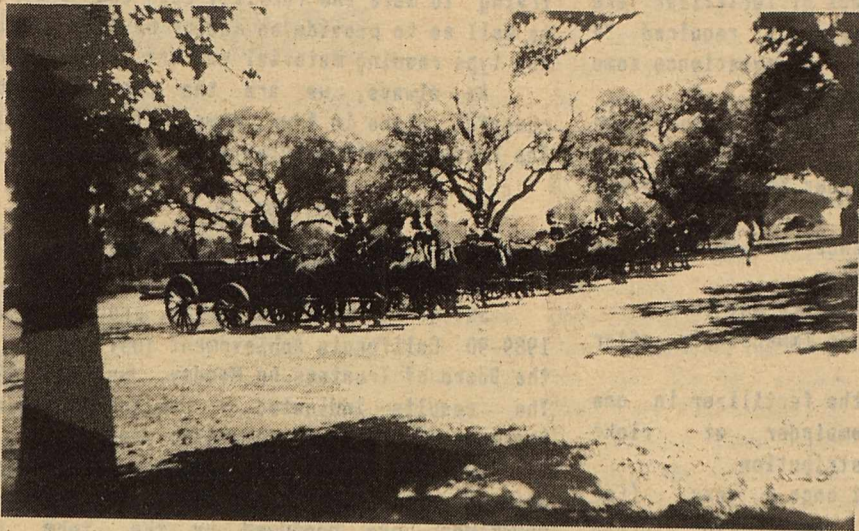



To make matters worse Ethylene Oxide has a health hazard No. 2 rating and if inhaled it can be fatal. Vapors are irritating plus contact may cause burns to the skin and eyes. Contact with the liquid may cause frostbite. Runoff can cause pollution, cancer and D.N.A. disruption.

The Glycol and JP4 tankers are not ruptured but the tanker of Ethylene Oxide is ruptured and a vapor cloud is building.

The emergency personnel on the scene must take command of the situation and important decisions must be made. The sheriff has radioed back the first reports of the damaged area and dozens of decisions must be made almost simultaneously.

The command post must be established southeast of the destruction since the winds are blowing from the south-southwest at 5-10 knots. Emergency personnel are north of the area and must be re-routed to the south.

Once a command post is established, the Key Emergency Management personnel must be kept informed. However, no phone lines are available in the area and fire, rescue and law enforcement are limited to communication by already congested radio frequencies.

Can teams safely enter the area and can other teams attempt to contain and control the spills or must they wait?

Sunset is only 2 or 3 hours away and the contaminated area must be controlled.

Although the example used for this story was a train and hazardous materials, innumerable dangers are possible in every town every day. A tractor trailer can overturn, gas tanks can explode, planes crash; other natural disasters such as tornadoes and floods can occur. All these possibilities must be considered by law enforcement, emergency personnel, fire and rescue teams, city and county officials.

These teams are trained to handle the situations and train and work together. Emergencies need everyone working together and small towns cannot always wait for hours for help to arrive. Communication between agencies is vital and should include everyone who must respond to the situation from the emergency personnel, county, city, state and federal law enforcement, fire department, county and city officials and the media.

Last Saturday evening Kinney County proved itself. We've come a long way and we've a long way to still grow.



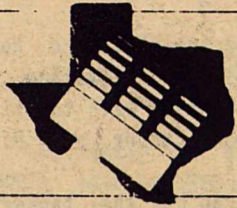

**LAWN GRASSES REQUIRE ADEQUATE NUTRITION**

A well-kept lawn adds to the material value of a home and is a basic requirement for an attractive yard. The difference between a thick, rich carpet of weed resistant turf and a weak, yellow-fringed lawn, with thin bare spots is often due to fertilization practices, although water management and proper mowing are equally important. Mowing is equally important. Most all soils are inherently low in some plant nutrients and require fertilization for maximum performance.

What are the functions of the plant nutrients in plant growth? Nitrogen stimulates vigorous growth of new leaves, resulting in greener turf. Phosphorous encourages rapid root development. Potassium puts "muscle" in the grass, making it more resistant to disease, droughts and cold weather. Calcium is needed to make the other nutrients more available to the roots. (In our area, however, calcium is so abundant that the problem is the exact opposite; nutrients are rendered unavailable to plants because of too much calcium). Sometimes it is necessary to apply iron to grass to correct for chlorosis (yellowing of leaves between the veins).

Two applications of a complete fertilizer are essential. Apply one in the spring and the other in the fall before frost. In addition, for peak performance, nitrogen should be top dressed every 30-50 days during the summer. Bermuda grass lawns need 2-3 pounds of actual nitrogen per 1000 square feet of area. To figure this using a 16-8-8 fertilizer, you simply take the pounds of nitrogen you want (2 lbs.) and divide by the 1st number of the formulation (.16) 2-.16 is 12.5 pounds of a fertilizer.

There is no magic about fertilizers for various plants. Most any formula offered for sale can give essentially the same results, if used properly. There is far more overuse of plant foods rather than under use. Ammonium sulfate (21-0-0) has a reputation as causing burning. For the most part, any of the inorganic fertilizers will cause burn. When

three or four 50-pound bags of fertilizer are used on a lawn that actually required 28 pounds, then you certainly will experience some burn.

Here are a few guidelines for correct lawn fertilization:

- (1) Use a reliable spreader that accurately distributes the fertilizer.
- (2) Calibrate your spreader so you are sure of how much is being applied.
- (3) Never apply fertilizer to wet turf
- (4) "Water-in" fertilizer immediately after applying.
- (5) Apply one-half of the fertilizer in one direction and the remainder at right angles to avoid uneven distribution.
- (6) Add iron at least once a year. (For troublesome chlorotic spots in grass you can spray the foliage with three level tablespoons of iron sulfate (copperas) in three gallons of water and add one and one-half tablespoons of liquid household detergent to insure even coverage.
- (7) Increase the fertilizer rate about 50 percent under trees.

Geronimo was one of the wildest and most dangerous of all Indians. He was born Goyathlay to the Apaches in Arizona in June 1829.

In 1858 Mexicans killed his wife and children, he began to raid relentlessly on a period of vengeance.

When he was young he had associated with Cochise in many of his raids, and finally became a chief of the Chiricohua Apaches. Sometimes he was on the reservation and sometimes he was on the War Path.

In 1876 the apaches were forced to flee to New Mexico and Geronimo fled to the Mexican mountains and raided across the border. Then he came back and farmed on the reservation for awhile before trouble with the whites drove him off again. He attacked the white settlers in New Mexico and Arizona until General George Crook was sent to subdue him. But Geronimo bolted again and Crook was replaced by General Nelson A. Miles who finally captured Geronimo in 1886. Geronimo was a prisoner many years in Fort Sill. After a time he was released and became a Christian and began farming.

In his later years he appeared at fairs around the country and became a favorite tourist attraction. He also rode in President Theodore Roosevelt's inaugural parade.

When he died he was buried at Fort Sill in 1909. His name lives on and became well known as a jumping call of the United States Paratroopers.

## REFLECTIONS

When a person finishes high school or college, or when school is out for the summer, we should not think that school is over. We may still enroll in another school. Why not take the suggestion and get into the school of prayer?

The school of prayer does not demand any tuition payments. It's open for everyone. Jesus is the high priest in heaven who knows all who call upon Him. Additionally, God wants to answer us when we pray -- with a yes, no or wait-a-while answer. All of this makes prayer a tantalizing experience, doesn't it?

We may pray for our physical well-being, our health. (At the same time, keep in mind that we are living in bodies that suffer from the curse of sin and these bodies will get sick and will die. To deny this reality of sickness in a fallen, sinful world is to be blind to the truth of the original Fall and all the "fallouts" of sin). In fact, cells in the body by millions are sick and dying every minute! In the mortal bodies of clay there is no such thing as perfect health!

And yet, we may pray for health! C.S. Lewis in his classic *The Screwtape Letters* has the devil (Screwtape) tell his nephew Wormwood to keep a man's prayers "ineffective" by keeping them "spiritual." That is, Screwtape says tell him to pray for a person's soul and not that one's rheumatism. Well, we may pray for relief from cancer, headaches, and a bruised thumb!

We may pray that God's Word may prosper. That's one of the greatest areas of concern which any of us may have! After all, God's eternal and inerrant message of life in Jesus Christ for time and eternity embraces everything we are and will ever be.
