



#### RAINBOW TROUT WITH MANDARIN ORANGE SALSA

1 can (11 ounces) mandarin oranges; drained; each section cut into thirds



6 tablespoons diced, mild green

cup chopped green onions (3 stalks) 1/4 cup chopped red bell pepper

tablespoons orange juice (divided in half)





#### Tigers fall to the Pirates 77-82


The Tigers traveled to Lytle on Tuesday, but fell to the Pirates 77-82 in overtime.

Brackett and Lytle were tied at 72-72 when the final buzzer sounded at the end of regulation sending the game into a three-minutes of overtime period. The Pirates earned their victory on the free-throw line as they sank six of seven free-throws as they outscored Brackett 10-5 in overtime.

Tevin Senne was giving Clay Hunt an alley-oop pass just before half-time, but to everyone's surprise sank the shot from almost mid-court for three points. That pulled Brackett within one point, as the Pirates led 38-37 at half-time.

Three Tigers scored in double-figures. Clay Hunt let with 23 points, while Lesly Floyd had 21 and Tevin Senne scored 18. Floyd sank five three-pointers for the second consecutive game. Senne had three. Others Scoring for Brackett were: John Hernandez, six points; W.T. Hunt, four points; Peter Perez, three points; and Steve Clementz, two points.

Gilbert Innocencio led Lytle with 27 points, while Brandon Mullins had 22 and Juan Garcia made 11. Brad Bates scored eight, Phillip Ramos had five, Henry Siller contributed four, Clint Collins sank a three-pointer, and Emilio Reyes added two points.

#### JV's VS Eagle Pass

The J.V. Tigers hosted the Eagle Pass 9th graders last Friday. Brackett fought hard until the final buzzer, but fell 35-42.

J. J. Sandoval and Lynn Floyd both hit three points in the first period to get the team's adrenalin flowing. Eagle Pass overcame Bracketts outside shooting, to grab a 12-11 lead after the first eight minutes. The Tigers held on in the second period to outscore the Eagles by one basket for a 22-21 halftime lead.

The third period was

evenly matched up, but the final stanza became the deciding factor.

The two teams were tied up at 29-29 going into the last quarter, but Eagle Pass outscored the Tigers 13-6 for the victory.

Floyd and Sandoval both sank two three-pointers each during regulation. Floyd led Brackett in scoring with 14 points, while Sandoval and Lenny Wardlaw both made 8. Jesse Terrazas and Isauro Rivas added two apiece, and Gabriel Flores added a free throw.

## Floyd Led Scoring in Game Against Rocksprings

The Junior Varsity Tigers are 3-6 on the season after a busy week of action highlighted by a second place finish at the Rocksprings junior Varsity Tournament.

Brackett opened the Tourney against El Dorado. Coach Ken Campbell's Tigers were victorious 42-39.

The Tigers had a 13 point advantage with a 37-24 lead after the first three periods.

El Dorado outscored Brackett 15-5 in the final stanza, but the Tigers held on for a spot in the championship game.

Lynn Floyd and J. J. Sandoval both scored in double-figures to lead Brackett. Floyd had 13 while Sandoval made 10. Lenny Wardlaw contributed nine points, while Jesse Terrazas and Victor Sanchez both scored four points, and Isauro Rivas added two points.

The Tigers faced the hometown Angoras in the championship game. Rocksprings captured first placed with a 47-35 victory.

Floyd, once again, led Brackett in scoring with 14 points. Others contributing were: J. J. Sandoval and Isauro Rivas, Eight points each; Lenny Wardlaw, three points; and David Durrough, two points.


#### Lady Bulldogs of La Pryor hold First Place

## Heroes Of Medicine

#### **Researcher Honored**

Vernon R. Young, Ph.D, D.Sc., director of research of the Shriners Burns Institute in Boston, was elected to membership in the prestigious National Academy of Sciences. He was also awarded the J. Arthur Rank Prize by the Royal Society of London. Young, who is only the fourth U.S. scientist to receive this coveted award, also recently as-

sumed the presidency of the American Institute of Nutrition.

In addition to his post at the Shriners Hospital, Young serves as professor of nutritional biochemistry at the School of Science and Clinical Research at the Massachusetts Institute of Technology. He was recently honored at a meeting of the Shrine's Boards of Directors and Trustees.

### Transamerican Diagnostic Area Mammography Service Accredited by American College of Radiology

The Mobile Breast Cancer Detection Unit of Odessa, Texas, which services Brackettville, Texas today received the certification of the American College of Radiology Mammography Accreditation Program.

Mammography is an x-ray examination of the breast, which the American Cancer Society and other medical experts see as the best means for the early detection of breast cancer.

The program is voluntary and is designed to insure that women receive optimum quality mammographic examinations. The process is done through a peer review evaluation of the facility's staff qualifications, equipment, quality control and quality assurance programs, image quality, and breast dose. The accreditation must be renewed every three years.

The accreditation program was instituted because of the concerns of radiologist, other national medical organization, and the public that qualified personnel perform and interpret mammograms and mammograms and that dedicated mammographic equipment be used. The American College of Radiology received an American Cancer Society Control Grant which was used to pilot test the Accreditation Program.

Breast cancer will strike one in 10 American women. The American Cancer Society predicts that about 41,000 women will die of breast cancer this year. As there is no way to prevent the disease, early detection and treatment offer the greatest hope of survival.

The American Cancer Society recommends that women do monthly breast self-exams and have regular physical breast exams by a doctor. It further recommends mammography on the following schedule:

A baseline mammogram (for reference) between age 35 and 39.

A mammogram every one or two years between age 40 and 49.

An annual mammogram from age 50.

UNITED MEDICAL CLINIC TO SPONSOR BREAST CANCER DETECTION UNIT

According to the American Cancer Society, one out of every ten women in the United States will develop breast cancer sometime during her lifetime. Every year over 37,000 women die as a result of breast cancer.

According to a spokesman from the Regional Breast Care Center at Women's & Children's Hospital in Odessa, Texas "The death rate from breast cancer could be drastically reduced if women would have mammograms done before a problem exists." By using modern state of the art e-ray equipment, breast cancers can be found when they are about the size of a grain of rice and well before the cancer can be felt. A woman who is diagnosed with breast cancer at this early stage has a 90%-97% survival rate. However, a woman who is not diagnosed until a lump can be felt has approximately a 50% survival rate in five years.

In an effort to find cancers at the earliest possible stage and prevent unnecessary deaths, a mobile breast cancer detection unit will be made available to local women. On Wednesday, January 30th, the mobile unit will be parked at United Medical Clinic, 201 James Street, Brackettville, Tx. Appointments may be made by calling 563-2434.

Jacob S. Coxey was a laborer turned businessman who felt bad about the problems of the unemployed during the depression of 1894.

He had a plan and wanted the government to spend millions of dollars to employ men for the country's highway construction.

On Easter Sunday he left Massillon, Ohio at the head of a hundred men. Other groups were also gearing up to march on Washington. The most notable of these industrial armies was led by "General Kelly" and started from San Francisco.

The "armies" were getting free train rides and meals on their way east. Among the followers of "General Kelly" was young Jack London.

There were other armies including the "Montana Commune"; one from Sacramento, California led by John Shuler, another from Sacramento, California led by a woman, Anna Smith.

As these armies traveled eastward they met hostility from

some communities. Sometimes the National Guard and other United States Army units were called out to keep them in line.

May 1, 1894, Jacob Coxey lead his "industrial army" on a parade down Pennsylvania Avenue in Washington, D.C. - but he only had 500 men instead of his hoped for 100,000. Coxey was arrested for trespassing on the lawn of the Capitol and his "army" just gradually drifted away. Meanwhile some of the other armies were still coming. On May 9, 1894, Kelly's army made it as far as Des Moines, Iowa, and there the citizens helped them to build boats. They moved down river and finally got as far as Quincy, Illinois. There they also gradually drifted away. Jack London hopped a freight to Chicago. Kelly and a few members of his army made it to Washington.

The term "Coxey's Army" became a part of our language, meaning a man enticing a group of other men to follow him in his endeavors.

"And God created man in His own image, in the image of God He created him; male and female He created them" (Gen. 1:27). These verses in Genesis about man being created in the image of God have caused much consternation among Bible students through the centuries, because the Bible doesn't explain what is meant by the term, "created in the image of God." Christ Himself said, "God is spirit, and those who worship Him must worship in spirit and truth" (John 4:24). Scripture uses many anthropomorphisms (manforms) in describing God ("...I will uphold thee with the right hand of my righteousness," "...Noah found grace in the eyes of the Lord, "etc.); anthropopathisms (man-emotions) are also attributed to God ("...anger of the Lord was kindled against...", "...but the wrath of God abideth on him..."). However, since God is neither anthropomorphic nor anthropopathic, these terms are used in scripture so that man will get the point of the message. Scripture ascribes human attributes to God so that man will understand what God wants man to know.

Since the Bible does not explain what it means to be created in the "image of God," we are forced to speculate as to its



THE CITY OF BRACKETTVILLE IS ENFORCING ORDINANCE #226. ANY ANIMALS RUNNING LOOSE WILL BE PICKED UP BY THE CITY. OWNERS WILL HAVE 10 DAYS TO CLAIM ANIMALS AND PAY NECESSARY COST.

#### Ordinance #226

PROHIBITING ANIMALS FROM RUNNING AT LARGE IN THE CITY LIMITS; PROVIDING FOR ANNUAL VACCINA-TIONS; IMPOUNDING, EUTHANIZING, REDEMPTION AND SALE OF ANIMALS; PRESCRIBING A PENALTY OF A FINE OF NOT LESS THAN \$1.00 NOR MORE THAN \$1,000.00; AND REPEALING ALL PARTS OF ORDINANCE IN CONFLICT HEREWITH.

This Ordinance can be seen in it's entirety at City Hall. This Ordinance was passed and approved on July 9th, 1984.

EXCERPTS: Page 2 - F. Animal Nuisance Animal Nuisance shall mean any animal destroying public or private property not controlled by its owner; chasing, biting, or otherwise severely alarming adults or children while not on the owners property or premises; making loud noises (barking) at quiet time of the night without sufficient provocation; by littering garbage or excrement on public or other places; or otherwise offending the peace and/or dignity of the City and its inhab-

Page 2 - G. Permit A permit shall mean the permission of the City to allow City Residents to own and maintain domesticated animals and wild animals with the City limits. Permits are revocable on an individual basis for cause without further legal action if the owner violates provisions of this ordinance or is convicted of willful cruelty to animals. Permissions will be revoked by letter to the owner's address of record informing owner that the animal must be removed from the City limits within three (3) days following receipt of said letter. Charge for permits will be one dollar (\$1) per animal up to five (5) animals. Five dollars (\$5) per family with more than five animals.

All domesticated animals must be vaccinated for rabies before a permit will be issued. Owner of the dog/gods or cat/cats being registered for a City permit must present the City with a receipt showing that the animal has been vaccinated for rabies. All dogs and cats must be vaccinated yearly to obtain a City permit.
