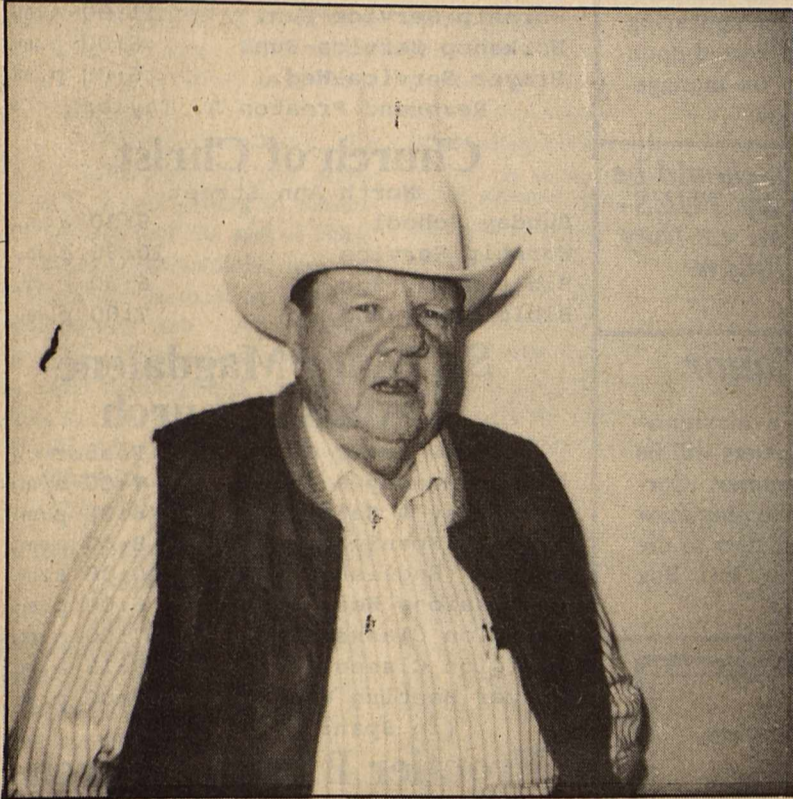


Bill Lindeman appointed Constable



Bill Lindeman was appointed Kinney County Constable by the Commissioners' Court, Monday, February 11, 1991. This action occurred after Constable Gregorio Juarez resigned in

December because he could not get certified. The Commissioners appointed Bill Bizzell to replace Juarez. Bill Bizzell resigned leaving the position open.

Bill Lindeman was born

in Hayes County Texas, August 26, 1925, on a ranch twenty miles Northwest of San Marcos and remained there in the ranching business until he was employed by the Texas Game & Fish Commission on June 9, 1959.

His first law enforcement job was constable of Pct. 4, Hayes Co., being appointed January 6, 1956 and serving in this capacity until June 9, 1959. He was the only officer in Pct. 4, Hayes County, and it kept him busy. He learned everything from the school of trial and error (as they didn't have all of the training centers to help beginning officers.)

He ran for this office one time during his three and one half years. He ran a real fine race, as he had no opponent. That ended his career as a politician.

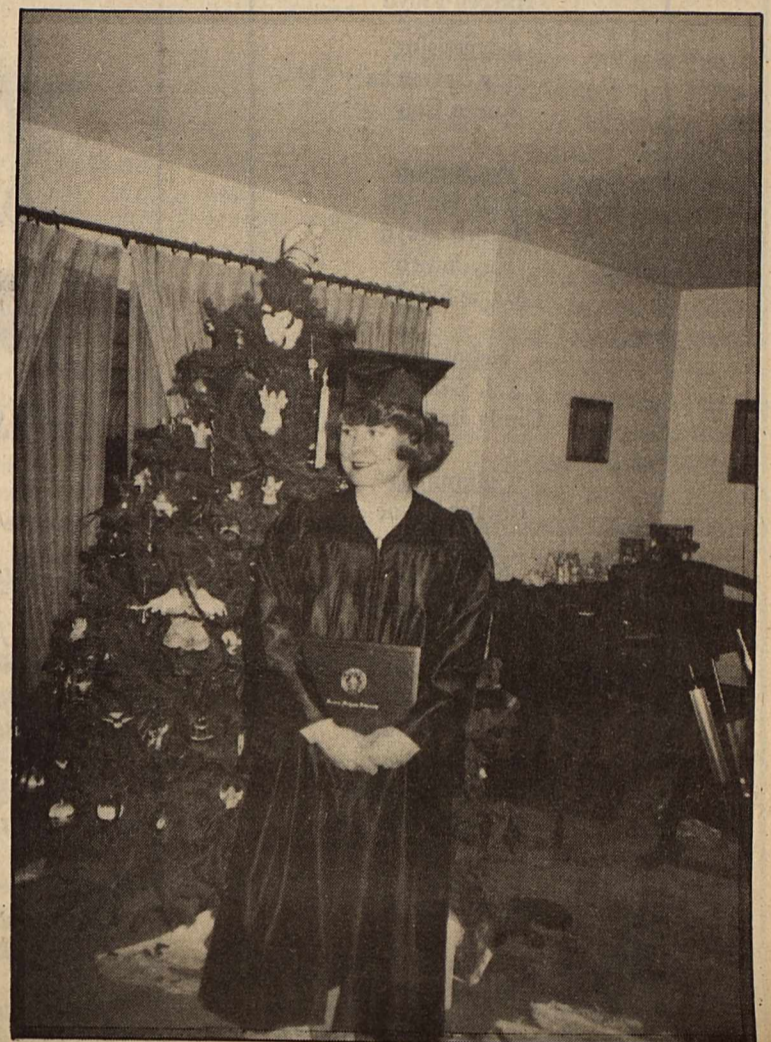
He began his Game Warden Career in Edna Jackson County. When he was hired, the Department would hire a man and give him a lawbook and a badge and put him to work until they ran the next Game Warden Training Academy. He remained in Jackson County from June 15, 1959 until November 28, 1959, at which

time he was sent on a detail to work for Captain Herbert Ward in Maverick County at Eagle Pass, until he could attend the Training Academy at A & M University.

Bill left Eagle Pass in January 1960 to attend the 12th Game Warden Academy. After completion of the Academy, he returned to Maverick County as State Game Warden. He remained there, living in Quemado, until Game Warden Clarence McBee retired in Brackettville. Clarence retired the last day of 1961. At that time, Bill requested a transfer to Kinney County as he had been assigned to work both Kinney and Maverick Counties. He moved to Brackettville, February 1, 1962 and has been here ever since.

Bill retired as Game Warden in July 1989. He did not completely retire as he worked as a Private Game Warden for the J. K. Burr Ranch south of Spofford.

Bill stated, "I am happy about the appointment and I would like to thank those that were responsible for the appointment, and for having faith and confidence in me."

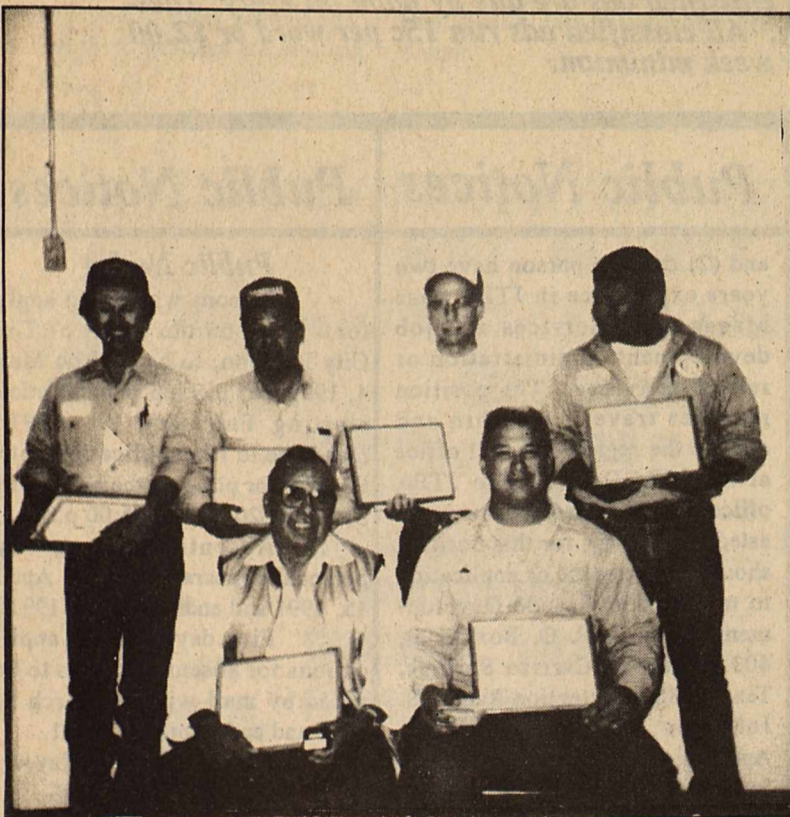


Else Sanders Graduates

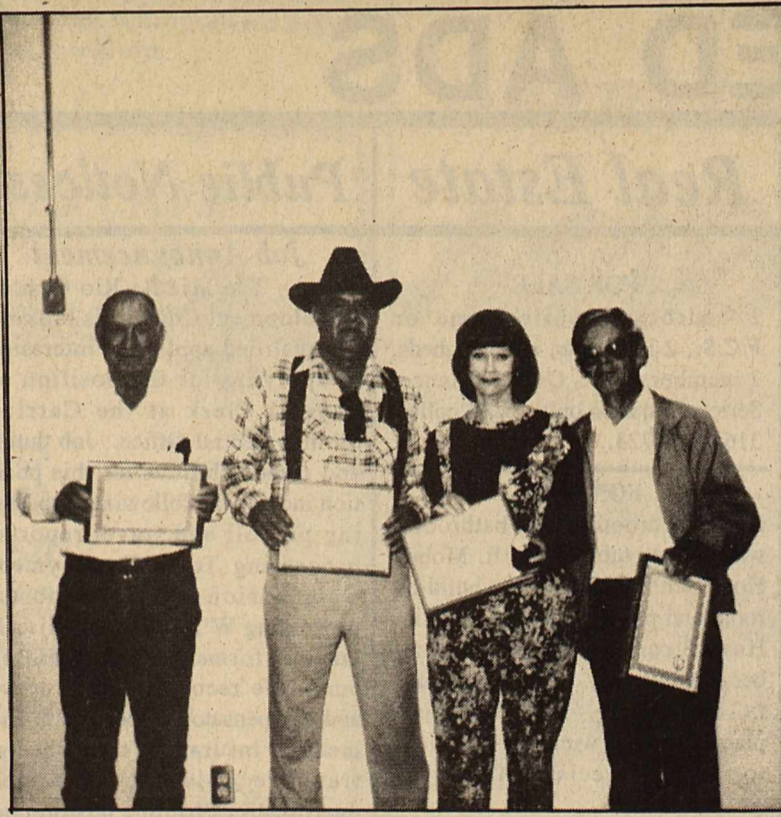
Tuesday, February 12th, during a luncheon at the Rio Grande Electric Co-op office in Brackettville, six employees and four retired employees received awards from the Co-op.

Commissioners' Court Discuss Swimming Pool

On the 11th of February, 1991, at 9:00 a.m., the regular meeting was held at the Kinney County Courthouse, Brackettville, Tx.

County Judge Tim Ward called the meeting to order and determined that a quorum was present, as all Commissioners were present. Judge Tim Ward read a list of twenty-one names of county residents serving with the Armed Forces in the Middle East, in Operation "Desert Storm." Commissioner McClure suggested that the Court send each one of them a letter. The minutes of the January 14, 1991 meeting were read and approved. County Officials, which included the Road

Supervisor, Librarian, Sheriff, County Clerk, Director of Elderly Nutrition, and the Indigent Health Care Officer gave monthly reports. A Depository for County Funds was designated, which will be the First State Bank of Brackettville. The resignation of TAC Board member Cordelia Mendeke was accepted, and a replacement was discussed and appointed. The new Board Member is Joe Garza. The resignation of County-wide Constable Bill Bizzell was accepted. The next subject for discussion and possible action was a replacement for the Constable's position, and whether to go ahead with an appointment and what qualifications,

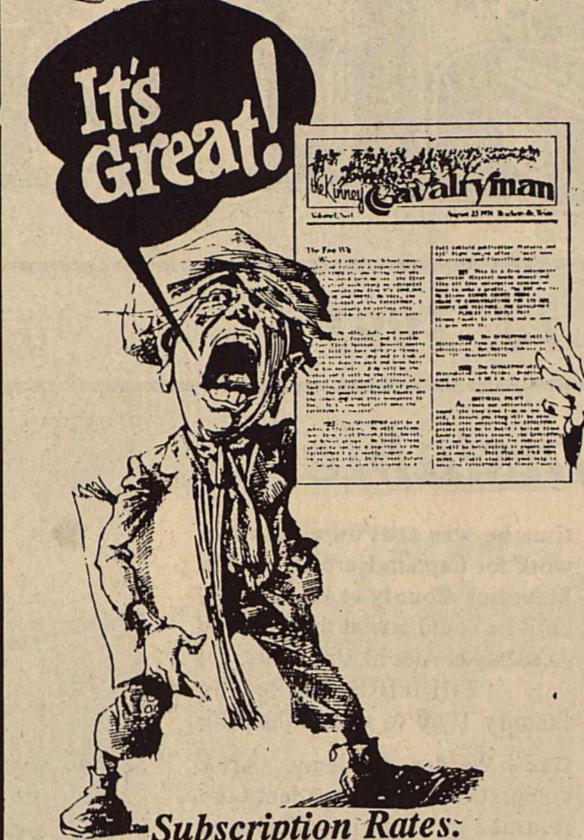

Word Studies

"But as for me, I trust in Thee, O Lord, I say, 'Thou art my God.' My times are in Thy hand; Deliver me from the hand of my enemies..." (Psalm 31:14-15a). In these verses, the Psalmist, King David, is stating his trust in the Lord for time and eternity. When David wrote, "My times are in Thy hand," he was expressing his faith that his life was in the Lord's hand, and that nothing would ever happen to him unless the Lord wanted it to happen, or allowed it to happen. The same idea is expressed in the New Testament when the Apostle Paul wrote, "For I am convinced that neither death, nor life, nor angels, nor principalities, nor things present, nor things to come, nor powers, nor height, nor depth, nor any other created thing, shall be able to separate us from the love of God, which is in Christ Jesus our Lord" (Romans 8:38-39).

With the war in the Persian Gulf raging, many of us have children and grandchildren involved in the fighting, or apt to be called to fight. As Christians, we are praying for the Allies to win this war quickly, with as few

TEXAS SENATE WEEK IN REVIEW

AUSTIN - On Tuesday, February 6, the Texas Senate met in Joint Session with the Texas House at 12 noon to hear Governor Ann Richards deliver her first State of the State Address. Governor Richards presented her vision for a "New Texas" with special emphasis on restructuring state government, calling for a state lottery, ethics reform, and "legendary customer service" by state government to the citizens of Texas. Governor Richards singled out the State Board of Insurance for ignoring the needs of the people, and demanded the remaining commissioners resign. Governor Richards reemphasized her commitment to education by returning the individual schools back to the teachers, parents, and students who attend them, and creating an equitable and stable funding for the schools, but refusing to "level down" or "mandate mediocrity" as a basis for meeting the Supreme Court's April 1 deadline. Lieutenant Governor Bob Bullock indicated that the address was a strong one and that he looked forward to working with the Governor in meeting the challenges ahead.

Pending in the Senate Finance Committee is a package of bills sponsored by Senator Carl Parker of Port Arthur, which will attempt to establish a state-wide property tax to fund Texas Public schools. The Parker plan calls for a one-dollar for every 100 dollars of assessed value to replace local school taxes. The funds will then be redistributed to local districts

based on the number of students. Under this plan, local districts will be able to tax an additional 25 cents per 100 dollars of assessed value for local enrichment. This package contains legislation for a constitutional amendment which will allow the voters to decide in a special election their choice for funding public schools.

In other committee business, the Senate Subcommittee on Water heard testimony on Senate Bill 14, sponsored by Senator Parker, relating to oil and other chemical spills. The bill has received support from environmental groups, as well as the oil and gas industry.

Today the Senate met as the Committee of the Whole Senate for the purpose of hearing presentations from staff members on key components of redistricting. Every ten years, based on information gathered from the U.S. Census, lawmakers are charged with the task of redrawing legislative and congressional districts using the new population figures. Upon the conclusion of the presentations, the Redistricting Subcommittee on Congressional Districts convened with Senator Eddie Bernice Johnson of Dallas as Chair to organize and prepare for hearings. The Subcommittee on Legislative Districts is expected to meet next week with Senator Bob Glasgow of Stephenville as the Chair.

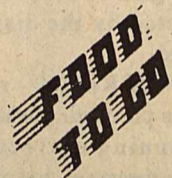

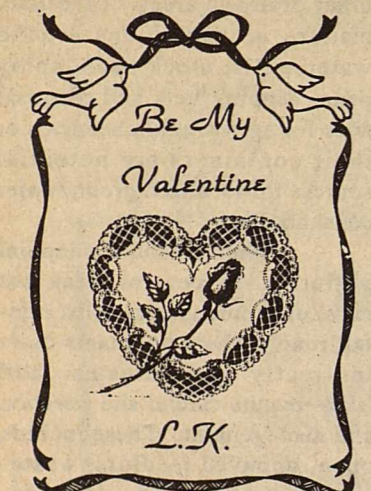


The Bibles Says

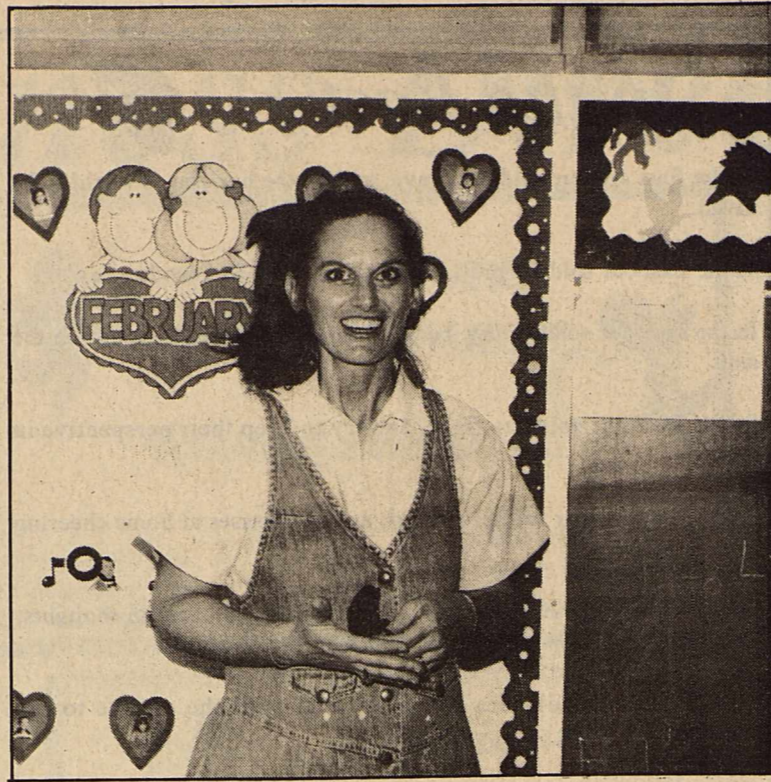

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRACKETTVILLE: Supports the creation of a solid waste disposal district in the Middle Rio Grande Region of Texas.

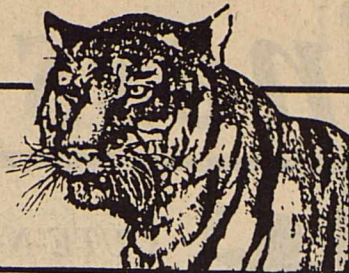

Tiger Baseball Begins February 18th

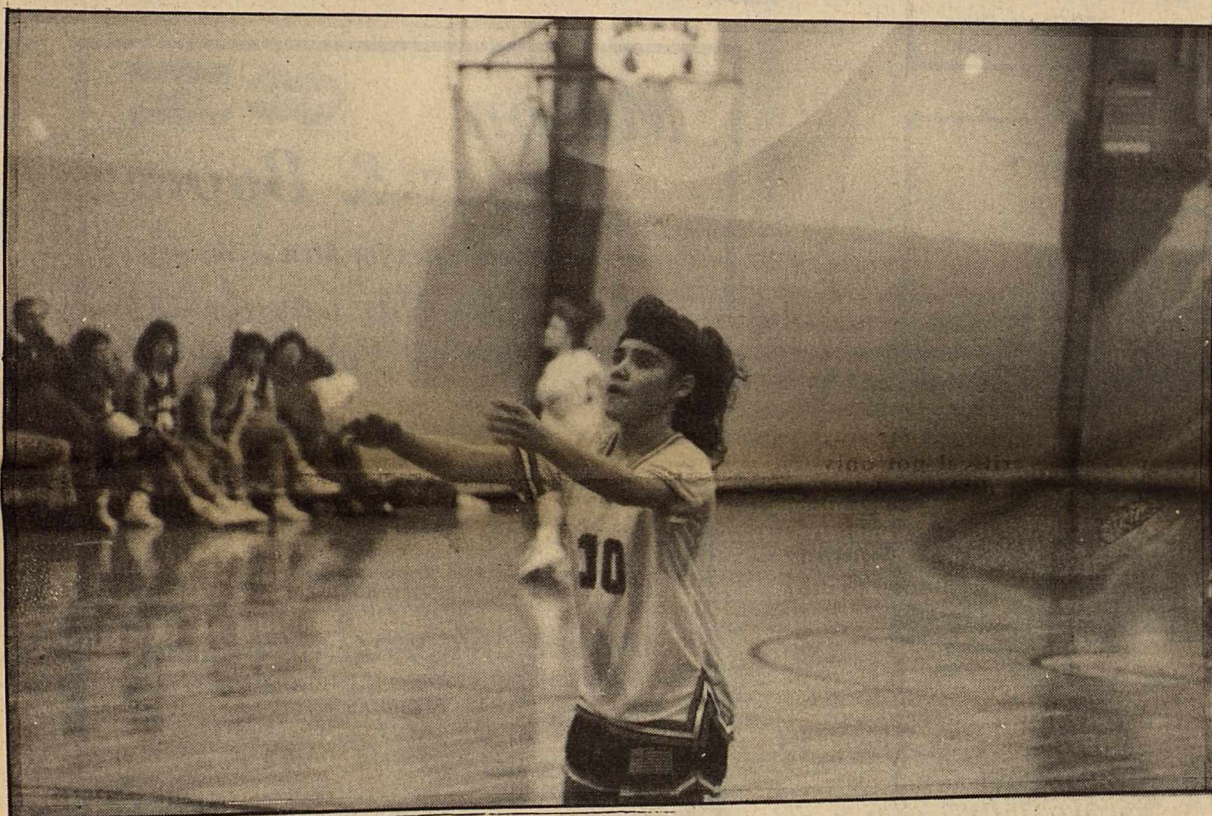

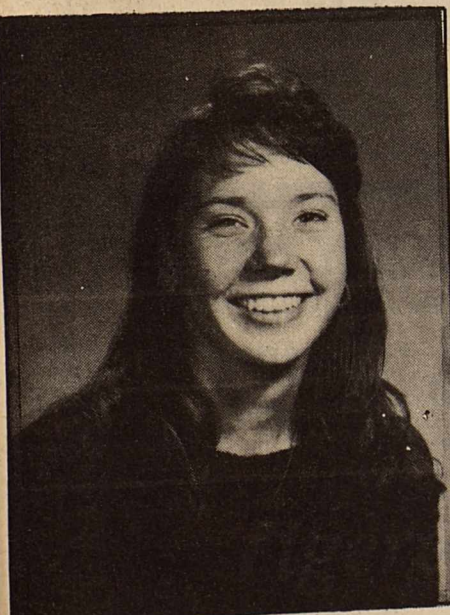
J.V. Over Natalia

"The bench played real well," said Coach Ken Campbell. "We would have scored a lot more if the starters had their regular playing time," he concluded.

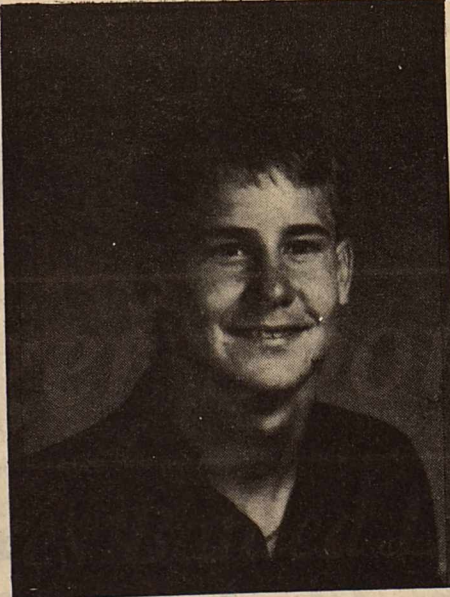

City Council votes down CNN news

Monday night at City Hall, the regular Council meeting was held with all Council members present.

The minutes of the previous council meeting were read and approved as was the City & Utility Department Financial & Operational reports.

Mr. Ron Barbutti spoke on the Planning Grant and demonstrated to the Council 6 or 7 base maps of the entire town. Maps were categorized by housing that was vacant or occupied; standard, sub-standard, 0-10% of estimated value needing repair, deteriorated, 10% to 60% of estimated value needing remodeling and 60% or over being dilapidated. Mr. Barbutti went on to explain that housing was further itemized as to trailers on wheels, extensions built onto trailers, manufactured homes being pre-built or doublewide. Then areas of moderate and low income were identified with further discussion needed on this in order to identify them according to the map. Also completed were the water system layout which identifies water lines, gas lines and waste water lines in the entire city. "The map for the Planning Grant needs to be 1 inch equal to 400 feet which is too small for you to use," stated Mr. Barbutti. "Another map in different colors which will give the City Utility people something to work with is being done." Street and highway maps were also broke down and explained. Then commercial and residential district map needs to be finished. Maps on the Central Business District still need to be done, and economic plan and a capital improvements plan. An open meeting is to be held on Monday, Feb. 25th, at 6:30 p.m. at the Brackett High Auditorium to show the maps to the public and to get input from the public.

Comment sheets will be at the meeting to be filled out with no signature required. Meeting will address areas of future growth and the areas of housing, what sort of programs housing ought to address and what sort of economic development the people would like to have here.

On the swimming pool, Council is just waiting for the Texas Department of Health's comments on plans. It will take approximately 90 days to complete. (15 days to bid and 70 days to complete work.)

John J. Ruiz from Del Rio, Middle Rio Grande Development Council was present to ask for support from the 9 counties and municipalities to help get this Regional Landfill Resolution through Legislation. A solid waste task force will be made up of elected officials in the different counties represented by MRGDC.

Mrs. Molly Schroeder was present to explain that The Well has been exempt from taxes from the county as a Historical site and has had it's Medallion since 1979. She asked if Council would exempt it from city tax also. Council looked at the amount of taxes to be exempt and approved the exemption.

Police Chief Johnny Fritter asked the Council to approve purchase of a camcorder to be used on patrols. It would be attached to the windshield and pick up sound also. It was approved as long as all council members are informed of the price beforehand. Price is not to exceed \$1200.

Chief Fritter, David Tillery and David Martinez have been going to Animal Control School. For 90 days warnings will be given out for animals not permitted or stray animals, after 90 days citations will be given out. David Tillery, who was appointed

by Council as the local health authority stated that there are a lot of stray cats, dogs, possums, skunks, coons, etc. which could propose health problems. One child had been bit badly approximately 3 weeks ago by a stray.

A motion to take \$5000. from Street repair and put into Utilities for extension of water lines to be laid on both east and west sides of town was approved. It was discussed that monies will have to be budgeted from now on to cover costs of expansion of city growth in order to get more revenue.

The CNN cable TV poll showed that of those polled, 45% were for and 55% were against having the new channel added for \$1 more a month. Motion to refuse the new station was approved.

March 18th to 22nd was approved for Clean Up Week concentrating on the main thorough fares in town. Wood by-products will be allowed to be dumped at no charge. Wood by-products being limbs, grass, debris and lumber. A cleanup committee consisting of David Esparza and David Tillery with one person from each precinct to check during free week. Citations will be given out to trouble areas, if not done during the free week.

Since funds are available, it was approved to purchase a new computer to be used in Bookkeeping.

It was approved to let the Chamber of Commerce bring in a carnival for this year's Frontier Fair.

The Council then went into executive session to discuss: a. personnel policy- was tabled b. probationary period of David Esparza was voted to be terminated.

But beloved, be not ignorant of this one thing, that one day is with the Lord as a thousand years, and thousand years as one day. The Lord is not slack concerning his promise, as some men count slackness; but is long suffering toward us, not willing that any should perish, but that ALL SHOULD COME TO REPENTANCE." (vs. 1-9)

A true Christian will encourage you about the soon coming of Jesus Christ; they will point to scriptures that prophecy about the return of our Lord, which are now being fulfilled all

Rather than scoff at these signs, Paul said the Christian will "comfort one another with these words." (I Thes. 4:18)

Peter went on to say in II Peter 3:10-12, "But the day of the Lord will come as a thief in the night; in the which the heavens shall pass away with a great noise, and the elements shall melt with fervent heat, the earth also and the works that are therein shall be burned up. Looking for and hastening unto the coming of the day of God, wherein the heavens being on fire shall be dissolved, and the elements shall melt with fervent heat? Tracks Along the Trail

John Colter began his exploring career with Lewis and Clark. After six wilderness trips he quiet saying, "After six years, I'd as soon hang onto my scalp."

Colter signed on with Lewis and Clark in 1803, but left on the return trip to join a trapping outfit.

In 1807 his employer sent him to confer with Indian Tribes around the Yellowstone. Colter was credited with exploring present-day Yellowstone Park.

In 1808 Colter was hunting with a group of Crow Indians along the Missouri, when they met a large group of Blackfeet, who were on their way to kill a few Crows. During the bloody battle that followed, Colter was seen killing a Blackfoot. Because of this incident he was a marked name among the tribe.

A year later Colter and another trapper, John Potts, had

another run in with the Blackfeet. Potts was cut to pieces and scalped. Colter was stripped and told to run and run he did. He gradually pulled way ahead of the tribe, except for one brave who he disarmed and killed the Indian with his own spear.

In 1810 he returned with a large party of trappers and erected a stockade. After the Blackfeet had killed and robbed and scalped five of his party he decided to settle down.

Colter moved to the vicinity of St. Louis, married a young lady and settled down on a farm to try living a more peaceful life, and as he said when he died, at least he still had his hair.

When he died in 1913, his wife couldn't afford a coffin or a funeral, she put his pouch on his body and left.

Years later in 1926, Colters remains were found.

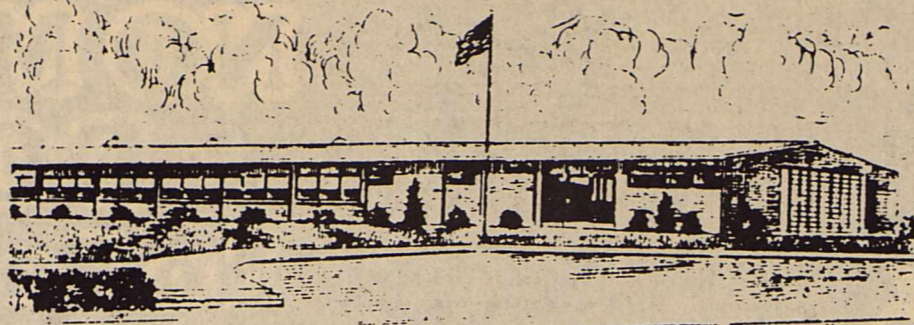

BRACKETT TRUSTEES WORK TO SET PRIORITIES FOR BUILDING PROJECTS

Brackett ISD Trustees and Administrators continue to plan for the District's future. The Trustees will hold a Saturday morning workshop with architect Don Legge to consider priority projects for the school district. The Trustees have already given top priority to the construction of additional classroom space to accommodate the growing elementary population and the building of an Ag Science classroom and shop. Refurbishing of Jones Elementary is another priority item.

Saturday morning, the Board will look at the cost effectiveness of constructing an elementary gym against the cost of building a new cafeteria/dining area and preserving the existing gym for elementary use. Also being considered are general repairs to the older buildings and removal or relocation of portable buildings. Updating facilities used for physical education and extracurricular activities will also be discussed.

THIRD GRADE LETTERS TO SAUDI ARABIA

BRACKETT FACULTY ELECTS DISTRICT ADVISORY COUNCIL

Senate Bill 1 from the 1990 Special Session of the Texas Legislature mandated that each school district set up a council made up of professional employees to act in an advisory capacity to the Board of Trustees. The Brackett ISD conducted an election under the guidelines of SB1 on February 11, 1991. Professional personnel were elected in three categories: Regular Secondary Teacher, Regular Elementary Teacher, and Other Campus Professionals. Three representatives were elected from each category. Elections will be held annually with one-third of the membership terms expiring each year.

The committee will meet with the Board at least four times each year. The committee will also meet with the Superintendent monthly. The committee acts in an advisory capacity to consider district educational goals and objectives and major district wide classroom instructional programs identified by the Board or the Superintendent.

BRACKETT TRUSTEES RESCHEDULE REGULAR MEETING FOR THURSDAY, FEBRUARY 14

The Brackett ISD Board of Trustees rescheduled their regular February meeting to Thursday, February 14, 1991. The meeting will be held in the Board Room at 6:30 p.m. The meeting was changed because of a Tigerette basketball game that was played Monday evening in Hondo. The Board will deal with regular agenda items and will schedule an extended public forum in order to give citizens an opportunity to express their views on the recently called bond election.

In addition to their regularly monthly meeting, the Board will meet with the district architect on Saturday, February 16, 1991 for a long range planning session concerning anticipated construction projects. The workshop will be held at the school campus beginning at 8:00 a.m.

SCHOOL DISTRICT APPEALS FOR HELP IN CONTROLLING VANDALISM AT THE TIGER TRACK

The Tiger Track has been the scene of increasing vandalism in recent months. The first vandalism occurred when the timing stand was turned over. After it was repaired, it was turned over again. Recently, the restrooms were broken into and the light fixtures and the sinks were destroyed. The resulting water leaks caused some damage to stored materials. Also, a continuing problem at the facility is the number of beer bottles and associated trash thrown on the fence line and in the facility itself. Superintendent Bob McCall stated, "There have been instances where beer bottle and wine bottles have been broken in the long jump pit. This is extremely dangerous to the students and members of the community who use the facility."

The track remains open to public use throughout the year. The school district officials ask that anyone who has information

relating to the vandalism and litter at the facility contact the district or local law enforcement authorities.

"We have no desire to close the facility to the public," McCall said, "But we have to be able to protect district property and equipment." It would be a shame if the district were forced to lock the facility because of a few individuals who have no respect for the community or district property."

"We have asked that local law enforcement officials include the track in their regular patrols and we have had a very positive response," McCall stated.
