



# Six Tigerettes chosen for All-District Team


This past September 13,

Northern Mexico, Circa 1913, 5th Cavalry Regiment. Occasionally while on the march on a campaign, a soldier's home was a little better than a pup tent or just sleeping under the stars (or dark clouds & thunder storms) on a saddle blanket. This photo depicts a quarters almost as the barracks back at the post, but not quite! As seen in this photo, two nice cots, with

mattress's, wooden flooring, hooks to hang garments and other necessary items on, a table of sorts, and best of all, standing room in the tent. Note the saber standing in the far right corner, and the trooper's campaign hat hanging on the wall above the right cot. ### Walker Named TASB Executive Director

Austin -- Dr. Billy D. Walker has been appointed executive director of the Texas Association of School Boards (TASB) at a special called session of the TASB Board of Trustees January 26, 1991 in Dallas.

TASB President Patti Clapp of Richardson Independent School District said, "Dr. Walker was selected with the full support of the board because of his strong background in school finance, his credibility with public schools, and his ability to work with state and national leaders."

Since 1989 Dr. Walker had served as director of the Texas Center for Educational Research (TCER) in Austin. He is chairman of the Technical Advisory Committee to the State Property Tax Board and was a member of the Governor's Task Force on Public Education (1989) and the Governor's Select Committee on Education (1988). In addition, Dr. Walker serves on several other state and national committees and task forces.

With a strong background in education, Dr. Walker has experience as a teacher, elementary and middle school principal, and education service center consultant. From 1976-1981 he was director, division of administrative services at Region

XIV Education Service Center in Abilene, where he also served as a consultant in school administration and coordinator of special projects. In 1981 he moved to Ector County Independent School District (Odessa), where he held the position of deputy superintendent for business affairs before joining

A native Texan, Dr. Walker earned his bachelor of science in education and doctor of education from Texas Tech University and master of arts from Hardin-Simmons University. He is the author of "The Basics of Texas Public School Finance" and more than 40 articles and monographs on school finance.

Dr. Walker replaces Orbry D. Holden, who resigned as TASB executive director after 13 years of service.

TASB is a voluntary. nonprofit association established more than 40 years ago to serve local Texas school districts. It is composed of 1,058 school districts and county school board, 47 junior colleges, 66 tax appraisal districts, 50 educational cooperatives, and the 20 education service centers. Together, TASB represents the largest group of publicly elected officials in the state with combined expenditures of \$15 billion annually and more than 400,000 employ-







## Governor Richards Supports Lottery Bill

Texas, I believe, is total \$731 million. missing a bet by not taking a chance on a state-run lottery. Fortunately, the lottery door is still open -- if the Legislature acts quickly. Lawmakers have to decide that the time for protracted lottery debate is over. It's time to let the people decide whether they want to take advantage of this profitable, wholly voluntary means of raising much-needed state revenue.

I was once a lottery skeptic myself. But after analyzing the moral, practical and fiscal questions that the lottery issue raises, I'm persuaded that a state-run lottery is a good idea. I believe we need to do everything possible to save money, to consolidate state government and to raise revenue from sources other than taxes. And that's why I have designated lottery legislation as an emergency matter during the current session of the Legislature.

I support the lottery bill proposed by Rep. Ron Wilson of Houston and Sen. John Montford of Lubbock for two simple reasons: (1) Texas needs the money; (2) Texans deserve a say.

Thirty-three states and the District of Columbia administer lotteries. So do Canada, Mexico, Australia and several nations of Western Europe. Texas is the largest non-lottery state, the only one of the nine most populous states without a lottery.

Last year, lottery sales across the nation totaled \$20 billion. Lottery revenue accounts for about 2 percent of all stategenerated revenue in the United States. That figure translates into \$7.75 billion. Texans ought to be taking advantage of such a popular revenue producer.

Estimates of the net annual revenue-raising potential of a Texas lottery range from \$500 million to \$800 million for what the experts call a "mature" lottery, a lottery that is four or five years old. A report prepared for my office by the Comptroller's Office estimates that if the Legislature passes a lottery bill quickly enough The Cavalryman may for Texas voters to act in May, charge me for advertising space if ticket sales could begin as early as this articles becomes any longer. A lottery is no budget panacea, but with an estimated \$4.6 billion shortfall casting a chilly cloud over essential state services, every little bit helps. Given our budget situation, those lottery revenues look mighty

The question I keep asking lottery opponents is "Where else can we come up with money we need so quickly -- and so painlessly?" So far, they have failed to give me a satisfactory answer.

A lottery might prevent an undesirable rise in the sales tax, already one of the highest in the nation. A Texas lottery also could attract revenue from out-of-states eager to play in Texas. Texans spend money on other state lotteries, and on Canadian and Mexican lotteries. I'd be willing to bet that a Texas lottery would attract players worldwide. There is, of course, a Texas mystique, and we ought to capitalize on it.

Most people who walk into a 7-Eleven to buy a lottery ticket see it as close in spirit to a church bingo game or a PTA cakewalk or a volunteer fire department raffle. It's entertainment. They know the odds of winning are slim, but they see no harm in spending a dollar or two a week to give it a try. It's fun, it's voluntary, and like a fire department raffle, the proceeds go to a

Beyond the money a staterun lottery would raise is the question of the people's will. And that's important. Texans have said repeatedly that they want a lottery. That was the message that came through loud and clear as I campaigned from one corner of this state to the other last year. The Texas Poll found that 76 percent preferred a lottery to a sales tax increase. The same percentage preferred a lottery to a state income tax. And 93 percent said that the state should give Texans a chance to vote on a lottery.

We should let the people decide whether Texas will have a lottery. They will decide, after all, whether they will play if the lottery motion carries. We in state government can trust their common sense, their good judgment. It's a fundamental principle of the New Texas that when the people are given a say, the odds are always excellent that Texas will come up a winner.



expect to finish in last place."


Pictured Tevin Senne as he steals the ball from a Pirate player as John Hernandez breaks down court.







As I write this article on Sunday, Feb. 17, I am excited about what I just read in columnist Jack Anderson's article in todays Express News in which Anderson talks about the American troops in Saudi Arabia. In discussing what the troops do with their time, he says, "A surprising number have turned to religion. The boom item here is not beer, but Bibles. Thousands of special Bibles with desert camouflage covers are being shipped in." Anderson further states that there are more than 700 American chaplains serving the troops, and there have been "more that 100 Christian baptisms..." What an striking contrast this presents; the 700 chaplains bravely sharing the Gospel in combat conditions with America's courageous young men and women, and our "Christian" leaders back home conducting peace demonstrations! "SHALL the Board of Trustees of the Brackett Independent School District in Kinney County, Texas be authorized to issue bonds of the District in the principal amount of \$1,000,000 for the construction and equipment of school buildings in the District and the purchase of the necessary sites therefore; and shall there be pledged and levied, assessed and collected annually ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds as the same become due; said bonds to mature serially or otherwise not more than FORTY (40) years from their date, to be issued in one or more series at any price or prices, and to bear interest at such rate or rates (fixed, floating, variable or otherwise and not to exceed the maximum rate permitted by law at the time of issuance of the bonds) as in its discretion the Board of Trustees shall determine?"

SECTION 2. The entire District shall constitute one election precinct for this election and the Brackett Independent School District Central office, 400 Ann Street, Brackettville, Texas is hereby designated the polling place. The persons hereby appointed to serve as the election officers at said polling place are as follows:







#### Texas Agricultural Extension Service By Alan L. McWilliams

Many of us have horses in this area. Horses are a joy to own and also useful in every day ranching operations. Often, we feed our horses without much thought as to how the quality of feeds affects the horses overall nutrition.

Quality roughage serves as the foundation for a safe and effective horse feeding program. Roughage helps to maintain the integrity of the digestive tract and serves to help minimize certain vices such as wood chewing or cribbing. Good quality hay can also meet a majority of the nutrients required for mature, idle horses and dry pregnant mares in the early stages of pregnancy.

Hay selection is critical to insure maximum nutrient supply per dollars spent. Careful selection will allow the horseowner to avoid purchasing inferior quality hay that could potentially contribute to digestive disorders such as colic. Horse owners who intend to purchase large amounts of hay at a time will benefit from retrieving a core sample of hay that can be analyzed for nutrient content.

Hay should always be selected on important visual criteria. Characteristics of good quality may include (1) a high leaf to stem ration, (2) a fresh smell and appearance, (3) cleanliness (free of weeds, trash, dirt) and (4) to some extent the color of the hay. Hay that is steamy has been cut at a more mature stage of growth and will be significantly lower in nutrient supply and digestibility. The presence of weeds in the hay affects total quality and some weeds may be highly toxic to horses.

Hay that smells the least bit musty or moldy should be avoided. In some havs, a white. floury, powder-like appearance mold. Horses that are not overly hungry will often refuse to eat moldy hay if given a choice. However, hungry individuals will readily consume moldy hay when no other alternative is available. Round bales are sometimes used in horse feeding programs and can be very effective in providing a source of nutrients for horses.

Even with round bales, emphasis should be placed on quality. The other layer of weathered and/or spoiled hay may need to be removed to let horses access the high quality roughage in the bale. Horseowners are wise to consider the economics, while keeping in mind that some hay wastage is essentially inevitable when round bales are used.

Unfortunately, many of the decisions that horseowners make in choosing a particular type of hay are based on tradition. In reality, horsemen can have an equally effective feeding and conditioning program with either legume or grass hay serving as the roughage source. The type of hay dictates the concentration of nutrients that will be needed in the grain mix or concentrate for a particular class of horse.

Purchasing and providing top quality roughage for horses is a challenging and continuing effort. But, it is well worth the time in being able to effectively manage and enjoy horses, regardless of what they are used for.



Eighteen year old Susan Magoffin, the first American woman over the Santa Fe Trail described Bents Fort when she stopped there as an "ancient castle" of Mexican style with an American flag flying overhead. There were twenty -five rooms and shops built along the walls. The parlor had no chairs, just cushions along the walls and the company sat all around in a large circle. There was a table which contained a bucket of water. The floor was dirt and if you had water left in your dipper it was thrown onto the

During the long winters the trappers gathered in the parlor for "sing along," taffy pulls and dancing. Many a trapper who could not write his own name could quote Shakespeare. There was lots of gambling, a billiard room, a regular race track and a

The Bent brothers, Charles and William and Ceran St. Vrain ran Bents Fort which was north of Mara, New Mexico. They were leading dealers in the buffalo robe business on the Santa Fe Trail.

The first regiment of cavalry dragoons under Captain Clifford Wharton provided Army escort for the traders. When the Mexican import duty was raised to \$500 a wagon, traders just got larger wagons. Bent hired Kit Carson to help hunt the one thousand pounds of meat needed daily to feed the Fort. Carson earned one dollar a day.

Each caravan of traders was organized where the traders selected the caravan captain. The captain then chose a wagon boss, chief scout, "pace" lieutenants (four for each twelve wagons) and a stock wrangler.

The provision list for the two months journey to Santa Fe included about fifty pounds of flour, fifty or more pounds of bacon, ten pounds of coffee, twenty pounds of sugar and a little salt. Beans and crackers were considered luxuries.

There were two Army escorts of the caravans, one in the spring and one in the fall. Thirty traders transacted \$450,000 worth of business in Santa Fe in 1844.



#### NEW RULES CLEAN UP **CAMPUS**

New Rules for being tardy and for single absences have cleared the halls in Brackett High School. Students who have been prone to be slightly tardy have changed their ways when they change classes.

The Board of Education, in their January meeting, adopted new rules that had been developed by the Brackett High School Student Counsel, the Brackett High School Faculty, and the Principal's office. The new rules entail stronger penalties for being tardy to a class and being absent to a single class. These rules pertain to unexcused tardies and absences.

For single, unexcused absences, the first offense is punishable by one day in-house suspension, the second and additional offenses are punishable by one day of Saturday class. This process is renewable on a six-weeks basis.

Being tardy to class is similar. The first offense is punishable by one day of in-house suspension and the second and additional tardies punishable by Saturday classes

Brackett High School students have cooperated with the new rules in a very positive manner. Classes are running much better since they are not interrupted by tardies as much and much more instruction takes place both by not having classes interrupted by late students and by having the students there every day.

#### TRUSTEES CONSIDER PLAN TO KEEP SCHOOLS OPEN PAST A POLI 1 SUPREME ime during Texas Public School COURT DEADLINE

heard a report from Superintendent Bob McCall on the possibility of the Texas Supreme Court cutting off state funds to school districts if the Texas Legislature fails to act before April 1, 1991 on a new school finance plan. Mr. McCall told the Board that in his opinion the Court was serious about the cut off of state money. He is also concerned that the plaintiffs in the Edgewood V. Kirby case have said that they will seek an injunction prohibiting local districts from spending even local money after April 1 to keep schools open.

McCall told the Board that the priority for Brackett ISD should be to keep the schools open if possible. The Board agreed that this would be the goal of the district. McCall then informed the Board that the District was preparing a contingency plan. Under this plan, the District would be prepared to make an advanced payment to employees on March 31, 1991. This payment would be sufficient to assure that the schools remained open through the end of

McCall stated, "This will allow students to receive credit and graduate. Seniors can continue to make college plans. Teachers and students will not have to worry about returning during the summer months to make up days missed if the schools close."

This is just a contingency plan. If the legislature acts before April 1 or if the Supreme Court extends the deadline then the District can continue business as usual.

#### BRACKETT TRUSTEES VOLUNTARY APPROVE FOR TESTING STUDENTS AND FACULTY

Brackett Independent School District Trustees gave final approval to a voluntary drug testing program for the professional staff and students in grades 7-12. Testing will be done once each six weeks through a random drawing of students and staff who choose to participate. Testing will be done for a variety of drugs, alcohol, and/or steroids.

Students and staff that test positive will be referred to the district counselor and the family will be referred to a drug abuse counseling agency. The program will be implemented in September of 1991. The Board agreed with the administration that the program will be voluntary and that the goal will not be punitive. The objective of the program is to give students another reason to "say NO to drugs" and to resist peer pressure to use drugs and alcohol.

Testing procedures will be established to protect the confidentiality of the tests. School Superintendent, Bob McCall, noted, "I do not expect to find any positive tests from participating students and staff. We have had drug dogs in the schools at least once per month for the last two years and we have not had a positive "hit" yet. We want to do what we can to help students resist the temptation of drug and steroid use. I think that we will get a majority of the students and staff to participate the

- 4. The Board approved the recommendations of the Brackett ISD Textbook Committee and adopted all titles from a list of books approved by the State Textbook Committee. 


