A reception honoring Mrs. Roy D. Smith on her 83rd birthday was held this past Sunday from 2:30 to 4:00 p.m. in the O'Donnell Community Center. Her children, Roy F.; Augie Mc-Carter; Nannie Bell Harris; Georgia Mae McKee; Ross D.; and Dorothy Hays, served as hosts and hostesses for the event.

Mrs. Smith's grandaughters presided at the serving table; and guest were registered on a ninety year old table belonging to the late Mr. Smith's aunt. It was decorated with a gold high top shoe with gold flowers and a crystal ink-well and quill. A color scheme ranging from light pink to hot pink was carried out in the other decorations.

Mrs. Smith was born in Level, Tennessee in 1888: and moved with her family to near Waco when she was 8 years old. Throughout the years she has also lived in Abilene and Bonham.

In 1902, her husband, the lat e Roy D. Smith, purchased a farm near O'Donnell. They were married in 1907 and came to West Texas in a Model T. Ford.

Through the years Mrs. Smith was very active in all organizations of her community such as Eastern Star; Red Cross; Home Demonstration Club; P.T.A.; and many charitable activities. She was instrumental in organizing the O'Donnell Cemetery Association; and has been an active member of the First Baptist Church in O'Donnell for from far and near. 47 years. She still attends church regularly; and participates in all Eastern Star activities.

Mrs. Smith has pioneered many of the trails of this area while watching the community grow into what it is today. She has been through two depression eras; and the 1938 tornado which destroyed everything except one old chair.

When O'Donnell needed a new principle for the grade school, Mrs. Smith carried a petition around that helped get Mrs. Paul Gooch elected to that position. She has consequently helped many underpriviledged people, regardless of race, throughout the years; and as a result enjoys a wide circle of friends.

E. F. Chastain, Austin; Dr. O. Chastain, Edenburg; and Mrs. J. A. Moody, San Angelo-brothers and sister of Mrs. Smith were at the reception.

Mrs. Smith has one living uncle, George Chastain, of Ft. Worth; 12 grandchildren; 20 great-grandchildren; and 1 great-great grandchild.

Before her husband died three years ago, he and Mrs. Smith had already celebrated their Golden Wedding Anniversary in 1957; and their 60th Wedding Anniversary again in 1967.

Did you know that the number of ships in the U.S. Fleet has declined 30 percent since 1968, while Russia has been filling the seas?



The Twirlers are currently practicing for their twirling contest and hoping for a first place as is the band.



Commissioner Don A. Jones made a motion that County and District Clerk's request be granted and the money be turned into the Officer's Salary Fund, motion seconded by Commissioner Hubert Walker, and approved unanimously.

A Report was made by Bobby Malone, E. E. Merriman and Compa y, Auditor, Lubbock, -Texas on the audit made in the County Offices, Precincts and all county business.

Commissioner Don A. Jones made a motion that the current accounts in the amount of \$15,2445.53 be approved, motion seconded by Commissioner M. Eddie Simer, and approved unamimously.

Commissioner Don A. Jones made a motion to renew Food Stamp Program for 1972, motion seconded by Commissioner M. Eddie Simer and approved unanimously.

Co. and terminating at the place of eeginning and the same having been duly considered, it is ordered that the same be approved and that said road be, and it is hereby, established, and that the field notes of said survey and description of aid road be and they are hereby recorded in the minutes of this court, to wit: Beginning at Southeast corner of Section 86, Thence North a

It is further ordered, upon consideration of the claimants' statements of damages and assessments thereof by said jury, that there be allowed and paid as just damages, and as adequate compensation for the land taken for said road, the amounts of money as follows: To See \$500.00 for Land. 





New Rules "New Rules of the Road" School Buses: A new statute prescribes methods of overtaking and passing a school bus from any direction other than on a divided highway, must stop and not proceed until the bus either discontinues the flashing of the visual danger signal or " begins to move.

Bike Riders: must not ride double unless they have factory installed double seats. He must also ride near the right side of the road and have head lights visible for 500 feet and a tail reflector visible at 300 feet or more if used at night.
