

2008 DCP Sign-up Underway; USDA Reminds Growers of Other Sign-up Deadlines

On June 25, Agriculture Secretary Ed Schafer announced that signup for the 2008 Direct and Counter-cyclical Payment Program (DCP) would begin immediately and continue until September 30, 2008.

Producers can fill out their 2008 DCP contract at any USDA Service Center. Pro-ducers can also sign-up online. Through the online sign-up process producers can choose payment options, assign crop shares and sign and submit their contracts from any computer with Internet access. They can also view and print submitted contract options for their records as well.

One important note for both growers and landowners to remember is that when sign-ing up for the 2008 DCP landowners is that a new Power of Attorney form granting authority to the producer to act on behalf of the landowner may be required in order to sign-up for the 2008 DCP program.

Producers and landowners (grantors) who previ-ously executed FSA-211 or other Power of Attorney, authorizing an attorney-in-fact to act on their behalf for anything other than "all current and

future programs," will need to execute a new FSA-211 or other Power of Attorney.

Under rules established for the 2008 DCP program, USDA will compute DCP pay-ments using base acres and payment yields established for each farm. Eligible producers will receive direct payments at rates established by the Food, Conservation and Energy Act of 2008.

Under the 2008 DCP, eligible producers may request to receive an advance payment of 22 percent of the direct payment for each commodity as-sociated with the farm. USDA will issue advance direct payments as soon as practical af-ter enrollment. Final direct payments will be issued after October 1, 2008.

Growers can also elect to receive advance Countercyclical program payments when their availability is announced for a commodity whose estimated effective price is below its target rice (which takes into account the direct payment rate, market price and loan rate).

The online, electronic DCP (or eDCP) service saves producers time, reduces paperwork and speeds contract processing at USDA Farm Service Agency offices. It is available

to all producers who are eligible to participate in DCP who and obtain eAuthentication accounts. The electronic service is available by going to http:// www.fsa.usda.gov/edcp and clicking on "Access eDCP Service.

To access the service, producers must have an active **USDA** eAuthentication Level 2 account. To get a Level 2 account, producers must complete an online registration form at http:// www.eauth.egov.usda.gov and then visit the local USDA Ser-vice Center to verify their identition to verify their they are completing their 2008 to provide the set of the

FSA's eAuthentication service has strict security measures to protect participants' private information. Only authorized federal employees have access to information producers submit electronically.

Given the fact that additional time has been granted to complete the certification process, growers are encouraged their county offices to complete these and any other outstanding business they may have down at their county FSA office

Oven Canning Oven-canning canning method involves placing jars in an oven and heating. In oven canning, product temperapoint because the jars are not covered. It is, therefore, not safe to require temperatures higher than

Because this process fails to botulinum, it can cause the food to become toxic during storage. Also, canning jars are not designed for intense dry heat and may explode resulting in serious cuts or burns.

Open Kettle Canning The Studies have concluded that: open-kettle method involves placing hot food in jars and sealing with no further heat treatment. This method is NOT recommended for home canning because the amount of heat applied may not be sufficient to destroy bacteria and the product may spoil quickly or cause llness when consumed.

Microwave Processing Microwave oven cannot be used for home canning. Microwaved food uniform. There is also a danger of explosion of the jars within the microwave oven or as food is being removed from the oven.

Good luck to the shooters attending the San Angelo Texas Shotgun Shootout this coming weekend.




