USDA Announces 2009 DCP Signup

ACRE Sign-up to Begin In Spring 2009

The United States Department of Agriculture has announced that enrollment for the 2009 Direct and Countercyclical Payment (DCP) Program for farms with base acres began Dec. 22 both online and at local USDA service centers and will continue until June 1, 2009. The June 1, 2009 deadline is mandatory for all participants. USDA will not accept any late-filed applications.

Producers who are eligible for the 2009 DCP Program will also be eligible to enroll in the Average Crop Revenue Election (ACRE) Program. The enrollment period for the ACRE Program will begin in

Producers may first enroll in the DCP Program, elect to receive advance direct payments and then later modify their en-rollment to include the ACRE program or they may wait and enroll in DCP and ACRE at the

same time in Spring 2009.

USDA computes DCP Program payments using base acres and payment yields established for each farm. Eligible producers receive direct payments at rates established by statute regardless of market

For 2009, eligible producers

may request to receive advance direct payments based on 22 percent of the direct payment for each commodity associated with the farm. USDA will issue advance direct payments beginning December 2008. Counter-cyclical payment

rates vary depending on mar-ket prices. Counter-cyclical payments are issued only when the effective price for a commodity is below its target price. The effective price for each covered commodity and peanuts equals the direct payment rate plus the higher of the national average market price received by farmers during the 12-month marketing year or the national average loan rate.

Producers are urged to make use of the eDCP automated website to sign up; however, producers can visit any USDA Service Center or their administratively assigned center to complete their 2009 DCP con-



Feeling Stuffy? Check Indoor Humidity

at home? Anybody in the family had a mysterious nose bleed or some unexplained conges-

Getting a physical examination might be a good idea - but also consider checking indoor humidity. Excessive static electricity and/or persistent respiratory problems may be symptoms that the humidity levels in your home are out of balance. How do you know if your home's humidity needs to be adjusted? Watch for symptoms in the house itself, she

Indoor air that's too dry can cause too much static electricity in clothes and carpets. Too much indoor humidity will show up as water - condensation, frost or ice - on the insides of windows, damp spots and mold on walls or ceilings, and sweating water pipes

People tend to be comfortable when the temperature is between 68 F and 72 F and the relative humidity is between 25 percent and 50 percent. Normal indoor living activities

such as cooking, bathing, doing laundry, washing dishes, breathing and perspiring - generally add enough moisture to the air to keep relative humidity levels at the comfort zone. But being comfortable is one thing - knowing your home's humidity level is another. You don't really know if the relative humidity is high enough or too high unless you are monitoring it. And that's where a gauge comes in handy. We recommend that you have a hygrometer to monitor both temperature and humidity. A portable one can be taken from room to room to monitor. In humid areas during the winter.

Do your sinuses feel slightly indoor humidity should be no stuffy after a couple of hours more than 40 percent, to reduce more than 40 percent, to reduce condensation on windows.

In very dry climates, keeping a vaporizer or humidifier going in the house can maintain indoor humidity at comfortable levels. Once again, monitoring is the key. most practical way to control moisture problems in the home is controlling the source. Make sure plumbing leaks - both indoor and outdoor - are fixed, water use is reduced and/or improved, and the home is weatherized as well as insu-

Improving air circulation and ventilation inside the house can help too, but just opening windows might not be enough. That depends on moisture in the outdoor air, pollutants in outdoor air and other factors.

Opening windows to improve air circulation may work best in dry climates. However in wetter climates the air conditioning or heating system may also be used to help dehumidify indoor air

Mandatory Public Notification Language Notice of Drinking Water ARSENIC Violation

The Texas Commission On Environmental Quality (TCEQ) has notified the Borden County Water System that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for ARSENIC. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL ARSENIC at .01 mg/L, and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for ARSENIC indicates a level of .0043 mg/L for the 4th quarter of 2008.

This is not an emergency. However, some people who drink water containing ARSENIC in excess of the MCL over many years could experience skin damage or problems with their circulatory system, and may have increased risk of getting cancer.

You do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you.

Borden County Water System is installing equipment to lower the level of ARSENIC to below the U.S. Environmental Protection Agency (U.S. EPA) standards.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

Mandatory Public Notification Language Notice of Drinking Water FLUORIDE Violation

The Texas Commission On Environmental Quality (TCEQ) has notified the Borden County Water System that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for FLUORIDE. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL FLUORIDE at 4 mg/L, and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for FLUORIDE indicates a level of 5.5 mg/L in the 3rd quarter mg/L in 2008 and a level of 5.5 mg/L in the 4th quarter of 2008.

This is not an emergency. However, some people who drink water containing FLUORIDE in excess of the MCL over many years could get bone disease, including pain and tenderness of the bones. Fluoride in drinking water at half the MCL or more may cause mottling of children's teeth, usually in children less than nine years old. Mottling, also known as dental fluorosis, may include brown staining and/or pitting of the teeth, and occurs only in developing teeth before they erupt from the gums.

You do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you.

We are working to correct the problem by investigating the possibility of connecting to another system.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.
