9 Harvest Gaining Steam

The past two weeks have cotton. allowed the High Plains to gain a little traction on the 2009 harvest. Recent estimates indicate the area is close to having 25 percent of the crop harvested.

Yields reports continue to be favorable with a great many early-harvested irrigated fields being reported in the two to three bale per acre range. Early non-irrigated yields are also holding up

As more non-irrigated fields are harvested dryland yields are likely to fall back because many lower yielding dryland acres have been sitting on the sidelines waiting on a hard freeze to prepare them for har-

Getting to the 25 percent harvested milestone hasn't been an easy process. Several brief weather events that could have caused significant probwell with a fair number of lems, thankfully, failed to creacres reporting bale an acre ate widespread issues for cotton producers.

While a few isolated areas did receive more than an inch of moisture, most producers haven't been kept out of the field for more than a day or two with any of the recent weather. Following each event conditions recovered quickly enough for growers to get back to work with minimal delays.

A favorable forecast for next week should allow growers to pick up their pace even more and rapidly advance 2009 harvest progress.

Coyotes Stay Perfect With Victory Over Westbrook

making their final appearance of the 2009 season at home before the play-offs start in a couple of weeks. Seniors, Michael Cooley, Flynn Chapman, Karl Lamming, RT Shafer, Brendan Tarleton and Skyler Dear playing in their final home game, not their final football game got the start on offense for the Coyotes.

These six seniors made good on their start as they used a nice 4 play offensive drive to start what would be a school record for points in a quarter as Lamming hit Tarleton on a nice 13 yard pass and catch to give the Coyotes a quick 6 to 0 lead. Chapman, who has been kicking extra-points for 3 years connected for the 8-0

The first team defense did not allow a single first down, in fact, the Borden County defense on the evening only gave up one first down and 20 total yards of offense, -11 rushing yards of offense, -11 fushing yards and 31 yards passing. After forcing the Wildcats to give the ball up on downs, Cooley had his first score of the evening on the Covote first play of their second series, scoring from 24 yards out. Chapman added the extrapoint kick for a 16 to 0 lead.

The Coyotes forced a turnover as Cooley sacked the Wildcat quarterback and John Hensley recovered for the Coyotes. The Coyotes used 3 plays to score as Chapman rumbled in from the 1 yard line to push the lead to 22-0 and then his kick made it 24 to 0. After a forced Wildcat punt, the Coyotes used another one play drive to get on the board again as Cooley scored from 19 yards out after having his punt return touchdown called back because of a penalty. The PAT failed and the Coyotes had a 30 to 0 lead with 3:57 remaining in the opening quar-

Six Coyote seniors were the first play, David Rodriquez aking their final appearance carried the ball 43 yards to set up another Lamming touch-down pass, this time to Zach Telchik and the PAT kick by Chapman made the score 38 to

On the next Wildcat possession, Quint Shafer forced a fumble on his sack of the Wildcat possession. cat quarterback and Miles Valentine recovered for the Coyotes. On the first play, Rodriquez made good on this run covering the 11 yards needed for the score and a commanding 46 to 0 lead following another Chapman kick with 2:58 left in the first.

The Wildcats were forced to punt again, this punt put Borden County deep in their own territory at their own 10 yard line. But, as was the theme most of the night, another one play series resulted in another Coyote touchdown, this time Tony Soto was the recipient as he followed some nice blocks by the rest of the 2nd team offense on his way to a 70 yard touchdown and a 52 to 0 lead, still in the first pe-

Another Wildcat fumble gave the Coyotes the ball at the 20 yard line and as was the case most of the evening, a one play drive would follow as John Hensley got into the act as he scampered in from 20 yards out to make the score 58 to 0 in one quarter of play, believed to be a school record for points in a quarter while in six-man play.

The 2nd quarter saw more of the same defensively, as another forced punt was quickly followed by a one play drive as Rodriquez scampered in from 38 yards out to make the score 62 to 0.


The Wildcats finally had a little success as they got their initial first down of the game and managed to drive into Coyote territory, but any hopes of aining in the opening quar-c. getting on the board were dashed when Tanner Richey jumped in front of a Wildcat forced a Wildcat punt and on to intercept a pass. This time

the Coyotes took two plays, but the results were the same as Rodriquez had his 3rd touchdown and Chapman added the kick to make the score 70 to 0.

Richev recovered a fumble on the ensuing kick-off. The coyotes moved the ball into field goal range and Chapman came in to try his first ever field goal attempt, he did not waste the opportunity as he connected on the 37 yard field goal to make the score 76 to 0.

On the final defensive series of the evening, the Coyotes put all six seniors back on the field, having to move one or two into different positions to make this work, but the results did not change as the game ended with Borden County making another defensive stop as the final horn sounded and a very solid home finally for the seniors.

Leading the way for the Coyotes was Rodriquez with 150 yards on 5 carries and 3 touchdown's, while making 5 tackles. Miles Valentine had 11 tackles a big hit and a fumble recovery. Skyler Dear had 5 tackles, Quint Shafer had 6 tackles a sack and a caused fumble. Zach Telchik had a 7 yard catch for a score and was in on 4 tackles and 2 passes broken up. RT Shafer had a sack and 4 tackles, Brendan Tarleton had a 13 touchdown catch and 5 tackles and a caused fumble and pressure. John Hensley had 4 tackles and a carry for 20 yards and a score. Tanner Richey had 7 tackles, a pass broken up, an interception and a fumble recovery. Michael Cooley had 90 yards on 5 carries and 2 td's and was in on 3 tackles, with a sack a caused fumble and a pass broken up. Tony Soto had 105 yards on 3 carries and 1 touchdown, and was in on 6 tackles. Karl Lamming was 2 of 2 passing for 20 yards and 2 scores and in on one tackle. Derek Tatum was in on 3 tackles and caused a fumble. Flynn Chapman had a catch for a yard and 15 yards on 2 carries and a touchdown and had 6 tackles and 2 pressures and was 6 of 10 on extra points and made a 37 yard field

After the defense, consisting of ends, Zach McMeans, Brady Dowds and Tristen Benavidez, linebacker TJ Basquez, corners Matthew Proulx and Matthew Ham (moving from safety to corner to replace injured Kurt Shafer) and Safety Ricky Torres quickly forced a 3 and out. Ricky Torres returned the punt to the Wildcat 4 yard line and the first team offense of Proulx, Dowds, McMeans, Ham, Basquez, and Benavidez wasted little time taking the lead as Ham followed some nice blocks to cover the remaining five yards and the first



lyzing prices at a nearby grocery store, the verdict is this: if you are a savvy shopper, you can purchase a variety of healthful snack options at a reasonable cost. Here are some tips for snacks that make nutritional sense

1. Individually packaged snacks have their appeal. One hundred calorie packs, which

help you to limit portion size, range in cost from \$.46/ pack for mini bags of

popcorn to \$.60/pack for animal-shaped crackers. Purchasing your own box of crackers and portioning out serving size portions may save a few pennies—whole wheat

crackers and whole grain fruit-filled cookies were \$.26/ ounce portion. Individually packaged fruits—clear cups of mixed fruit and small boxes of raisins—ranged in price from \$.67/name brand individual mixed fruit cup to \$.28/box of store brand raisins.

2. Are pudding snacks a standard fare at your housethese may contribute some calcium, but not as much as the real thing made with milk. Pudding snacks were priced

at \$.37 to \$.53/serving. Other comparably priced options that were higher in calcium would be individual yogurt (\$.44 to \$.55/serving) or Lincoln, The Nebline individually wrapped string

After researching and ana- fruit-flavored snacks do not count as part of the fruit group. Although, these may have added vitamin C, the first ingredient is likely sugar. Go for the real thing instead. These snacks cost \$.29 to \$.33/serving. An individual piece of fruit—say a banana, orange or apples, on sale—is naturally sweet, packs fiber and other nutrients for \$.20 to \$.33/piece. Look for specials, buy fruits and vegetables in season to save \$\$\$ in the produce section. Also, a piece of fruit makes a good substitute for the .55 candy bar at the checkout.

better than you might think in comparison to soda at \$.38/

• No-name water—\$.17/

· Calorie free, antioxidantrich black and flavored teas-\$.18/bag

• Hot cocoa (still a sugary choice)—\$.20/packet.
• 100 percent juice pouch—

· Store brand tomato juice (packed with flavor and vitamin C)—\$.33/6 ounce can.

Plan to purchase healthy snacks to avoid the default high fat, high sugar and low nutrient snack foods.
