

Bi-District Champions Coyotes Lasso Loop Longhorns

The Borden County Coyotes got off to a great start for the 2009 play-offs as they traveled to O'Donnell to battle the Loop Longhorns. The outcome of this game was decided early as the Coyotes quickly built a 30 to 0 lead in the opening quarter before cruising to a 62 to 6 victory in a game stopped at halftime by the 45 point mercy rule. The Coyotes suited up 24 Coyotes and all 24 Coyote players contributed to the Bi-district victory to start the 2009 play-offs.

The Borden County Coy-otes won the coin flip and then promptly took 2:05 off the clock and 6 plays to take a quick 6 to 0 lead. This touchdown came on a 10 yard run by Michael Cooley. Flynn Chapman added the extrapoint kick to give the Coyotes an 8 - 0 lead. The Coyote defense bent a little on the first drive, but after dodging a well executed drive by the Longhorns, the Coyotes added an-other touchdown following another nice drive, this drive culminated with a 3 yard Cooley run, which was set up by a nice 49 yard pass and catch from Miles Valentine to Quinton Shafer. This time the PAT was a little wide and the Coyotes had a 14 to 0 lead with 3:48 left in the opening quarter.

On the next drive, the de-

fense got into the action, as nice pressure by RT Shafer, John Hensley and Flynn-Chapman forced an errant pass by the Longhorn quarterback. Tony Soto was quick to turn the errant pass into a change of possession as he intercepted the pass at the Longhorn 15 yard line. Two plays later, Cooley and the rest of the Coyotes had their 3^{rd} score of the game. Chapman again found the mark on the PAT to push the Coyote lead to 22 to 0 with 1:43 to go in the quarter.

On the next Longhorn drive, the defense continued flexing their muscles as RT Shafer sacked the quarterback, and in the process, the ball popped loose and John Hensley was Johnny on the spot to not only recover the ball, but scoop it up and rumble 25 yards to pay dirt and another touchdown for the Coyotes with 1:14 left in the quarter. Again, Chapman converted to push the lead to 30 to 0.

On the ensuing Coyote kickoff, 3 Junior varsity players got an opportunity to get a taste of play-off football, but in their over eager state, they ran by the Longhorn return man, and after breaking a one Coyote tackle, the Longhorns got on the board courtesy of the 60 yard kick-off return.

Borden County wasted very

little time regaining control, as Cooley set sail on a 54 yard run with :20 seconds left in the opening quarter. Chapman's PAT made the score 38 to 6.

After forcing a Longhorn punt to start the 2nd quarter, Cooley got loose on another (Continued to Page 3)





Finishes Season With Win Against Whitharrel





USDA Reminds Producers of Upcoming Livestock Disaster Assistance Deadlines

Garza-Borden County SDA Farm Service Agency SA) Executive Director Vic-USDA Farm Service Agency (FSA) Executive Director Victor Ashley, reminds eligible ranchers and livestock producers of the Dec. 10 deadline for applying for benefits under the provisions of the Livestock Forage Disaster Program (LFP) for losses incurred dur-ing calendar year 2008. For losses incurred during the 2009 calendar year, the deadline to apply for benefits is Jan.30, 2010.

LFP provides payments to eligible livestock producers that have suffered livestock grazing losses due to qualifying drought or fire. Fire losses apply only to federally managed rangeland. Eligible live-stock under LFP include beef cattle, alpacas, buffalo, bee-falo, dairy cattle, deer, elk, emus, equine, goats, llamas, poultry, reindeer, sheep and swine. For losses due to drought, qualifying drought ratings are determined using www.drought.unl.edu/dm/ the U.S. Drought Monitor lo-

In order for an LFP applicant to qualify for program .. benefits, the applicant must have purchased insurance cov-erage through FSA's Noninsured Crop Disaster Assistance Program (NAP) or the Pasture, Rangeland and Forage Insurance (PRF) program offered through the Risk Management Agency (RMA).

Leonard, northeast of Dallas, when I saw this sign that read TEXAS SIDECARS. It piqued my curiosity. When I got to town, I saw a motorcycle with a sidecar on it. It was a nifty looking thing and reminded me of a bullet. It was black and shiny. It belonged to Bob Darden, who owns Texas Sidecars. He started his business ten years ago as he was winding down his job as a designer of computer programs. Before that he was a teacher.

"It was sort of a hobby," says Bob. "I built my first chassis for a sidecar in the 70's and took my kids for motorcycle rides. I wanted to retire to some facet of the motorcycle business. I had worked in fairly sedentary jobs and wanted something where I could do more mechanical things. I'm sixty now but when I was fifty or fifty one, the company I worked for was closing down the division I was in and I made the decision not to relocate back to the big city. I had worked in Washington and Boston and wanted to get out of the rat race. I had a good friend here and one day I woke up and said, 'what am I doing here' and came to Texas. My wife and I decided we would make this work.

Bob climbed on his motor-cycle and took me for a ride in his sidecar. It was a new experience for me. I loved it. I felt the breeze.

He can make a sidecar for a motorcycle or scooter. "The majority of motorcycles and scooters on the market today have very sturdy frames. We are able to design a mounting kit for both. About a third of texassidecars.com.

Most of his customers are in their fifties and sixties. "They want to keep riding and with a side car they don't have to worry about balance, they don't have to put their feet down and hold up an 800 pound machine and they can carry more stuff. We advertise it as the world's largest purse for women. Or men who carry purses. We sell a lot of these to people who want to give their dogs a ride." A law went into effect this year that says any child under five years old who is a passenger on a motorcycle must be in a sidecar. He says there is some loss of safer. "You drive a sidecar rig where you ride a motorcycle or scooter. With a sidecsar, you may slide when you hit a patch

Bob says putting a sidecar on or taking it off is easy. It connects to the motorcycle or By Coach Benavidez scooter with just four bolts. Bob's company makes four models of fiberglass sidecars with prices starting at \$2900. Some extra fancy ones that are wider, taller and deeper with all sorts of equipment can go as high as \$10,000. They all come with windshields. He can make a sidecar for the right side or the left side. He can also build a special motorcycle ramp and locking device so that a handicapped person can drive the motorcycle from a wheelchair. He sells at least one sidecar a week and has sold them to every state except Wyoming. Bob Darden's website


