Have an Attitude of Gratitude

Focus on and be thankful for the good things in your life. Take nothing for granted. Every morning recharge your gratitude. Be grateful for everything you have, not upset over what you feel is missing.

Being bitter or resentful makes things worse. People who are bitter frequently find that their situations deteriorate and their mental and physical health decays.



2009-Crop Average Price Received Still Inching Up

Cumulative 2009 Upland cotton marketings through the month of June 2010 now total 9.238 million-bales according to information released July 30, 2010 by the USDA National Agricultural Statistics Service.

USDA estimated June 2010 cotton marketings at 299,000 bales with an aver-

age selling price of 67.60 cents per pound. The preliminary mid-month price reported for July 2010 was 67.50 cents per pound.

The 2009 Upland cotton Weighted Average Price calculated through June 2010 now stands at 62.10 cents per pound with only one month of data to be added before computing the final marketing year aver-

age price.

Currently the estimated 2009 Upland cotton Weighted Average Price is 10.10 cents above the 52-cent threshold where the Upland cotton Counter-cyclical payment rate begins to drop below the statutory maximum rate. Based on the current numbers the esti-

Cruising on the Big Ship

I went cruising the other day with some of my friends, about 6,200 of them to be more specific. In addition there were some 2,500 crewmembers to make our trip enjoyable. We were on Royal Caribbean's Oasis of the Seas, the largest cruise ship in the world, nearly four football fields long.

The ship has nearly everything you can imagine. It's a combination of big city sophistication and Disneyland. It was built at a cost of one billion dollars and has 9,000 pieces of art displayed throughout the ship, 7,000 of them commissioned. The ship's original name was Genesis, but was changed because of its religious connotations. It is truly a floating oasis.

The ship has a carousel with handcrafted horses, zebras, ostriches and other wildlife made from wood and painted in bright colors. It has special engineering to accommodate the ship's movement, even though the ship moves smoothly through the water and we had a hard time realizing we were on a ship. Steady she goes.

The ship's ice rink offers ice skating to passengers and quality entertainment by extremely talented athletes and artists. The lights, music and costumes make for an enchanting evening. The Aqua Theater offers productions similar to acts by Cirque du Soleil. Some of the divers have been in the Olympics and won national honors both in collegiate and professional competition. They show incredible strength and some dive into the small pool from a perch seven stories above the water. It is a thrilling spectacle. The Aqua Theater is also the location of

the belly flop competition, one of the best attended attractions on the ship. The Opal Theater offers Broadway-style entertainment. We saw the musical Hairspray. Late night opportunities include a comedy club and dancing to live music.

The spa, climbing wall, zip line, surfing area, jogging track, miniature golf course and a dozen hot tubs and swimming pools (some salt water, some fresh water) are among the diversions offered. A parade moves through the Royal Promenade that makes you think you're at a circus. The Rising Tide Bar rises 2 stories while you sip your favorite beverage. You can stroll along Central Park or the Boardwalk to shop and dine. There are 24 restaurants and 20 bars on board.

Nobody got hungry or thirsty for very long. People celebrated birthdays, quinceaneras, weddings, anniversaries and family reunions, with plenty of activities for kids.

We cruised in the Caribbean with stops in Nassau, St. Thomas and St.

Maarten. Passengers had the opportunity to go to a beach or take a tour. Shopping Shelby, the shopping consultant, offered suggestions about where to buy diamonds, black coral, tanzanite and ammonite. For the most part, though, people took the trip to experience the ship.

Seventy-five countries were represented. We talked to people from Rome and Rio who flew to Florida to board the ship in Fort Lauderdale for the week-long trip. Royal Caribbean is building another ship like the Oasis. We just might have to try it.

Rise and Shine Timesavers

It is hard to believe that school is beginning in only 10 days! Now is the time to start preparing yourself and your children to get ready for back to school so that on that first day back there aren't as many groans about getting up early and heading off to learn!

Organization is even more important when your child is not a morning person (do we hear sympathetic groans?). Here are tried-and-tested tips to get kids up in the morning and out the door!

Wake Them Up! Raise the blinds. About 10 minutes before the kids need to wake up, go into their bedrooms and quietly raise the blinds so they can slowly get accustomed to the light.

Play upbeat music. Set the radio alarm for a station with energetic music your children can wake up to. Or play a CD of your own selection, especially one they like and that gets their bodies moving. It's hard to stay in bed when the tempo is fast.

Get Them Dressed! Shower before the troops. If possible, make sure you get up in time to shower before the rest of the family.

Schedule the bathroom. If you have more than one child, or only one bathroom, set a monthly schedule of who uses it when. (Schedule some children to take their bath/shower at night, others in the morning, and specify the exact time each child has to be out of the bathroom.) Do ask your child for his or her preference. Warning: this plan won't always work, but knowing you have a plan may give you some peace of mind!

Prep the gym clothes weekly. Like taxes, dirty gym clothes are inevitable. So every weekend wash and dry your children's dirty gym clothes and put them back in each child's gym bag. Then hang the bag on the doorknob of their respective bedrooms. In the morning, all they have to do is snatch the bag on their

way out. Depending on the child's age (e.g., high schooler) and the weather, gym clothes may need to be washed more than once a week. (Note that this can also be applied to younger children's nap blanket/pillow or other special items they need in school.)

Kid-proof the closet. Have two closet rods for hanging clothes in your child's closet (if you only have one, lower extension bars can be found at your local mass merchandise store or online); Shirts go on top, pants/skirts on the bottom. Shelves are not so practical for children because they are hard to reach and stuff just starts to pile up in multiple layers! If possible, store off-season clothing on these shelves.

Label everything. Remember our mom's sewing name labels into every piece of our clothing when I was a child. Today, most elementary schools ask parents to label each individual marker, crayon, glue stick and plastic supply as well! The easiest way is to mark everything (including non-clothing) with a fine point permanent marker or a permanent marker laundry pen. You can either write directly on the item or write on adhesive address labels and cut them to fit the item.

Get Them Fed! Make lunches the night before and set the breakfast table the night before.

After the kids are in bed and the kitchen table is cleaned, put out plates and cutlery for breakfast. That way, the table is ready in the morning. That's one less last-minute morning chore.

Bake cookies for the week. One Sunday each month, bake a couple of batches of your children's favorite cookies and freeze them in individual freezer bags. They can keep them in the freezer up to three months.

Give a choice of breakfast foods. In most houses, nobody wants the same breakfast. So offer two choices: for instance,

cereal or eggs on one day; oatmeal or frozen waffles (the ones with no trans fat) on another. If they don't like the choice, they can get a granola bar from the cupboard or toast a frozen waffle.

Get Them Packed! Check the school folder nightly. Every night check your children's school folders (where they keep teacher notes, announcements, etc.) to make sure that permission slips are signed and you are not expected to bake three dozen cookies by the next morning!

Program and recharge your child's cell phone (if they have one). If your child has a cell phone, make sure you program it with emergency numbers (work and cell numbers of both parents/caregivers, other relatives, adult family friends, hospital, taxi, etc.). And make sure the phone is charged every night.

Rearrange backpack the night before. Make sure all homework, books, pens, etc. are packed in the backpack the night before. Then leave it right next to the front door or in the same place, every day.





mated marketing year-end Counter-cyclical payment rate has now fallen to 2.48 cents per pound.

Producers who received the 1.03 cent 2009 advance Counter-cyclical program payment could see a final payment rate equal to 1.45 cents per pound if there are no significant revisions in the preliminary monthly data already reported.

With such a small difference between the 2009 CC advance payment amount and the projected final payment rate it is entirely possible for revisions in preliminary data to alter the calculated Weighted Average Price that will determine the final CC payment rate.

Based on provisions of the 2008 Farm Bill, the Upland cotton Counter-cyclical payment rate goes to zero when the Weighted Average Price Received hits 64.58 cents per pound. Accordingly, any increase in the 2009 Weighted Average Price Received above 63.55 cents means the USDA Farm Service Agency would have to seek repayment of some portion of the 2009 advance CC payment as well.

With only one month of data remaining to be reported it seems unlikely that the calculation based on preliminary data will move above 63 cents.

Unfortunately, recent history proves that USDA revisions to previously released figures published in the monthly Agricultural Prices report can have a significant impact on the final calculation.

Since future revisions could substantially impact the final payment rate calculation the current 1.45 cent difference between the estimated Weighted Average Price Received and the FSA-paid advance CC payment rate is narrow-enough that it could be erased with the right combination of revised data and unreported marketing and price information.


