Money - Part 2

To ease financial strain you can increase income, reduce expenditures, or do both. Lowering expenses will provide you with immediate financial breathing room. To minimize expenses, cut spending on those items that are unessential.

Be honest about whether you really need something or just want it. Many things are nice to have but optional. You are not in competition with anyone nor do you have to show off. Being over your head in debt is nothing to brag about nor is it something to emulate.

There's a broad scope of choices when deciding how to accommodate your fundamental requirements. Whenever possible, spend less than you can afford. Rent a cheaper apartment, buy a smaller house, purchase a less expensive car, shop for clothes on sale, and comparison shop for food. Bring lunch to work instead of eating out. Rent a video rather than going to the theater.

Discretionary spending affords many opportunities to be resourceful. Entertainment, recreation, and vacations are examples of major elective expenditures. All of these areas provide significant possibilities for cutting costs. With

Effort and creativity will save you money. Consistently reducing expenses, even a small amount, makes a difference. Every ten dollars per week you cut back adds up to over \$500.00 per year. There's probably a lot more than ten dollars that you can't account for

Not being attentive to where your money is going is a recipe for trouble. A budget is a simple, effective tool for managing your finances that is often overlooked. It allows you to track income and expenses. Identifying your costs gives you the ability to effectively plan and cut back wherever possible.

To create a budget, itemize all take-home income and expenses. Divide expenditures into two groups: required and optional. Subtract all of your mandatory expenses from your income. The difference is your discretionary income. This discretionary income is your extra money to use anyway you want

If you desire something that exceeds your discretionary income, save for it rather than going into debt. Don't charge

USDA Deadline to Apply for SURE Crop Disaster Benefits is July 29

(POST, Texas), July 11, 2011 –Garza-Borden County USDA Farm Service Agency (FSA) Executive Director Victor Ashley, announced that the deadline to apply for assistance for 2009 crop losses under the Supplemental Revenue Assistance Payments (SURE) program is July 29, 2011.

"The SURE program compensates producers for production and/or quality losses during times of disaster," said Ashley. "All producers who have experienced crop production and/or crop quality losses must apply for SURE program benefits by the July 29th deadline," he said.

To meet program eligibility requirements, the farming operation must be physically located in a county that was declared a primary or contiguous disaster county by the Secretary of Agriculture under a 2009 Secretarial Disaster Designation.

Producers located in designated disaster counties must have suffered at least a 10 percent loss on a crop of economic significance and purchased crop insurance through the Federal Crop In-

surance Act or the Noninsured Crop Disaster Assistance Program (NAP).

However, an operation located in a county that did not receive a primary or contiguous disaster designation, can still qualify for SURE benefits if the actual farm production was less than 50 percent of the normal production on the farm due to a qualifying disaster event.


Producers and legal entities collectively cannot, directly or indirectly, receive more than \$100,000 in SURE and other

FSA disaster assistance payments. FSA disaster programs include SURE, Livestock Forage Program (LFP), Livestock Indemnity Program (LIP), and Emergency Assistance for Livestock, Honeybees, and Farm-raised Fish (ELAP).

Producers or legal entities, whose nonfarm income is more than \$500,000, are not eligible for SURE program payments.

The Six-man All Star Week works by each sport nominating its top athletes for the opportunity to practice and compete in an intensive but valuable weeklong clinic and All Star game at the end of the week. Athletes will be split into teams based on their school's geographical location and division. The athletes will be divided by men and women, West and East, and in divisions I and II (only basketball). All practices will be held in an intense two-a-day style Tuesday-Friday; football practices will be held at Monterey and Lub-bock High School fields and basketball practices at Estacado and Lubbock High Schools. USDA Designates 213 Counties in Texas as Primary Disaster Areas

WASHINGTON, The U.S. Department of Agriculture has designated 213 counties in Texas as primary natural disaster areas after one of the worst droughts in more than a century. The state sustained excessive heat, high winds and wildfires that burned hundreds of thousands of acres.

"Many producers have lost their crops due to the devastation caused by the drought and wildfires," said Agriculture Secretary Tom Vilsack. "Presi-dent Obama and I want these farmers and ranchers to know that we will support them through the recovery process and help them once again become productive suppliers of food, fiber and fuel that keep America prospering. This designation will help provide that support."



In addition to being delicious, berries offer many health benefits that you may not even realize. Since they are naturally sweet, adding berries instead of refined sugar is a healthy alternative to sweeten foods you often eat. Berries are also a great source of dietary fiber, which promotes a healthy digestive system, and are packed with Vitamin C, an immune boosting vitamin and antioxidant.Special compounds in berries may even prevent some forms of cancer!

The abundance of berries this month will most likely drive down the price at your local grocery store. Take advantage of those specials and stock up on these powerful little fruits.

storing berries:
• Choose plump, brightly colored berries at the grocery store. Unlike other fruits like peaches and mangoes, berries

If you've been to the gro- do not ripen further once picked and should have a beautiful color when purchased.

Store berries uncovered in the refrigerator and hold off on washing them until you're ready to eat them. Damp berries will spoil quickly.

If you purchased too many, rinse and seal in a plastic freezer bag. Berries freeze well and can be used months from now when they're out of season and prices have risen.

To incorporate more berries into your diet:

· Stir them into breakfast cereal, oatmeal, pancake batter or add some on top of waffles.

· Toss a handful of sliced strawberries into a salad at dinnertime.

· Cook up a berry compote. This versatile sauce can be eaten with waffles at breakfast or served as a savory side with a lean cut of meat at dinner.

Blend fresh or frozen berries into a smoothie or layer them into a yogurt and granola parfait. Using lowfat milk and yogurt will boost your intake of calcium and Vitamin D, too!



more on your credit cards than you can pay off in full each month. If you are unable to pay off your balance, stop charging until you do.

Your budget should account for every dollar spent. Don't spend more than your income. Predetermine how much to spend on discretionary purchases. Stick to the plan and resist temptation to deviate from it. Don't make impulsive buying decisions. Debt can pile up and always has to be paid back. Project ahead for major purchases or vacations.

Establish a savings program. Every time you get a paycheck, pay yourself first. Consider yourself a mandatory expense. Ideally, put away at least 10% of your take-home pay. This money should be placed in savings or other low risk investments. If 10% is impossible, pick an amount that you can manage and stick with it, no matter what. Saving consistently adds up.

Ensuring that you are not stretched to the financial

breaking point, or beyond, provides you with a great deal of peace of mind. A quality lifestyle is much more valuable than accumulating a lot of possessions that keep you in financial bondage. Peace of mind is priceless.

Prudent financial management requires planning, self-discipline, and restraint. Don't buy things you can't afford just because you have available credit. What others can afford has no bearing on you. Some-one with an outwardly affluent lifestyle may be drowning in debt. If you use these people as role models, you will wind

up the same way.
Being financially proactive keeps economic issues from becoming a negative undercurrent. It doesn't require much to develop good money habits.



Story Musgrave: Space Man

"I knew at a young age that I would be a survivor, an explorer and would have to take care of myself."

Story Musgrave grew up on a dairy farm in Massachusetts and learned how to repair farm equipment by the time he was five years old. Eventually he was an astronaut for thirty years, longer than anyone else. Before joining NASA, he was a surgeon.

"I practiced only two or three days a month while I was with NASA. My job, of course was a NASA astronaut. But to stay proficient in medicine, and that was one reason they hired me, I did trauma surgery for two or three days a month for twenty-five or thirty years."

Story got his name from his mother. It was her family name. He has seven graduate degrees in math, computers, chemistry, medicine, physiology, literature and psychology. He has been awarded twenty honorary degrees. He made six spaceflights and repaired the Hubble telescope.

six spaceflights and repaired the Hubble telescope.

"In 1975 they told me that the machine had been developed and I was to look after it with a spacewalk, not robotically. They said to look at every possible thing that could go wrong with it and be able to develop the tools and procedures to fix it. I worked with Hubble eighteen years before I went to fix it on a spacewalk."

Story Musgrave has a media production company, designed rides for Disney, and is a landscape architect. He operates a palm farm in Florida and teaches design at a college in Pasadena, California. He is a motivational speaker and goes to public schools encouraging students to reach their potential. He lives in Kissimmee, Florida and has seven children ranging in age from five to fifty. He says he was destined to become an astronaut.

"Space exploration happened late in my life, not when I was a kid. I decided to do that when the National Academy of Science and NASA decided to put their heads together about enhancing their interpretation of space flight by employing people with a formal education who could propose experiments to execute in space. I thought everything I had ever done I could apply to this job. It was a perfect fit."

Story never finished high school. He dropped out his senior year and joined the Marines. He says he had big responsibilities on the farm and the abstract nature of the classroom didn't appeal to him. "If I would have had good mentors they would have looked after me and understood who I was and what I needed. But I had no mentors and fell by the wayside."

Story says his experience on the farm, learning how to use his imagination to make things work and fix them when they broke gave him the ability to apply that farm boy knowledge to everything he does.
