Dare to Live Big Third Quarter Gets Coyotes First Win Over **Two-Time Defending State Champion Bearkats**

The Borden County Coyotes used a big third quarter to overcome a halftime deficit by the Garden City BearKats. The Coyotes were hoping to regain a little revenge having lost to the Bearkats twice last year by a total of 3 points. Although the faces of both teams have changed a bit, the need for a victory by the Coyotes was very important.

The Coyotes got off to a great start Friday as Austin Fields followed some nice blocks by the Coyote offense of Helio Rosales, Quint Shafer, TJ Basquez, Tanner Richey, Matt Roberson and Tristen Benavidez to reach the endzone from 53 yards away. The kick by Rosales was good and with only 53 seconds gone in the game, Borden County owned a quick 8-0 lead. On the very first defensive play for the Coyotes, junior Jared Smith had his first interception of his high school career which gave them nice field position.

The good fortunes did not last long as on the 2nd play of this possession the Coyotes turned the ball back over to the Bearkats. The Bearkats made the home team pay and managed to reach the endzone for a score of their own with 4:38 left in the period to tie the game at 8. Then, the Coyotes kept on giving to the visitors from the south as they turned the ball over again, this time with an interception deep in their own end. The Bearkats scored again with 3:02 left in the first to make the score 16

On the next Coyote possession they again found some difficulties and turned the ball over on downs. The Coyote defense finally stiffened and got the ball back after forcing a turnover on downs. They finally got their offense rolling and in the end the Coyotes got on the board on a Richey to Basquez 7 yard touchdown reception. Rosales kick tied the game at 16 with 6:35 left in the 2nd. The Bearkat offense con-

tinued their success against the Borden County defense as they scored with 2:09 left in the 2 to regain the lead at 22 to 16. The Coyotes wasted very little time responding as Richey hit Shafer on a 19 yard pass and catch play to tie the game with:57 left. Another Rosales kick gave the home team the lead again at 24 to 22. The Bearkats marched down the field and made a field goal on the last play of the half to grab the lead at half 26 to 24.
The Coyotes had to kick to

start the 2nd half and chose to give the wind to the Bearkats in order to have the wind at their back in the 4th quarter. Borden County did something that they have only done twice in the last 5 years, they kicked an onside kick. The strategy paid off as kicker Rosales recovered his own kick to give them possession of the ball. The Coyotes used a nice 6 play drive to regain the lead with a







National Breast Cancer Awareness Month

upon us, it is important to remember that October is National

Breast Cancer Awareness Month. Today, breast cancer is the most common cancer among women in the United States and the second leading cause of cancer death among North American women. Unfortunately, many women with breast cancer do not evenknow that they have cancer until it is in its advanced stages. It is estimated that 1 in 8 womenwill be diagnosed with breast cancer in their lifetime, and 1 in 30 women will die of the dis-

So what can we do to decrease our risk of dying of breast cancer? Early detection or via health screenings, such as mammography, is an important step. Screening examinations can detect breast cancers early, before symptoms occur, which may make it easier to treat the disease. Screening involves getting mammograms, clinical breast exams, and self breast exams, which are optional. There are many factors in predicting the chances of survival of a woman who is diagnosed with breast cancer, but finding the cancer as early as possible greatly improves thelikelihood that treatment will be effective.

When should women starting screening for breast cancer? If you are over 40 years old, you need a mammogram every year. A mammogram is an x-ray of the breast that usually involves two views, or pictures, of each breast. Mammograms help find lumps or growths that are too small for you or your health care provider to feel when conducting

With the fall season now an exam. Additionally, women who are younger than 40 and have had breast cancer or breast problems or have a family history of breast cancer need a mammogram once a

> A clinical breast examination is an examination of your breasts by a health professional, such as a doctor, nurse practitioner, nurse, or doctor's assistant. This exam is also known as a CBE. Clinical breast exams should be part of a periodic health exam, at least every three years for women in their 20s and 30s, and every year for women 40 and over. During your CBE, yourhealth care provider may tell you how to perform a breast self-exam, BSE.

> regularlyperforming BSEs, you will learn how your breasts normally feel, and you will be able to reportany changes in your breasts to your health professional as soon as you find them. Finding a breast change does not mean that there is a cancer. You may choose not to do BSEs, or you canjust do them occasionally.

Remember: The most important screening tools we have are mammograms and clinical breast exams. To reduce your risks of dying from breast cancer, you need to follow the guidelines on when to get them. Taking charge of your health now can lead to a healthier tomorrow. Start by getting screened this month in recognition of National Breast Cancer Awareness Month.




