Dare to Live Without Limits

Play Your Hand

You have to play the cards you are dealt. Although you can exert control over many of life's aspects, there are factors beyond your control. Any reaction of anger, blame, or regret will be self-defeating and counterproductive. You've got to take what you've been given and create a strategy to get the most from it.

Of course, who wouldn't want to have everything perfect? No one wants to deal with unpleasant or unfortunate circumstances. But they occur. Once they are present, you have no choice but to make the best of the situation.

Each person has their own idea of what defines a "good hand." The winner of a card game is not necessarily the one who had the best cards. The skilled player knows how to make the most of what they are dealt. Anyone who drops out of the game, when they get a bad hand, will rarely win and often stops playing altogether.

Similarly, winning in life requires the same approach. Every situation you face, and each set of circumstances you encounter, contains one or more opportunities to turn a bad hand into a winning one. It's not the cards you are dealt but how you play them that determines the outcome.

Life is a mix. Everyone gets

both good hands and lousy hands. No one is singled out for all good or all bad. What matters is how you react when your cards are less than ideal. Don't fall apart. Don't get angry. Don't blame others. Don't act like a victim.

You can't go back in time. There is no way to redo or undo events. You are where you are and circumstances are what they are. The only option is to work with what you have to move forward.

There are some simple things you can do to mitigate a bad hand. One option that produces absolutely no positive results is worry. Worry is a totally useless, unproductive, waste of time. Instead, identify what options are available. Evaluate each to determine the pros and cons. You are looking to see what you can do to get the most from what you've got.

Not all action you can take will be productive. Avoid activities that will make matters worse. Don't act impulsively with a knee jerk reaction. Always think before you act. Actions taken and words spoken can not be recalled once launched. Devote your time to only those actions that move you in a positive direc-

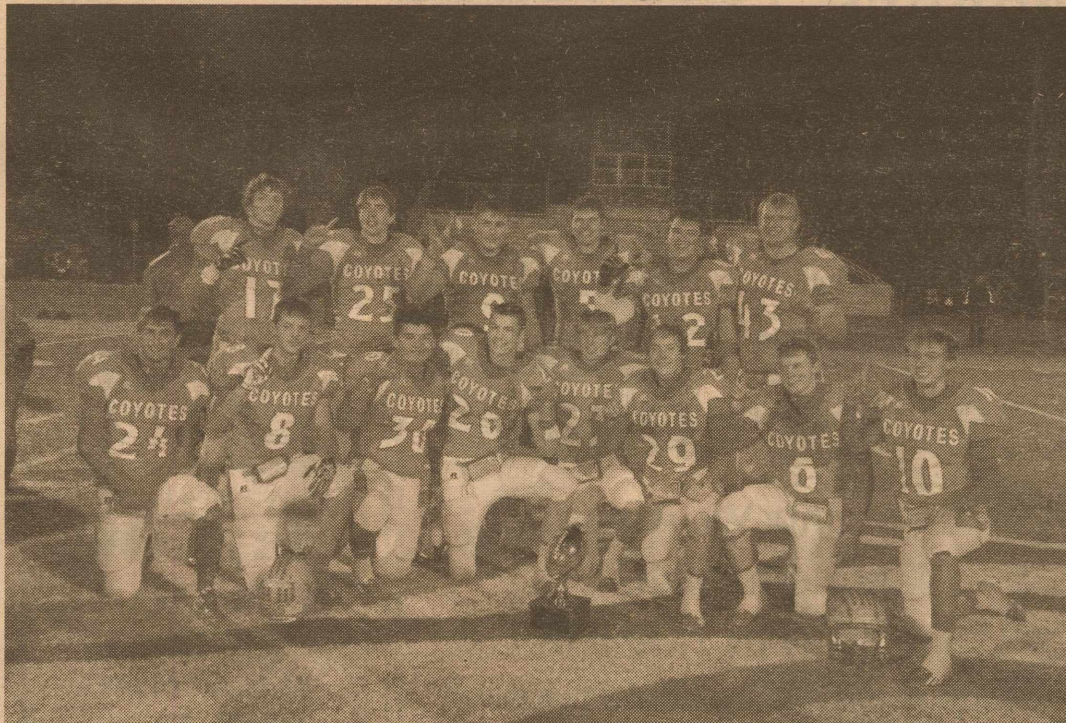
The Borden County Coyotes played host to the Sands Mustangs in a match-up that was predicted this summer to be for the district title during the 2011 season and that is exactly what the final regular

The cross country teams ended their season at the Regional Cross Country meet held in Arlington last weekend. Tye Basquez led the charge for the Lady Coyotes finishing just 3 spots shy of qualifying as an individual to the State meet. Tye finished 13th with a time of 13:04.76. Kalyn Massingill ran a personal best 13:33.46 which placed her 22nd overall. Pups Mash the Mustangs To Earn 5th District Title in Six

The Borden County Pups traveled to Ackerly Thursday in hopes of finishing the year with a 6 and 2 record, but more importantly a 4 and 0 record in district play. The home town Mustangs made things interesting most of the evening, but in the end, the Pups behind some timely passing by Thomas Harrison to go with a dominating rushing attack from Hunter Jones, Joel Andrade, Thomas Harrison, Colby Pennell, Rhaden Bland and newly inserted running back Nathan Souder, the Pups came away with a commanding 46 to 26 victory to grab the 2011 junior high district championship. This running game was a direct result of the blocking of linemen, Merrik Valentine, Joel Andrade, Kace Lott, Colby Pennell, and Robert Jordan.

The Pups got off to a very fast start as Hunter Jones reached pay dirt from 10 yards out to give the visitors from Gail a quick 6-0 lead, but Sands answered back to tie the game at 6. Nathan Souder then came in to debut in the backfield on a regular basis after he showed much promise on his carry in last weeks' game and he was needed as Jones got his bell rung and had to sit out for a few plays. Meanwhile the rushing attack of Souder helped produce another pup score to take a 12-6 lead. After Harrison hit Valentine in the endzone the Pups had a 13 to 6 lead. Again the Mustangs answered as they scored on a long run and made the extra point kick to take their first lead of the game at 14 to 13. Borden County answered right back as Souder followed a nice run by Valentine with one of his own to set the Pups up near the goal line. Souder took the hand-off and

followed some nice blocks by Lott, Valentine, Pennell, Harrison and Andrade to reach paydirt for his second score and gave the Pups a lead they would not surrender again.

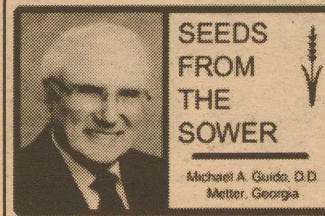
The Mustangs looked poised to retake the lead, but a nice defensive play near the goal line forced a Mustang fumble that was recovered by Pennell for the Pups. Joel Andrade rumbled for 20 yards on the first play to give Borden County some breathing room and then Souder made a couple of nice runs to get the Pups in scoring position. In fact they scored but had the touchdown called back due to a penalty. With time running out on the first half, Harrison made a tremendous throw to Jones on a beautiful 25 yard scoring strike to give the Pups a 25 to 14 lead. Harrison hit Valentine in the endzone again on the extra point play to push the lead to 26 to 14 at halftime.

The Pups came out in the 2nd half and continued their rushing dominance as Jones broke loose on a 55 yard run to extend the lead to 32 to 14. Jones added the point after run to make the score 33 to 14. The Mustangs would answer on a 4th down play from their own 7 yard line that resulted in a 73 yard touchdown run to cut the lead to 33 to 20. Borden County would answer with another nice run by Souder for another score from 34 yards out. Bland then got in the act with the extra point run to make the score 40 to 20. The Mustangs would get another score on a kick-off return against the Pups 2nd team to make the score 40 to 26. The Coyotes would get one more score to end the game as Thomas Harrison would get in the act on a nice 15 yard run to bring closure to the game and

seal the deal on a 46 to 26 district championship victory. This victory was also a strong credit to the improved defensive play of the Pups. Defensive ends Merrik Valentine, Joel Andrade, Kace Lott and Nathan Souder, corners Rhaden Bland, Robert Jordan, Colby Pennell and linebackers Thomas Harrison and Hunter Jones gave up a couple of scores but created a couple of turnovers and some very solid and bone crushing tackles that left a lasting impression on the hometown Mustangs.

Before this game, the 2nd team offense and defense play a 15 play scrimmage against the 2nd team Mustangs. The Pups put on a clinic in this 30 play scrimmage as the group of Dylan Murphy, Jayton Lewis, Kace Lott, Samuel Raborn, Flint Roberts and Braxton Coor completely dominated both sides of the ball. Each of the above mentioned plays had a hand in several tackles that resulted in giving up only a few positive plays but did allow one touchdown. On the offensive side, Robert Jordan joined this group to play quarterback and this team scored several times. Jayton Lewis scored on two 60 yard runs. Jordan hit Lott on a 60 yard scoring pass play. Flint Roberts had a 60 yard run for a score. Robert Jordan had a 60 yard run for a score and Braxton Coor had a couple of nice catches. In the end, this group scored 5 touchdowns while giving up the one.

Congratulations Pups on the great victory and a junior High district Championship. The future looks very bright for these young Pups. I would also like to thank all of the support that has been given to these young men throughout this exciting football season. Parents, we truly have enjoyed your enthusiasm and excitement and you all should be so very proud of your young men as they showed so much growth throughout the course of the 2011 football season. 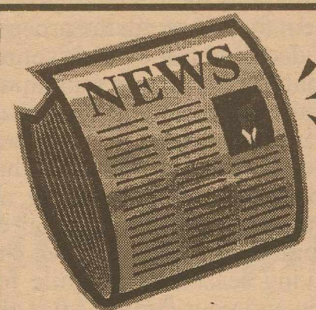

Feeling the need to help others, Borden County Coach Peter Benavidez has rallied his Spanish Club to conduct a fund raiser for Elora Rosales and Brooke Ballard.

The "Lassos For Love" roping competition next Saturday will benefit the medical funds of the two young ladies who are fighting life-threatening illnesses.

Rosales, a 2011 O'Donnell High School graduate, was diagnosed with Stage 3 ovarian cancer just days after graduation in June.

She has undergone several chemotherapy treatments and has had to put her college plans on hold.

Rosales is the daughter of Chris and Mary Rosales.

Brooke is a five-year-old who needs a heart transplant. But in the last several weeks, her family reports that she has suffered several setbacks.

"Brooke is still struggling. For several weeks now she has been fighting fever, throwing up, has a lot of fluid in her lungs and has and the breathing tube in and out," said

Brooke's aunt, Alexis Rodriguez. "And with an infection, she is not eligible for a heart."

Doctors are doing everything they can to stabilize Brooke so that she may be put back at the top of the heart transplant list.

"She has the Berlin Heart, which is a mechanical heart that is attached to her heart. But since she is a child, her chest is not big enough to fit the Berlin inside so it rests on the outside of her chest," added

Rodriguez.

The Berlin Heart is keeping Brooke alive until she can receive a new heart.

"She did sit up for the first time in nearly two months yesterday! She is very scared and in some pain. But she is so kind, smart, helpful and in good spirits. She will never give up," Rodriguez said.

Roping books open at 12 noon next Saturday at the Borden County Event Center Rodeo Arena.

"Please come help support a very worthwhile cause," said Coach Benavidez. "All proceeds go to helping these two beautiful young ladies continue fighting courageously for their lives."

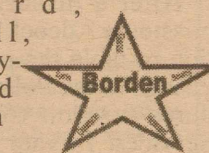

Crews Begin Removing Night and Truck Speed Limit Signs

Crews began removing night and truck speed limit signs in TxDot's 13-county Abilene District November 4th.

The 65 mph nighttime and truck speed limit was eliminated by HB 1353 enacted by the 82nd Legislature. Although the law went into effect September 1st, signs are just now coming down because the removal had to be scheduled by contract throughout the entire state, said Roy Wright P.E., Transportation Operations Director for TxDOT's Abilene District.

Signs along I-20 in Callahan, Taylor, Nolan, Mitchell and Howard Counties were removed first, beginning November 4. Signs along other highways throughout the district will be removed over the next two weeks. The Abilene District includes Kent, Stone-wall, Haskell, Borden, Scurry, Fisher, Jones, Shackelford, Howard, Mitchell, Nolan, Taylor and Callahan counties.

DISCUSSION FOR FUTURE AGENDA

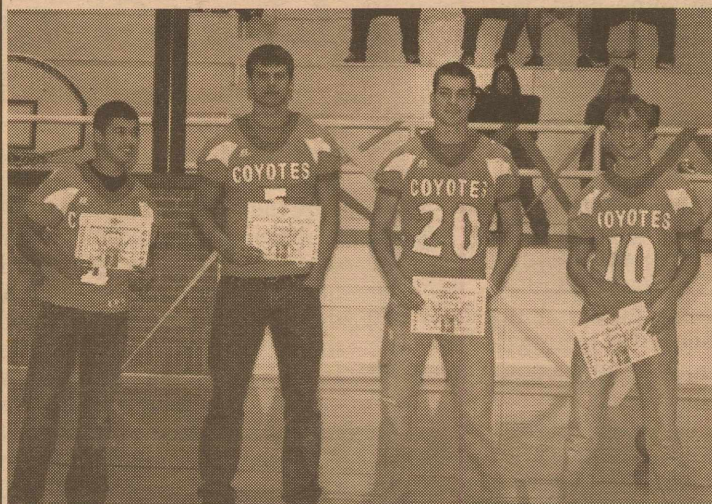

The Board of Trustees of the Borden County Independent School District of Gail, Texas, met in regular session at 7:00 P.M. in the Conference Room of the Borden County I.S.D. Board members present were John Anderson, Joel Dennis, Joe Harding, Dennis Poole, and Mike Valentine. Carol Lewis and Randy Hensley were absent. Superintendent, Jimmy Thomas and principal, Bart McMeans were also present. Guests present were Santana Gonzales, and James Hicks.

1. The meeting was called to order at 7:00 P.M. by John Anderson.

2. There was no community input.

3. A motion was made by Joel Dennis and seconded by Dennis Poole to approve the minutes of the September 19, 2011 board meetings. The motion carried unanimously.

4. A motion was made by Mike Valentine and seconded by Joe Harding to approve the October 2011, bills. The motion carried unanimously.

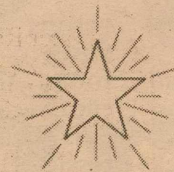

struggles in that department as well.

With all of that being said, the Coyotes found out moments before the opening kick-off that their senior tailback/cornerback Austin Fields would not be able to play in this game due to a calf injury. With that injury Collin Telchik would have to step into the role of the feature back having only averaged 5 carries a game on the season. Collin stepped in and carried the ball 17 times in this contest and did an amazing job rushing for a career high 235 yards. On those 17 carries, Collin also reached the endzone 4 times rushing and also caught a long touchdown pass from quarterback Tanner Richey. On the defensive side, corners Jared Smith and Austin Tyler usually rotate at their corner spot, but this time were asked to stay on the field at the corner positions and also it meant that sophomore Matt Ham would get an opportunity occasionally and he made two tremendous plays during the game and possibly one of the biggest tackles of his brief varsity career during the final defensive possession of the game. Smith broke up a pass in the end zone on the Mustangs 8th 4th down opportunity of the game and was only the second time the Coyotes stopped the visiting Mustangs on 4th down. The pass break up gave Borden County the ball with a minute and a half left and with a first down carry by Telchik, the Coyotes were able to get into victory formation to kneel on the ball and secure their 4th consecutive district championship with the heart stopping 62 to 60 victory.

Things got going pretty fast for the home team. Collin Telchik after two plays of the Coyote defense and sophomore TJ Basquez recovered a Sands fumble, reached the endzone for the first of his 5 scores with 9 minutes left in the first to give the Coyotes a 5-0 lead. Helio Rosales behind a change in the front line of the extra point team was given more time to kick and the change resulted in Rosales making 7 of 8 kicks on the evening. This resulted in the difference in the game. The visiting Mustangs took the ensuing kick-off and after con-

verting the first of 6 fourth down conversions quickly found themselves in the endzone and tied the contest at 8-8. On the Coyotes next possession, Telchik scored on the first play from 45 yards out and with the Rosales kick Borden County again had the lead at 16 to 8. Sands countered with another 4th down conversion which also resulted in a score to tie the game again at 16.

On the next Coyote possession Richey found Quint Shafer on a 13 yard scoring strike to regain the lead at 22 to 16. The Mustangs again answered and also missed their extra point to make the score 22 to 22 just moments into the 2nd quarter. On the Coyotes next possession, they overcame a couple of penalties to reach the endzone as Richey hit Tristen Benavidez for his first career touchdown on the biggest stage of the season from 30 yards out. Rosales got back into the groove to give his team a 30 to 22 lead. Again though, the Mustangs converted a 4th down to tie the game at 30.

On the next Borden County offensive possession, the Coyotes got inside the Mustang 10 yard line, but facing a 3rd and 1 and then a 4th and 1 could not convert. To make matters worse, the Mustangs went for it on another 4th down play from their own 17 and not only converted took their first lead of the game with 2 and half minutes left on a busted play that resulted in a 63 yard scoring play to give the Mustangs a 36 to 30 lead but the 2nd missed extra point would prove to be the difference in this game later on.

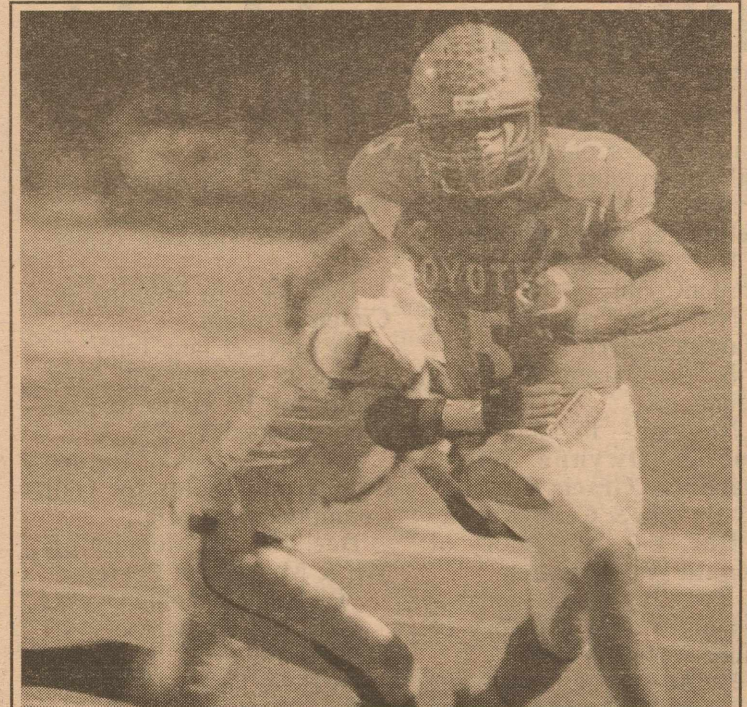
The Coyotes wasted very little time regaining the lead as Richey connected with Telchik on a nice 37 yard pass and catch with two minutes left in the first half. The Rosales kick gave the Coyotes the lead at 38 to 36, but the Mustangs would not slow down and they continued to put pressure on the home team. Just when it appeared that the visitors had run out of time in the first half they were given one more second on the clock from the Borden County 4 yard line. As the buzzer sounded the Mustang runner crossed the goal line to give the Mustangs a 44 to 38 lead heading into the locker

room.

On the opening kick-off of the 2nd half, the Mustangs, which use the onside kick on every kick-off of the game managed to knock the ball loose from a Coyote and recovered the onside to give Sands the ball in Coyote territory to start the 2nd half. As was the theme of the game, the Mustangs used a 4th down conversion to keep the drive alive and in the end managed to reach the endzone and push their 6 point lead to 14 at 52 to 38.

On the next Borden County possession, the home team started out with a nice pass and catch play from Richey to Shafer and then a nice telchik run followed by a Telchik 1 yard plunge to cut the lead to 52 to 46. The Coyotes again as had been the story of the game looked poised to get a stop, but a busted coverage allowed the Mustangs to reach paydirt again on a 58 yard scoring pass. After the kick the Mustangs had a 60 to 46 lead with 4:14 left in the third quarter. This would be the final points allowed by the Coyote defense. They finally got into a defensive rhythm as they were sparked by the return of junior helio Rosales who has missed the last couple of games due to an injured elbow. Helio came in at the start of the half and with his presence; the defensive intensity grew with each defensive possession.

The Coyotes took only one play to bounce back from their 2nd 14 point deficit of the evening as Telchik had his 5th and final touchdown of the evening with 4:00 minutes left in the 3rd quarter. Telchik, as had been the case all evening followed some very impressive blocks by the front line, fullback and quarterback that allowed Telchik to have the career night. Center Matt Roberson, guard Tristen Benavidez, end Quint Shafer, fullback TJ Basquez, and quarterbacks Tanner Richey and occasionally Jared Smith. Now, it was the defenses turn to finally get a few stops and that is just what they did as they quickly forced the ball over after holding the Mustangs on a 4th down play for the first time on the night.

Unfortunately, the Coyotes came up short on their own 4th down play inside the Mustang 20 yard line and they still trailed by 6 heading into the 4th quarter at 60 to 54.

On the next Coyote defensive possession, they forced the Mustangs to punt from near midfield with 7 minutes left in the game. On the punt, Richey hauled the ball in at his own 10 yard line. Just as he caught the ball he had to make a Sands defender miss and then another just to get rolling. After the 2nd defender missed, Richey got a nice block by Shafer and then another block by Austin Tyler and then it was a foot race to the end zone and the Coyotes were now tied at 60 with the extra point pending. On the extra point kick, Helio Rosales was true with his kick and Borden County rebounded from a 14 point deficit to regain the lead at 62 to 60.

Now, it was up to the defense to get a 3rd straight stop. The Mustangs managed to convert another 4th down on their final drive and looked poised to move in for the score to get the lead back, but a tremendous defensive play by Matt Ham on 3rd down forced the Mustangs into the 8th fourth down attempt. At this, Jared Smith stuck his hand in to break up the potential touchdown to give the Coyotes the ball and the victory. The third back to back district championships, the 4th straight for this years' senior class,

who ironically only had one player from that group play in the previous three district championship games in Austin Fields. He was the only one in that class that did not get to play in the final district championship game his senior year, but he and the other seniors will get to play in as many play-off games as possible as long as the Coyotes continue their winning ways. The Coyotes will next travel to Hermleigh on Friday the 11th of November to play the Aspermont Hornets at 7:30.

Leading the way for the district champion Coyotes was Collin Telchik with 17 carries and 235 yards rushing and 4 scores and 1 reception for 37 yards and a score. Quint Shafer had 16 tackles and a tackle for loss and 2 receptions for 47 yards and a score. Helio Rosales was 7 of 8 kicking and was in on 10 tackles and 2 for loss. Tristen Benavidez had 2 catches for 38 yards and a score and was in on 2 tackles. Matt Ham was in on 3 tackles and a pass break up. Kurt Shafer had 2 tackles. TJ Basquez had 15 tackles a fumble recovery and a tackle for loss. Austin Tyler had 11 tackles and a tackle for loss. Tanner Richey was 5 of 8 passing for 122 yards and 3 scores and 6 carries for 50 yards and was in on 21 tackles and a pass break up. Luke Burkett had a tackle. Matt Proulx had a tackle. Jared Smith had 5 tackles and the big pass break up. Matt Roberson had a tackle for loss.
