# Coyotes Sting the Hornets in Bi-District Battle

The Borden County Coyotes fresh off their fourth straight district championship matched up with the Aspermont Hornets for the second straight year in the Bidistrict round of the play-offs. As was the case a year ago, the Hornets came in with a solid record (9-1) and a care free attitude as they were big underdogs in this contest. The Hornets put up a tremendous fight early against the Borden County Coyotes in a game played at Hermleigh and their newly finished football facilities.

The home team on the scoreboard, the Aspermont Hornets got off to a very quick start as they scored on a run to take a quick 6-0 lead, but the Coyotes and Collin Telchik subbing for the injured Austin fields answered the Hornet score with one of their own as Telchik scampered in from 36 yards out. The Helio Rosales kick gave the Coyotes a 8-6 lead. The Hornets however would answer back on a busted play that resulted in a Hornet score and allowed them to regain the lead at 14 to 8. The visiting Coyotes again wasted very little time answering the Hornets as TJ Basquez got the first of his 4 scores from 22 yards out to regain the lead at

16 to 14.

On the next defensive possession for the Coyotes they stiffened and forced a punt by the Hornets. Again Borden County quickly marched down the field behind the running of Telchik and Basquez. The drive was then capped off by newly inserted tailback in our jumbo set, senior Quint Shafer as he scored from 7 yards out. A third straight extra point kick gave the Coyotes a 24 to 14 lead still in the first quarter.

The Hornets again would not fold up as they continued to attack the inexperienced corners of the Coyotes and ultimately led to another first quarter score for the Hornets and trimmed the lead to 24 to 20 in favor of Borden County. The visiting team again would answer as Basquez broke loose on a nice 45 yard run to push the lead back to 10 at 30 to 20.

The Hornets would turn a busted play into a long touchdown pass to cut the lead to 30 to 27, but that would be all the Coyotes would allow the rest of this game. Tanner Richey got into the act as he broke free on a 25 yard touchdown run and with the Rosales kick Borden County lead 38 to 27.

On the next defensive pos-

on the next defensive possession, Rosales would hit a runner from behind which would force a Hornet fumble and Richey picked it up and carried the pigskin across the goal line to end the half and with the Rosales kick Borden County had their largest lead of the evening at 46 to 27. The Coyote defense would not give up a first down in the entire second half of this Bi-district contest.



The Lady Coyotes beat the Roby Lady Lions 40-32 Saturday in Gail.







#### Helping Hands at the Holidays

scending for the holidays, the machine. number of helping hands in your household will (hopefully!) increase. But as dishes and laundry pile up, you may need to give those helpers a bit of direction. Not everyone understands the importance of reading the cleaning-product labels and using the proper dosage, which means using the correct amount of product for the job at hand.

to dishwashing detergent and laundry products, many people tend to guess about how much product to use and don't give any thought to the consequences of using too much or too little. In the dishwasher, too little detergent means that the dishes, glassware and utensils don't come out clean, but in-stead, if your water is hard, with film and spots on them. Still-dirty items will need to be rewashed by hand or put back into the dishwasher for another cleaning cycle. Too much detergent can also leave a film over everything. Over time, if you consistently use too much

With family and friends de- detergent, it can damage the

In the case of laundry, using too much detergent can make your clothes stiff and dingy. In addition, overdosing may require that consumers repeat the wash cycle. For consumers who are working to be more environmentally conscious, this can defeat the purpose and cause more water and energy to be used.



### **USDA** Announces Disaster Assistance Sign Up for 2010 **Crop Loss**

A) Executive Director VicFor more information on USDA Farm Service Agency (FSA) Executive Director Victor Ashley today announced that the Supplemental Revenue Assistance Payments (SURE) crop year losses began November 14, 2011. program enrollment for 2010

"Producers across the state sure. experienced several natural disasters during the 2010 crop year that caused hardship and financial losses to many agri-cultural operations," said Ashley. "The SURE program provides assistance to produc-ers when disaster strikes, so I strongly encourage producers with 2010 crop losses to con-tact the Garza-Borden County FSA office to learn more about the program," he said.

To qualify for a SURE pay-

ment, the producer's operation must be located in a county that was declared a disaster for 2010 and have at least a 10 percent production loss that affects one crop of economic significance. Producers with agricultural operations located outside a disaster county are eligible for SURE benefits if they had a production loss greater or equal to 50 percent of the normal production on

The following counties received a disaster designation during 2010: Borden, Crosby, Dawson, Dickens, Garza, Howard, Kent, Lubbock, Lynn, Martin, and Scurry.

To meet program eligibility requirements, producers must have obtained a policy or plan of insurance for all insurable crops through the Federal Crop Insurance Corporation and obtained Noninsured Crop Disaster Assistance Program (NAP) coverage on non-insurable crops, if available, from FSA. Eligible farmers and ranchers who meet the definition of a socially disadvantaged, limited resource or beginning farmer or rancher do not have to meet this requirement. Forage crops


