

How It All Began, The History of Borden County Schools The School

Editors Note: Dorothy Dennis was a long time resident of Borden County. She and her husband Bert arrived in the county in 1942. They operated the Flying D Ranch. Bert was the first rancher in the county to use a plane for ranch work. Dorothy and Bert raised three children: Steve, Joel and Lisa. This story about the consolidation of school districts comes from Dorothy's book, "In Pursuit of Happiness".

The Lamesa-Snyder highway was in the process of being paved when we arrived in Borden County in 1942. The ranch and farm roads were in terrible condition. When it rained it was almost impossible to move a vehicle through the mire. Ask Shirley Newton or Barbara Farmer to tell some of their experiences of getting to school during that era. At this time all high school and some elementary students were driven in buses to surrounding counties.

Since I had been reared in San Angelo I had some difficulty adjusting to the austere life I now led. World War II was at its height-everything was rationed- and I can remember going into Gail about every two weeks for the mail.

High School Track Gets Off to Great Start at Klondike

The Borden County Track teams got off to a very good start to the 2013 season as the Borden County Girls won the varsity girls division with a 156 points. The JV boys won their division with 183 points and the varsity boys won their division by two points winning the final event of the evening scoring 126 points to Meadow's 124 points.


The Varsity girls got gold medal performances from Zoie Key in the 3200 meter run and the 1600 meter run with times of 14:52.15 and 6:42.80. Zoie also helped the girls out by stepping in and replacing an injured Kalyn Massingill in the Mile Relay and ran a very solid anchor leg to help the quartet of Lady Coyote runners win the relay in a time of 4:47.2. Other members on that relay were fellow freshman Cheyenne Tucker, Tatum Richey and sophomore Tye Basquez. Cheyenne had a nice day running a leg on the 400 relay that finished 2nd and ran a 14.08 in the 100 to place 4th. She also finished 4th in the long jump with a 13'7" jump and 2nd in the triple jump with a 29'5" leap. Tatum Richey ran a leg on the winning 800 relay, finished 2nd in the long jump with a leap of 14'1 ¼" and won the triple jump with a leap of 29'9 ¾". Tatum qualified 2nd for the finals of the 100 hurdles but jumped the gun. At the request of the coach, she was allowed to run the race anyway but not allowed to receive points or a medal and she promptly ran a 18.09 to cross the line first in convincing fashion for some adding a silver in the 100 very valuable experience. Tye Basquez joined the 800 relay team of Richey, Massingill and Teryn Soto for the victory in a time of 2:02.62 and then finished 2nd in the 800 with a 2:43.82. Teryn Soto won the high jump with a leap of 4'8" then ran a leg on both the 400 relay and 800 relay before qualifying with the fastest time in the 200 with a nice time of 28.91 before faltering a bit in the finals to finish 5th. Another freshman Karly Etheredge ran Rhaedan Bland competed in a leg on the 2nd place 400 relay the high jump, the 100 meters with a time of 55.88 and then placing 6th with a time of 13.87

finished 6th in the 100 falling short of her best time of 13.78 in the prelims, running a 14.59 in the finals. Kalyn Massingill ran on the 400 and 800 relays and then won the long jump with a leap of 14'4" in spite of never hitting the board on her take-off. Bailey Robinson competed in the discus and shot put, finishing 4th in the discus with a throw of 62'9". Clair Shafer finished 5th in the shot put with a put of 27'8 ¹/₄" and Kalyn Dean finished 2nd with a put of 29'1".

In the JV boys division the Coyotes did not let a disqualification in the 400 relay slow them down as they still amassed 183 points. Helio Rosales won the JV shot with a throw of 36'8 ½" and was 2nd in the discus with a throw of 88'10" and ran two great legs on the 400 relay and the winning 800 relay. Rosales was joined on the 800 relay with Ricky Torres, Riley Herridge and Tristen Benavidez. Torres high jumped and long jumped, finishing 3rd with a jump of 15'8" and ran great legs on the 400 relay and the 3rd place 1600 relay. Benavidez ran solid legs in all three relays running the anchor in all three. In the sprint relay Tristen came from way back to catch the leader at the line but the coyotes had a baton exchange out of the zone for the DQ. Riley Herridge ran on the 3rd place 1600 relay and finished tied for 2nd with teammate Thomas Harrison in the pole vault with a jump of 8'0". Harrision turned in a great day as well meters with a time of 13.11 and a gold in the 200 with a time of 26.60. Colby Pennell joined Benavidez, Herridge and Torres on that 3rd place 1600 relay and then also competed in the long and triple jumps. Colby finished 2nd in the long with a jump of 16'0" and another 2nd in the triple with a jump of 34'4". Colby also took silver medals in the 400 meters and the 800 meters with a time of 63.3 and 2:33.28.

and 200 meters placing 5th with a time of 29.10. Robert Jordan also had a nice day winning the pole vault with a vault of 9'0" and then added a silver in the 3200 meters in a time of 12:51.75 and a gold in the 1600 meters with a time of 5:49. Cayden Vaughn finished 4th in the long jump with a leap of 14'10 1/4" and ran a leg on the 400 relay before injuring his leg. Michael Taylor threw the shot and discus, finishing 2nd in the shot with a 35'8 ½ and 3rd in the discus with a throw of 73'3". Joel Andrade won the discus with a throw of 91'4" and was 4th in the shot put with a put of 31'2". Joel also ran the 100 with a time of 15.53. Caelan Thuett also competed for the covotes in the JV division throwing the shot and discus not receiving no marks and then ran the 100 in a time of 15.28.

In the varsity boys division, the Coyotes used an tremendous effort in the mile relay to come from behind to grab the team championship away from Meadow by a score of 126 to 124. The relay team of Matt Ham, Jared Smith, Korbin Martinez and Matt Proulx ran a solid time of 3:49.20 to win the relay and help capture the team title. Proulx added the 400 meter gold winning in a time of 55.90. Matt Ham ran the lead leg on all three relays and Smith ran a leg on all three relays as well as the coyotes finished 4th in the 400 relay with a time of 47.45 and 3rd in the 800 relay with a time of 1:41.12. TJ Basquez who had a good day throwing the shot and discus joined these two along with Steven Howard in both relays. Basquez threw the discus 101'1" to finish 2nd and the shot put 45'11 ½" to grab the silver. Steven Howard ran the 100 in a time of 11.56 to finish 7th and also long jumped 17'5 ½". Kurt Shafer added a 3rd place finish for the coyotes in the 110 high hurdles with a 19.31 and 3rd in the triple jump as well with a jump of 37'4 1/2 Korbin Martinez and Jordan Martinez competing in their



Helping Your Child Feel Good

One of my favorite quotes is 'Parents need to fill a child's bucket of self-esteem so high that the rest of the world can't poke enough holes to drain it dry...' by Alvin Price. In this fast paced world we live in, we often neglect to take the time to fill those buckets. We are not necessarily draining them, but we are not filling them to overflowing as we should...

Many of us are concerned with how our child is received by his peers and his teachers, but do we concern ourselves with how our child feels about himself/herself? Often, we don't realize that they are having problems with self-esteem. Self-esteem is important for your child to grow to be the best that they can be. As a parent, it's important to help your child have a positive self-esteem. We want them to be happy and like themselves.

You can tell if your child has

You can tell if your child has a positive self-esteem by how they refer to themselves. Are they confident? Do they tell you how they feel? Do they put themselves down or praise themselves for a job well done? Does he/she get along with his friends? Do your child's friends respect him/her? All of these questions can serve as indicators of how your child views himself/herself. Your child will be responsive and eager to tell you about their accomplishments when they have a positive self-esteem.

In order to encourage a positive self-esteem in our child, we should praise them, not put them down. Do *not* use words like, "I cannot believe that you didn't listen to me *again*! You are so stupid. You'll never learn!" Instead of becoming angry and insulting your child, use positive words like, "I am sorry that you did not follow my instructions. Next time, you should listen and you won't have to be punished." Of course they are not perfect. We

all make mistakes, but the way to handle them is to make a lesson out of it. What did you learn from this mistake? How will you do things differently next time?

We must continually make an effort to be positive role models for our children. It is very difficult to do, especially if we do not think highly of ourselves. As adults, we can often lose our self-esteem to our spouse, our peers, our boss, our co-workers, etc. Follow the same ideas above to help strengthen your self-esteem. It is ok to praise yourself and feel good about you! After all, we should all be happy and enjoy the person we are. [Note: Even if you don't have children, these "rules" can still be applied to your everyday life.]

Ways to Praise a Child

Here are a few words to help us in praising our children, peers, or ourselves.

Wow • Special • Excellent • I'm proud of you • You're incredible • Bravo • You're fantastic • How nice • You're beautiful • You're spectacular • Hip, hip hurray • You are responsible • What an imagination • What a good listener • You're growing up • You tried hard • You mean a lot to me • You brighten my day • You mean the world to me • You're wonderful • You made my day • Way to go

Remember, a smile is worth 1000 words!

ted with Mrs. Cathey at the post office and couldn't pass up a visit with Mr. and Mrs. Dorward in the drug store. After the boys were big enough we began attending the Methodist Church in Gail

I truly had misgivings about the boys attending school at Gail. The old building left a lot to be desired and I felt it was a sorry place in which to entrust small children. It certainly was unsafe, with old, creaky wooden floors that shook every time you walked over them, and there was a strange, unpleasant odor permeating everything. There were no inside toilet facilities.

The school consisted of four

large rooms with sufficient lighting and a mammoth hall in the middle. There was a basement where we all gathered for school plays, Christ-mas parties and community suppers. Upstairs in the large hall I noticed that all the children put their lunches in wire cages and fastened them. One day I asked Mr. Harris why they did this and he said, "to keep out the rats!" Needless to say I nearly had a nervous breakdown and vowed to move to San Angelo as soon as possible. Every summer I thought about this more seriously, always torn between separating our family and the worry over doing what was right for the boys' education. I did realize Mrs. Harris was an excellent teacher. She was patient and kind and I must have turned it all over to God and Mrs. Harris, as I became so involved with taking care of the boys, feeding men at the ranch and constantly painting and papering the old ranch house that time began to rush by.

The first week Steve attended school was a night-mare! It had rained at least seven inches. There were no buses so we drove him in, a fourteen mile round trip and it took at least forty-five minutes to drive one way. I no more had arrived back home and prepared lunch than it was time to start back for him

The next year, Joel began school. A few years later we permitted them to drive an old pickup to the outside gate opened in the fall of 1952 but there was much yet to be done. There were no doors on class-rooms, for example, and many

where a bus picked them up. When they left in the pickup, all I could see were the tops of two coonskin caps. Each of the boys could write a book on their mishaps, such as knocking down gate posts, not putting on the brakes soon enough and going through the gates, and I am sure many happenings I don't even know about.

Bert began serving on the school board in 1948. It was soon evident that Borden County would have to do something about their school situation. O'Donnell and Coahoma had notified us that neither wanted our students any longer. Luckily in the late 40s the Reineke and Good oil fields were developed, giving hope to evaluation that would permit the consideration of building a school. So the Borden County Rural School District was formed.


These men were appointed to the county school board: Lloyd Murphy, who moved to New Mexico soon after his appointment. Melton Davis succeeded Mr. Murphy. Mr. Davis, a farmer, represented the Murphy district. Frank Beaver, rancher, represented the Glen Creek district. J.D. Shephard, stock farmer, represented the Willow Valley district. E.S. Kingston, farmer, represented the Mesquite district. Roy Burdett, farmer, represented the Plains district. Bert Dennis, rancher, represented the Gail district. S.P. Stewart was school superintendent and C.S. Harris was County Judge and County School Superintendent.

After the consolidation of the districts, the board had to vote bonds for construction of a school building. On June 1, 1951 bonds amounting to \$500,000 were voted for this purpose. Another bond election had to be held May 31, 1952 for \$150,000. This latter bond was needed in order to finish the school. The Korean Conflict had begun and prices soared, making it impossible to complete and furnish the school properly. The school opened in the fall of 1952 but there was much yet to be done. There were no doors on class-

details needed finishing.

During the planning and construction of the school plant there was a tremendous strain put on everyone as well as the board members. Each member traveled many miles for meetings every few days. Since communications were bad (the only phone in Gail was at Dorward Drug), Bert would fly over the home of each member and announce meetings over the loud speaker. Mr. Shephard told Doris Beaver an amusing story about the first time Bert flew over his home with a meeting announcement.

Watering Landscapes

tant concept in Earth-King landscaping is to water properly. Knowing when to water and for how long is fundamental to maintaining a quality landscape that is water effi-

Newly planted trees and shrubs will need more frequent watering from the planting time until they are well-rooted. During this establishment period, plants can be gradually weaned to a smaller amount of water. Proper weaning develops deep roots and makes plants "drought enduring"

Of the tremendous amount of water applied to lawns and gardens, much of it is never absorbed by the plants and put to use. Some water is lost to runoff by being applied faster than the soil can absorb it, and some water evaporated from exposed, unmulched soil before it can be sued by the plant. Yet the greatest waste of water is when too much is applied too often. More plants are killed by too much water than by too little.

Most lawns receive twice as much water as they require for a healthy appearance. It is best to not water by the calendar, for example, once a week. It is

Probably the most impor- better to water when the plant needs watering. Most gardeners can readily recognize lawn stresses due to lack of water, such as wilting and yellowing. The key to watering lawns is to apply the water as infrequently as possible, yet thor-

> As with lawns, trees and shrubs should be watered infrequently as possible, yet thoroughly. Most established trees and shrubs will benefit from a twice a month thorough watering during the growing season in the absence of adequate rain. Normal lawn watering is no substitute for thorough tree and shrub watering.

There are two types of irrigation systems for use in landscapes—sprinkler and drip irrigation. With a Earth-King landscape, it is recommended to use a combination of both systems in watering turfgrass, trees, shrubs, ground covers, flowers and vegetable gardens. When properly utilized, irrigation systems should give plants a sufficient amount of water without waste. In addition, planting areas which have a higher water requirement can by watered separately from lower-water-use plants by zoning the irrigation systems.

All in all, what a great start to the 2013 Coyote and Lady







didn't think of Bert's flying over until I attended that night's meeting.

Since the people in the county had never worked together on anything many of them looked at one another with distrust. The board members realized this and knew they had to get their act together. They began by appreciating and respecting one another, listening to problems, and working together for a common goal. They put in long hours and sometimes had to meet as often as four times a week. This on top of their regular work on their ranches and farms proved to be quite

being issued from heaven. I taxing on them physically and mentally. Besides the plans for the school, each member had to convince families in their district that it was necessary for them to send their children to school in Gail, whereas up to now these children had been attending other schools. It was decided to build small schools at Glen Creek {Miller}, Murphy and Plains in addition to the school at Gail. The Murphy and Glen Creek Schools had to close after a while due to the lack of children attending. The Plains school lasted a long time but finally closed and the building was converted to a community center. Now all children in

Borden County are brought to the centrally located modern

school facility in Gail. It was understandable how tough it was on children to change from their old schools and come to Gail, especially hard on high school students when friendships are so important. It was the most difficult to get the necessary four seniors required by state law, but these four did agree to come and we will always be grateful: Brent Murphy, Margaret Sexton, Bill Staggs, and James Worley.

Dedication of the new school was held at 3 p.m. on March 8, 1953. The write up in the Snyder paper read:

"Borden County, which covers 900 square miles of land and has a population of 1, 106 people, and its rural school district are being used as a model rural school system by both the Texas Education Agency and by national education organizations. There are 30 students enrolled in the sixth and seventh grades and

there are 124 pupils in the first six grades of the four schools in the system. The high school was built to accommodate more than 100 students but has only 35 at present. Three conventional school buses, two Jeep station wagons and two Chevrolet station wagons are used to transport students.'
