Greenbelt Bowl Gives Richey Good Tune-Up for College Shot

Being an all-stater all four years in his phenomenal high school football career at Gail, Borden County's Tanner Richey has made quite a name for himself in that game.

But, like most would agree, there is quite a difference between the six-man and 11-man games.

While Richey helped Borden County win more than its fair share of six-man games in the past four seasons, this 2013 Borden County graduate gave that 11-man a shot again last weekend at the Greenbelt Bowl at Childress.

Richey, who accounted for over 4,300 yards of offense last season in his final go-around as a coyote, ended up seeing playing time on both sides of the ball in last week-end's Greenbelt Bowl. Offensively, he played wide receiver where he hauled in a couple of catches in addition to playing free safety where he broke up a couple of pass plays.

Although Richey and the South ended up losing the high school all-star game at Childress to the North, 7-0, this four-time Borden County all-stater could not help but feel like a winner afterward.

"Absolutely! This ended up being an opportunity he'll never forget." said Borden County head football coach and Tanner's dad, Trey Richey.

Tanner ended up turning down a scholarship to play ball up at Wayland (Baptist). Those guys ended yp being his coaches in this all-star game. As parents, we couldn't help but be a little concerned going into this but we couldn't have expected our son to get treated any better than what those guys did last week and in this game.

In addition to coming up with big plays on both sides of the line of scrimmage, Tanner was also one of his team's captains.

"Getting the chance to play in this game was definitely a blessing," Trey said of his son's Greebelt Bowl experience.

'Tanner ended up getting a slight concussion on a kickoff return, which kept him out of the fourt quarter. That was Tanner's second concussion. The coaches up there called this week to check

The last time Tanner played any 11-man ball it was back when he was a sixth grader right here by playing in the Lamesa Youth Football League.

"It was lots of fun for him just getting the chance to play for guys who coach this game on a college level," Coach Trey Richey said. "Any parent should feel extremely comfortable sending their sons to play for these guys.

While some of the terminology as well as some of the routes were a little different than what Tanner was accustomed to playing back in high school at Gail, many of the things were the same.

Defensively, there were a lot of familiar points like back pedaling and breaking on a ball," Coach Richey said.

Last weekend's Greenbelt Bowl experience provided Tanner a good re-fresher course on the 11-man game for what lies ahead of him, starting this fall at Baylor University. This four-time six-man all-stater plans on giving college ball a shot in the Big 12 at Waco as a Baylor bear.

"As a parent, we just want to see him go out and experience this and then we'll see what happens from there," Coach Richey said. 'One of the biggest reasons why we want to see him try this now is that we don't want him to have any regrets about it later.

Perhaps, the biggest draw-back in Richey's Greenbelt Bowl experience was sustaining that second concussion


"Hopefully, that's something he won't' have to go through again,' Coach Richey said. "But, that's why we don't want him to play in that Texas Bowl this summer at

Who doesn't enjoy basking in the warm West Texas sun? We all do! Many of us spend the majority of our time outdoors, which means we are at a greater risk for sun damage or skin cancer. Therefore, we need to protect ourselves from the sun. There are a few simple things you can do to protect yourself from the damaging rays of the sun.

Minimize sun exposure between 10:00 a.m. and 4:00 p.m. when the sun is strongest.

- 1. Wear a hat, long sleeve shirts and long pants when out in the sun.
- 2. Apply a sunscreen before every exposure to the sun, and reapply frequently and liberally every two hours as long as you stay in the sun.
- 3. Remember to wear sunscreen even on overcast or cloudy days. The sun can be just as damaging on these days as on a sunny
- Beware of reflective surfaces such as sand, snow, concrete more than half of the sun's rays Newsletter onto your skin.

5. Last but not least, remember this slogan. SLIP on a longsleeve shirt, SLAP on a hat, and SLOP on the sunscreen!
