



In addition to their original problems, they have dug a deeper hole for themselves.

These individuals may even claim that they will cease their destructive behavior once their problems go away. This is just an excuse. Their problems won't fix themselves and will get worse. Subsequently, they will continue to spiral downward until they decide to end their harmful behavior and take



some Coyotes there was some welcoming news, as Nathan Ham would return to the field 6-weeks removed from his dislocated knee injury he suffered in the Rankin game. The Coyotes learned throughout the week that defensive leader and leading receiver Frank Banman would be used in a very minimal fashion due to reaggravating a knee injury. In fact, Banman the team's second leading tackler would play no defense in this contest.

The Coyote offense would take to the field first and as is their custom fashion wasted very little time driving down the field garnering their first points of the contest, using a 45 yard pass from Trace Richey to senior Cayden Vaughn to set them up deep in Cougar territory, senior Mason Coor found pay dirt moments later from 11 yards out to give Borden County a lead they would never relinquish. In fact, about the only thing that went wrong for the Coyotes on this day, after enduring a diffi-cult week was the kicking game, which has been a strength all season and will be again as the year progresses, but tonight the Coyotes struggled a bit on extra points as they failed to convert 4 times this evening. So, with all of that being said, they jumped out to a quick 6-0 lead. The defense got into the act as senior Sean Tucker caused a Cougar fumble and freshman Trace Richey jumped on it to give Borden County the ball back. Moments later the Coyotes extended their lead as Coor hit Frank Banman in the end zone with a nice and catch to give the visiting team a 12-0 lead with 6:56 left in the opening stanza.

The hometown Cougars mounted a nice drive which culminated with a one yard run to cut the Coyote lead in half at 12-6, but the Coyotes quickly answered as sophomore Hunter Jones sprinted 40 yards to a touchdown and extend the lead to 18 to 6. Riley Herridge booted the extra point thru the uprights to extend the lead to 20-6 with 2:51 left in period number one. The Borden County defense which played well all evening long got some great play by a couple

of players that stepped toward the end of last week with some solid play and had that effort carry over to this game. The Coyotes that stepped in played well on the defensive side were Ryan Willborn with his first start of the season, Cayden Vaughn returning to the starting lineup for the first time since early in the season and Colby Pennell who played his best defensive game of his var-sity career Friday night. After forcing a punt by the home town Cougars the Coyotes again wasted very little time adding to their point total, this time Trace Richey rumbled 20 yards to the end zone to give the Coyotes a 26 to 6 lead with 9:29 left in the 2<sup>nd</sup> period. The defense almost got into the act as Tucker and Pennell almost sacked the Cougar Quarterback in the end zone. Then, trying to just get rid of the ball almost saw Richey catch it for a touchdown, but in the end the Coyotes quickly took over the ball again and in one play added to their point total as Jones hit Tucker with a 5 yard strike to increase the lead to 32 to 6.

On the next possession Klondike again mounted a nice drive, converting a 4th down in the process before getting as close as the one yard line. On the first play on the one, jun-ior Korbin Martinez blitzed and sacked the Cougar quarterback for a loss putting some life back into the defense. After another stop on 3<sup>rd</sup> down the Cougars faced a 4<sup>th</sup> down at the Borden County 3 yard line, this time defensive coordinator Bubba Edwards blitzed Richey and his gamble paid off as Richey sacked the Cougar quarterback to give the ball back to the Coyotes. Once again they wasted almost no time as they used a two play drive, a nice 15 yard run by Coor followed by a 55 yard touchdown run by Hunter Jones. With the extra point kick by Herridge the Borden County had a 40 to 6 lead. The Cougars marched back into Coyote territory just before half, but back to back sacks by Colby Pennell ended any hope of scoring as Hunter Jones batted down a hail mary effort to end the half with Borden County up 40-6.

Klondike would get the 2nd

half kick-off and with the way several games have gone this season with the Coyotes having a sluggish 3rd quarter the first defensive series would be huge for the visitors. On the first play an innocent looking pass play turned into a turn-over as Richey, while making a tackle, forced the ball loose and Tucker jumped on the ball. The Coyotes would answer quickly as the offensive line of Banman, Herridge, Ricky Torres, Cayden Vaughn, Nathan Ham, Colby Pennell, Noah Morales dominated up front all evening and that's just what they did in this two play drive that ended with Coor reaching the end zone again. This time from 5 yards out and with another Herridge kick the Coyotes had a very commanding 48 to 6 lead. During the next Cougar drive, Colby Pennell while making one of his team high 13 tackles on the evening stripped the ball from the Klondike runner and even came up with it himself as he simply pulled the ball out of the home town runner giving the Coyotes the ball back. This time, they took to the air, but still in quick fashion as on the very first play Hunter Jones hit Riley Herridge with the District Championship clinching 33 yard touchdown pass ending the game due to the mercy rule at 54 to 6 with 8:05 left in the 3<sup>rd</sup> period.

What a great total team effort as the Coyotes will now host O'Donnell in the final regular season game of the 2014 season bringing a close to phase II of the season and bring us to phase III, the knock-out phase. The Coyotes entering the tournament hope to get five more games under their belt, but they also understand that records mean absolutely nothing now as a loss will end the season.

The Coyotes will play their

game Thursday instead of Friday as Cross country runner Korbin Martinez will be competing in the state cross country meet Saturday morning. O'Donnell also has a runner and a girl's team competing so it just made sense to give these young men and women a chance to have as much rest as possible before they run. The JV will play at 5:30 here followed by the final regular season game at 7:30.

Leading the way for the district champion Coyotes Friday was Mason Coor with 10 carries for 117 yards and 2 scores and was 1 of 1 passing for 19 yards and another score. Mason was also in on 3 tackles. Hunter Jones had 4 carries for 104 yards and 2 scores and was 2 of 3 passing for 38 yards and 2 scores. Hunter was also in on 9 tackles and a pass break up and an interception. Frank Banman had a 19 yard touchdown catch; Riley Herride was 3 of 7 on extra points and had a 33 yard touchdown catch. Sean Tucker had a 5 yard touchdown catch and was in on 6 tackles, caused a fumble, had a pressure a tackle for loss and a fumble recovery. Cayden Vaughn had a 45 yard reception and was in on a career high 10 tackles had a pass break up that is credited with an interception since it was a 4th down play. ### Diabetes Meal Plan and Daily Food Choice

right times is vital to keep blood glucose in control to manage your diabetes, but don't forget that foods must also be eaten in the right quantities. That's why carefully measuring the serving size is so important.

Portion size is the key to good blood glucose management, as is selecting foods wisely and then eating them in the right amounts throughout

The Diabetes Food Guide Pyramid has been adapted for people with diabetes, with attention to foods high in carbohydrates and those with little or no carbohydrates. For example, the starchy vegetable group is found within the grains, beans, and starchy vegetables group. Only the nonstarchy vegetables are included in the vegetables group. Ac-cording to the Diabetes Food Guide Pyramid, a healthy daily meal plan contains six or more servings of breads, cereals, rice and pasta, and starchy vegetables (potatoes, corn, green peas, etc.); three to five serv-ings of nonstarchy vegetables and two or four servings of fruits; two or three servings of milk, yogurt, and cheese; two or three servings of meat, poultry, fish, beans, eggs, or nuts; and small amounts of fats, oils, and sweets.

A popular meal plan uses exchange lists, where foods are given a certain value—starch exchange, milk exchange, and so on—which can then be mixed into a healthy daily menu. In 2007, the latest version of this meal plan was introduced, "Choose Your Foods: Diabetes Exchange List." One exchange is a single serving and can be substituted for other exchanges in a healthy manner. These easy-to-use substitutions can help people with diabetes count calories, maintain their blood sugar levels, and obtain

Eating the right foods at the nutrients. More information is available from the American Diabetes Association and the American Dietetic Associa-

Knowing what each exchange contains is important. For example, one starch exchange—bread, cereal, croutons, rolls, pasta, tortillas, etc.—has 15 grams of carbohydrate, three grams of protein. one or less gram of fat, and 80 calories. One fruit exchange or serving provides 15 grams of carbohydrate and 60 calories. One milk exchange provides 12 grams of carbohydrates, eight grams of protein, and differing amounts of fat and calo-

Counting carbohydrates is also a popular method of building healthy menu plans. This method provides several choices of carbohydrates for each meal and each snack. Each choice provides about 15 grams of carbohydrate, which might be a starch, a fruit, or a serving of milk.

Another method that has been helpful in controlling your portion size is what is called the plate method. To learn more about this useful tool for helping you control your blood glucose, be sure and enroll in the Do Well, Be Well with Diabetes classes offered through the Extension office to learn what this method of portion control using a visual approach can do to help you manage your food

Whichever meal plan you and your health care provider choose for you, portions must be monitored by measuring. A small scale designed for food portions can be helpful with this process. When food portions are measured in ounces, a scale can provide the most accurate portion control. Once you are more familiar with what these portions look like, you will be better able to guess- program.



No one wants problems but everyone has to deal with them. When they occur, you can minimize their longevity by handling them as quickly as possible. Attempting to run away from them will just prolong your problems as well as enabling them to get worse. Every problem has a solution. Put your energy into solving your problems, not running away.






