

# **Coyote JV Earn District Championship With Win Over the O'Donnell Eagles**

The Borden County Coyote yard pass and catch. The Coyote offense got the ball back and quickly extended their lead as Nick Proulx found a wide open Braxton Coor as the two connected with a 30 yard scoring strike extending the Coyotes lead to 18-6. After another defensive stop Brian Torres added another touchdown run that was set up by a Proulx to Thomas Nix 29

wasted very little time seizing control of this game. This game also meant the final home game for seven seniors. Unfortunately one of those seven would have to watch from the sidelines. Frank Banman, a three year starter for the Coyotes was sidelined with a knee injury hoping to comeback for the play-off run, which meant with only 6 healthy seniors they would be

able to take the field together. The six seniors, Sean Tucker, Mason Coor, Riley Herridge, Ricky Torres, Nathan Ham and Cayden Vaughn would step on the field together on the offensive side of the ball. This group used a 3 play drive to get on the board first for the Coyotes as on first down Mason Coor hit Ricky Torres with a nice 21 yard pass play. Coor followed with a 17 yard run and then capped it off with a 23 yard scoring strike from Riley Herridge to Nathan Ham to give the Coyotes a quick 6-0 lead. An interesting note, with the Ham touchdown, it meant that all 15 Coyote varsity players have scored a touchdown this season (that is an amazing stat). The Eagles came out in an offense the home team had not seen all season long and with it, the visi-tors had some early success only to see their drive come to an end as Hunter Jones forced a fumble that was recovered by Sean Tucker.

Moments later, with the seniors still at the helm the Coyotes would add to their lead as Mason Coor powered in from a yard out to cap the drive and Riley Herridge added the kick to make the score 14 to 0 with 3:58 left in the first quarter. Borden forced a punt by the visiting O'Donnell Eagles. On the first offensive play as the normal starters entered the game, the Coyotes extended the lead to 20-0 as Corbin Sumners followed blocks by Herridge, Tucker, Ham, Jones, and Trace Richey for a 59 yard jaunt to the end zone with 1:59 left in the first quarter. The Coyote defense got another stop as starters, Tucker, Jones, Richey, Cayden Vaughn, Colby Pennell and Korbin Martinez were joined with rotating subs of Ryan Willborn, Jayton Lewis, Corbin Sumners and Noah Morales. Moments af-

The Eagles used a busted coverage to get on the board as they cut the Borden County lead to 28 to 8, but the Coyotes quickly answered as a long run by Coor set up a 5 yard score by Sumners and the Herridge kick pushed the lead back to 36 to 8.

The Eagles would not quit however, as a long kick-off return set up the Eagles deep in Coyote territory and with another busted coverage the Eagles had another touchdown to cut the lead to 36 to 14. That would be all that the stingy Coyote defense would allow the rest of this contest. The Coyotes answered the latest Eagle score with a one play drive as Coor followed some very nice blocks to sprint untouched from 33 yards out. Herridge again split the up-rights to extend the Coyote lead to 44 to 14. On the next defensive possession Borden County continued to play everyone as Ricky Torres and Riley Herridge got into the action at defensive end and linebacker. Hunter Jones ended the Eagles next threat as he intercepted a pass in the end zone to give the ball back to the coy-otes. On their first offensive play, Corbin Sumners showed his speed as he outran the eagle defense on his way to a 76 yard touchdown. Herridge added the kick to make the score 52 to 14 with 6:05 left in the 2<sup>nd</sup> quarter. The Coyote defense forced the ball over on downs and again wasted very little adding to their lead as Sumners rumbled 14 yards to the end zone, unfortunately, needing only a point or the kick to make the game possibly end at half due to the mercy rule the coyotes missed the point after kick making the score 58 to 14 with 3:01 left in the half. The Eagles made a push to get a score just before half, but some nice pressure by Hunter Jones and passes broken up on back to back plays by Cayden Vaughn and Trace Richey the Coyotes kept the Eagles out of the end zone to end the half. ball to start the second half,



tackles and 166 yards on 6 carries and 4 touchdowns and 1 of 1 passing for 15 yards and a score; Trace Richey with 13 tackles including 3 tackles for loss, 2 pressures and a pass break up; Jayton Lewis with 6 tackles and a tackle for loss; Hunter Jones with 8 tackles, 2 pass break ups, an intercep-tion, 2 pressures and a caused fumble and 26 yards on one carry; Korbin Martinez had 6 tackles with 2 tackles for loss and Colby Pennell had 9 tackles and a pressure. 


A neighbor was sprinkling his lawn. The water was bursting forth from his hose.

Our Lord said, "Whosoever believes in Me. streams of living water will flow from within him."




### **District Food Show**



# **USDA Offers Farm Loans for Socially Disadvantaged Groups**

Agency (FSA) Executive Director, Judith A. Canales, reminds producers that FSA offers specially-targeted farm ownership and farm operating loans to Socially Disadvan-taged (SDA) applicants.

"Each year, a portion of FSA's loan funds are set aside to lend to socially disadvantaged farmers and ranchers,' said Canales. "Farming and ranching is a capital intensive business and FSA is committed to helping producers start and maintain their agricultural operations.

During fiscal year 2014 (Oct. 1 through Sept. 30, 2014) Texas FSA obligated \$52,2 million in SDA loans.

USDA defines socially dis-advantaged applicants as a group whose members have been subjected to racial, ethnic, or gender prejudice be-cause of their identity as members of the group without regard to their individual qualities. For farm loan program purposes, SDA groups are women, African Americans, American Indians and Alaskan Natives, Hispanics and Asians and Pacific Islanders.

SDA producers who cannot obtain commercial credit from a bank can apply for either FSA direct loans or guaranteed

loans are made by lending institutions who arrange for FSA to guarantee the loan. FSA can guarantee up to 95 percent of the loss of principal and interest on a loan. The FSA guarantee allows lenders to make agricultural credit available to producers who do not meet the lender's normal underwriting criteria.


The direct and guaranteed loan program offers two types of loans: farm ownership loans and farm operating loans.

Farm ownership loan funds may be used to purchase or enlarge a farm or ranch, purchase easements or right of way needed in the farm's operation, build or improve buildings such as a dwelling or barn, promote soil and water conservation and development and pay closing cost.

USDA Texas Farm Service loans. Direct loans are made to may be used to purchase live-gency (FSA) Executive Di-applicants by FSA. Guaranteed stock, poultry, farm equipment, fertilizer, and other materials necessary to operate a success-ful farm. Operating Loan funds can also be used for family living expenses, refinancing debts under certain conditions, paying salaries for hired farm laborers, installing or improving waters systems for home, livestock, or irrigation use and other similar improvements.

Repayment terms for direct operating loans depend on the collateral securing the loan and usually run from one to seven years. Financing for direct farm ownership loans cannot exceed 40 years. Interest rates for direct loans are set periodically according to the Government's cost of borrowing. Guaranteed loan terms and interest rates are set by the lender.

Johnny Lee has had a string bered the night we met. He hit songs. His recording of said he did. I told him I had of hit songs. His recording of LOOKING FOR LOVE topped the chats for three weeks. Other Johnny Lee Songs are CHEROKEE FIDDLE, HEY BAR-TENDER, RAMBLIN' ROSE and RED SAILS IN THE SUNSET. He has been sing-ing since he was in high school. He grew up on a dairy farm

herd cattle. Since I new the words to about every song on the radio, I'd sing out loud. Of course the only ones who could hear me were my horse and the cows.'

Singing outside like that probably gave him his deep and loud voice. It has served him well. In high school some guys were starting and band and were looking for a singer. That started his career and he's been singing ever since. His big break came when he met Mickey Gilley.

"He was Jerry Lee Lewis's cousin and was hot stuff. He had a nightclub in Pasadena called Gilley's. I wanted to get a job with a big star. I went up him and acted like I knew him from a while back and said, 'I know you don't remember me but I did a TV show with you in Galveston at the Pleasure Pier, the Larry Cain Show. You came on after me, but I had time to stick round and hear a couple of your songs.' He asked me what I was doing in town. I told him, 'I just wanted to stop by and say hello and tell you how great I think you are.' He said, 'well, hey, you want to sit in and sing a few songs?' I said, 'sure, what the heck.' I came back a few times and two months later he hire me. He gave me ninety dollars a week. Cash. All I had to do was sing five or six hours a night, seven nights a week. That was 1979. Then in 1980 when the movie URBAN COWBOY came out, and LOOKING FOR LOVE went gold and platinum and triple platinum, he raised me to a hundred dollars. But after I was working for him a while, I asked Mickey if he remem-

never seen him before in my life. He said, 'I didn't want to be rude, but I didn't remember vou, either."

Johnny Lee served two tours in Vet Nam while he was in the Navy. He has worked as a longshoreman, carpenter and appliance salesman. He per-forms somewhere every week near Houston. "I'd get out on a horse and until he dies. He says people till enjoy the music and he's booked solid. Occasionally

he'll sing on a cruise ship. "I used to watch OZZIE AND HARRIET when I was growing up. Ricky Nelson was my hero. When my granddad came out there, we had to switch to country. That used to irritate the heck out of me but looking back on my rebellious years, I wish I had learned to like country because it has changed.

After years of living in Branson, Missouri, Johnny has come home to Texas and bought some acreage near Sul-phur Springs. He wants to raise cows.


