USDA Announces 2015 Acreage Reporting Dates

In order to comply with FSA program eligibility requirements, all producers are encouraged to visit the Garza-Borden County FSA office to file an accurate crop certification report by the applicable deadline.

The following acreage reporting dates are applicable for Garza and Borden Counties:
July 15, 2015:

- Sorghum Forage planted

with the intended use of grazing or forage.

- CRP, Corn, Cotton, Grain Sorghum, Soybeans and Sunflowers

- Millet and Dual Purpose Sorghum

The following exceptions apply to the above acreage re-

porting dates:

If the crop has not been planted by the above acreage reporting date, then the acreage must be reported no later than 15 calendar days after planting is completed.

· If a producer acquires additional acreage after the above acreage reporting date, then the acreage must be reported no later than 30 calendars days after purchase or acquiring the lease. Appropriate documentation must be provided to the county office.

· If a perennial forage crop is reported with the intended use of "cover only," "green manure," "left standing," or "seed," then the acreage must be reported by July 15th.

Noninsured Crop Disaster Assistance Program (NAP) policy holders should note that the acreage reporting date for NAP covered crops is the earlier of the dates listed above or 15 calendar days before grazing or harvesting of the crop begins.

Art of Grief by guest writer T.R. Gardner

"Grief and love are conjoined; you don't get one without the other."—Jandy Nelson,

Sometimes I just want to do what Judy Benjamin did in the movie "Private Benjamin" after her husband of six hours dies. She holes up in a hotel for eight days and then enlists in the Army. While the military enlistment might not be the exact exit from the real world I

would choose, the point is, I would like sometimes to just disappear.

A broken heart. A very sick friend. Death. The loss of a job. The injustice of a rumor. The mean-spirited face of politics. A divorce. A debilitating illness. I'm not trying to ruin a positive image of Thanksgiving, but grief's cornucopia is filled with so many shapes, sizes, and sources of pain. The last thing I want to do is be grateful for that.

No one is protected from pain and grief. It is the club to which we all belong, the human

race, and sometimes it just stinks.

There is no shortage of books or spiritual resources or prayer chains that can do their part to guide us through the process. Well-intentioned comments abound. Cards in the mail can certainly let us know we are not alone. It still stinks.

The one—and perhaps only—redeeming facet of grief is that it stems from love. Had I not loved, my heart would not have been broken. Had I not had her or him for a friend, I might not be hurting now over her or his illness. If I didn't care about my country so much, the bitter campaigns would just be a funny reality show. Death would faze me less if I had not cared.

Love guarantees grief, and love will make us want to die.

Emily Dickinson's poetry, as it is prone to do, simplifies the concept of grief by posing all of us in as observers into other's pain. When we look at someone, what grief is written

"I wonder if it [grief] weighs like mine."
A more specific Dickinson would have written, "I wonder if a parent in Massachusetts who has buried a child grieves as much as a parent in Texas?

Does a cancer diagnosis in Canada create as much anxiety as one in a small town clinic

Of course the answer is yes. And herein lies the art of grief. It can be a beautiful thing to behold.

When people grieve, that pain stems from a deep love for someone or something that is gone: a life, security, health, career, a pet.

The only way any of those scenarios can be remotely beautiful to behold is what happens in their midst when human nature does what God intended it to do: love. We love by grieving, either for ourselves or for others.


It is no coincidence that on many walls in this part of the country are crosses, placed




