Earlier in the week, Borden hosted the second place team, Hermleigh. The Coyotes jumped out an early 16-10 first quarter lead. Borden would extend their lead at the half,

tightened their defense allowing only 12 points in the second half. The Coyotes scored 12 points in the third frame and 20 points in the fourth period to win the contest, 64-33.

Braxton Barnes led all scorers with 14 points and had three assists. Trace Richey added 11 points along with eight steals and six assists. Nick Proulx also scored 11 points for the Coyotes. Ben Justice chipped in seven points followed by Easton Edwards with five points. Corbin Sumners, Hunter Jones, and Diego Bernal contributed four points. Borden made 9 of 10 free throws in the second half to win the contest 42-37, and secured a spot in the champion-

ship game.

Justice finished the evening with 21 points followed by Morales with 10 points. Lewis added seven points and Yarbro chipped in four points.

In the championship game, Borden faced a very tough Lubbock Titan squad who had defeated the Coyotes earlier in the year, 39-22. The Titans brought a couple of reinforcements off their varsity for the tournament. The Coyotes struggled early with their of-fense and trailed 24-8 at the half. The Coyotes fought back the second half making the second half score at 29 all, but lost the contest 53-37.

Justice led all scorers with 26 points followed by Morales with three points. Lewis, Wilborn, Collins, and Yarbro finished with two points.

The Coyotes are 9-5 on the season and remain undefeated in district play.



Money Talks: Using Communication Skills to Discuss Finances

ever fought over money? You are not alone — most couples have experienced an argument or regular conflict about money. Regardless of income, money is one of the most common issues of conflict in a relationship. When money gets tight, the chance for conflict is even higher. Having to decide priorities of spending when money is tight is not an easy endeavor. However, there are some tips that can help when talking about issues that cause conflict. When bringing up a topic that is likely to be a source of conflict, use the SPEAK/HEAR skills to help.

Start with a positive. Start by saying something positive about your concern, such as "I know that it is important for our family to be financially safe" or "I'm glad that we agree that the bills must be paid first". We are all more eager to listen when the tone for the conversation starts with a posi-

Pay attention to what you say and how you say it. Be careful about the words you use, your tone of voice and your body language. You are more likely to be listened to if you speak in a gentle, non-

threatening way. Explain how you feel, using details. Share how something makes you feel and what specific situations have upset you. Use an "I" statement to take charge of your own feelings. Name the specific behavior that concerns you and how that behavior makes you feel. For example, "I feel frustrated when you say you will save money and instead you spend money on expensive coffeehouse drinks.

Avoid trigger words, like always and never. Trigger words are words that can quickly turn a conversation into a fight. These include words like always and never. cus on what your partner is versity of Missouri Extension

Have you and your partner Everyone has their own set of trigger words as well. Recognize these words and avoid us-

Keep it brief, then give your partner a chance to talk. Briefly share your concerns with your partner, then allow your partner a chance to paraphrase what you said and share his or

her thoughts.

Once you have had a chance to share your side of the story, give your partner a turn to use the SPEAK skills while you listen using the HEAR skills. Use HEAR skills when you are listening to your partner share thoughts, feelings, or concerns. When using the HEAR skills, you are only listening to your partner's viewpoint, not sharing your own.

Honor your partner's thoughts and feelings. Honoring your partner is about making your partner feel valued IA; and Tina Lewis of Dallas, and showing respect for his or her thoughts and feelings. Show your partner that you value him or her by listening and focusing on what your partner is saying, not what you Missy. want to say next.

Empathize: Put yourself in your partner's shoes. Empa-thizing with your partner means that you understand and can imagine how your partner might be feeling. Show your partner that you respect his or her feelings as being real and

Allow a difference of opinion. Even if you disagree with your partner, your job as the listener is only to listen to what your partner is saying and to repeat back what you hear. Don't judge your partner or share how you feel

Repeat respectfully. After your partner is done sharing his or her feelings, repeat what your partner said as closely to his or her words as you can. Repeating your partner's

The Lewis Family wrote their own eulogy.

Few words written here or spoken in the years to come could be as eloquent as their lives were.

But for posterity's sake, we



Despite the horrific way that events unfolded last Thursday, we are comforted by knowing that Jesus called them home, softly and tenderly—just as it should be for these three precious souls.


