We were talking to a Santa Anna citizen recently who brought this point home to us quite strongly. He has been employing a number of local workers, doing home repairs, carpentry, roofing, and a number of other related services. During the recent rash of reroofing necessitated here in Santa Anna,



Financial experts agree that any given amount of money spent in a community will change hands on an average of six times before leaving the city. This means that this one operation, this one "industry" increased the buying power of Santa Annans by some \$54,000.

While we aim at getting new industries for our city, we need to remember, and to appreciate, those that we have now, operations that are providing many jobs that would otherwise not be available, and adding im-measurably to the economy of Santa Anna.

We are fortunate to have a base of industry here, both the smaller informal type described above, and the regular industry usually considered when the term is used, such as the tile company, the hospital, the nurs-ing home, the burlap bag com-pany, and some others. And all of these parts of the local economic picture, working together, along with new and increased industry we can bring in, will ment opportunities to be found here, to the prosperity of our retail stores and businesses, and people of our town.
