

> Again, to sell the bonds below par would be a positive violation of the law, and it is not believed that our commissioners court would stoop to such a thing. The law explicitely states that these bonds must be sold to the highest and best bidder for

cash "at not less than their par value" if sold at all. That means 100 cents on the dollar and nothing less. They cannot be sold at 90 or 95 cents and the shortage made up by claiming the difference was paid the agent for selling them. Nor can the sale be made legal by transferring enough money from some other fund to this M. K. JACKSON, Agent. fund to make up the deficit.
