





### Heavy Load of Cotton.

Taylos, Tex., Sept. 26 .- Further illustrating the value and convenience of good macadam roads, John P. Burns, Jr., of the Rice community, ten miles south of Taylor, this morning drove into Taylor with sixteen bales of cotton loaded on one wagon and drawn by a team of two spans of mules. Estimating the weight of the driver, harness and wagon at 700 pounds, this team of four mules pulled a weight of 9,500 pounds a distance of ten miles in five hours time. Aside from the driver, wagon and mules, the value of the load was appreximately \$1,285.

\$36,000 Suit for Libel at Ballinger. Ballinger, Tex., Sept. 26 .-- The first ibel suit ever filed in the district court of this county was filed here today when Goldsdell & Srisham, of Winters, representing J. O. Harrell, Elgin Davidson and C. W. Caldwell. of Winters, filed three suits against the Western Telephone Company and the Ledger publishing Company for damages aggregating \$36,000.

The suit grew out of an article signed by A. W. Wood, manager of the Western Telephone Company, and published in the Daily Ledger of the 19th inst. J. O. Harrell is a stockholder and manager, and Davidson and Caldwell are stockholders, in an independent telephone company, with headquarters at Winters, known as the Bool Weavil Telephone Company. The independent company came into Ballinger with their line and competition has been very strong between the two companies and resulted in an article being written by the manager of the West Texas Telephone Compay attacking the responsibility and standing of the independent company. The controversy and suit between the two factions is attracting a great deal of attention.

# Written By a Nebraska Farmer, Who Writes of the Auto's Serviceability In the Country From Actual Experience.

It is said that thirty million dollars represents the value of the motor cars of Nebraska. That is a tremendous sum, but it is not a wasted value, for it represents human life, human happiness, human comfort and human progress. If anyone on earth needs the motor car it is the farmer. He lives a distance from town. All the city folks can use the street cars or attend meetings or go to business easily, but we the people on the farms, are the people who need these distance annihilators. You have heard the charge that the automobile leads to extravagance. Millions have gone into the telephone and come back to us again. Millions have been expended on rural mail routes, but the government estimates that the people realize big dividends on the investment. So it is with the automobile; it costs money, but happy families will earn more than it costs.

Isn't it better to buy a motor car and add ten years to mother's life? Let us figure. A satisfied, happy, jovial mother is worth, at a fair average, \$500 more a year than a cynical, dissatisfied one. If you can add ten years of happiness to her life you have enough to buy an auto and keep it going. Then a satisfied boy on the farm is worth \$500 more a year than a cynical, dissatisfied one, and if the auto keeps him that way it is pretty good interest on the \$1,280 you have invested. Besides that, it creates a big interest in machinery. He learns the use of gasolin and oil and becomes a mechanical expert when compared with his fathers of 60 years ago. A mechanical expert on the farm is worth some more good, hard cash.

But some people are so very practical that they cannot be convinced that happiness is worth a dollar. They have to see the actual eagle before they give up that anything pays. To those fellows we will say that scores of times the automobile brings in pretty good interest on the money. For instance, if some member of the family is feeling pretty sick and it would cost six or eight dollars to get the doctor, you can easily make up your mind to stand a trip in the auto, and by the time you get to town you are so much rested that you get a few doses of medicine and the doctor charges you 50 cents.

We needed some repairs in the harvest; one of the shockers stopped for an hour and th binder kept right on going. Often we go to town and get needed supplies before breakfast, or while the horses are resting at noon, and not an hour is lost, thus half a day is saved and in the busy season that means actual dollars. A neighbor driving by found that he had lost his endgate and was about to lose a load of hogs. We ran out the auto, went back a mile and found the endgate, while he watched the back of the wagon for a few minutes. A can of cream can be whisked to town in short order.

Then on the threshing eve the phone got out of order and we made a round before breakfast the next morning, then went to town, seven miles away, and got back before the machine was set for work, driving 20 miles in all

Perhaps you want to attend a sale some dozen miles away; you are there in an hour. I used my auto in assessing this precinct this spring and drove it over every mile of road in the six miles square, thus proving the fact that an automobile can be used on bad roads.

Tire trouble is the biggest bother, but we have a pair of inside tires and use them on the oldest tires, thus using them out completely. I now have on a tire that I threw away a year ago because it was We put some clinchers over the blowout, a heavy leather patch inside and then the inside blown out. tire and the inside tube. In this way tire trouble is greatly lessened, but these aids should be used when the fabric weakens and before the blowout comes then you can use tires longer

Do not always be tinkering with your engine; fix anything that needs it, oil liberally and ask the garage man to keep an eye on your machine.

If you are not in debt buy a Studebaker Car, if you want one, pay your own bills and be as happy as if you had saved up your money and bought an extra 80 that some poor fellow wants for a home.
