SNEED IS INDICTED.

Efforts to Get Bail Will be Stubbornly Fought-Banker Given Same **Treatment as Other Prisoners** 

The result of the grand jury investigation of the killing of A. G. Brice, Sr., was the returning of an indictment against J. B. Sneed, charging him with murder. Sneed's attorneys, McLean, Scott & McLean, announce that the trial will be called January 29th.

W. A. Hanger, of Fort Worth, counsel for Capt. Boyce in his successful efforts to secure the dismissal of the indictments against his son, Albert G. Boyce, Jr., already has been employed as special prosecution in the case. Other attorneys will also be employed to assist the state.

Any efforts to secure bail for Sneed will be stubbornly resisted, according to prosecuting attorneys. To an intimate friend and an attorney Henry Boyce said that he and his brothers would do everything in their power to prevent Sneed from being released on bond. Henry Boyce would make no comment on the killing of his father and even to his intimate friends he voiced no craving for personal vengeance. "I have no wish except that the law may take its course," he said,

In the jail the wealthy cattleman and banker occupies the same quarters as other prisopers. Under the rigid rules that governs the treatment of all prisoners, he gets the same fare, the same kind of bed and the same attention as others, although his friends relieve the tedium by sending him newspapers and magazines. He is allowed to talk with relatives, but no others are admitted by Jailer Moore.


